### ONLY LEAGUE ACTION SEEN ABLE TO SAVE DANZIG JEWS

DANZIG, Nov. 8. (JTA) -- ONLY STRONG INTERVENTION BY THE LEAGUE OF NATIONS CAN PREVENT THE FREE CITY FROM DRIVING ITS 7,000 JEWS OUT OF THE TERRITORY AND CONFISCATING THEIR CAPITAL, IT BECAME APPARENT TODAY AS A RESULT OF DEVELOPMENTS OVER THE WEEK-END.

ACTING UNDER ORDERS FROM BERLIN, THE DANZIG ADMINISTRATION HAS APPARENTLY DECIDED THE TIME IS RIPE TO CHALLENGE CONTROL BY THE LEAGUE BY IGNORING ITS GUARANTEE OF EQUAL RIGHTS FOR ALL, AND BY MAKING DANZIG "JUDENREIN" THROUGH PASSAGE OF LAWS SIMILAR TO THE NUREMBERG LAWS IN GERMANY AND THROUGH CONFISCATION OF JEWISH CAPITAL ON A LARGE, ORGANIZED SCALE.

IN WEEK-END SPEECHES, BOTH DR. ARTHUR GREISER, SENATE PRESIDENT, AND ALBERT FORSTER, NAZI DISTRICT LEADER, OPENLY DECLARED THE DANZIG ADMINISTRATION WAS DETERMINED TO RID THE FREE CITY OF ITS JEWS.

"FOR DANZIG-BORN JEWS," DR. GREISER STATED, "WE WILL INSTITUTE THE SAME LAWS AS IN GERMANY, WHILE JEWS WHO ARE FOREIGN-BORN WILL HAVE TO LEAVE DANZIG WHETHER THEY WISH TO OR NOT."

"WE PREFER TO SEE DANZIG DWINDLE TO NOTHING AND BECOME A SMALL TOWN IN THE GERMAN REICH," FORSTER ASSERTED, "RATHER THAN TO SEE IT PROSPER UNDER JEWS."

THE DANZIG AUTHORITIES ARE CONTINUING SEIZURE OF JEWS AND CONFISCATION OF THEIR PROPERTY, BEGUN LAST WEEK WITH THE ARREST OF SEVERAL JEWISH BUSINESS MEN AND IMPOUNDING OF SOME 2,000,000 GULDEN OF THEIR FUNDS. BANK ACCOUNTS OF JEWS ARE BEING CONFISCATED AND PROPERTY AUCTIONED OFF ON THE PRETEXT OF IMPOSING FINES FOR ALLEGED INCOME TAX IRREGULARITIES WHICH SUPPOSEDLY TOOK PLACE SIX OR EIGHT YEARS AGO.

THE REAL MOTIVES FOR THE CONFISCATION OF MONEY IS THE FEAR OF THE AUTHORITIES THAT THE JEWS WILL REMOVE THEIR CAPITAL FROM THE FREE CITY, SINCE WITH THE EXCEPTION OF DANZIG AND POLISH CURRENCIES, ALL CURRENCIES CAN BE EXPORTED OR OBTAINED WITHOUT RESTRICTIONS. CONFISCATIONS OF JEWISH CAPITAL TO DATE, IT IS ESTIMATED HERE, TOTAL MANY MILLION GULDEN.

THE AUTHORITIES HAVE ALSO PROHIBITED BUILDING OWNERS FROM RENEWING LEASES OR RENTING PROPERTY TO JEWS. SINCE ACCORDING TO DANZIG LAWS ANY BUSINESS MOVING FROM ONE STREET TO ANOTHER MUST OBTAIN A NEW LICENSE, THE NEW MEASURE PRACTICALLY MEANS JEWISH ENTERPRISES DEPENDANT ON RENTALS MUST GO OUT OF BUSINESS WITH THE END OF THE YEAR.

A CONFERENCE OF JEWISH LEADERS HERE DECIDED THE ONLY HOPE FOR DANZIG JEWS LAY IN ORGANIZED EMIGRATION TO PREVENT THEM FROM BECOMING BURDENS ON JEWISH ORGANIZATIONS ABROAD. AMONG PARTICIPANTS IN THE MEETING WAS DR. JAMES BERNSTEIN, DIRECTOR OF HIAS-ICA (JEWISH EMIGRANT AID SOCIETY), WHO MADE A SPECIAL TRIP FROM PARIS.

#### MEMORANDUM TO LEAGUE CITES DISCRIMINATIONS

GENEVA, Nov. 8. (JTA) -- DISCRIMINATORY MEASURES AGAINST DANZIG JEWS ARE LISTED IN A NEW MEMORANDUM SUBMITTED TODAY TO THE LEAGUE OF NATIONS BY DR. STEPHEN S. WISE ON BEHALF OF THE WORLD JEWISH CONGRESS.

LISTING FIVE MAJOR COMPLAINTS, DR. WISE DECLARES THE POSITION OF DANZIG JEWS HAS BECOME DESPERATE AND REVEALS THAT THE QUESTION OF AIDING THEM TO EMIGRATE IS BEING CONSIDERED. THOSE JEWS WHO REMAIN IN DANZIG, HOWEVER, MUST BE ASSURED OF AN ECONOMIC EXISTENCE, HE DECLARES.

HIS MEMORANDUM CITES THE FOLLOWING POINTS:

1--GAULEITER ALBERT FORSTER RECENTLY ATTACKED THE JEWISH POPULATION IN DANZIG AND CALLED FOR A BOYCOTT OF THE JEWS;

2--DR. ARTHUR GREISER, SENATE PRESIDENT, TOLD A JEWISH DELEGATION THAT DANZIG LIFE WOULD BE SYNCHRONIZED WITH GERMANY, EVEN IF THAT VIOLATES THE CONSTITUTION;

3--MANY ANTI-JEWISH REGULATIONS HAVE BEEN RECENTLY ENFORCED, SUCH AS JEWS' BEING PROHIBITED FROM USE OF PUBLIC BATHS, JEWISH DOCTORS EXCLUDED FROM NIGHT SERVICES; JEWISH BUSINESSES OUSTED FROM CENTRAL STREETS BY APPLYING PRESSURE TO THE OWNERS OF BUSINESS PREMISES TO TERMINATE LEASES OF JEWISH MERCHANTS; OTHER JEWISH MERCHANTS FORCED TO SELL OUT AT LOW PRICES TO "ARYAN" COMPETITORS;

4--STRICT FINANCIAL MEASURES HAVE BEEN TAKEN AGAINST JEWS ON THE PRETEXT OF EXAMINATION OF THEIR ACCOUNTS;

5--THE DANZIG SENATE IS PREPARING A NEW LAW PROHIBITING EMPLOYMENT OF "NON-ARYAN" SHOP ASSISTANTS AND CLERKS.

#### 500 JEWS SEIZED IN BUDAPEST RAIDS; 30 TO BE DEPORTED

BUDAPEST, Nov. 8. (JTA) -- THIRTY OF MORE THAN 500 JEWS SEIZED IN POLICE RAIDS HERE WILL BE DEPORTED TO THEIR COUNTRIES OF ORIGIN, IT WAS STATED TODAY. THEY WERE DETAINED FOR DEPORTATION WHEN THEY COULD NOT PRODUCE PROPER IDENTIFICATION PAPERS.

THE RAIDS, LARGEST IN BUDAPEST'S HISTORY, WERE CARRIED OUT DURING THE NIGHT IN THE CITY'S JEWISH QUARTER, THE POLICE DRAGGING MEN, WOMEN AND CHILDREN FROM THEIR BEDS AND RUSHING THEM BY AUTOMOBILE TO HEADQUARTERS, WHERE THEY WERE HELD FOR QUESTIONING THE ENTIRE DAY. ALL BUT THE 30 HELD FOR DEPORTATION WERE RELEASED.

THE OFFICIAL HUNGARIAN NEWS AGENCY ANNOUNCED THIS MORNING THAT THE ALIENS DEPARTMENT ALONE WAS RESPONSIBLE FOR THE RAIDS. IN THE FUTURE, IT DECLARED, IDENTIFICATION PAPERS OF FOREIGNERS WILL BE EXAMINED STRICTLY BEFORE THEY ARE PERMITTED TO ENTER THE COUNTRY.

SMALLER RAIDS WERE CARRIED OUT IN THE SUBURBS OF ALTHOFEN, WHERE 15 PERSONS WERE ARRESTED, AND IN BONYHAD, SITE OF A FAMOUS YESHIVA.

TODAY'S NEWSPAPERS GIVE PROMINENT DISPLAY TO THE RAIDS, EMPHASIZING THEIR UNUSUAL NATURE. THE ACTION WAS MOTIVATED, IT WAS STATED, BY THE SUSPICION THAT MANY POLISH JEWS HAD ENTERED THE COUNTRY ILLEGALLY IN RECENT MONTHS. THE ANTI-SEMITIC PAPER VIRRADAT JUSTIFIES THE RAIDS ON THE GROUND OF AN INFLUX OF GALICIAN JEWS.

#### ARAB DISORDERS CONTINUE; SOLDIERS CONSTANTLY UNDER ARMS

JERUSALEM, Nov. 8. (JTA) -- BRITISH SOLDIERS WERE ORDERED TODAY NOT TO LEAVE CAMP UNARMED AND FORBIDDEN TO PATRONIZE ENTERTAINMENT PLACES IN SOME TOWNS AS ARAB DISORDERS CONTINUED IN VARIOUS PARTS OF PALESTINE.

AT HEBRON, AN ARAB AND A BOY WERE SERIOUSLY WOUNDED WHILE FILLING A BOMB WHICH EXPLODED PREMATURELY. A JEWISH CAR WAS SHOT AT NEAR BENYAMINA AND THE OWNER WOUNDED. THIRTY-FIVE HEAD OF CATTLE WERE STOLEN BY AN ARAB BAND AT SEISSIL, NEAR HEBRON.

A PUNITIVE POLICE POST OF 20 HAS BEEN ESTABLISHED AT THE ARAB VILLAGE OF SILWAN IN CONNECTION WITH THE ATTACK ON TROOPS SEARCHING FOR THE SLAYERS OF TWO BRITISH SOLDIERS AND DISCOVERY OF MUNITIONS IN THE VILLAGE.

AN ARAB ARRESTED FOR OPPOSING POLICE AND THREATENING THEM WITH A REVOLVER DURING THE SEARCH OF THE OUTLAWED ARAB SUPREME COMMITTEE'S PREMISES WAS ACQUITTED IN COURT TODAY.

#### PALESTINE PROBLEM SURVEYED AS MANDATES COMMISSION OPENS SESSION

GENEVA, Nov. 8. (JTA) -- THE MANDATES COMMISSION OPENED ITS THIRTY-THIRD REGULAR SESSION TODAY UNDER THE CHAIRMANSHIP OF PROF. WILLIAM E. RAPPARD, VICE-PRESIDENT, WHO PRESENTED A DETAILED SURVEY OF THE LEAGUE OF NATIONS COUNCIL AND ASSEMBLY.

THE COMMISSION DECIDED TO POSTPONE CONSIDERATION OF VARIOUS PETITIONS TO THE SPRING SESSION. AMONG THE PETITIONS IS ONE FROM HAJ AMIN EL HUSSEINI, FUGITIVE MUFTI OF JERUSALEM, SUBMITTED BEFORE HE WAS DEPOSED AS PRESIDENT OF THE MOSLEM SUPREME COUNCIL. THE PETITION REFERS AT LENGTH TO A SPEECH MADE BY DR. STEPHEN S. WISE AT THE RECENT ZIONIST CONGRESS IN ZURICH.

#### FOREIGN POLICY ASSOCIATION CALLS PARTITION PLAN "POLITICAL ABSURDITY"

WASHINGTON, Nov. 8. (JTA) -- THE BRITISH PLAN TO PARTITION PALESTINE IS TERMED "A POLITICAL ABSURDITY" AND HELD "FRAUGHT WITH THE GRAVEST DANGER" IN A REPORT MADE PUBLIC BY THE FOREIGN POLICY ASSOCIATION. THE REPORT ALSO STRESSES BRITAIN'S RESPONSIBILITY TO STAMP OUT ARAB TERRORISM.

THE AUTHOR OF THE REPORT, DAVID H. POPPER, CITES AS OBJECTIONS TO THE PLAN THE FACT THAT THE ALMOST 47 PER CENT OF THE JEWISH STATE'S POPULATION, OR 225,000, WOULD BE ARABS. HE ALSO POINTS OUT THAT SIX SEPARATE POLITICAL ENTITIES WOULD OCCUPY A COASTAL STRIP ONLY 400 MILES LONG.

WITHOUT ARAB-JEWISH UNDERSTANDING "NEITHER JEWS NOR ARABS CAN EXPLOIT THE FULL POTENTIALITIES OF PALESTINE," THE REPORT SAYS.

#### IMPORTANT MEXICAN SENATE BLOC ASKS ENTRY CURBS ON JEWS

MEXICO CITY, Nov. 8. (JTA) -- A RISING ANTI-SEMITIC CAMPAIGN HAS BEEN CLIMAXED BY A MOVEMENT, SUPPORTED BY AN IMPORTANT BLOC IN THE SENATE, TO PROHIBIT JEWISH IMMIGRATION BY AMENDING ENTRY REGULATIONS TO SET UP BARS AGAINST "UNDESIRABLE ELEMENTS" FROM ABROAD.

THE DRIVE, UNDER THE LEADERSHIP OF SENATOR SINLOA RODOLFO T. LOISA, WAS LAUNCHED AFTER PROPOSED RESTRICTIONS ON JEWS WERE DECLARED ILLEGAL BY THE INTERIOR MINISTER ON THE GROUND THEY DISCRIMINATED AGAINST A PARTICULAR RACE.

THE NEWLY-PROPOSED IMMIGRATION BARS WOULD BE SO STRICT THAT EVEN CHILDREN AND CLOSE RELATIVES OF JEWS NOW IN THE COUNTRY WOULD NOT BE PERMITTED TO ENTER. IN A STATEMENT TO THE NEWSPAPER EXCELSIOR SENATOR LOISA SUPPORTED HIS PROPOSAL BY HOLDING THE JEWS WERE "HARMFUL ELEMENTS." OTHER SENATORS CLAIMED SUPPORT OF LABOR ORGANIZATIONS FOR THE ENTRY RESTRICTIONS.

(THE NEW YORK TIMES REPORTED FROM MEXICO CITY TODAY THAT THE NATIONAL REVOLUTIONARY PARTY BLOC IN THE SENATE HAS ASKED THE INTERIOR DEPARTMENT TO SEND CONGRESS A LIST OF JEWS IN MEXICO, A REPORT ON THEIR STATUS UNDER MEXICAN LAW AND AN ESTIMATE OF THE AMOUNT OF CAPITAL THEY HAVE IN THE COUNTRY. THIS BLOC SUPPORTS PRESIDENT LAZARO CARDENAS.)

PRESIDENT CARDENAS RECENTLY PROMISED TO STUDY JEWISH COMPLAINTS AGAINST ANTI-SEMITIC PROPOSALS IN THE SENATE. THE JEWISH CHAMBER OF COMMERCE HAD TELEGRAPHED THE PRESIDENT ASKING FOR AN INTERVIEW. HE WIRED IN REPLY THAT HE WAS TOO BUSY TO SEE A DELEGATION, BUT ASKED THE CHAMBER TO SUBMIT A MEMORANDUM, WHICH HE SAID WOULD BE GIVEN FAIR CONSIDERATION.

#### JOHN M. SCHIFF ELECTED PRESIDENT OF HENRY STREET SETTLEMENT

NEW YORK, Nov. 8. (JTA) -- JOHN M. SCHIFF, NEPHEW OF THE LATE FELIX M. WARBURG AND GRANDSON OF THE LATE JACOB H. SCHIFF, HAS BEEN ELECTED PRESIDENT OF THE HENRY STREET SETTLEMENT SUCCEEDING MISS LILLIAN D. WALD, IT WAS ANNOUNCED TODAY.
