REICH FINANCING OF ANTI-SEMITIC PROPAGANDA ABROAD REVEALED BY BERNE ARREST

BERNE, SWITZERLAND, Nov. 23. (JTA) -- THE NAZI GOVERNMENT'S METHODS OF SPREADING ANTI-SEMITISM ABROAD AND FINANCING ANTI-JEWISH ACTIVITIES THROUGHOUT THE WORLD WERE REVEALED TODAY BY THE ARREST HERE OF BORIS TOEDLI, A SWISS CITIZEN, ON SUSPICION OF CONDUCTING ESPIONAGE ACTIVITIES ON BEHALF OF GERMANY.

POLICE DISCOVERED IN TOEDLI'S HOME 300 DOCUMENTS AND LETTERS INDICATING THAT HE AND OTHERS WERE IN CONSTANT TOUCH WITH THE THIRD REICH AND RECEIVED FUNDS AND INSTRUCTIONS FOR STIMULATING ANTI-JEWISH PROPAGANDA. POLICE IMPOUNDED MORE THAN 150 OF THE DOCUMENTS AND PHOTOGRAPHED THEM FOR USE AS EVIDENCE IN TOEDLI'S TRIAL.

AMONG THE DOCUMENTS ARE PAPERS INDICATING THAT THE GERMAN AUTHORITIES FINANCE THE ACTIVITIES OF WHITE RUSSIAN ANTI-SEMITES AND AID THEM TO THE POINT OF ISSUING GERMAN VISAS TO THEM.

AN OFFICIAL RECEIPT WAS FOUND, SIGNED BY TOEDLI ON MAY 5, 1935, ACKNOWLEDGING MONEY FROM GERMANY "COVERING THE COST OF THE PROTOCOLS TRIAL." THIS EVIDENTLY REFERS TO THE TRIAL IN BERNE IN THE AUTUMN OF 1934 IN WHICH THE JEWISH COMMUNITY INSTITUTED LIBEL PROCEEDINGS AGAINST SWISS NAZI LEADERS FOR DISTRIBUTING THE "PROTOCOLS OF THE ELDERS OF ZION," PURPORTED RECORD OF A PLOT FOR JEWISH DOMINATION OF THE WORLD. THE VERDICT AT THIS TRIAL DECLARED THE "PROTOCOLS" A FORGERY.

THE SEIZED DOCUMENTS ALSO INVOLVE A NUMBER OF RUSSIANS IN PARIS AND HARBIN, MANCHUKUO, INCLUDING MARKOFF, THE NOTORIOUS LEADER OF THE ANTI-SEMITIC FRACTION OF THE PRE-REVOLUTIONARY RUSSIAN DUMA. ACCORDING TO INFORMATION RECEIVED HERE, MARKOFF RECENTLY TRANSFERRED FROM PARIS TO ERFURT, GERMANY, WHERE HE IS ACTING AS ASSISTANT TO COL. ULRICH FLEISCHAUER'S "WELTDIENST," WORLD-WIDE ANTI-SEMITIC PROPAGANDA SERVICE.

TOEDLI, IT WAS SHOWN, ACTED AS BERNE REPRESENTATIVE OF THE WELTDIENST, AS WELL AS GAULEITER (NAZI DISTRICT LEADER) FOR BERNE AND ALSO DEPUTY LEADER OF THE RUSSIAN WORLD FASCIST ORGANIZATION, WHICH HAS HEADQUARTERS IN HARBIN. ALTHOUGH SWISS-BORN, TOEDLI LIVED MOST OF HIS LIFE IN RUSSIA, AND THE NAZIS ASSERTEDLY BROUGHT HIM FROM HARBIN TO SWITZERLAND IN ORDER TO USE HIS SWISS CITIZENSHIP TO COVER UP HIS NAZI ACTIVITIES.

AMONG TOEDLI'S DOCUMENTS POLICE UNEARTHED A LIST OF FALSE NAMES UNDER WHICH 26 NAZI AGENTS WERE SAID TO BE OPERATING IN VARIOUS COUNTRIES. THE PAPERS ALSO REVEALED THAT GERMAN CONSULATES HAVE BEEN INSTRUCTED TO ISSUE VISAS TO WHITE RUSSIANS ACTING AS GERMAN AGENTS WHO ARE INCAPABLE OF OBTAINING VISAS FROM THE NANSSEN INTERNATIONAL OFFICE FOR "STATELESS" REFUGEES.

SOME OF THESE RUSSIANS, IT WAS DISCLOSED BY THE DOCUMENTS, WERE PAID FROM NAZI SOURCES TO TRAVEL TO BERNE TO TESTIFY AGAINST THE JEWS AT THE SENSATIONAL "PROTOCOLS" TRIAL. THE MONEY APPEARED TO HAVE BEEN OBTAINED CHIEFLY FROM ALFRED ROSENBERG, "SPIRITUAL LEADER" OF THE THIRD REICH, AND DR. SIEVERT, ONE OF THE EDITORS OF REICHSFUEHRER HITLER'S VOELKISCHER BEOBSACHTER, CHIEF ORGAN OF THE GERMAN NAZI PARTY.

IN ADDITION TO THE FORTHCOMING TRIAL OF TOEDLI, THE SWISS FEDERAL AUTHORITIES ARE STARTING PROCEEDINGS AGAINST COL. FLEISCHAUER, ANTI-SEMITIC LAWYER AND PROPAGANDIST, ON CHARGES OF GIVING FALSE EVIDENCE AT THE 1934 TRIAL.

BRITAIN URGED TO CONSIDER ANTI-JEWISH PROPAGANDA IN TALKS WITH REICH

LONDON, Nov. 23. (JTA) -- THE BRITISH GOVERNMENT WAS URGED TODAY TO KEEP NAZI ANTI-SEMITIC PROPAGANDA IN MIND WHEN CONDUCTING NEGOTIATIONS WITH GERMANY, IN AN ADDRESS BY LEONARD G. MONTEFIORE, CO-CHAIRMAN OF THE JOINT FOREIGN COMMITTEE OF THE BOARD OF DEPUTIES OF BRITISH JEWS AND THE ANGLO-JEWISH ASSOCIATION.

MR. MONTEFIORE DISCUSSED BEFORE A MEETING OF THE BOARD OF DEPUTIES THE INTERNATIONAL ASPECTS OF NAZI ANTI-JEWISH PROPAGANDA, IN CONNECTION WITH THE VISIT TO BERLIN OF VISCOUNT HALIFAX, LORD PRESIDENT OF THE BRITISH CABINET COUNCIL.

REFERRING TO LORD HALIFAX'S VISIT TO AN EXHIBITION OF SPORTS TROPHIES IN GERMANY, MR. MONTEFIORE SAID THERE WAS ANOTHER EXHIBITION IN GERMANY WHERE HE WOULD HAVE FOUND JEWS OF ALL COUNTRIES HELD UP TO RIDICULE. THE ALLUSION WAS TO THE NAZI "ETERNAL JEW" EXHIBITION IN MUNICH.

"IF LORD HALIFAX VISITED THAT EXHIBITION," THE JEWISH LEADER SAID, "HE WOULD FIND DESCRIPTIONS DESIGNED TO HOLD UP TO RIDICULE AND HATRED THE JEWS IN WHATEVER COUNTRY THEY MAY BE. I SPEAK WITH SOME FEELING AS THERE ARE SOME OF MY OWN RELATIVES AMONG THEM."

"I URGE THAT IN ANY GENERAL DISCUSSION OF ANGLO-GERMAN RELATIONS THAT MAY TAKE PLACE IN THE NEAR FUTURE THESE THINGS BE BORNE IN MIND," MR. MONTEFIORE CONTINUED. "PILLORYING INSULTS HEAPED ON CITIZENS OF FOREIGN COUNTRIES CANNOT IN ANY SENSE BE REGARDED AS A MATTER OF INTERNAL POLICY."

HE ALSO HELD THAT THE COLLAPSE OF THE NAZI REGIME AS THE RESULT OF A MILITARY DEFEAT WOULD NOT NECESSARILY BRING TOLERANCE FOR THE JEWS, BUT RATHER THE PROBABILITY OF INCREASED PERSECUTION OF JEWS.

28 MORE SEIZED IN DRIVE ON TERRORISTS; 2 JEWS, 2 ARABS HURT IN CLASH

JERUSALEM, Nov. 23. (JTA) -- PRESSING ITS DRIVE TO STAMP OUT ARAB TERRORISM, THE AUTHORITIES TODAY ARRESTED 28 MORE SUSPECTED TERRORISTS IN THE VILLAGE OF AL MAZAR, NEAR JENIN, WHERE SHEIKH FARHAN ESSADI, 70-YEAR-OLD BANDIT CHIEFTAIN, AND THREE AIDES WERE SEIZED SUNDAY

NIGHT WITH ARMS AND AMMUNITION. SIX ARAB HOUSES, WHOSE OWNERS WERE CHARGED WITH HARBORING BANDITS, WILL BE DYNAMITED, IT WAS ANNOUNCED FOLLOWING THE NEWEST ARRESTS.

SHEIKH FARHAN, REGARDED AS SUCCESSOR TO SHEIKH KASSAM EL-DIN, TERRORIST GANG LEADER WHO WAS KILLED BY THE POLICE TWO YEARS AGO, WILL GO ON TRIAL TOMORROW AT HAIFA BEFORE THE NEWLY-ESTABLISHED MILITARY COURT. HE AND HIS AIDES FACE THE DEATH PENALTY UNDER THE POWERS GRANTED THE COURT.

A NEW REGULATION PUBLISHED TODAY IN THE OFFICIAL PALESTINE GAZETTE PUTS THE COURT'S DECISIONS BEYOND CHALLENGE. WRITS OF HABEAS CORPUS ISSUED BY CIVIL COURTS, THE REGULATION PROVIDES, WILL NOT BE ACCEPTED.

DISPUTE OVER TITLE TO LAND IN THE VICINITY OF HAIFA LED TODAY TO AN ATTACK BY ARABS OF THE VILLAGE OF SAADI UPON A GROUP OF PLOUGHMEN OF THE NEARBY JEWISH SETTLEMENT OF HAZOREA. TWO ARABS AND TWO JEWS WERE WOUNDED IN THE CLASH. THE ASSAILANTS WERE FINALLY DISPERSED BY A SUPERNUMERARY WHO FIRED HIS RIFLE INTO THE AIR.

BOMBS WERE THROWN NEAR THE BRITISH POLICE BARRACKS AT GAZA AND NEAR THE RAILWAY STATION. THE TRACKS WERE DAMAGED SHORTLY AFTER THE TRAIN TO EGYPT HAD PASSED. THE DISTRICT COMMISSIONER THREATENED PROMINENT ARAB CHIEFTAINS OF THE VICINITY WITH PENALTIES IF THE BOMB-THROWERS WERE NOT TURNED OVER TO THE POLICE BY NOON.

520 DETAINED UNDER EMERGENCY REGULATIONS

LONDON, Nov. 23. (JTA) -- COLONIAL SECRETARY WILLIAM ORMSBY-GORE REPORTED TO COMMONS TODAY IN REPLY TO A QUESTION THAT AT THE BEGINNING OF NOVEMBER 520 PERSONS HAD BEEN DETAINED UNDER EMERGENCY REGULATIONS IN PALESTINE.

OF THESE, 360 WERE CONFINED IN THE ACRE CONCENTRATION CAMP AND THE REMAINDER IN JAILS AND LOCK-UPS THROUGHOUT THE COUNTRY. "AS THESE ARE CASES OF PREVENTIVE DETENTION, NO QUESTION OF TRIAL OR CONVICTION ARISES," MR. ORMSBY-GORE SAID.

IT WAS REPORTED FROM BEIRUT THAT HIGH COMMISSIONER SIR ARTHUR GRENFELL WAUCHOPE HAS REQUESTED THE LEBANESE GOVERNMENT TO SEND TROOPS TO THE LEBANESE-PALESTINE FRONTIER TO CHECK SMUGGLING OF ARMS AND MEN.

CRACOW U. TO INTRODUCE "GHETTO" BENCHES; WAWELBERG STUDENTS STILL BARRED

WARSAW, Nov. 23. (JTA) -- CRACOW UNIVERSITY TODAY JOINED UNIVERSITIES IN WARSAW, POZNAN AND WILNO IN DECREERING "GHETTO" BENCHES FOR USE OF JEWISH STUDENTS.

THE UNIVERSITY'S RECTOR, FOLLOWING REPEATED DISORDERS ARISING FROM EFFORTS OF NATIONALIST STUDENTS TO FORCE SEGREGATION OF JEWS AND AFTER A DELEGATION HAD CALLED ON HIM WITH A REQUEST THAT THE BENCHES BE INSTITUTED, ANNOUNCED THE SYSTEM WOULD BE INTRODUCED WITHIN THE NEXT FEW DAYS. HE CALLED UPON STUDENTS TO MAINTAIN ORDER.

MEANWHILE, ATTACKS ON JEWS CONTINUED, NATIONALIST STUDENTS BEATING UP SEVERAL AND EJECTING THEM FROM CLASSROOMS IN THE ANATOMICAL FACULTY.

WARSAW ENGINEERING SCHOOL, WHICH WAS FOUNDED FIFTY YEARS AGO BY THE JEWISH BANKERS, WAWELBERG AND ROTWAND, REFUSED TO RE-ADMIT THIRTEEN JEWISH STUDENTS EXPELLED BECAUSE THEY HAD BALKED AT USING "GHETTO" BENCHES. SENATOR MOSES SCHORR PROMISED A DELEGATION OF STUDENTS THAT HE WOULD INTERVENE ON THEIR BEHALF WITH THE MINISTER OF EDUCATION.

NATIONALIST STUDENTS IN THE MATHEMATICAL FACULTY AT WARSAW UNIVERSITY FORCED JEWISH STUDENTS TO OCCUPY THE SEGREGATED BENCHES DESPITE VIGOROUS RESISTANCE.

LABOR MEASURES TO RESPECT INTERNATIONAL OBLIGATIONS, TATARESCU PROMISES

BUCHAREST, Nov. 23. (JTA) -- INTERNATIONAL OBLIGATIONS WILL BE RESPECTED BY RUMANIA IN DRAFTING MEASURES FOR THE "PROTECTION OF NATIONAL LABOR," IT WAS ASSERTED TODAY BY PREMIER GEORG TATARESCU IN A PROCLAMATION TO THE NATION IN WHICH HE OUTLINED HIS GOVERNMENT'S POLICY ON MINORITIES.

"WE ARE GUIDED BY PRINCIPLES OF CONSTRUCTIVE NATIONALISM," THE PREMIER STATED, "IN OUR ACTIONS FOR THE PROTECTION OF NATIONAL LABOR, WHICH WILL BE COMPLETED BY MEASURES TAKEN WITH DUE RESPECT TO INTERNATIONAL OBLIGATIONS. THESE MEASURES DO NOT AFFECT THE POSSIBILITIES OF DEVELOPMENT OF LOCAL ETHNICAL MINORITIES WHO HAVE ADAPTED THEMSELVES TO LIFE IN THE STATE. RESPECT OF LANGUAGE AND CREED ASSURED WITHIN THE FRAMEWORK OF THE LAW, WE CALL ON MINORITIES TO COOPERATE FOR THE PROGRESS AND CONSOLIDATION OF THE COUNTRY."

THE PROCLAMATION CONCLUDED: "THE THOUGHT OF UNITY CONQUERS HATRED IN A SPIRIT OF UNDERSTANDING."

SHANGHAI JEWS APPEAL FOR MATZOTHS AFTER RAZING OF BAKERY

SHANGHAI (JTA) -- THE JEWISH COMMUNITY HERE, FACING ITS FIRST PASSOVER WITHOUT MATZOTH AS A RESULT OF THE DESTRUCTION BY SHELL-FIRE OF THE YANGZEPPOO MATZOH-FACTORY, HAS APPEALED TO AMERICAN JEWRY FOR 25,000 POUNDS OF MATZOH.

(IT WAS INCORRECTLY REPORTED IN YESTERDAY'S JTA NEWS THAT \$125,000 HAD BEEN REQUESTED. THE "25,000 POUNDS" MENTIONED IN A DISPATCH WAS THOUGHT TO BE MONEY, BUT LATER INFORMATION MADE IT CLEAR THAT IT WAS MATZOH WHICH WAS ASKED.)

CONNECTICUT TOWN MEETING VOTES AGAINST PERMITTING NAZI CAMP

SOUTHBURY, CONN., Nov. 23. (JTA) -- YANKEE FARMERS AT A TOWN MEETING TODAY VOTED AGAINST PERMITTING THE PRO-NAZI GERMAN-AMERICAN BUND TO ESTABLISH A CAMP HERE. EVERY RESIDENT OF THIS NEW ENGLAND TOWN, HAD RECEIVED A MAILED APPEAL TO ATTEND THE MEETING WITH AN ATTACHED REPRINT OF A MAGAZINE ARTICLE ON THE NAZI CAMP MOVEMENT CALLING IT A DIRECT ARM OF GERMAN GOVERNMENT PROPAGANDA. THE BUND HAS ACQUIRED A 178-ACRE TRACT IN THE KETTLETOWN SECTION.

MUFTI'S RETURN TO PALESTINE SEEN BY JURIST VITAL TO PEACE

NEW YORK, Nov. 23. (JTA) -- THE CONTENTION THAT THE RETURN OF THE DEPOSED MUFTI OF JERUSALEM IS NECESSARY FOR PALESTINE'S PEACE IS MADE BY PROF. PIERRE CRABITES, FORMER AMERICAN MEMBER AND CHIEF JUDGE OF THE MIXED INTERNATIONAL TRIBUNAL AT CAIRO, IN A THREE-COLUMN LETTER PUBLISHED BY THE NEW YORK TIMES SUNDAY. CRABITES, WHO IS NOW PROFESSOR OF LAW AT LOUISIANA UNIVERSITY, URGES ZIONISTS TO INSIST THAT THE EX-MUFTI, HAJ AMIN EL HUSSEINI, BE PERMITTED TO RETURN AND BE RESTORED TO HIS OFFICES ON THE GROUND THAT THEY WILL NEED HIS COOPERATION WHEN BRITAIN ABANDONS HER ROLE AS POLICEMAN IN PALESTINE.
