GOGA CABINET QUITS; COALITION, EXCLUDING EXTREMISTS, MAY RULE; CITIZENSHIP EDICT NOT VOIDED

BUCHAREST, FEB. 10. (JTA) -- OCTAVIAN GOGA'S SIX-WEEK-OLD GOVERNMENT COMPOSED OF MEMBERS OF HIS NATIONAL CHRISTIAN PARTY AND RIGHT-WING NATIONAL PEASANT PARTY LEADERS RESIGNED TODAY .

THE ANTI-SEMITIC, PRO-FASCIST CABINET WAS EXPECTED TO GIVE WAY TO A COALITION INCLUDING THE NATIONAL PEASANTS' PARTY, GOGA ADHERENTS AND OTHER PARTIES, BUT NOT INCLUD-ING FOLLOWERS OF PROF. ALEXANDER CUZA, CO-LEADER WITH GOGA OF THE NATIONAL CHRISTIANS. OR THE FASCIST "ALL FOR THE FATHERLAND" PARTY (IRON GUARD).

THE JEWISH TELEGRAPHIC AGENCY UNDERSTANDS THAT NO ESSENTIAL CHANGES ARE EXPECTED IN ANTI-SEMITIC REGULATIONS ALREADY ISSUED SINCE ANTI-JEWISH FEELING IS CONSIDERED IN OFFICIAL CIRCLES TO BE STRONG ALL OVER THE COUNTRY.

HOWEVER, IT WAS BELIEVED POSSIBLE THAT THE NEW GOVERNMENT MIGHT SOFT PEDAL ANTI-SEMITIC MEASURES IN ORDER TO RENDER THEM LESS OB JECTIONABLE TO OPINION IN DEMOCRATIC COUNTRIES.

A REPORT PUBLISHED ABROAD THAT THE JURIDICAL COMMITTEE HAS RULED UNCONSTITUTIONAL THE DECREE FOR REVISION OF NATURALIZATIONS BECAUSE IT SINGLES OUT THE JEWS WAS ASCERTAINED TO BE WITHOUT FOUNDATION.

IT IS UNDERSTOOD THE TERM FOR SUBMISSION OF DOCUMENTS ON REVISION OF JEWISH CIT-IZENSHIPS, EXPIRING FEB. 12, WILL BE EXTENDED BECAUSE REGULATIONS ESSENTIAL TO APPLICAT-ION OF THE ROYAL DECREE HAVE NOT YET BEEN PUBLISHED. THE REGULATIONS ARE EXPECTED TO BE PUBLISHED BY THE END OF THE WEEK.

PREMIER GOGA, WHOSE PARTY GAINED LESS THAN 10 PER CENT OF THE VOTES IN LAST DEC-EMBER'S ELECTION, RESIGNED WITHOUT WAITING FOR THE NEW PARLIAMENTARY ELECTIONS CALLED BY KING CAROL FOR MARCH 2. THE RESIGNATION CAME AFTER CAROL HAD SUMMONED A NUMBER OF POLITICAL LEADERS TO THE ROYAL PALACE FOR CONFERENCES.

(THE ASSOCIATED PRESS SAID KING CAROL HAD COMMISSIONED EX-PREMIER GEORGE MIRONESCU. FORMER LEADER OF THE NATIONAL PEASANTS PARTY, TO FORM A NEW CABINET. THE A.P. ALSO STATED THAT PATRIARCH MIRON CHRISTEA HAD DECLINED A SUGGESTION BY THE KING THAT HE TAKE OVER THE

BEFORE THE ANNOUNCEMENT OF THE GOVERNMENT'S RESIGNATION, IT WAS STATED THAT TWO RUMANIAN REPRESENTATIVES IN THE UNITED STATES WHO ARE JEWISH HAD BEEN RECALLED. THEY ARE CAROL TARCAUANU, CONSUL IN NEW YORK, AND JACOB ROSENTHAL, PRESS ATTACHE OF THE RUMANIAN LEGATION.

(THE STATUS OF THE TWO IN VIEW OF GOGA'S RESIGNATION WAS NOT CLEAR. THE RUMANIAN LEGATION IN WASHINGTON SAID THAT ROSENTHAL HAD BEEN RECALLED, BUT THAT THE RECALL WAS "ROUTINE." ROSENTHAL, WHO IS STATIONED IN NEW YORK, SAID WHEN REACHED AT THE HOTEL RITZ-CARLTON THAT HE HAD NOT BEEN NOTIFIED OF ANY RECALL AND DENIED REPORTS THAT HE HAD RESIGNED. HE HAS HELD HIS POST EIGHT YEARS. TARCAUANU ALSO ASSETTED THAT HE HAD RECEIVED NO NOTIFICATION OF RECALL. BOTH ARE CONTINUING THEIR DUTIES.)

THE MINISTRY OF HEALTH YESTERDAY ORDERED REVISION OF ALL MEDICAL AND PHARMACEUTICAL DIPLOMAS GRANTED SINCE 1919, THE YEAR THAT RUMANIA ANNEXED HUNGARIAN, AUSTRIAN AND RUSSIAN PROVINCES TO DOUBLE ITS TERRITORY AND POPULATION.

THE REVISION WILL BE CONDUCTED BY A SPECIAL COMMISSION COMPRISING AN APPEALS COURT JUDGE, TWO DOCTORS, A PHARMACIST AND A LAWYER. WITHIN 20 DAYS FROM TODAY ALL DOCTORS AND PHARMACISTS MUST SUBMIT TO THE COMMISSION THEIR DIPLOMAS, LICENSES TO PRACTICE, MATRICULATION CERTIFICATES AND NATIONALITY PAPERS. THE COMMISSION HAS BEEN EMPOWERED TO STRIKE FROM THE REGISTER ALL DOCTORS AND PHARMACISTS WHOSE PAPERS ARE NOT IN ORDER.

AT THE SAME TIME, THE JUSTICE MINISTRY DECIDED TO EXAMINE ALL DECISIONS SINCE 1919 WHICH PERMITTED JEWS TO CHANGE THEIR NAMES.

THE FOREIGN EXCHANGE BOARD ANNOUNCED FOREIGN CURRENCY WILL HENCEFORTH NOT BE GRANTED TO JEVISH STUDENTS STUDYING ABROAD. OWNERS OF BUCHAREST RESTAURANTS AND CAFES HAVE BEEN SUMMONED TO THE LABOR MINISTRY AND WARNED TO DISMISS ALL JEWISH WORKERS WITHIN 14 DAYS, INCOMPLIANCE WITH A RECENT LABOR MINISTRY DECREE.

MAYOR BRAIESCHU OF BUCHAREST DECIDED JEWISH FIRMS WERE NOT TO GET MUNICIPAL CONTRACTS.

7 NATIONS SIGN REFUGEE PACT; 4 OTHERS URGE SPECIAL BODIES TO HANDLE PROBLEM; POLAND BALKS

GENEVA, FEB. 10. (JTA) -- SEVEN GOVERNMENTS TODAY SIGNED A CONVENTION FOR THE REG-LATION OF THE LEGAL STATUS OF GERMAN REFUGES AT A PUBLIC SESSION CONCLUDING A FIVE-DAY INTERGOVERNMENTAL CONFERENCE. THE CONVENTION GOES INTO EFFECT IN MARCH.

THE SIGNATORIES ARE BRITAIN, FRANCE, BELGIUM, SPAIN, THE NETHERLANDS, DEMMARK AND NORWAY. ALL MADE RESERVATIONS REGARDING THE SECTIONS DEALING WITH SOCIAL RELIEF AND REGARDING THE APPLICATION OF THE CONVENTION TO COLONIES AND PROTECTORATES.

FOUR ADDITIONAL COUNTRIES -- CUBA, SWITZERLAND, SWEDEN AND CZECHOSLOVAKIA -- SIGNED A CODICIL RECOMMENDING THE ESTABLISHMENT OF A SPECIAL COMMISSION IN EACH COUNTRY TO DEAL WITH QUESTIONS RESPECTING REFUGES AND TO COOPERATE WITH ORGANIZATIONS FOR REFUGE ASSISTANCE.

POLAND REFUSED TO SIGN EITHER THE CONVENTION OR THE CODICIL. THE NETHERLANDS REPRESENTATIVE, BEFORE SIGNING, MADE A DECLARATION STRESSING THE NEED OF AN INTERNATIONAL ORGANIZATION TO DEAL WITH EMIGRATION OF FUGEES AND ANNOUNCING THAT THE NETHERLANDS WAS RAISING THE QUESTION AT THE SEPTEMBER SESSION OF THE LEAGUE OF NATIONS ASSEMBLY. THE PROPOSAL WAS SUPPORTED BY GREAT BRITAIN, SPAIN, BELGIUM, POLAND AND SWITZERLAND.

JEWS EXCLUDED FROM SCHOOL FEE CUTS IN PRUSSIA; JEWISH AUCTIONEERS BANNED

BERLIN, FEB. 10. (JTA) -- JEWISH AND ALSO "STATELESS" PUPILS ARE DEPRIVED OF THE BENEFIT OF A REDUCTION IN SCHOOL FEES IN PRUSSIA, IT WAS ANNOUNCED TODAY. THE REDUCTION INCREASES WITH EACH CHILD IN THE FAMILY AFTER THE FIRST. SIMILAR MEASURES ARE EXPECTED IN OTHER STATES.

(PERSONS HERE FAMILIAR WITH GERMANY'S EDUCATIONAL SYSTEM EXPLAINED THAT IT IS CUSTOMARY TO LEVY A SCHOOL TAX ON A FAMILY WHEN A CHILD ENTERS SCHOOL. THIS TAX IS PROGRESSIVELY REDUCED FOR EACH SUCCESSIVE CHILD OF A FAMILY WHO ENTERS SCHOOL. JEWS HAVE NOW BEEN BARRED IN PRUSSIA FROM THE BENEFITS OF THIS REDUCTION, AND HENCE MUST PAY THE SAME FEE FOR SUCCESSIVE CHILDREN AS FOR THE FIRST.)

JEWISH AUCTIONEERS, UNDER A DECREE OF THE ECONOMICS MINISTRY, WILL BE ELIMINATED AS OF JULY 31. EFFECTIVE IMMEDIATELY, NO LICENSES WILL BE ISSUED TO JEWS AND ALL PRESENT LICENSES OF JEWS EXPIRE JULY 31. THE DECREE AUTHORIZES THE MINISTER TO EXTEND THE RULE TO AUCTIONEERS' AGENTS.

BERLIN WOMEN ARE FORCED TO WEAR "CHEMICAL HATS" BECAUSE THE JEWISH-CONTROLLED HAT INDUSTRY IS BOYCOTTING THE ARTIFICIAL FLOWER INDUSTRY, DER ÄNGRIFF, A NAZI ORGAN, COMPLAINS. IT DESCRIBES THE "BOYCOTT" AS A "JEWISH TRICK" TO DESTROY THE ARTIFICIAL FLOWER INDUSTRY ONCE LARGELY IN JEWISH HANDS.

PALESTINE QUESTIONS GET THOROUGH AIRING IN HOUSE OF COMMONS

LONDON, FEB. 10. (JTA) -- ZIONIST LEADERS STUDIED TODAY THE PALESTINE DISCUSSION IN COMMONS YESTERDAY DURING WHICH COLONIAL SECRETARY WILLIAM ORMSBY-GORE REITERATED THE GOVERNMENT'S DETERMINATION TO PARTITION PALESTINE, DECLARED FUTURE IMMIGRATION POLICY HAD NOT BEEN DETERMINED, AND AVOIDED COMMENTING ON THE PLAN FOR A PALESTINE JEWISH DOMINION IN THE BRITISH COMMONMEALTH OF NATIONS.

REPLYING TO A SERIES OF INTERPELLATIONS FROM ALL SIDES OF THE HOUSE, THE COLONIAL SECRETARY SAID THE BRITISH GOVERNMENT STILL ADHERES TO PARTITION AS THE BEST SOLUTION OF THE PALESTINE PROBLEM. HE ANNOUNCED THAT "THE NEW TECHNICAL COMMISSION HAS BEEN APPOINTED TO WORK OUT A DEFINITE SCHEME, AS REQUIRED BY THE RESOLUTION PASSED BY COMMONS THE TWENTY-FIRST OF JULY."

WHEN CAPTAIN VICTOR CAZALET (CONSERVATIVE) ASKED IF THE MANDATE WOULD REMAIN IN FORCE UNTIL PARTITION WAS OPERATIVE, MR. ORMSBY-GORE SAID: "CERTAINLY! UNTIL THE MANDATE IS ENDED BY THE COUNCIL OF THE LEAGUE OF NATIONS, IT CANNOT BE ALTERED BY THE GOVERNMENT."

SIR PERCY HARRIS (LABORITE) INTERPOSED, POINTING TO THE CONSTERNATION CAUSED BY THE DELAY. THE COLONIAL SECRETARY DEPLORED THE DELAY, BUT REFERRED TO THE LEAGUE MANDATES COMMISSION'S REQUEST THAT AN ADEQUATE INTERVAL EXIST BETWEEN THE EXISTING MANDATE AND ANY FUTURE ARRANGEMENT.

MR. ORMSBY-GORE EVADED GIVING A DIRECT REPLY TO GEOFFREY MANDER'S (LIBERAL) REQUEST FOR A STATEMENT ON THE RESOLUTION OF THE BOARD OF DEPUTIES OF BRITISH JEWS FAVORING A JEWISH DOMINION. HE SAID THAT "THE DECLARED POLICY OF THE GOVERNMENT REGARDING PALESTINE HAS BEEN COMMUNICATED TO THE HOUSE,"

MR. MANDER ASKED WHETHER THE "GRATIFYING RESOLUTIONS" FAVORING A JEWISH DOMINION WOULD BE COMMUNICATED TO THE LEAGUE AND ITS MANDATES COMMISSION. MR. ORMSBY-GORE REPLIED: "I AM SURE THEY WILL. I DON'T KNOW, HOWEVER, WHETHER THEY WILL REGARD THEM WITH THE SAME ENTHUSIASM AS THE HONORABLE MEMBER."

HE DID NOT REPLY TO THE ASSERTION OF WILLIAM GALLACHER (COMMUNIST) THAT THE RESOLUT-

THE IMMIGRATION ISSUE WAS RAISED BY TOM WILLIAMS (LABORITE), WHO DECLARED THE IMPOSITION OF A POLITICAL HIGH LEVEL WAS INJURIOUSLY AFFECTING THE ECONOMIC LIFE OF PALESTINE.
HE ASKED WHETHER, IN VIEW OF THE COLONIAL SECRETARY'S STATEMENT IN GENEVA THAT THIS WAS
A TEMPORARY MEASURE AND THE MANDATES COMMISSION'S DECLARATION THAT IT CONSTITUTED A DEPARTURE FROM THE PRINCIPLE SANCTIONED BY THE COUNCIL, NR. ORMSBY-GORE WOULD GIVE ASSURANCE
THAT THE HIGH LEVEL WOULD NOT BE EXTENDED PAST MARCH 31 (WHEN THE CURRENT ENTRY SCHEDULE
EXPIRES).

MR. ORMSBY-GORE REPLIED THAT ARRANGEMENTS FOR IMMIGRATION AFTER MARCH WERE STILL UNDER CONSIDERATION AND HE WAS NOT IN A POSITION TO MAKE A STATEMENT YET. MR. WILLIAMS INTER-ECTED THAT THE UNCERTAINTY WAS HAVING A DISTRESSING EFFECT AND URGED A SPEEDY DECISION.

THE COLONIAL SECRETARY EXPRESSED THE HOPE THAT A DECISION WOULD SOON BE REACHED. "I REALIZE THAT UNTIL IT IS REACHED THE FLOOD OF PROPAGANDA AND COUNTER-PROPAGANDA I AM RECEIVING WILL CONTINUE." HE SAID.

D.L. LIPSON (INDEPENDENT CONSERVATIVE) ASKED MR. ORMSBY-GORE TO BEAR IN MIND THAT INCREASED SEVERITY OF ANTI-JEWISH MEASURES IN RUMANIA AND ELSEWHERE NECESSITATED A LARGE PALESTINE IMMIGRATION. THE COLONIAL SECRETARY RETORTED: "ALL THAT HAS TO BE TAKEN INTO CONSIDERATION, BUT THE ECONOMIC CONDITIONS OF THE JEWS IN PALESTINE MUST ALSO BE CONSIDERED."

THE COLONIAL SECRETARY TOLD THE HOUSE THAT TWO MURDERS, TWO SERIOUS WOUNDINGS, EIGHT SLIGHT CASUALTIES, ONE BOMBING AND SIX CASES OF SABOTAGE OCCURRED IN PALESTINE FROM JAN. 31 TO FEB. 7.

COURT RULING-MENACES STATUS OF 20,000 WHO ENTERED PALESTINE ILLEGALLY

TEL AVIV, FEB. 10. (JTA) -- THE STATUS OF AN ESTIMATED 20,000 JEWS WHOSE ENTRY TO PALESTINE WAS IRREGULAR WAS TODAY MADE PERMANENTLY INSECURE BY AN ASSIZE COURT RULING THAT ILLEGAL IMMIGRANTS MAY BE EXPELLED AT ANY TIME THEY ARE DISCOVERED. PREVIOUSLY THEY COULD BE DEPORTED ONLY IF DISCOVERED WITHIN TWO YEARS OF THEIR ENTRY.

PROCLAMATION URGES ARAB POLICEMEN TO DESERT TO TERRORIST BANDS; OFFERS HIGHER PAY

JERUSALEM, FEB. 10. (JTA) -- A PROCLAMATION, PURPORTEDLY SIGNED BY THE COMMANDER-INCHIEF OF PALESTINE TERRORISTS, TODAY URGED ARAB GHAFFIRS AND CONSTABLES TO DESERT THEIR GOVERNMENT JOBS AND ENLIST WITH ARAB BANDS AT HIGHER PAY. CIRCULATED THROUGHOUT PALESTINE, THE PROCLAMATION OFFERS GHAFFIRS MONTHLY SALARIES OF ABOUT \$18, AGAINST \$15 THEY RECEIVE IN THE GOVERNMENT SERVICE, AND CONSTABLES \$35 INSTEAD OF THEIR PRESENT WAGE OF \$30. DEATH IS THREATENED FOR FAILURE TO COMPLY WITHIN TWO WEEKS.

THE AUTHORITIES WARNED PALESTINE NEWSPAPERS NOT TO PUBLISH NEWS OF THE DOCUMENT. THEY ALSO FORBADE PUBLICATION OF THE ARREST IN HAIFA YESTERDAY OF HAJ ACHMUD EL HUSSEIN, KNOWN AS A FOLLOWER OF THE BANDIT CHIEFTAIN SHEIK AL KASSAM, FOR POSSESSION OF A GUN. ANOTHER ARAB WAS ARRESTED IN HAIFA YESTERDAY WHILE ATTEMPTING TO KILL TWO ARAB MEMBERS OF THE CRIMINAL INVESTIGATION DEPARTMENT.
