REGISTRATION OF JEWS' PROPERTY UNDER WAY IN REICH; AMERICANS AFFECTED

BERLIN, JUNE 14. (JTA) -- DESPITE THE AMERICAN GOVERNMENT'S STRONG PROTEST IN BEHALF OF AMERICAN NATIONALS, FOREIGN JEWS AS WELL AS THOSE OF GERMAN NATIONALITY ARE AFFECTED BY THE GOERING PROPERTY REGISTRATION DECREE, IT WAS REVEALED TODAY.

A FOUR-PAGE FORM, SUBJECTING THE BULK OF JEWRY'S WEALTH HERE TO VIRTUAL CONFISCATION, IS NOW BEING DISTRIBUTED BY POLICE THROUGHOUT THE REICH. THE FORM IS TO BE FILLED OUT BY EVERY PERSON RESIDENT IN GERMANY WHO IS A JEW UNDER DEFINITION OF THE NUREMBERG LAWS AND BY EVERYONE MARRIED TO A JEW WHOSE FORTUNE EXCEEDS \$2,000. THE ONLY TYPES OF PROPERTY EXEMPT ARE PORTABLE OBJECTS EXCLUSIVELY FOR PERSONAL USE AND HOUSEHOLD GOODS IN SO FAR AS THEY ARE NOT LUXURIES.

AN EXPLANATORY LEAFLET ACCOMPANYING THE FORM DECLARES: "THE EXTENT OF THE PROPERTY TO BE EVALUATED AND REGISTERED IS AS IT WAS ON APRIL 27. JEWS OF GERMAN NATIONALITY AND JEWS WITHOUT ANY NATIONALITY ARE TO REGISTER THEIR ENTIRE DOMESTIC AND FOREIGN PROPERTY, IRRESPECTIVE OF WHETHER EXEMPT FROM ANY PARTICULAR TAX. JEWS OF FOREIGN NATIONALITY ARE TO REGISTER AND EVALUATE THAT PART OF THEIR PROPERTY LYING IN GERMANY."

WHILE THE ORIGINAL DEADLINE OF JUNE 30 SET FOR FILING OF THE FORMS PERHAPS PROVIDES ADEQUATE TIME FOR GERMAN NATIONALS WITH MODEST FORTUNES IN THE REICH, IT WILL PROVE A TREMENDOUS HARDSHIP FOR THE OWNERS OF PROPERTY ABROAD. REPORTS THAT THE FILING DATE WILL BE EXTENDED TO DEC. 30 HAVE NOT BEEN CONFIRMED.

RELIABLE BUT NOT OFFICIALLY AUTHENTICATED REPORTS HAVE IT THAT ITALIAN JEWS MIGHT BE EXEMPT FROM REGISTERING THEIR PROPERTY UNDER THE COMMERCIAL TREATY BETWEEN ITALY AND GERMANY. THIS, IT IS POINTED OUT, MIGHT PROVIDE THE BASIS FOR FURTHER URGENT REPRESENTATIONS BY THE UNITED STATES, WHOSE FIRST PROTEST AGAINST APPLICATION OF THE DECREE TO AMERICAN NATIONALS WAS PREDICATED ON THE 1923 COMMERCIAL TREATY BETWEEN THE UNITED STATES AND GERMANY.

THE GOERING DECREE, MADE PUBLIC ON APRIL 27, PROVIDES FOR PENALTIES OF TEN YEARS AT HARD LABOR AND CONFISCATION OF PROPERTY WHERE REGISTRATIONS ARE NOT MADE OR ASSETS NOT FULLY LISTED.

THE EFFECTS OF THE RAIDS LAST WEEK ON CAFES ALONG THE KURFUEURSTENDAMM HAVE NOT YET WORN OFF. JEWS ARE AVOIDING THE LARGER JEWISH-OWNED CAFES, WHICH, FOR THE LAST

SEVERAL YEARS, HAVE SERVED AS ALMOST THEIR ONLY MEANS OF RELAXATION. MORE THAN 300 JEWS WERE ARRESTED IN THE CAFE RAIDS, MOST OF WHOM WERE RELEASED AFTER A NIGHT IN CUSTODY. IT IS RELIABLY REPORTED, HOWEVER, THAT MORE THAN 50 ARE STILL IMPRISONED, ALTHOUGH SPECIFIC INDIVIDUAL CHARGES AGAINST THEM HAVE NOT YET BEEN PUBLISHED.

HAVAS NEWS AGENCY REPORTED THAT FLYING POLICE SQUADRONS RAIDED A SERIES OF BERLIN CAFES FREQUENTED BY JEWS. IN ONE OF THE BIGGER ESTABLISHMENTS ON THE KUEFUEBERTENDAMM, AN OFFICER STATIONED IN THE DOORWAY BARRED ALL ENTRANCES AND EXITS WHILE POLICEMEN "FRISKED" THE PATRONS, EXAMINING THEIR PASSPORTS AND CONFISCATING THOSE WHICH DID NOT APPEAR ENTIRELY IN ORDER. TWO WOMEN WHO WERE UNABLE TO ESTABLISH THEIR IDENTITY TO THE SATISFACTION OF THE INQUISITORS WERE TAKEN TO THE STATION HOUSE.

RUTHLESS "ARYANIZATION" METHODS REVEALED

AMSTERDAM (JTA) -- THE "ARYANIZATION" OF JEWISH BUSINESSES IN THE PROVINCIAL CENTERS OF GERMANY IS BEING CARRIED OUT WITH UNPRECEDENTED RUTHLESSNESS, A SPECIAL SURVEY MADE BY A SPECIAL J.T.A. CORRESPONDENT RECENTLY SHOWS.

IN ONE OF THE DISTRICTS IN THE NORTH OF GERMANY THE GAULEITER AND THE NAZI PRESIDENT OF THE LOCAL CHAMBER OF COMMERCE ORDERED THE LABOR FRONT ENTIRELY TO "ARYANIZE" THE CLOTHING AND TEXTILE INDUSTRIES BY THE END OF THE PRESENT YEAR. THE METHODS EMPLOYED BY THE LABOR FRONT TO CARRY OUT THIS ORDER ARE RUTHLESS TO THE EXTREME. FOUR LABOR FRONT OFFICIALS USUALLY APPEAR BEFORE A JEWISH BUSINESSMAN AND ASK HIM WHAT STEPS HE HAS ALREADY TAKEN TO SELL HIS BUSINESS TO AN "ARYAN." IF THEY FAIL TO RECEIVE A DEFINITE ANSWER, THE JEWISH BUSINESSMAN IS TOLD THAT HE MUST SELL HIS BUSINESS WITHIN A FORTNIGHT. HE IS ALSO ORDERED TO PRODUCE A LIST OF HIS CUSTOMERS. A JEWISH OWNER OF A GENTLEMEN'S CLOTHING ESTABLISHMENT WHO REFUSED THE LAST REQUEST, CHIEFLY BECAUSE HE WISHED TO SPARE HIS "ARYAN" CLIENTELE, WAS THREATENED WITH THE GESTAPO AND HE HAD TO COMPLY. HE WAS ALSO FORCED TO SELL HIS BUSINESS FOR A SONG WITHIN A FORTNIGHT. ANOTHER JEWISH OWNER OF A CLOTHING ESTABLISHMENT WHO RAISED OBJECTIONS WAS SUMMONED TO THE LOCAL OFFICE OF THE LABOR FRONT, WHERE HE WAS MERCILESSLY BEATEN UP. OTHER JEWISH BUSINESSMEN WHO WERE SUMMONED TO THE LABOR FRONT OFFICES WERE REVILED IN UNPRINTABLE LANGUAGE. A JEWISH BUSINESSMAN WHO INFORMED A LABOR FRONT OFFICIAL THAT HE ALREADY HAD AN "ARYAN" CUSTOMER FOR HIS BUSINESS, WAS TOLD BY THE OFFICIAL THAT HE (THE OFFICIAL) HIMSELF INTENDED TO ACQUIRE HIS BUSINESS AND THAT THE JEW WOULD BE UNABLE TO SELL IT TO ANYONE ELSE AS EVERY SALE OF A JEWISH BUSINESS HAD TO BE SANCTIONED BY THE NAZI AUTHORITIES. FACED WITH SUCH A DILEMMA, THE JEWISH BUSINESSMAN WAS FORCED TO SELL OUT TO THE OFFICIAL AT A RIDICULOUSLY LOW PRICE.

THE DISMISSAL OF JEWISH TRAVELLERS OF GERMAN FIRMS IS ALSO PROCEEDING AT A QUICK RATE, THE SURVEY SHOWS. GERMAN MANUFACTURERS HAVE BEEN TOLD TO DISMISS THEIR JEWISH TRAVELLERS WHO HAD BEEN WITH THEIR FIRMS FOR MANY YEARS AT LEAST BY THE END OF 1938. SHOULD THEY DISOBEY THIS ORDER, THEY ARE THREATENED THAT THEIR SUPPLIES OF RAW MATERIALS WOULD BE CUT OFF. MANY GERMAN MANUFACTURERS ASSURED THE J.T.A. SPECIAL CORRESPONDENT THAT THEY HAD OBEYED THE ORDER VERY UNWILLINGLY BECAUSE THEIR JEWISH EMPLOYEES HAD BEEN VERY LOYAL TO THEM. THE MANUFACTURERS HAVE ALSO BEEN ORDERED TO DISMISS THEIR JEWISH AGENTS ABROAD. TODAY THERE ARE ONLY A VERY FEW JEWISH REPRESENTATIVES OF GERMAN FIRMS EITHER IN GERMANY OR ABROAD.

IN THE SMALL TOWNS IN GERMANY JEWISH PEDDLERS FIND IT QUITE IMPOSSIBLE TO OBTAIN LICENSES, ALTHOUGH LEGALLY THEY ARE ENTITLED TO THEM. THE PLIGHT AMONG THE JEWISH PEDDLERS IS CONSEQUENTLY INDESCRIBABLY GREAT. JEWISH PEDDLERS ALSO FIND IT IMPOSSIBLE TO GO TO ANOTHER GERMAN TOWN. IF A JEWISH PEDDLER ASKS THE GERMAN AUTHORITIES FOR ADVICE, HE IS TOLD TO EMIGRATE. BUT EMIGRATION HAS BECOME VERY DIFFICULT FOR THE JEWS IN THE PROVINCES SINCE ALMOST ALL THE JEWS HAD BEEN DEPRIVED OF THEIR PASSPORTS. NO REGULATIONS ABOUT THE EMIGRATION OF JEWS EXISTS, AND EVERY MUNICIPALITY PLEASES ITSELF IN THE TREATMENT OF WOULD-BE JEWISH EMIGRANTS.

BRITAIN URGED TO MODIFY REGULATIONS ON REFUGEES

LONDON, JUNE 14. (JTA) -- A DELEGATION REPRESENTING ORGANIZATIONS IN ENGLAND INTERESTED IN ASSISTANCE TO REFUGEES TODAY SUBMITTED A MEMORANDUM TO THE HOME OFFICE URGING MODIFICATION OF REGULATIONS REGARDING REFUGEES AND FACILITATION OF INTERNATIONAL SCHEMES OF MIGRATION AND SETTLEMENT OVERSEAS. IN THE ABSENCE OF HOME SECRETARY SIR SAMUEL HOARE, THE DEPUTATION WAS RECEIVED BY SIR ALEXANDER MAXWELL, PERMANENT UNDER-SECRETARY OF STATE, WHO PROMISED THE HOME SECRETARY'S SYMPATHETIC CONSIDERATION FOR THE PROPOSALS.

THE DELEGATION WAS HEADED BY THE ARCHBISHOP OF CANTERBURY AND INCLUDED LORD CECIL, THE BISHOP OF CHICHESTER, FREDERICK KENYON, SIR WYNDHAM DEEDS AND OTTO SCHIFF. THE MEMORANDUM URGED:

1-- MODIFICATION OF EXISTING PRACTICES REGARDING THE CONDITIONS UNDER WHICH DE FACTO STATELESS ALIENS LIVE IN ENGLAND AND BRITISH DEPENDENCIES, AND UNDERGO TRAINING WORK AND BECOME NATURALIZED;

2-- THAT THE AUTHORITIES NOT INSIST THAT THOSE INTENDING TO IMMIGRATE TO ENGLAND AS REFUGEES MUST BE ABLE TO RETURN TO GERMANY;

3-- APPLICATION OF THE GENEVA CONVENTION REGULATING REFUGEES' LEGAL STATUS TO THOSE DEPRIVED OF GERMAN CITIZENSHIP AFTER RATIFICATION OF THE CONVENTION ON FEB. 10. IT IS AGREED THAT NOTHING BE DONE TO ENCOURAGE THE REICH GOVERNMENT TO DISENFRANCHISE MORE SUBJECTS AND TO MAKE LIFE IMPOSSIBLE FOR THEM, BUT IT IS ASSERTED THAT THE CONSTANT INTERFERENCE OF THE NAZI GOVERNMENT WITH CIVIL AND RELIGIOUS LIBERTY HAS ALREADY PLACED MANY HUMAN BEINGS IN SUCH A POSITION THAT THEIR ONLY CHANCE OF A TOLERABLE EXISTENCE LIES IN EXILE.

4-- GENERAL UNDERSTANDING THAT THE TEMPORARY PERMITS OF ALIENS BE RENEWED FOR PERSONS OF GOOD CHARACTER ON RECOMMENDATION OF A RESPONSIBLE ORGANIZATION, AND ACCEPTANCE OF THE PRINCIPLE THAT FAMILIES ARE TO BE TREATED AS UNITS AND THAT REGULATIONS SHOULD NOT OPERATE TO KEEP WIVES, HUSBANDS, PARENTS AND DEPENDENT CHILDREN APART;

5-- THAT THE AUTHORITIES RECOGNIZE THE COORDINATING COMMITTEE FOR REFUGEES AS THE UNITED KINGDOM'S ADVISORY BODY ON REFUGEE QUESTIONS.

DANZIG JEWS FEAR INTRODUCTION OF NUREMBERG LAWS

FREE CITY OF DANZIG, JUNE 14. (JTA) -- DANZIG JEWS EXPRESSED ANXIETY TODAY OVER THE NEWS THAT THE NAZI-DOMINATED VOLKSTAG WILL MEET JUNE 19 WITH REICHS MINISTER OF PROPAGANDA PAUL JOSEPH GOEBBELS PRESENT. THE JEWS FEAR INTRODUCTION OF THE GERMAN NUREMBERG RACIAL LAWS HERE AND THE PROCLAMATION OF THE VOLKSTAG AS "A NAZI PARLIAMENT."

CZECH TOWN NAMES JEWISH COUNCILLOR TO AVOID HENLEINIST

PRAHA, JUNE 14. (JTA) -- THE TOWN OF DUERMAUL, NEAR MARIENBAD, WHICH HAS ONLY 26 JEWISH VOTERS, ELECTED A JEWISH PARTY CANDIDATE FOR THE MUNICIPAL COUNCIL IN SUNDAY'S ELECTIONS, IT WAS REVEALED TODAY. THE NON-JEWS APPARENTLY VOTED FOR THE JEW RATHER THAN SUPPORT KONRAD HENLEIN'S SUDETEN PARTY CANDIDATE. NO OTHER LIST WAS PRESENTED. FIVE OTHER JEWISH PARTY CANDIDATES WERE ELECTED IN SUNDAY'S BALLOTING, THREE IN TEPLITZ-SCHOENAU AND TWO IN BRATISLAVA.

U.S. JEWRY'S "BIG FOUR" MOVE TO CREATE UNITED FRONT; REFERENDUM OUT

PITTSBURGH, JUNE 14. (JTA) -- AN AGREEMENT REACHED HERE BY REPRESENTATIVES OF THE FOUR MAJOR JEWISH ORGANIZATIONS IN THE UNITED STATES, LOOKING TOWARD COORDINATION IN DEFENSE OF JEWISH RIGHTS AND INVOLVING ABANDONMENT OF THE PROPOSED AMERICAN JEWISH CONGRESS REFERENDUM, GAVE JEWISH LEADERS THE HOPE OF LONG-SOUGHT UNITY TODAY.

THE AGREEMENT WAS REACHED LAST NIGHT BY REPRESENTATIVES OF THE AMERICAN JEWISH CONGRESS, THE AMERICAN JEWISH COMMITTEE, B'NAI B'RITH AND THE JEWISH LABOR COMMITTEE AT A MEETING HELD AT THE INITIATIVE OF PITTSBURGH JEWISH LEADERS WITH THE ENDORSEMENT OF 28 JEWISH COMMUNITIES THROUGHOUT THE COUNTRY.

THE AGREEMENT, WHICH IS SUBJECT TO RATIFICATION BY THE RESPECTIVE ORGANIZATIONS BY JUNE 20, PROVIDES:

1-- NO REFERENDUM TO BE HELD BY ANY OF FOUR ORGANIZATIONS PENDING A REASONABLE OPPORTUNITY TO EFFECT THE CREATION OF A SINGLE BODY;

2-- EQUAL REPRESENTATION IN THIS BODY FOR THE ORGANIZATIONS;

3-- AUTONOMY FOR THE INDIVIDUAL BODIES TO BE RETAINED;

4-- CONSIDERATION OF QUESTIONS INVOLVING RACIAL, NATIONAL OR RELIGIOUS PHILOSOPHIES TO BE EXCLUDED.

THOSE WHO PARTICIPATED IN THE MEETING AS REPRESENTATIVES OF THE NATIONAL JEWISH ORGANIZATIONS ARE: AMERICAN JEWISH CONGRESS: LOUIS LIPSKY, PROFESSOR JEROME MICHAEL, SIGMUND DAVID, DAVID WERTHEIM, LEON GELLMAN AND LOUIS SEGAL. AMERICAN JEWISH COMMITTEE: LEWIS STRAUSS, JAMES N. ROSENBERG, MORRIS WALDMAN, SIDNEY WALLACH AND LEON FALK. B'NAI B'RITH: HENRY MONSKY, LOUIS FABRICANT, MAURICE BISGYER, BENJAMIN SAMUELS, SIGMUND LIVINGSTON AND RICHARD GUTSTADT. JEWISH LABOR COMMITTEE: A.I. MINKOFF, I. GOLDBERG AND JOSEPH BASKIN.

ALTHOUGH THE AGREEMENT COMMITS THE CONGRESS TO ABANDON ITS REFERENDUM, SCHEDULED FOR JUNE 25, 26 AND 27, ON THE QUESTION OF CREATING A UNIFIED AGENCY TO COMBAT ANTI-SEMITISM, THE CONGRESS ELECTION OF DELEGATES TO THE EXTRAORDINARY SESSION NEXT SEPTEMBER WILL BE HELD ON THOSE DATES AS SCHEDULED.

THE MEETING, WHICH CLIMAXED A CONTROVERSY RAGING IN AMERICAN JEWISH LIFE SINCE THE CONGRESS ANNOUNCED THE REFERENDUM ON MAY 2, WAS HELD AT THE INITIATIVE OF PITTSBURGH JEWISH LEADERS HEADED BY EDGAR J. KAUFMANN, PROMINENT MERCHANT AND PHILANTHROPIST.

TEXT OF AGREEMENT

THE TEXT OF THE RESOLUTION ADOPTED AT THE MEETING FOLLOWS:

"WE, REPRESENTATIVES OF THE AMERICAN JEWISH CONGRESS, THE AMERICAN JEWISH COMMITTEE, THE B'NAI B'RITH AND THE JEWISH LABOR COMMITTEE, GATHERED TOGETHER IN PITTSBURGH THIS THIRTEENTH DAY OF JUNE, 1938, UPON THE INVITATION OF PITTSBURGH JEWRY, ENDORSED BY THE JEWRY OF MANY OTHER AMERICAN CITIES, PROPOSED TO THESE ORGANIZATIONS THE IMMEDIATE COORDINATION OF THOSE ACTIVITIES OF THE AMERICAN JEWISH CONGRESS, THE AMERICAN JEWISH COMMITTEE, THE B'NAI B'RITH AND THE JEWISH LABOR COMMITTEE WHICH RELATE SPECIFICALLY TO SAFEGUARDING THE EQUAL RIGHTS OF JEWS THROUGH THE CREATION OF A SINGLE BODY IN WHICH EACH OF THESE RESPECTIVE ORGANIZATIONS SHALL HAVE EQUAL REPRESENTATION, BUT WITHOUT AFFECTING THE AUTONOMY OF ANY OF THESE ORGANIZATIONS AND EXCLUDING THE CONSIDERATION OF QUESTIONS INVOLVING RACIAL, NATIONAL OR RELIGIOUS PHILOSOPHIES.

"WE FURTHER PROPOSE THAT, AFTER ITS ORGANIZATION, THE PROPOSED BODY SHALL ENLARGE ITS MEMBERSHIP BY THE ADDITION OF REPRESENTATIVES OF OTHER AMERICAN JEWISH GROUPS WHICH SHOULD PROPERLY BE INCLUDED IN SUCH BODY, UPON VOTE OF FIVE-SIXTHS (OR SUCH OTHER VOTE AS THESE FOUR ORGANIZATIONS MAY HEREAFTER DETERMINE) OF THE REPRESENTATIVES OF THE AFOREMENTIONED FOUR ORGANIZATIONS.

"WE RECOMMEND THAT THE DECISION OF ANY ISSUE WITHIN THE SCOPE OF THESE PROPOSALS BY A TWO-THIRDS VOTE OF THE ENTIRE BODY SHALL BE BINDING UPON ALL CONSTITUENT GROUPS OF THE PROPOSED BODY.

"WE FURTHER RECOMMEND THAT, PENDING A REASONABLE OPPORTUNITY TO EFFECT THE CREATION OF SUCH BODY, NO REFERENDUM BE HELD BY ANY OF THE FOUR ORGANIZATIONS INVOLVED. THESE PROPOSALS ARE SUBJECT TO ADOPTION BY ALL OF THE FOUR ORGANIZATIONS ABOVE NAMED ON OR BEFORE JUNE 20, 1938.

"NOTHING HEREIN CONTAINED SHALL BE TAKEN TO MEAN THAT EITHER THE B'NAI B'RITH, THE AMERICAN JEWISH COMMITTEE OR THE JEWISH LABOR COMMITTEE APPROVE OF, OR PARTICIPATE IN, THE IMPENDING ELECTION OF DELEGATES TO ATTEND THE FORTHCOMING REGULAR SESSION OF THE AMERICAN JEWISH CONGRESS IN SEPTEMBER NEXT."

THE PITTSBURGH GROUP CONSISTED OF JEROME EDLIS, LOUIS YALE BORKON, SAMUEL L. FUSS, WALTER BURKE, IRWIN D. WOLF, WILLIAM B. KLEE, JR., LEON FALK, JR., CHARLES DREIFUS, HARRY APPLESTEIN, EDGAR J. KAUFMANN, FRANK R.S. KAPLAN, M. LEON TOLOCHKO, A.L. WOLK, SAMUEL KRIMSLEY, LOUIS CAPLAN, LEO LEHMAN, HENRY ELLENBOGEN, AND MORRIS NEAMAN. MR. WOLF PRESIDED AT THE MEETING.

LATE BERLIN NEWS

BERLIN, JUNE 14, (JTA) -- THE MOST INTENSIVE POLICE CAMPAIGN AGAINST JEWS IN THE OLD REICH SINCE 1933 WAS APPARENTLY UNDER WAY TODAY WITH WHOLESALE ARRESTS OF JEWS REPORTED FROM MANY SECTIONS OF THE COUNTRY. THERE IS REASON TO BELIEVE THE ROUND-UP WILL CONTINUE AT LEAST FOR A WEEK, WITH THE NEW CONCENTRATION CAMP AT BUCHENWALD NEAR WEIMAR IN PROSPECT FOR MANY HUNDREDS.

SO FAR POLICE ACTIVITY HAS BEEN REPORTED FROM ESSEN, KOENIGSBERG, Breslau AND NUMEROUS SMALL PROVINCIAL CENTERS. A TRANSPORT OF PRISONERS WAS REPORTED TO HAVE LEFT THE ALEXANDERPLATZ POLICE HEADQUARTERS IN BERLIN TODAY FOR THE BUCHENWALD CAMP. IT WAS LEARNED THAT PERSONS ARRESTED WERE EXAMINED MEDICALLY TO ESTABLISH THEIR FITNESS FOR HARD LABOR.

THE DRIVE DOES NOT APPEAR TO BE AIMED AGAINST JEWISH LEADERS OR CAPITALISTS, BUT OFFERS A READY PARALLEL WITH THE MASS ARRESTS WHICH TERRORIZED AUSTRIAN JEWRY. THE VIENNA POLICE DISTRICT COMMANDERS HAD APPARENTLY BEEN GIVEN QUOTAS OF ARRESTS TO FILL WITHIN A SPECIFIED TIME.

BERLIN JEWRY FEARS THAT "VIENNESE DAYS" HAVE COME TO THE CAPITAL TO STAY. THE WRITER TODAY WITNESSED A REMARKABLE DEMONSTRATION OF THE PANIC WHICH HAS GRIPPED GERMAN JEWRY. A SCORE OF JEWS QUIETLY DRINKING COFFEE NEAR THE OLIAERPLATZ SUDDENLY LEFT THE CAFE IN HASTE, SOME NOT EVEN STOPPING TO PAY THEIR CHECKS. INQUIRY REVEALED THAT SOMEONE HAD HINTED THAT POLICE WERE IN THE NEIGHBORHOOD.
