ROOSEVELT NOMINATES FRANKFURTER TO SUPREME COURT TO FILL CARDUZO'S SEAT

WASHINGTON, JAN. 5. (JTA) -- FELIX FRANKFURTER WAS NOMINATED BY PRESIDENT ROOSEVELT TODAY TO THE UNITED STATES SUPREME COURT SEAT VACATED BY THE DEATH OF JUSTICE BENJAMIN N. CARDOZO ON JULY 8. THE WHITE HOUSE ANNOUNCED THAT THE NAME OF THE HARVARD LAW SCHOOL PROFESSOR HAD BEEN SENT TO THE SENATE FOR CONFIRMATION.

REPORTS THAT PROF. FRANKFURTER WOULD BE NAMED TO THE HIGHEST BENCH HAD BEEN CURRENT FOR MONTHS. HE WAS SPONSORED ON CAPITOL HILL BY SENATOR NORTIS, WHO HAD URGED HIM FOR THE POST AS THE MAN WHO MOST "FULLY AND TRULY REPRESENTS THE PHILOSOPHY OF GOVERNMENT OF JUSTICE HOLMES AND HIS SUCCESSOR, JUSTICE CARDOZO."

PROF. FRANKFURTER, WHO IS 56, HAS BEEN ACTIVE IN JEWISH CAUSES, PARTICULARLY IN THE ZIONIST MOVEMENT. HE WAS A MEMBER OF THE ZIONIST DELEGATION AT THE PARIS PEACE CONFERENCE, MORE RECENTLY, THE ZIONIST GENERAL COUNCIL IN AUGUST, 1937, SELECTED HIM AS AN ALTERNATIVE MEMBER OF THE ZIONIST EXECUTIVE'S CONSULTATIVE POLITICAL COUNCIL. LAST MONTH HE WAS NAMED TO THE BOARD OF DIRECTORS OF THE AMERICAN FRIENDS OF THE HEBREW UNIVERSITY. HE HAS VISITED PALESTINE THREE TIMES, THE LAST TIME IN 1934, AND HAS WRITTEN A NUMBER OF PAMPHLETS AND ARTICLES ON THE HOLY LAND.

THE HARVARD PROFESSOR, A CLOSE FRIEND OF PRESIDENT ROSSEVELT, OBTAINED CONSIDERABLE NEWSPAPER ATTENTION AS A NEW DEAL ADVISER. HE WAS REPUTED TO HAVE DRAFTED SOME OF THE NEW DEAL LEGISLATION. ANTI-SEMITIC GROUPS, SEEKING TO ATTACK THE ADMINISTRATION, CHOSE HIM AS THEIR CHIEF TARGET. HE WAS A MEMBER OF PRESIDENT ROSSEVELT'S SO-CALLED "BRAIN TRUST." GENERAL HUGH S. JOHNSON, FORMER NEW ADMINISTRATOR, HAS CALLED HIM "THE MOST INFLUENTIAL SINGLE INDIVIDUAL IN THE UNITED STATES."

PROF. FRANKFURTER WILL BE THE THIRD JEW TO BE A MEMBER OF THE HIGHEST TRIBUNAL, THE OTHERS BEING JUSTICE CARDOZO AND JUSTICE LOUIS D. BRANDEIS, WHO HAS BEEN REPORTED TO BE CONSIDERING THE POSSIBILITY OF RETIREMENT. THERE HAD BEEN SOME OPPOSITION TO THE HARVARD PROFESSOR'S APPOINTMENT FROM THOSE WHO BELIEVED THAT IT WOULD INCREASE ANTI-SEMITIC SENTIMENT. THIS ATTITUDE WAS CRITICIZED BY SECRETARY OF INTERIOR HAROLD L. ICKES IN TWO PUBLIC ADDRESSES AND BY SEVERAL NEWSPAPER COMMENTATORS, AMONG THEM HEYWOOD BROUN.

WHILE HE HAS BEEN INFLUENTIAL IN THE ADMINISTRATION, THE SUPREME COURT SEAT WILL BE PROF. FRANKFURTER'S FIRST HIGH PUBLIC OFFICE. IN 1932, WHEN NOMINATED TO THE MASSACHUSETTS SUPREME JUDICIAL COURT, HE DECLINED ON THE GROUND THAT "I HAVE OTHER RESPONSIBILITIES WHICH I FEEL I OUGHT NOT TO SEVER." IN ADDITION, IT IS GENERALLY KNOWN THAT HE COULD HAVE HAD THE POST OF SOLICITOR GENERAL, BUT DID NOT WISH TO ACCEPT IT.

HIS PREVIOUS PUBLIC SERVICE WAS: ASSISTANT UNITED STATES ATTORNEY FOR THE SOUTHERN DISTRICT OF New York, 1908 to 1910; LAW OFFICER OF THE BUREAU OF INSULAR AFFAIRS OF THE WAR DEPARTMENT, 1911 to 1914; CHAIRMAN OF THE WAR LABOR POLICIES BOARD, 1918; JUDGE ADVOCATE OF THE OFFICERS RESERVE CORPS, UNITED STATES ARMY; ASSISTANT TO THE SECRETARY OF WAR, ASSISTANT TO THE SECRETARY OF LABOR AND SECRETARY AND COUNSEL TO THE PRESIDENT'S MEDIATION COMMISSION.

THE "OTHER RESPONSIBILITIES" WHICH HITHERTO PREVENTED PROF. FRANKFURTER FROM ACCEPTING HIGH PUBLIC OFFICE WERE MAINLY HIS POSITION AT HARVARD LAW SCHOOL. SERVING AT HARVARD SINCE 1914, HE HAS ACHIEVED A REPUTATION AS ONE OF THE FOREMOST LEGAL EDUCATORS IN THE COUNTRY. HIS DEVOTION TO HIS TEACHING POSITION HAS BEEN MOTIVATED BY HIS BELIEF THAT "THE FUTURE DIRECTION OF BAR AND BENCH WILL BE DETERMINED BY THE QUALITY OF DUR LAW SCHOOLS."

LAST MAY THE NATIONAL INSTITUTE OF IMMIGRANT WELFARE CONFERRED ON PROF. FRANKFURTER A SCROLL OF HONOR AS ONE OF THE "DISTINGUISHED CITIZENS OF FOREIGN BIRTH WHO HAVE MADE SIGNIFICANT CONTRIBUTIONS TO AMERICAN LIFE." BORN IN VIENNA ON NOV. 15, 1882, HE WAS ONLY 12 WHEN HE CAME TO THE UNITED STATES. HE WAS EDUCATED AT THE COLLEGE OF THE CITY OF NEW YORK AND AT HARVARD UNIVERSITY. AFTER A PERIOD IN THE PRIVATE PRACTICE OF LAW, HE WENT INTO THE GOVERNMENT SERVICE AND THE WAS NAMED TO HARVARD LAW SCHOOL. PROF. FRANKFURTER MARRIED MARION A. DERMAN IN 1919.

SENSIBLE OF COLIGATION AND HONOR, FRANKFURTER SAYS

CAMBRIDGE, Mass., Jan. 5. (JTA) -- "I AM OF COURSE SENSIBLE OF THE OBLIGATION AND THE HONOR INVOLVED," PROF. FELLY FRANKFURTER TOLD THE J-TA-A. TODAY WHEN REACHED AT HIS HOME FOR COMMENT ON HIS NOMINATION TO THE SUPPEME COURT. HE DECLINED TO MAKE A MORE DETAILED STATEMENT, PREFERRING TO MAINTAIN HIS TRADITIONAL RETICENCE.

U.S., BRITISH DIPLOMATS IN ROME STUDY JEWISH QUESTION, OBSTACLES TO EMICRATION

ROME, JAN. 5. (JTA) -- AMERICAN AND BRITISH DIPLOMATS TODAY PRESSED INTENSIVE ACTIVITIES REGARDING THE PROBLEM OF THE JEWS IN ITALY. UNITED STATES AMBASSADOR WILLIAM PHILLIPS, FOLLOWING HIS CONVERSATIONS TUESDAY NIGHT WITH PREMIER BENITO MUSSOLINI, KEPT IN CLOSE CONTACT WITH BRITISH AMBASSADOR LORD PERTH, WHO WAS PREPARING DOCUMENTARY MATERIAL ON THE JEWISH POSITION IN ITALY FOR THE USE OF PRIME MINISTER NEVILLE CHAMBERLAIN WHEN HE ARRIVES HERE FOR DISCUSSIONS WITH PREMIER MUSSOLINI.

MR. PHILLIPS HAS ASSIGNED A.S. ROGERS, A MEMBER OF THE AMERICAN EMBASSY STAFF, TO STUDY IN DETAIL ALL PROBLEMS RELATING TO FOREIGN AND NATIVE JEWS IN ITALY. AMONG THESE QUESTIONS WERE BELIEVED TO BE: (1) THE EFFECTS OF THE DECREE ORDERING ALL FOREIGN JEWS TO LEAVE ITALY BY MARCH 12. AMERICAN NATIONALS HAVE SO FAR NOT BEEN EXEMPTED FROM THE TERMS OF THIS ORDER DESPITE THE UNITED STATES GOVERNMENT'S PROTEST. (2) THE POSSIBILITIES OF PERMITTING EMIGRATING JEWS TO WITHDRAW THEIR CAPITAL FROM ITALY. (3) HOW THE UNITED STATES IMMIGRATION QUOTA, WHICH IS UNFILLED, CAN BEST BE UTILIZED TO ENABLE ITALIAN JEWS TO MIGRATE TO AMERICA.

WHILE 15,000 FOREIGN JEWS MUST, UNDER THE EXPULSION ORDER, LEAVE ITALY NO LATER THAN MARCH 12, JEWISH LEADERS ESTIMATE THAT AT LEAST 5,000 OF THEM WILL BE UNABLE TO EMIGRATE BY THAT DATE. IN THE FIRST PLACE, THE PASSPORTS OF MANY HAVE EXPIRED AND HAVE NOT BEEN RENEWED BY THE CONSULATES OF THEIR RESPECTIVE COUNTRIES, THUS RENDERING THEM STATELESS PERSONS WHO CANNOT GAIN ENTRANCE INTO OTHER COUNTRIES. SECONDLY, GERMANY AND POLAND ARE NOT ADMITTING THEIR JEWISH NATIONALS FROM ITALY AT ALL.

EVEN JEWS WHO ARE READY TO LEAVE ITALY IMMEDIATELY ARE PREVENTED FROM DOING SO BY EXCHANGE RESTRICTIONS AND BY THE LACK OF A PROPER INTERPRETATION OF DECREES. THUS, FOREIGN JEWS HOLDING VALID PASSPORTS, SECURING FOREIGN VISAS AND HAVING THE FINANCIAL MEANS TO LEAVE ITALY PRIOR TO THE DEADLINE, INEVERTHELESS CANNOT LEAVE SECUSE THE LAW PROVIDES THAT THEY MUST FIRST OBTAIN SO-CALLED "NULLA OSTRA" CERTIFICATES FROM THE ROME INSTITUTE DI CAMBIESTERO ATTESTING THAT THEY HAVE NOT DEALT IN FOREIGN EXCHANGE AND HAVE PAID ALL TAXES.

THOUSANDS OF APPLICATIONS FOR SUCH CERTIFICATES, WITHOUT WHICH IT IS IMPOSSIBLE TO LEAVE ITALY, HAVE SO FAR RECEIVED NO REPLIES, NOT FOR ANTI-SEMITIC REASONS, BUT SIMPLY BE-CAUSE THE INSTITUTE IS UNABLE TO FIND A CLEAR INTERPRETATION OF THE DETAILS OF THE DECREE. THE AMERICAN EMBASSY IS NOW STUDYING THE "NULLA OSTRA" PROBLEM WITH A VIEW TO BRINGING TO THE GOVERNMENT'S ATTENTION THE FACT THAT IF MANY JEWS DO NOT LEAVE BY MARCH 12 IT WILL NOT BE THEIR FAULT, BUT THE FAULT OF THE DELAY IN ISSUANCE OF THESE CERTIFICATES.

THE PROBLEM OF EFFECTING THE TRANSFER OF JEWISH CAPITAL ALSO INTERESTS THE EMBASSY BECAUSE THE ACCOUNTS OF ALL JEWS ARE BLOCKED AND NONE IS PERMITTED TO DRAW MORE THAN 5,000 LIRES MONTHLY NOR TO EXPORT EVEN THIS AMOUNT. THE PROBLEM OF UTILIZING THE UNFILLED UNITED STATES IMMIGRATION QUOTA, WHICH IS 5,000 TO 6,000 ANNUALLY, WILL BE DISCUSSED BY THE EMBASSY WITH THE AMERICAN CONSUL GENERAL, WHOSE OFFICE IS AT NAPLES. THE DIFFICULTY ARISES FROM THE FACT THAT ITALIAN JEWS, UNLIKE OTHERS, USUALLY DO NOT HAVE RELATIVES IN THE UNITED STATES WHO CAN SEND AFFIDAVITS, SINCE THE JEWS HAVE LIVED IN ITALY FOR GENERATIONS, NEVER THINKING TO LEAVE THEIR FATHERLAND.

PHILLIPS ASKED SETTLEMENT IN ITALIAN EMPIRE, BERLIN SAYS

BERLIN, JAN. 5. (JTA) -- THE CONVERSATIONS BETWEEN PREMIER BENITO MUSSOLINI AND AMBASSADOR WILLIAM PHILLIPS IN ROME HAVE AROUSED EXTRAORDINARY INTEREST HERE, PARTICULARLY IN VIEW OF THE FACT THAT THEY DISCUSSED, ACCORDING TO THE ROME ANNOUNCEMENT "THE WHOLE EUROPEAN REFUGEE PROBLEM." THE NAZIS GREETED THE DEVELOPMENT AS A STEP TOWARDS THE GOAL OF INTERNATIONAL TREATMENT OF THE JEWISH QUESTION, HOLDING THAT IT WAS A MOVE TOWARD THE CONSIDERATION OF THE JEWISH PROBLEM AS ONE FOR ALL OF EUROPE RATHER THAN AS STRICTLY GERMAN.

THE ROME CORRESPONDENT OF THE DEUTSCHE ALLGEMEINE ZEITUNG ASSERTED THAT MR. PHILLIPS IN EFFECT HAD PROPOSED THAT ITALY SET ASIDE A PART OF HER AFRICAN EMPIRE FOR JEWISH COLONIZATION. THE CORRESPONDENT RECALLED THAT ITALIAN EAST AFRICA HAD BEEN MENTIONED FOR POSSIBLE SETTLEMENT AT THE MEETING OF THE FASCIST GRAND COUNCIL. HE ALSO REPORTED THAT THE TUESDAY CONVERSATIONS MARKED THE SECOND SUCH MEETING, MR. PHILLIPS HAVING PREVIOUSLY DISCUSSED THE QUESTION WITH ITALIAN FOREIGN MINISTER GALEAZZO CIANO.

BERLIN SEES ROOSEVELT MESSAGE 'INSPIRED BY JEWISH BANKERS'

BERLIN, JAN. 5. (HAVAS) -- THE NAZI FINANCIAL NEWSPAPER, BERLINER BOERSENZEITUNG, ASSERTED TODAY THAT PRESIDENT ROOSEVELT'S WARNING TO THE UNITED STATES CONGRESS AGAINST THE THREAT OF DICTATORS WAS PRINCIPALLY INSPIRED BY "THE SLAVERY IN WHICH WASHINGTON FINDS ITSELF WITH REGARD TO THE JEWISH HIGH FINANCE OF WALL STREET." IT ALSO LISTED "THE GROWING OPPOSTION TO ROOSEVELT WITHIN HIS OWN PARTY AND, THIRDLY, THE FACT THAT ROOSEVELT WISHES TO BECOME PRESIDENT OF THE UNITED STATES FOR THE THIRD TIME AND BELIEVES THAT ANY MEANS ARE JUSTIFIED BY THIS END."

THE 12-UHR BLATT ALLEGED THAT "JEWS ARE MASTERS OF THE AMERICAN ADMINISTRATION" AND IN PARTICULAR THAT "THEY SWARM ABOUT HAROLD L. ICKES," SECRETARY OF INTERIOR.

NAZIS REPORTED REDUCING ROTHSCHILD RANSOIT DEMAND

LONDON, JAN. 5. (JTA) -- THE EVENING STANDARD REPORTED TODAY THAT THE MAZIS HAVE REDUCED THE RANSOM SET FOR BARON LOUIS DE ROTHSCHILD'S RELEASE FROM \$10,000,000 TO \$2,500,000. THE BARON, HEAD OF THE AUSTRIAN BRANCH OF THE FAMOUS BANKING FAMILY, HAS BEEN IMPRISONED IN VIENNA SINCE ANSCHLUSS LAST MARCH.

POLAND READY TO REPATRIATE 4,000 JEWS IN REICH IF SHE CAN GET 70% OF THEIR PROPERTY

BERLINA JAN. 5. (JTA) -- THE POLISH GOVERNMENT IS PREPARED TO REPATRIATE FOUR TO FIVE THOUSAND POLISH JEWS RESIDING IN THE REICH, PROVIDED THAT THE GERMAN GOVERNMENT IS WILLING TO HAND OVER 70 PER CENT OF THEIR PROPERTY AND AN EQUAL PROPORTION OF THE FORTUNES OF THE 6,000 JEWS PREVIOUSLY DEPORTED, NAZI SOURCES REVEALED TODAY. THE PROPOSAL WAS ADVANCED, THESE SOURCES SAID, DURING TODAY'S SESSION OF THE NEGOTIATIONS BETWEEN THE POLISH DELEGATION AND GERMAN GOVERNMENT REPRESENTATIVES.

THE JEWS TO BE READMITTED TO POLAND WOULD BE THOSE WHO HAVE BEEN DENATIONALIZED OR WHO FACE DENATIONALIZATION SOON. ACCORDING TO THE SAME SOURCES, THE GERMANS ARE NOT INTERESTED IN THE FATE OF THE STATELESS, AND DEMAND 70 PER CENT OF THE JEWS' FORTUNES AS THEIR OWN SHARE OF THE SPOILS. THE STATELESS JEWS, ALONG WITH ALL GERMAN, POLISH AND OTHER JEWISH NATIONALS, ACCORDING TO THE NAZIS, WILL BE LEAVING GERMANY WITHIN A YEAR OR TWO IN ANY CASE.

FROM THE NAZI VIEW, A COMPROMISE MUST BE REACHED DIRECTLY WITH THE POLISH GOVERNMENT AND NOT WITH THE DEPORTED POLISH JEWS TO WHOM THE MONEY BELONGS. THE NAZI STAND IS THAT IF AS A RESULT OF THE NEGOTIATIONS MOLAND IS GRANTED POSSIBLY HALF OF THE AMOUNT INVOLVED, IT IS ENTIRELY UP TO POLAND TO DECIDE WHAT SHARE, IF ANY, WILL BE YIELDED TO THE JEWS. SOME QUARTERS BELIEVE THAT THE JEWS ULTIMATELY WILL RECEIVE NOT MORE THAN 15 PER CENT.

INFORMED CIRCLES DECLARE THAT THE REICH IS NOT LIKELY TO REPEAT THE MASS DEPORTATIONS OF POLISH JEWS. A DECISION TO THIS EFFECT IS SAID TO HAVE BEEN REACHED AFTER POLAND GAVE ASSURANCES TO THE REICH ON THE NUMBER OF POLISH JEWS RESIDENT IN GERMANY WHO ARE SLATED FOR DENATIONALIZATION. APPARENTLY, THE NUMBER DOES NOT EXCEED 4,000. NAZI SOURCES DECLARE SGERMANY DOES NOT INTEND TO TAKE PRECIPITATE ACTION AGAINST THE STATELESS JEWS BUT EXPECTS THEM TO LEAVE THE REICH. TOGETHER WITH ALL OTHER JEWS IN THE COURSE OF THE NEXT FEW YEARS. PAST TREATMENT OF THE STATELESS DOES NOT LEND CREDIBILITY TO THE DECLARATION.

BECK DISCUSSES PROBLEM WITH HITLER

BERCHTESGADEN, JAN. 5. (HAVAS) -- FOREIGN MINISTER JOZEF BECK OF POLAND CONFERRED TODAY WITH CHANGELLOR ADOLF HITLER AND FOREIGN MINISTER JOACHIM VON RIBBERTROP, AND WAS EXPECTED TO HAVE ANOTHER TALK WITH VON RIBBERTROP AT MUNICH TOMORROW. ONE OF THE QUESTIONS BELIEVED TO HAVE BEEN DISCUSSED TODAY WAS THE FATE OF THE POLISH JEWS EXPELLED BY THE REICH, WHICH IS NOW UNDER NEGOTIATION BETWEEN POLISH AND GERMAN REPRESENTATIVES IN BERLIN. THE BERLIN TALKS ARE EXPECTED TO DEAL WITH TECHNICAL PHASES OF THE QUESTION, WHILE CHANGELLOR HITLER AND COL. BECK PROBABLY WILL DECIDE WHETHER AN AMHORBLE AGREEMENT CAN BE REACHED.

POLISH JEWISH COLONIZATION COMMITTEE APPEALS TO INTERGOVERNMENTAL BODY

WARSAW, JAN. 5. (JTA) -- THE JEWISH COLONIZATION COMMITTEE, OF WHICH CHIEF RABBI MOSES SCHORR IS CHAIRMAN, APPEALED TO THE INTERGOVERNMENTAL REFUGEE COMMITTEE TODAY TO CONSIDER THE QUESTION OF THE "NATURAL EMIGRATION NEEDS OF POLISH JEWRY" AT ITS LONDON SESSION OPENING JAN. 26. A MEMORANDUM TO THE COMMITTEE MADE THE FOLLOWING POINTS: (1) JEWISH EMIGRATION FROM POLAND, STOPPED IN ITS NATURAL GROWTH, MUST BE RESUMED; (2) PALESTINE MUST BE REGARDED FIRST AMONG IMPORTANT OUTLETS FOR JEWISH EMIGRATION AND OTHER TERRITORIES SHOULD BE DISCUSSED ONLY IF PALESTINE IS UNABLE TO SOLVE THE PROBLEM; (3) JEWISH EMIGRATION FROM POLAND IS ONLY A LINK IN THE INTERNATIONAL PROBLEM OF JEWISH EMIGRATION.

ALL ZIONIST GROUPS BUT THE GENERAL ZIONIST "B" HAVE ISSUED A JOINT DECLARATION DIS-ASSOCIATING THEMSELVES FROM THE COLONIZATION COMMITTEE, STATING THAT THE LATEST TRAGIC EVENTS AND THE ACUTE REFUGEE PROBLEM "ARE ANOTHER PROOF OF THE ZIONIST THESIS THAT THE PROBLEM OF JEWISH HOMELESSNESS CAN BE SOLVED ONLY BY PALESTINE, THE ONLY COUNTRY WHERE JEWISH MASS IMM-IGRATION IS POSSIBLE." IT CALLED UPON POLISH JEWRY TO CONCENTRATE ITS ENERGIES ON DEFENSE OF PALESTINE RIĞHTS TOGETHER WITH THE FIGHT FOR EQUALITY OF RIGHTS IN POLAND, AGAINST DISCRIMIN-ATION AND FORCED EMIGRATION.

SEEK FARM SETTLEMENT POSSIBILITIES FOR HUNGARIAN JEWS IN CANADA, SOUTH AMERICA

BUDAPEST, JAN. 5. (HAVAS) -- A MISSION OF HUNGARIAN JEWS HOWEVALREADY LEFT FOR CANADA TO SOUND OUT THE DOMINION'S ATTITUDE TOWARD A SCHEME WHEREBY LARGE JEWISH-OWNED AGRICULTUFAL PLANTS IN HUNGARY WOULD BE TRANSFERRED TO CANADA IN EXCHANGE FOR AN INCREASE OF HUNGARIAN IMPORTS IN THE CANADIAN QUOTA, THE HAVAS CORRESPONDENT LEARNS. Dr. ÁLFRED LOEW, PROMINENT JEWISH ENGINEER, WHO HEADS THE DELEGATION, IS CARRYING DOCUMENTS WITH HIM TO PROVE TO CANADIAN OFFICIALS THAT THE DOMINION WOULD PROFIT UNDER THE PROPOSAL, WHICH IS PART OF A BROAD PLAN TO FINANCE EMIGRATION OF HUNGARIAN JEWS TO CANADA AND SOUTH AMERICA.

THE PLAN, WHICH RESPONDS TO THE DESIRES OF PREMIER BELA IMREDY'S GOVERNMENT, HAS ALREADY BEEN PREPARED AND FINANCED BY THE HUNGARIAN GENERAL CREDIT BANK (MAGYAR ALTALANDS HITLEBANK) IN WHICH THE ROTHSCHILD FAMILY HAS A SUBSTANTIAL INTEREST, AND THE IMPORTANT HOFHERE-SCHRANTZ-CLAYTON-SHUTTLEWORTH FARM IMPLEMENT FACTORY. IT WAS SPECIFICALLY STATED THAT LOEW IS MERELY COMMISSIONED TO EXPLORE THE POSSIBILITIES OF FINANCING EMIGRATION TO CANADA, NOT EMPOWERED TO CARRY ON NEGOTIATIONS TO THIS END. ON HIS RETURN, LOEW WILL REPORT ON THE RESULTS OF HIS MISSION TO LEADERS OF THE JEWISH COMMUNITY, AFTER WHICH A DEFINITE PLAN FOR EVACUATING JEWS FROM HUNGARY WILL BE FORMULATED.

AT THE SAME TIME DR. JOSEF SZILLY, AN AGRICULTURAL ENGINEER, HAS LEFT FOR BUENOS AIRES TO SOUND POSSIBILITIES OF ESTABLISHING COLONIES OF JEWISH FARMERS IN SOUTH AMERICAN COUNTRIES.

PREMIER IMREDY WILL SOON OPEN NEGOTIATIONS WITH DR. FRANZ BASCH, PRESIDENT OF THE PRONAZI GERMAN ASSOCIATION FOR POPULAR EDUCATION IN HUNGARY, WHOSE LEADERSHIP HAS BEEN APPROVED
BY BERLIN, IT WAS LEARNED. THE KEY QUESTION TO BE DECIDED CONCERNS THE RIGHT CLAIMED BY HUNGAR AN GERMANS OF PROFESSING NAZISM AND OFFICIALLY DECLARING THEMSELVES, WITH THE APPROVAL OF
THE HUNGAR AN GOVERNMENT, TO BE MEMBERS OF THE GERMAN PEOPLE UNDER THE LEADERSHIP OF CHANCELLOR
HITLER. SOME GERMAN LEADERS HERE, FAITHFUL TO THE MAGYAR TRADITION, HAVE PROTESTED AGAINST
NAZI RACIAL AND TOTALITARIAN TENDENCIES.

PRAGUE ASSISTS EMIGRATION OF 10,000 REFUGEES, HALF OF THEM JEWS

PRAGUE, JAN. 5. (JTA) -- THE GOVERNMENT HAS ANNOUNCED ITS DECISION TO ASSIST THE EMIGRATION OF 10,000 REFUGEES, BOTH JEWISH AND NON-JEWISH, TO SOUTH AMERICA, PALESTINE AND OTHER COUNTRIES. THE DECISION, REACHED AT THE FIRST CABINET MEETING SINCE THE HOLIDAYS, ESTABLISHES A SPECIAL DEPARTMENT IN THE WELFARE MINISTRY FOR REGISTRATION OF EMIGRANTS. THE DEPARTMENT WILL GIVE ADVICE AND INFORMATION TO APPLICANTS. FUNDS TO CARRY DUT THE EMIGRATION PLANS WILL COME LARGELY FROM THE \$50,000,000 BRITISH LOAN TO CZECHO-SLOVAKIA.

(A New York Times dispatch quoted official circles as stating that the first group of 10,000 refugees would comprise 5,000 Jews, who would go to Palestine on certificates already granted by the Palestine Government, and 5,000 persons of the German "race." In the latter category, definite arrangements were said to have been made for only 1,000, who will be accepted by Canada, with the remainder to be distributed among various South Amesican countries.

THE SLOVAKIAN AND SUB-CARPATHIAN GOVERNMENTS HAVE AGREED TO THE ESTABLISHMENT OF A JEWISH CHANGERY TO REPLACE THE DISSOLVED JEWISH PARTY. THE YOUNG WOMEN'S CHRISTIAN ASSOCIATION HERE HAS FORCED THE RESIGNATION OF FOUR MEMBERS OF ITS EXECUTIVE COMMITTEE WHO ARE OF JEWISH DESCENT, DISREGARDING THE INTERNATIONAL "Y" PRINCIPLE OF RACIAL AND RELIGIOUS NEUTRALITY.

1,500 JEWISH DOCTORS REPORTED DISMISSED

LONDON, JAN. 5. (JTA) -- IT IS REPORTED FROM PRAGUE THAT 1,500 JEWISH PHYSICIANS HAVE BEEN GIVEN NOTICE OF DISMISSAL FROM THE SICKNESS INSURANCE ORGANIZATION.
