JURY WEIGHS FATE OF 'FRONTISTS;' JUDGE HOLDS PLOT INTENT VITAL

NEW YORK, June 19. (JTA) -- A jury instructed that intent rather than accomplishment was the essential element in a plot this afternoon began consideration of charges of seditious conspiracy and theft of Government property against 14 men arrested last Jamaay by the Federal Bureau of Investigation.

After 11 weeks of testimony in Federal Court, Brooklyn, Judge Marcus Campbell gave a two-and-a-half hour charge to the jury in which he pointed out that in a conspiracy, an overt act was not necessary, nor did each defendant have to have knowledge of all of the details.

"If the agreement was to incite other classes—the Communists or the Jews—to revolt and then in the hour of emergency to come in and overthrow, that would be a violation of the law," he said. He summed up the issue thus: "The whole question was whether the action group (the Action Committee of which the defendants were members) conspired to inoite the Communists to riot so they could then step in and take over the Government. Was that what they planned to do, and was that why they armed themselves? That's the case, plain and simple."

Judge Campbell declared that "we are not trying the Christian Front, which was only used as a recruiting grounds for this group." In conclusion, he cautioned the jurors to weigh the evidence carefully because "this is a matter of importance to the defendants, the Government and the people of this land."

United States Attorney Harold M. Kennedy, in his closing address yesterday, said that four steps were involved in the plot-to stir up the Jews and Communists, to convince followers of the Action Committee that the Government was in the hands of Jews and Communists, to incite riots and disturbances, and finally to step in and seize control of the Government.

The number of defendants has dwindled from 17 to 14 since the trial began on April 5. Claus Gunther Ernecke, one of the alleged leaders of the plot, was found a suicide on April 15. Later, charges against George Kelly and Edward Walsh were dismissed on defense motions for lack of sufficient evidence. The remaining defendants are: John F. Cassidy, William Gerald Bishop, John Albert Viebrock, Macklin Boettger, Michael Vill, Alfred J. Quinlan, Andrew Buckley, William H. Bushnell Jr., Michael Joseph Bierne, John T. JEMS, EMIGRES TRAPPED IN PARIS REPORTED 'IN MORTAL TERROR'

MEM YORK, June 19. (JTA) -- Jews and foreign political refugees who were unable to escape from Paris before the Nazi occupation "are in mortal terror," it was reported by the United Press today in a dispatch from Frederick C. Oechsner, correspondent with the German army on route from the conquered French capital.

Oechsner reported that thousands of refugees from Nazi rule in Poland, Csechoslovakia and Austria were caught in Paris and that some were hiding in the woods around the capital or in cities to the south, with the Germans "closing in on them."

A Paris dispatch from the United Press reported that Gestapo chief Heinrich Himmler was understood to have arrived to assume police supervision of the capital. The dispatch added "thousands of Jews and political emigres were in panic."

DETAILS OF NAZI PLOT REVEALED IN REPORT BY URUGUAYAN BODY

MONTEVIDEO, June 19. (JTA) -- A widespread German plot to take over Uruguay was described in the first sections of a report by the Congressional Committee Investigating Masi Activities, made public here today. The committee claimed to have proof of the existence of a large and powerful military, political and economic Nazi network.

The German legation was declared to be directly implicated. Evidence produced by the committee was stated to prove that Otto Langmann, German Minister, had engaged in subversive activity.

The report charged that Uruguay has become the center of Nazi organizations throughout South America, excepting Brazil and Argentina.

The charges came officially to light today with publication of the proceedings of the first two secret sessions of Congress which heard the report of Julio Iturbide, secretary of the investigating committee.

Describing the role of Nazi diplomats as shown in the documents amassed by the committee, Iturbide said: "One constantly finds that Minister Otto Langmann has engaged in the activity of Masism in Uruguay contrary to our institutions."

In his report Iturbide criticised the attitude of Interior Minister Manuel Tiscornia, who for a long time had denied the existence of Nazi organizations in the country.

The committee came to 81 separate conclusions from the facts its investigators had gathered. Among them the most important were, in summary, as follows:

That a plan exists for the military occupation of the Republic with distribution of troops of the active army and of the reserve, placement of German officials, division of land, repression of attacks by enemies of Nazism, and the conversion of Uruguay into a colony of German peasants;

That the German Legation in Uruguay is participating in the political leadership of all the Nazi organizations in Uruguay, with Julius Dalldorf, the Nazi leader, functioning in the Legation and enjoying diplomatic immunity;

That the German Legation has been bringing contraband into the country in the form of abusive posters, propaganda injurious to countries friendly to Uruguay, films and radio sets, all in quantities far in excess of the needs of the Legation personnel.

Tomas Brena, chairman of the investigating committee, said 10 Nazi chieftains already arrested would be tried for crimes against the country. He said the Legation brought radios into the country in diplomatic parcels.

The roundup of known Nazi leaders continued. Officials today were questioning Julio Holzer, Nazi stormtroop chief, at police headquarters.

URGES IMMIGRATION INCREASE TO HELP FORGE PAN-AMERICAN DEFENSE FRONT

HIRGES CENTRAL BODY BE SET UP TO ORGANISE POST-WAR MIGRATIONS OF JEWS

CHARLEVOIX, Mich., June 19. (JTA) -- Creation of a central Jewish body to organize emigration of Jews from Europe after the war was urged tonight by Dr. Jacob R. Marcus, Professor of History at Hebrew Union College, in an address prepared for delivery before the Central Conference of American Rabbis, which is holding its fifty-first annual convention here.

Dr. Marous expressed the belief that "Palestine may not in our generation develop into a center for mass flight," while Rabbi Julius Gordon of St. Louis, participating with him in a symposium on "The Jewish People in the World Today," voiced faith in "the survival of Israel and in the revival of the land of Israel."

Dr. Marcus, whose subject was "Mass Migrations of the Jews and Their Effects Upon Jewish Life," said:

"We may confidently expect further economic dislocations and an intensification of the Jewish political and economic crisis after the second World War has come to an end. The probability of the opening of doors to immigration and the free flow of international trade are remote. The one hope for a post-war amelioration--and this only in the event of an Allied victory--is that the whole problem of the Jew in Europe will be reopened and seriously considered....

"The possibility of the transportation of great masses of Jews from a hostile, culturally low environment, and their colonization under governmental auspices will

no doubt be carefully weighed. To see that such a transplanting of the Jewish masses be more than a cruel deportation, it is essential that world Jewry create a powerful representative organization that can make this transfer spell a new chapter of hope in the history of the Jews."

Dr. Marcus described American Jewry as the greatest the world has yet seen and the only Jewish community that can possible challenge Palestine as potentially the leading center of Jewish learning and Jewish leadership. He saw no hope for the future of the Jewish community of Soviet Russia.

"There is not the remotest possibility that Russia will become a center of Jewish life," he said. "She will never tolerate a Jewish cultural center founded on religion, and world Jewry will never accept any leadership not based on religious tradition."

Rabbi Gordon, speaking on "Palestine, Its Part in Jewish Life and Literature," expressed faith in the ultimate survival of the Jewish homeland.

"Should the present war spread to the eastern end of the Mediterranean, the settlement in Palestine would inevitably suffer," he said. "Cities and colonies may go up in flames. Our youth in Palestine may be decimated. The economic and political status of Palestine may be seriously impaired. But even such a catastrophe would not spell the end of the Jewish community in Palestine. Nor would it spell the end of the Zionist movement. The same zeal which has enabled our people to overcome insuperable difficulties in the past will help us build a new world upon the ruins and ashes of the old."

Rabbi Albert G. Minda of Minneapolis, in a report of the Committee on Church and State, said this afternoon: "Due to the impact of world events, Democratic institutions and processes are no longer taken for granted. We cannot agree with the thesis that because the public school does not teach or sponsor religious instruction directly, that this institution is Godless and makes for atheism." The committee opposed introduction of the release time plan in schools as a violation of the principle of separation of Church and State, declared a majority of teachers in the public schools were religious-minded and that the responsibility for youth and crime rests on the home and the church as well as the school.

JABOTINSKY, AT RALLY HERE, PREDICTS JEWISH ARMY FIGHTING AT BRITAIN'S SIDE

NEW YORK, June 19. (JTA) -- In the near future a "co-belligerent" Jewish army will be fighting as an ally of Britain under the British army's command, Vladimir Jabotinsky prophesied tonight in an address prepared for delivery before several thousand persons at a mass meeting held at the Manhattan Center under the auspices of the New Zionist Organization.

"I challenge the Jews, wherever still free, to demand the right of fighting the giant rattlesnake, not just under British or French or Polish labels, but as a Jewish army," Jabotinsky said. "Some liars shout that we only want others to fight; some whisper that a Jew only makes a good soldbr when squeezed in between Gentile comrades. I challenge the Jewish youth to give them the lie."

He urged American Jews to demand the right to be able to fight in such an army. "It is for them to consult the Government or the Congress as to whether it is lawful or patriotic, so long as America as a whole cannot step in, for individual Americans to defend her cause in British or Polish or Jewish ranks."

Col. John H. Patterson, commander of Jewish battalions in Palestine during the World War, warning that a German victory would be followed by pogroms throughout the world, said: "If I were a Jew nothing would give me greater pleasure than to show the German criminals the Jews of today are capable of fighting just as their forefathers were 2,000 years ago."

Other scheduled speakers were Jean Mathias, a leader of the Jewish War: Veterans of the United States; Czech Consul Hudec and Charles Edward Russell. Messages were read from Senators Claude Pepper and Frederic Coudert.

The one hope for a post-war amelioration--and this only in the event of an Allied victory--is that the whole problem of the Jew in Europe will be reopened and seriously considered....

"The possibility of the transportation of great masses of Jews from a hostile, culturally low environment, and their colonization under governmental auspices will

Dr. Marcus described American Jewry as the greatest the world has yet seen and the only Jewish community that can possible challenge Palestine as potentially the leading center of Jewish learning and Jewish leadership. He saw no hope for the future of the Jewish community of Soviet Russia.
