FEAR FOR SAFETY OF ANTI-NAZI INTELLECTUALS IN FRANCE

LONDON, July 17. (JTA) -- Grave concern is expressed here regarding the fate of outstanding intellectuals, artists and writers in France, of whom the whereabouts of only a few are known.

Jules Romains, president of the PEN Club, has reached the United States with records of the club. Jean Giraudeaux is reported to be in Lisbon. The PEN Club here is gravely concerned over 40 refugee writers formerly aided by its Paris affiliate of whom no word has been received. Commenting on reports that Lion Feuchtwanger, Franz Werfel and Alfred Doeblin were executed by the Nazi authorities in France, Hermon Ould, general international secretary of the PEN Club, stated: "As far as we know, they are still alive."

FRENCH PAPER BLAMES 6 LIES 'SPREAD BY JEMS' FOR FRANCE'S DEFEAT

ZURICH, July 17. (ONA) -- The French newspaper Le Petit Journal in Clermont-Ferrand declared today that France lost the war because of "six lies" which were "greatly represented by Jewish and international agents present in France at the time," according to a German wireless dispatch from Vichy.

The paper was quoted as listing these "lies" as follows: "(1) The Maginot Line affords sufficient protection, since the time of wars of movement. (2) Agreement between Soviet Russia and National Socialist Germany is impossible and not to be thought of. (5) The Berlin-Rome axis will break like a piece of straw. (4) England will be able to put up a big army quickly. (5) Reich is short of breath. It has no resources and is not prepared to launch an offensive. (6) Unmotivated confidence is always a good thing, and genius for improvization is compensation for lack of organization."

7,500 OF 25,000 INTERNEES IN BRITAIN SENT OVERSEAS

LONDON, July 17. (JTA) -- Approximately 25,000 German and Austrian men and women have been interned and of these 7,500 have already been sent overseas, the House of Commons was informed by Capt. Osbert Peake, Foreign Undersecretary.

War Secretary Anthony Eden announced that 2,700 single male internees had been sent to Canada and that no more civilian internees would be transferred to that dominion. He said deportees sent to Australia would be accompanied or followed by their families.

3 FRENCH JEWISH LEADERS LOCATED

REPORTED SEIZURE OF \$300,000,000 OF JEWISH FUNDS IN FRANCE DENIED

BUENOS AIRES, July 17. (JTA) -- Commenting on a New York Jewish Morning Journal dispatch from London, which reported seizure of Jewish Colonization Association funds in Paris by the Nazis, local leaders of the ICA said that the organization had no funds in France.

NEW YORK, July 17. (JTA) -- Competent sources here denied today the report that some \$300,000,000 in funds belonging to the ICA, Alliance Israelite and other Jewish institutions had been seized in Paris by the Nazis. They pointed out that the Jewish organizations had nothing like such a sum in France.

U.S. REGULATIONS HINDER EMIGRATION FROM REICH

NEW YORK, July 17. (JTA) -- Regulations of the United States State Department affecting the departure of Jews from Germany, coupled with various wartime hindrances, are causing dismay among Jews in that country, the Associated Press reports in a Berlin dispatch.

Several Jews said they had been on the point of receiving visas and had bought steamship tickets when they were rejected. They expressed the view that a new line of questioning was evidently based on fears in America of "fifth column" operations. Wartime developments cutting off all but circuitous routes to the United States are increasing the difficulties of the Jews in their efforts to leave the Reich, the dispatch said.

A few are finding their way through Siberia, but the slow journey often has caused visas to expire enroute, it was added.

NAZI ANTI-SEMITIC AGITATOR IN CHILE EXPELLED

NEW YORK, July 17. (JTA) -- Chilean officials have expelled Hans Voigt, head of the German State Railways' Bureau at Santiago, for Nazi activities, Russell Porter, New York Times correspondent, reports in a Buenos Aires dispatch.

Osvaldo Fuenzalida Correa, director of the Chilean Investigation Department probing fifth column activity, told the correspondent that authorities cracked down on the German official a year ago when it was ascertained he was financing an anti-Jewish Nazi weekly called the Lunes. Herr Voigt was arrested and expelled so quickly that the German Embassy and his powerful friends had no time to intervene.

NAZIS PRODUCE "ARYANIZED" NEW TESTAMENT, OMITTING SEMITIC NAMES

LONDON, July 17. (JTA) -- Wartime preoccupations have not deterred the Nazis from continuing exhaustive efforts to remove Jewish "influence" from the Bible, reports reaching here today disclosed.

After long years of work, the Nazis have been able to produce a revised edition of the New Testament which not only curtails Jewish influence to a minimum but leaves out all Semitic names. Jesus is called the "First Aryan" and Bethlehem and Jerusalem are not mentioned. No Jewish names appear in this literary creation. A similar "revision" is planned for the Old Testament.

The Nazi-created Institute for the Research into Jewish influences in the Life of the German Church is cooperating in this work. Issuing their first report in the Luther Chamber at Wittemberg, members of the organization disclosed that their initial work consisted of eliminating the whole Gospel of St. John. The Gospels of Saints Matthew, Mark and Luke have been thoroughly renovated and all references to texts or incidents in the Old Testament expurgated.

PROF. JAMES GOLDSCHMIDT, REFUGEE JURIST, DEAD IN URUGUAY

MONTEVIDEO, Uruguay, (JTA-Airmail) -- James Goldschmidt, well-known Jewish-German jurist, who was invited to deliver a series of lectures for the University on the "Conception of Right," died here suddenly. He was 66. A native of Berlin, he was a professor of law at the Berlin University and the director of the Criminological Institute. After Hitler's rise to power, he settled in Spain where he lectured at the universities of Madrid, Valencia, Saragossa and Madrid. At the outbreak of the Franco revolt, he left for the United States.

A special memorial meeting of the law faculty of the University was held here-Dr. Antonio Grampana, dean of the Faculty, delivered the memorial address.

THORKELSON TRAILS IN MONTANA PRIMARIES

WASHINGTON, July 17. (JTA) -- Rep. Jacob Thorkelson, rabidly anti-Semitic Congressman, was trailing in the Montana Republican primaries behind Jeanette Rankin, former Congresswoman, who ran on a peace plank. Incomplete figures received on Capitol Hill gave Thorkelson approximately 2,400 votes to 2,500 for Rankin on the basis of 145 precincts.

FBI CLEARS CARL BYOIR OF 'NAZI PROPAGANDA' CHARGE

WASHINGTON, July 17. (JTA) -- Carl Byoir, whose court martial as a reserve officer was demanded by Rep. Patman for alleged Nazi propaganda activities, has officially been cleared of suspicion of un-American activities following an investigation by the Federal Bureau of Investigation, the Justice Department has announced.

The Department stated: "The investigation made by the Federal Bureau of Investigation concerning allegations against Carl Byoir discloses no evidence whatsoever that he has been engaged in any un-American activities. No basis for departmental action has been found and the case is regarded as closed."

Byoir said in a statement: "Naturally, I am most happy that the Department of Justice has let the public know that the F.B.I. investigation completely refutes charges of un-American activities made against me by Congressman Patman.

"I know that the public is not interested in an individual case, but I feel there is an important principle involved here. It would be a terrible situation if, in times of great public feeling, citizens had no protection against malicious accusations attacking their loyalty made on the floor of Congress by a Congressman abusing his legal immunity. Many people do not know that under this immunity a Congressman cannot be sued for slander for anything he says in Congress.

"Mr. Patman, of course, had attacked me in the hope of discrediting some of the opposition to his now dead chain store tax bill which I frankly opposed as a public relations counsel. The promptness with which the Federal Bureau of Investigation made a thorough investigation of Mr. Patman's charges seems to me to serve notice that no citizens will be burned at the stake in this country by irresponsible attacks even in high places."
