SCOTLAND YARD HALTS SEIZURES OF REFUGEES

LONDON, July 26. (JTA) -- The arrest of refugees for internment was temporarily suspended here today on instructions from Scotland Yard. Manchester police also halted their round-up pending further instructions.

This action followed Home Secretary John Anderson's statement in the House of Commons that police had been instructed not to arrest enemy aliens whose cases fall within the exemption categories and to postpone the internment of other cases of an exceptional nature.

Anderson also announced that civilian internees would no longer be sent overseas unless they volunteered for such a transfer or arrangements were made to send their families along.

Freud's Son, Grandson Among Interned

LONDON, July 26. (JTA) -- Martin Freud, eldest son of the late Sigmund Freud, father of psychoanalysis, has been interned by British authorities, it was learned today. Walter, 19-year-old son of Martin Freud, was sent abroad after being interned, it was ascertained. Sigmund Freud died in London on Sept. 23, 1939, about a year after he had emigrated from Vienna.

U.S. PLEDGES HAVEN FOR POLITICAL EXILES; MAY SEEK SAFE CONDUCT FOR CHILDREN

WASHINGTON, July 26. (ONA) -- The United States Government is going to do all in its power, within the limit of the law, to give haven to political and intellectual refugees now hiding from the Nazis in a number of European countries, Acting Secretary of State Sumner Welles said today.

President Roosevelt announced, meanwhile, that a request of guarantees for protection of American ships carrying children from England might be made shortly to Italy and Germany. House Foreign Affairs Committee approved a bill to use U.S. ships.

Welles' statement was made after he had conferred this morning with James G. McDonald, president, and George L. Warren, secretary of the President's Advisory Committee

on Political Refugees. He said the committee was particularly anxious to see what could be done to relieve the situation of intellectual and political refugees.

It was suggested, Welles said, and very heartily approved by the State Department that henceforth the advisory committee act as a channel or conduit to the Department for the relief of all cases that warrant favorable consideration. A difficulty encountered in saving these refugees, Welles said, was that a great many individuals and groups approached the Department on behalf of individual refugees. From now on the committee will handle these cases and make recommendations to the Department.

The Acting Secretary said it was the desire of the Department to do all in its power to relieve the situation of these people. A great number of refugees coming within the categories named by Welles are now in unoccupied France.

LATVIA LISTS 800 FIRMS FOR EXPROPRIATION

HELSINKI, July 26. (JTA) -- The Latvian Government has drawn up a list of 800 business concerns which will be expropriated, it was learned today. Jewish interests are among the hardest hit by the government action since they have played a major role in Latvia's business activities. The move follows Latvia's absorption by the Soviet Union.

STATE DEPARTMENT WATCHING RIED CASE

WASHINGTON, July 26. (ONA) -- Acting Secretary of State Sumner Welles said at his press conference today that the State Department has under consideration the case of Dr. Friedrich Ried, German official removed from his post as consul at Porto Alegre, Brazil, when the Brazilian Government protested against his fifth column activities, and who is now attached to the German consulate in New York.

In response to a question, Welles declared that this was all he could say about the Ried case at the present time.

Ried's removal from his post in the United States has been demanded by the New York Post and the Non-Sectarian Anti-Nazi League on the ground that his activities menaced American democracy.

Dr. Ried, a veteran Nazi propagandist, quietly took over his New York post on July 9. During his six years in Brazil, he not only represented the legitimate interests of German nationals but also devoted great attention to Brazilian citizens of German birth and descent.

The incident which incurred the wrath of the Brazilian Government was his eagerness to enlarge the circulation of the Nazified Deutsche La Plata Zeitung, owned by Karl Gundlach, a naturalized Brazilian, who also publishes the newly-founded Neue Deutsche Zeitung of Porto Alegre.

Aware of the fact that, according to international interpretation, a consul merely is "an official charged with the care of the commercial interests of citizens of the appointing government" and nothing more, the Brazilian Foreign Office insisted that Berlin recall the over-zealous Ried. The expulsion move was particularly important since

the State of Rio Grande do Sul is the very center of Nazi control over the large German minorities in the southern Brazil and Porto Alegre is as noticeably German as New York's Yorkville.

Ried also organized an exceptionally effective system of Nazi schools while in Brazil. In addition to keeping the schools running in spite of Brazilian opposition, Dr. Ried added new classes to the existing institutions.

He insisted that German be spoken at home as well as in the schools in order to spread the use of the language. Ried's pedagogical achievements in Brazil have won repeated commendation from Berlin. On various occasions the League for Germans Abroad has reported his activities in great detail to serve as an inspiration for Nazi propaganda activities in foreign countries in general.

WILL COOPERATE ONLY WITH U.S. ON BOLIVIAN TIN, HOCHSCHILD SAYS

WASHINGTON, July 26. (ONA) -- Mauricio Hochschild, German-born Jew, who is one of Bolivia's three biggest tin magnates, told the Overseas News Agency today that he would cooperate only with the United States in the development of the mines which American defense chiefs hope will furnish this country with sufficient quantities of the "critical mineral."

Hochschild was asked to comment on a Lima dispatch to the New York Times which said the Germans were seeking to wrest control of the Bolivian tin industry from the United States and that the German Legation in La Paz reportedly had instructions to do favors for Hochschild, despite Nazi anti-Jewish doctrines, to try to keep him from supporting the United States tin program.

"I will have nothing to do with them," Hochschild said. "I have never had anything to do with their diplomats or agents, and I never will. I am going to work only with the United States."

He added that the Nazis had been unable to bring any effective pressure to bear on him since he removed his family from Germany several years ago. He has lived in Bolivia ten years.

The tin magnate was here to confer with State Department and R.F.C. officials on the Bolivian tin situation. He described his talks as "very satisfactory" and left by plane for La Paz this afternoon saying he hoped to return shortly to conclude an agreement with the United States Government to insure that Bolivia's tin supplies would go to the United States.

NAZI SOLUTION OF 'JEWISH PROBLEM' IN POLAND URGED AT CRACOW

GENEVA, July 26. (JTA.) -- A constructive solution of the "Jewish problem" in Poland in "the spirit of National Socialism" was urged by Prof. Hans Juergen Seraphim, Nazi expert on Eastern European Economics, in an address at Cracow, the Krakauer Zeitung, Nazi organ in Poland, reports.

Speaking before the Institute for German Work in the East, Prof. Seraphim asserted that restriction of the activities of 1,470,000 Jews in Nazi Poland and their isolation was not enough and that a constructive solution was needed, the newspaper said.

RUMANIA ORDERS BESSARABIAN JEWS TO GO BACK

NEW YORK, July 26. (JTA) -- The Rumanian Ministry of the Interior has ordered all Jewish refugees from Russian-occupied territory to leave Rumania within five days, the New York Times reported today. Violators will either be interned or expelled from the country.

BIG MAJORITY IN U.S. OPPOSES APPEASEMENT POLICY, SURVEY SHOWS

NEW YORK, July 26. (JTA) -- Only 7.8 per cent of the population favors any plan of trying to get along peacefully with Hitler and Mussolini, while 88.3 per cent advocate full preparations for defense, at any expense, the Fortune Survey of Public Opinion reported today.

WALLACE STRESSES UNITY OF 2 FAITHS AND AMERICANISM

NEW YORK, July 26. (JTA) -- Secretary of Agriculture Henry A. Wallace, Democratic vice-presidential nominee, declared in an article in the Menorah Journal that "the Jewish tradition, the Christian tradition, the democratic tradition and the American tradition are all one." The article is entitled "Judaism and Americanism."

"It is right, of course," Wallace writes, "that both Jews and Christians should take pride in their respective heritages. But they should not allow this pride to shut themselves off from one another. The general welfare of American democracy calls us to big things. On us may depend the fulfillment of many a biblical prophecy in the trying years ahead.

"To preserve our democracy we must realize that the dictators have definite designs on this hemisphere. Pan-America must stand on guard against the desperate and the ruthless. We stand for peace in this hemisphere, but to make sure of that peace we must be fully prepared. The traditions of the past can be made into the fruitful realities of the future in terms of a broad and alert Americanism. Our motto must be: 'Peace Through Preparedness.'"

CATHOLICS RETURN TO ST. LOUIS INTERFAITH BODY

ST. LOUIS, July 26. (JTA) -- The rift provoked among Jews and Catholics by Rabbi Ferdinand M. Isserman's remarks regarding Myron Taylor's appointment as presidential envoy at the Vatican has been settled.

The executive board of the National Conference of Christians and Jews, whose Catholic members resigned last January in protest over the Rabbi's statements, has been reorganized and five men of Catholic faith appointed to the board to replace men who resigned. Four of the Catholics are widely-known St. Louis attorneys and the fifth is the head of an oil company.

Dr. R. Emmet Kane, prominent Catholic layman and physician, who led the revolt of the Catholics last January, played a leading part in the reorganization of the board, according to Henry S. Caulfield, former Governor of Missouri and co-chairman of the board.

CUBA LEGALIZES SPANISH FASCIST BODY

HAVANA, July 26. (JTA) -- The pro-Fascist Spanish Falangista Association has been legalized by the Havana Provincial Government, the newspaper Pueblo revealed today. The group was outlawed by Cuban authorities during the Spanish civil war to prevent disorders between factions sympathizing with the Spanish Republicans and those championing Franco.

'MOBILIZER' LEADER TO RUN FOR STATE ASSEMBLY

NEW YORK, July 26. (JTA) -- James A. Downey, self-styled "silver-tongued young orator" of the Christian Mobilizers will be a candidate for the State Assembly from the Sixteenth Assembly District, Manhattan, Mobilizer leader Joseph E. McWilliams announced last night. Downey will run on the American Destiny Party ticket against Democratic incumbent Robert F. Wagner, Jr. The district is in a predominantly Irish Catholic and German section of Yorkville.

DAVIS DENIES REICH SEIZED RED CROSS SUPPLIES

WASHINGTON, July 26. (ONA) -- Reports that Germany had confiscated American Red Cross supplies and funds are completely groundless, Norman H. Davis, chairman of the American Red Cross, said today.

He assured contributors to the war relief fund that the "Red Cross does not intend to engage in any relief program without adequate control over its operations or without ample consideration of the wishes of those who have contributed so generously."

Davis said the A.R.C. had established an efficient relief organization in France but was not at present conducting any relief work in German-occupied France except in Paris and its immediate vicinity.
