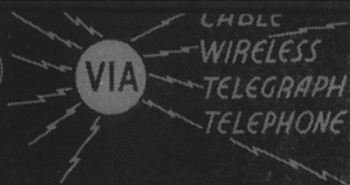

### RUMANIA PLANS CONFISCATORY TAX ON JEWISH PROPERTY; YOUTH BODY BARS JEWS

BUCHAREST, Aug. 8. (ONA) -- Rumania moved several stages further along the road to totalitarianism today as a result of a series of new decrees and dispositions.

While the Ministry of Education granted amnesty to Iron Guard students, Teofil Sidorivici, leader of the national youth organization known as the Straja Tarii (Guardians of the Country) expelled all Jewish children from the movement. Until now membership in the Straja Tarii has been compulsory for all boys between the ages of 7 and 18 and for all girls between the ages of 7 and 21. Henceforth only Christian children will be tolerated.

The Education Ministry decree permits all secondary students "who have suffered disciplinary punishment for political motives" to return to school and continue their studies. The amnesty applies for the most part to young Iron Guardists who were expelled from school during the two-month period when the Iron Guard was banned.

Meanwhile, it was officially announced that the Council of Ministers last night approved the final draft of Rumania's new anti-Semitic code, one of the main features of which is expected to be a confiscatory tax on Jewish-owned property. The new laws will probably be published tomorrow.

(According to the German wireless, the legislation sets up four categories of Jews--(1) those who participated in the war of 1877 and their descendants, (2) those who ten years after arriving on Rumanian territory applied for citizenship and who have been naturalized by law, (3) Jewish combatants in the Rumanian army during the World War, (4) Jews living in territories ceded to Rumania or who originate in these territories.

(It is reported that war veterans and their descendants will be permitted to hold office, but no new appointments will be made. Jews from the annexed regions who are not veterans will be barred from public office, from professions "having direct liaison with the public authorities" and from operating cafes, tobacco shops, cinemas and many other enterprises.

(The German wireless also reported that all Jewish civil servants were removed from the Rumanian Ministry of Economics on the ground that they were not members of the Party of the Nation, from which they have been barred. Among them are many commercial counsellors attached to Rumanian missions abroad.)

Slovakia Widens Anti-Jewish Law

BUDAPEST, Aug. 8. (JTA) -- The Slovak Government today announced a new and more stringent anti-Jewish law, which restricts Jews especially in the practice of law and other professions.

BUDAPEST, Aug. 8. (JTA) -- The Hungarian Government today closed 50 provincial Zionist organizations. The central Zionist office was permitted to remain open.

FAMOUS JEWISH JURIST REPORTED EXECUTED BY NAZIS IN HOLLAND

LONDON, Aug. 8. (JTA) -- Dr. Lewis E. Visser, president of the Supreme Court of the Judicature at The Hague, has been assassinated under orders of the Gestapo, the London Jewish Chronicle reported today. Dr. Visser was also president of the Palestine Foundation Fund in the Netherlands.

Dr. Visser was born in 1871 in Amersfoort, studied law and became an official of the Foreign Ministry. He joined Amsterdam University as a lecturer and was later appointed a judge in Amsterdam, and then in Rotterdam. In 1915 he was named to the Supreme Court and in 1939 was elevated to the presidency. He was the author of many works on Dutch commercial law.

M.P.'s URGE WIDENING OF CATEGORIES OF RELEASABLE INTERNEES

LONDON, Aug. 8. (JTA) -- Extension of the categories of enemy aliens who should be released from internment was urged today by a parliamentary deputation headed by Capt. Victor Cazalet, Conservative, in a visit to the Aliens Advisory Committee.

The deputation appealed for broader interpretation of the proviso dealing with release of internees for work of national importance.

At the same time it was reported that British authorities had rejected a plea by Sir Oswald Mosley, head of the British Union of Fascists, for release from internment.

ZIONIST GROUPS MOURN JABOTINSKY

NEW YORK, Aug. 8. (JTA) -- The Emergency Committee for Zionist Affairs of the Zionist Organization of America has adopted a resolution expressing grief at the death of Vladimir Jabotinsky, it was announced today. The resolution said that the passing of Jabotinsky, one of the outstanding figures in the history of the Zionist movement, constituted an irreparable loss to the Zionist cause and the Jewish people.

A similar resolution was adopted by Hadassah at a regular meeting of its summer executive committee. "Although in recent years Mr. Jabotinsky was not in agreement with the World Zionist Organization on the methods of attaining our common goal, his sincerity and unstinting devotion to the Zionist cause won the respect of his opponents as well as his thousands of friends," the resolution said.

## WORLD CONGRESS PLANS 'CONSTRUCTIVE RELIEF' FOR JEWISH REFUGEES

NEW YORK, Aug. 8. (JTA) -- Summarizing the relief activities it is now carrying on, the World Jewish Congress said in a statement here today that "plans of a more constructive nature are being formulated for those countries where the greatest number of Jewish refugees are congregated." The Congress described its activities as follows:

"Palestine: Polish refugees are being cared for through the medium of a special committee working closely with the national self-governmental institutions in this country and with the organizations affiliated with the Jewish Agency.

"Roumania: Until recently a special representative of the Congress was active in supervising relief work for Jewish refugees from Poland.

"Southern France: Two members of the Executive Committee of the World Jewish Congress are conducting relief work for the tens of thousands of refugees concentrated in Toulouse and in many other centers, one of the most important of these in Louchon. One of the former employees of the World Jewish Congress, traveling from camp to camp, relays to executives of the World Jewish Congress suggestions as to methods for carrying on relief work.

"Portugal: One of the leading personalities in the native Jewish population is active as a representative of the World Jewish Congress.

"German-occupied territories of Poland: The leading Jewish organizations are receiving the financial help of the World Jewish Congress to enable them to carry on their relief activities.

"Lithuania: Financial help granted to many of the refugees enabled them to proceed from there to Palestine."

### PROCEDURE FOR MAKING PAYMENTS FOR SHANGHAI LANDING PERMITS

NEW YORK, Aug. 8. (JTA) -- A memorandum detailing the procedure for making payments for landing permits in Shanghai was made public today by the Joint Distribution Committee. It follows:

1. Payments for landing permits must be made through the Chase National Bank, New York to the Chase Bank, Shanghai for credit of "Speelman." "Speelman" is the code name for the Committee for the Assistance of European Jewish Refugees in Shanghai. Payments addressed to "Speelman" are automatically credited to the Committee Emigration Deposit Account. Remittances sent through the Chase Bank should read "Speelman US\$400 account (name and address in Germany of proposed immigrant)." Unless sent in this manner considerable confusion will result for the Shanghai committee and unnecessary delay for the emigrant.

It should be emphasized that moneys transmitted for landing permits, in accordance with the above instructions, are not sent finally to Germany but are handed to the respective refugees personally on their arrival in Shanghai. It must also be emphasized that moneys transmitted for the above purpose through British banks will not be released, with resultant difficulties to the individual beneficiaries as well as to the Shanghai Committee. This consideration also applies to remittances sent through the Chase Bank and made payable to British banks in Shanghai.

2. When the Committee for the Assistance of European Jewish Refugees in Shanghai is notified that the transmission has been effected, it intercedes with the Shanghai Municipal Council, which is the body issuing the landing permit.

3. The Shanghai Committee then communicates the advice that the permit is available to the appropriate source.

#### NEWSPAPER HITS "BENEDICT ARNOLDS" HERE AIDING HITLER

NEW YORK, Aug. 8. (JTA) -- Col. Charles A. Lindbergh, a "few influential Jews" and some Catholic and Protestant clergymen are among the "Benedict Arnolds" advocating appeasement of the Reich, Henry Paynter charges in the first of a series of articles on the Nazi fifth column published in the newspaper PM today.

Paynter warns that Germany is waging an undeclared but deadly war against the United States, aided by "a German army corps of American citizens, brazenly recruited here right out in the open--the League of Benedict Arnolds."

"It is a strange collection, these Americans who espouse the policies of Hitler," Paynter says. "Although the Catholic hierarchy in America is overwhelmingly anti-Nazi, pro-American, it includes Catholic priests; it includes Italian American publishers, although Americans of Italian blood are among the most able and patriotic citizens; thousands of U.S. Communists...crackpots and bigots; some Protestant clergymen in the Bible belt; some intellectual bigots, such as Charles A. Lindbergh and his good friends; a few influential Jews who still fantastically cling to the appeasement theory; some industrial and financial leaders who trade with Germany."

In a full-page spread, PM also notes the similarity between the phraseology of Col. Lindbergh's speech at Chicago on Sunday and Nazi short-wave broadcasts addressed to the United States.

#### MOST JEWS HELD NOT AFFECTED BY FRENCH CITIZENSHIP REVISION

VICHY, France, July 23. (JTA - Airmail) -- Although the Petain Government is veering steadily toward totalitarianism, the situation of Jews in France is not as black as some reports have painted it.

Competent Jewish observers point out that the decree calling for revision of naturalizations granted since Aug. 10, 1927, will have little effect on the Jews as the bulk of foreign Jews who acquired French citizenship consist either of veterans of the Great War and their families or Jews who served in the armed forces in the present conflict. The Government announced citizenship of persons who served in the army in either war will be confirmed.

Those who served in these wars and their children similarly are exempted under the decree prohibiting the employment of foreigners and naturalized French citizens in State or municipal services.

Writing in Le Petit Journal, organ of his French Conservative party, Col. Francois de la Rocque asserts that the German conception of a nation on a racial basis is "incompatible" with the French ideal. "The German doctrine subordinates the quality of the

national to a nation on a racial basis," he states. "Our doctrine identifies the quality of a nation with recognition of Christian civilization."

Simultaneously, a columnist in the evening newspaper, Paris-Soir, urges "a total and daring solution of the Jewish problem" in France as essential to the country's recovery.

### ITALY SPEEDS 'LIQUIDATION' OF FOREIGN JEWS

ROME, July 27. (JTA-Airmail) -- The task of "liquidating" Italy's foreign Jews is progressing rapidly and in a manner which apparently is deemed "satisfactory" by the Italian Government.

Of the approximately 3,000 foreign Jews still in Italy, more than 1,000 already have either been interned in concentration camps or centered in several small villages in southern Italy. Although the number of women being rounded up is increasing steadily, those interned thus far are for the most part men between the ages of 18 and 50.

In contrast to previous methods of rounding up, in early morning raids, those to be interned, arrests are now being effected in a most inconspicuous manner. Each week additional groups of foreign Jews are selected and ordered, often by postcard, to report within two days to the concentration camp to which they have been assigned or to the authorities of the village where they are to be detained.

It is significant that baptized Jews apparently have been earmarked for earlier internment. The Italian Government has from the beginning shown marked disfavor toward Jews who attempted to escape the "lot of their caste" by baptism.

It is reliably reported that as soon as sufficient accommodations in concentration camps have been completed, with very few exceptions, all foreign Jews, including men, women and children, will be interned.

Provisorily, four camps are being used--two in small villages near Salerno, one near Cosenza and the fourth, for women, at Chieti. The largest number have been sent to the camp near Cosenza, where it is believed all will shortly be transferred.

Treatment accorded the interned refugees, although generally moderate, varies in the different camps, with some permitting more liberties than others. The six-and-a-half lire allotted daily for food is sufficient under the circumstances. In fact, it is more than most of the refugees have ever had at their daily disposal during their sojourn as free refugees in Italy. An additional 50 lire monthly rent allowance is given those for whom there are no sleeping accommodations in the barracks.

In most instances, interned refugees are given the freedom of the village where they are detained. All must report morning, noon and evening to the barracks. As far as is known, it is possible to leave the camps only for reasons of emigration and always under police escort. Every facility is accorded interned refugees to leave the country when they have acquired the necessary visas and transportation funds.

Informed observers believe that these foreign Jews will be detained even after the conclusion of hostilities until they have either emigrated from Italy of their own volition or have been disposed of under some Axis plan. According to conjecture in the Italian press, this Axis plan will take the form of a mass expulsion to Madagascar together with "all European Jews."
