# 60,000 JEWS KILLED IN RUMANIA; JEWISH POPULATION DEPRIVED OF MEDICAL AID

SOMEWHERE IN EUROPE, Jan. 6. (JTA) -- More than 60,000 Jews have been massacred in Bessarabia and Bukovina by Rumanian soldiers since June, it was estimated today by a neutral diplomat reaching here from Bucharest.

The Nezi-controlled Rumanian government, the diplomat said, has embarked on a policy of complete annihilation of all the Jews in the country. No medical aid is given to Jews despite the fact that typhus and other epidemic diseases are raging throughout the country. In addition to depriving the Jews of medical treatment, the Rumanian authorities have also confiscated practically all the clothing, shoes, linen and underwear of the Jews under the pretext that these articles are needed by the army.

The non-Jewish population in Rumania displays little sympathy for the persecuted Jews, the diplomat stated. The Rumanian press, controlled by the Nezis, is trying to impress the population with the idea that all Jews in the country are either "Communists" or "British spies."

The newest ghetto in Rumania has been set up in Ploesti, the city where the Rumanian oil industry is concentrated. All Jawish residents of Ploesti were ordered to leave most of their belongings behind when they were forced to move into the ghetto.

Jewish men between the ages of 18 and 50 who have not as yet been impressed into the existing forced labor battalions will have to report for forced labor registration on Thursday, January 8, in accordance with a special order issued by the authorities in charge of labor camps. They will be sent to work on military and civil projects and will have to report back to the registration offices immediately after finishing the specific tasks assigned to them.

# NEW RESTRICTIONS FOR JEWS IN VIENNA; ALL SYNAGOGUES, EXCAPT ONE, CLOSED

LISPON, Jan. 6. (JTA) -- The 40,000 Jews of Vienna, hitherto permitted to reside in four districts of the city, were this week ordered to move into the first and second district only according to a report reaching here today from Austria. Those unable to find dwellings under the new restriction will be sent to Nazi-occupied Eastern territories, the report said.

All Jewish schools in Vienna except two, according to the same report, have been evacuated to make room for German soldiers wounded on the Eastern front. One of the remaining schools houses a communal soup-kitchen. The other was used as a temporary concentration center for the Poland transports. There is only one synagogue for the city's forty thousand Jews. The same building also houses the community

organization. A Jew may not have more than 200 marks in his possession at any time. He may not have a newspaper delivered to his home, but he may buy one at a kiosk.

Mo Jew may buy coffee, cocoa, fruits, vegetables, honey, oils and milk, except in the case of children. He is entitled to buy, if the shops at which he is permitted to make his purchases neve sufficient stocks, one half kilo of potatoes per before on per week, eighteen grows of butter weekly, 400 grams of mutton, including bones, weekly, when avgilable. His bread is described as "adequate." He is forbidden to buy or possess tobacco, and tobacco shops display signs stating that Jews ere not semitted.

Many young Jews have been recruited for hard labor at a paper mill near Linz. They work under strict supervision and usually have to do "stretches" of eight months. There are two labor cemps for Jews in the vicinity of Vienna. At one, the Jews build roads, repair the railway right of way, break stones, etc., under the supervision of Schutz-Steffel, Standarte 89. Their pay is three warks every ten days. The other camp is a former Rothschild estete now taken over as an S.S. berracks. Here they work on estate "improvements," building roads, repairing and cleming stables.

Some Viennese Jews are employed in Nazi war industries, the report says. But they are not permitted to work in plants where they would have the opportunity to commit acts of sabotage or where they could learn secret manufacturing processes.

#### NAZIS RESUME DEPORTATION OF CZECH JEWS TO OCCUPIED POLAND AND UKRAINE

LONDON, Jan. 6. (JTA) -- Deportation of the 90,000 Jews who are still in the Ozech Protectorate is now being carried out in an even more drastic manner than previously, it was reported in Czechoslovak circles here today.

The report states that all male Jews in the Czech Protectorate between the sges of 16 and 50 have been rounded up and sent to forced labor camps, while those over 50, together with women and children, are being deported to camps in Eastern Poland and Nazi-occupied mussia.

Although little mail is received by Jews still in the Protectorate from their relatives in the camps, the reports that do trickle out tell stories of unspeakable suffering from lack of food and shelter. As a result of inadequate sanitary facilities and the wretched physical condition of the internees an epidemic of spotted fever is raging in many of the camps. Included in a list of deported Jews, which reached here today, are the names of several women over eighty years old.

# JEWS NO LONGER ACCUSED BY MAZIS OF SPREADING EPIDEMICS; BALTIC COUNTRIES ISOLATED

STOCKHOLM, Jan. 6. (JTA) -- All Beltic countries, in which the Jews have been isolated in special ghettos, have been placed under quarentine in view of the spread of spotted fever there, it was reported here today from Berlin.

Contrary to their previous tectics, the Nazi authorities no longer attribute the spread of epidemic diseases to Jews, since the Jews in Lithuania, Latvia and Estonia have long been segregated from the rest of the population. The report admits that German soldiers and officers in the occupied Baltic lands have been affected by the epidemics. Other information reaching here from Berlin reveals that the Alexanderplatz prison in the German capital, where many Jews are being held, has also been infected, while no typhus cases have been registered in the Jewish section of the city despite the poor living conditions there.

#### DANISH KING THREATENS TO QUIT IF NAZIS INSIST ON NUREMBERG LAWS IN DENMARK

LONDON, Jan. 6. (JTA) -- King Christian X of Denmark has threatened to abdicate if the Nazi occupation authorities insist on the introduction of the Nuremberg laws in his country, it is learned here today from reliable neutral sources.

According to these sources, three pro-Nazi members of the Danish government some time ago prepared anti-Jewish legislation for Denmark. The three are Foreign Minister Erik Seavenius, Minister of Transport Gunnar-Larsen and Minister of Justice Theodore Jacobson. It is understood that at a meeting of the Danish cabinet last week, however, the assembled ministers rejected the pro-Nazis' proposals and Premier Theodore Stauning refused to present them to the King.

As a result Scavenius is reported to have approached the king and asked him to override his ministers' veto, but the monarch refused, stating that he would approve the enti-Jewish legislation only if it were unanimously approved by the Panish parliament. Last Saturday, therefore, the three anti-Semitic ministers presented their proposals to a nine-man special parliamentary committee, which proceeded to reject them unanimously. At this point, the reports disclose the Germans openly entered the picture and demanded that the "urembarg laws be introduced immediately. It was then that King Christian threatened to abdicate. Whether the Germans will accede to the king's desires or whether they will insist on Denmark adopting the entire Nazi program is not yet known.

Recently there has been intensified anti-Samitic activity in Denmark by the Nazi followers of Fritz Clausen, the Danish Quisling. Anti-Samitic vandals attempted to destroy a Copenhagen synagogue, statues of Danish-Jewish public figures have been defaced and some Jews have been molested in the streets. The Clausenists have been particularly active since Denmark's forced adherence to the anti-Comintern pact in Bervin. last month.

### WEIZMANN OUTLINES JEWISH POST-WAR DEMANDS FOR PALESTINE: PROPOSES JEWISH STATE

NEW YORK, Jan. 6. (JTA) -- Jewish post-war demands for Palestine are outlined by Dr. Chaim Weizmann, president of the Jewish Agency for Palestine, in an article in the Jonuary issue of Foreign Affairs published here today.

"The Arabs," Dr. Weizmann writes, "will greatly profit from a British victory by obtaining independence in Syria and Libya, and as large a measure of national unity as they themselves are capable of achieving. On the other hand, it is essential to obtain such a settlement in Palestine as will help to solve the Jewish problem - one of the most disturbing problems in the world. The Arabs must, therefore, be clearly told that the Jews will be encouraged to settle in Palestine, and will control their own immigration; that here Jews who so desire will be able to achieve their freedom and self-government by establishing a state of their own, and ceasing to be a minority dependent on the will and pleasure of other nations.

"In that state," Dr. Weissann continues, "there will be complete civil and political equality of rights for all citizens, without distinction of race or religion, and, in addition, the Arabs will enjoy full autonomy in their own internal affairs. But if any Arabs do not wish to remain in a Jawish state, every facility will be given to them to transfer to one of the many and vast Arab countries. Considering the strategic and economic importance of Pelestine, the inclusion of the Jawish state within the British Commonwealth of Nations would be to the interest of both. But we should also be ready, if necessary, to consider joining, under proper safeguards, in federation with Arab states."

### "ENEMY ALIENS" CAN BECOME AMERICAN CITIZENS EVEN DURING WAR. WASHINGTON EXPLAINS

WASHINGTON, Jan. 6. (JTA) -- The office of the HIAS here was today authoritatively informed that there is no ground whatsoever to assume that non-citizens who are technically "enemy aliens" cannot become citizens of the United States for the duration of the war. Similarly there is no basis for the assumption that naturalization proceedings generally will be held up until the end of the war.

"The entry of the United States into the war," it was explained, "has brought into operation Section 326 of the Nationality Act of 1940 which governs conditions under which enemy aliens may become naturalized American citizens. Under these provisions; aliens who are nationals of Germany or of Italy may still become naturalized in the United States if on December 8, 1941 they: 1. had made a declaration of intention, first papers, at least two years but not more than seven years before that date; or 2. were entitled to apply for citizenship without making a declaration of intention, for example the husband or wife of an American citizen; or 3. had their petitions for naturalization pending in court.

"The Immigration and Naturalization Service was given, under wartime conditions, a period of 90 days in which to conduct an investigation and to submit objections to the Court if it is felt that the individual case warrants it. Aliens who do not fall within the above-described categories cannot be naturalized unless the President of the United States has exampted them from the enemy alien classification. In such cases the Department of Justice is required to make an investigation and submit a report to the President in order to establish their loyalty without question."

### HERMAN LIEBERMANN EULOGIZED AT OPENING OF FIRST POLISH COURT IN BRITAIN

LONDON, Jan. 6. (JTA) -- Tribute was paid today to the late Dr. Herman Liebermann, former Polish Minister of Justice, and the first Jew to sit in a Polish cabinet, at ceremonies marking the opening of the first Polish court in England, which will exercise jurisdiction over Polish citizens.

Karol Popil, acting Minister of Justice, lauding Dr. Liebermann, who secured the establishment of the courts, stated: "Today I am acting, so to speak, as the late Dr. Liebermann's deputy. Had not his great heart stopped beating it would have devolved upon him to inaugurate these ceremonies." The principle of a new legal order based on justice and freedom, as announced by Dr. Liebermann, will be the foundations of a new Poland, Popil stated.
