BERLIN ISSUES OFFICIAL INSTRUCTIONS TO SHOOT TYPHUS-STRICKEN JEWS

LONDON, Jan. 9. (JTA)-- An official order approving the execution of typhus-stricken Jews in Nazi-occupied territories has been issued by Berlin to the Nazi administration in Poland, the Baltic countries and the Ukraine, it is reported in the press here today. The order provides that Jews showing any symptoms of epidemic diseases should be shot, especially in places where there are no ghettos. All their belongings are to be destroyed at once, the order specifies.

The shooting of infected Jews has been going on in Nazi-held territories of Eastern Europe ever since the spread of typhus among the German soldiers. The latest reports reaching here reveal that many Jews were shot in Vilkomir and other cities in the Baltic section of Eastern Europe, in addition to hundreds of Jews shot in Poland.

Panic stricken over their failure to check the spread of typhus in Lithuania, Latvia and Estonia, the Nazi authorities there are reported to have introduced rigid isolation of Jews in the ghettos of Kaunas, Vilna, Riga, Tallin and Dwinsk. Jews are no longer taken from these ghettos for forced labor which might bring them in contact with Germans. Each of these ghettos, however, is not allowed to have more than three Jewish doctors for every thousand Jews. The rest of the Jewish doctors have been transferred to work in German military hospitals.

600,000 POLISH JEWS IN RUSSIA NOW REQUIRE RELIEF; SIKORSKI REPORTS ON REFUGEE NEEDS

LONDON, Jan. 9. (JTA)-- Some 600,000 Jews from Poland are among the approximately 2,000,000 Polish refugees now scattered in distant parts of Soviet Russia, all in need of relief, it was estimated here today by official Polish circles following a press conference addressed by General Sikorski, Polish Premier and Commander-in-Chief, who recently returned from Soviet Russia after conferences with Stalin.

The Polish civilians, Gen. Sikorski said, were confined in several hundred camps extending from Franz Josef Land to Archangel and Soviet Turkestan. The refugees from Poland, Jews and Poles alike, who have been held in the northern camps are now being brought to the south where climatic conditions and food supplies are better. Special inspectors appointed by the Polish embassy in Moscow are being given facilities to ameliorate the privations of the refugees. More than one-third of these inspectors are Jews, since it is believed that at least one-third of all Polish deportees in Russia are Jews.

Gen. Sikorski said that the Polish army which is now being formed in Russia of Polish and Jewish internees and civilians of military age, already numbers 100,000 men. Some 25,000 soldiers will be sent to the Near East and Britain while the remainder will be stationed in the sector of Tashkent and Almaata, where thousands of civilian Polish refugees are now permitted to reside and where the Polish Red Cross is trying to organize relief for them.

UNITED JEWISH APPEAL RENEWED FOR 1942 BY JDC, UPA AND NRS TO MEET WARTIME NEEDS

NEW YORK, Jan. 9. (JTA)-- The unified fund-raising campaign of the United Jewish Appeal for Refugees, Overseas Needs and Palestine will be continued for the critical war year of 1942, it was announced here today by Dr. Abba Hillel Silver, National Chairman of the United Palestine Appeal and Dr. Jonah B. Wise, Chairman of the Fund-Raising Committee of the Joint Distribution Committee. The United Jewish Appeal was established in 1939 to provide for the needs of the Joint Distribution Committee, United Palestine Appeal and National Refugee Service.

Following the precedent established in previous years, it was agreed that an initial sum of \$9,100,000 be appropriated to the three agencies to enable them to operate until an Allotment Committee shall have an opportunity to distribute all funds that will become available to the campaign. This initial sum is to be allotted to the participating organizations as follows: To the Joint Distribution Committee, \$4,525,000, to the United Palestine Appeal, \$2,575,000, and to the National Refugee Service a guaranteed sum of \$2,000,000. On this basis the balance of the funds is to be distributed between the Joint Distribution Committee and the United Palestine Appeal by the Allotment Committee established along the lines of similar committees in previous years.

Declaring that since the outbreak of the war in September 1939, the agencies represented in the United Jewish Appeal have been confronted with an ever-expanding theatre of Jewish suffering and need, the joint statement by Dr. Wise and Dr. Silver stressed the fact that America's entry into the war has imposed upon the Joint Distribution Committee, United Palestine Appeal and National Refugee Service even greater responsibilities, requiring them to conduct their operations on a full wartime basis.

INVESTIGATION OF "CHRISTIAN FRONT" ASKED BY ANTI-NAZI LEAGUE

NEW YORK, Jan. 9. (JTA)-- A "sweeping investigation" of the "Christian Front" throughout the nation was asked for today by the Non-Sectarian Anti-Nazi League in a wire to Attorney General Francis Biddle. The demand followed seizure of the Front's records in Boston by Massachusetts police and law enforcement officials, who found large amounts of pro-Nazi literature in the organization's headquarters.

Francis P. Moran, whose activities as leader of the Christian Front propaganda organization in New England were speedily halted by the Police Commissioner of Boston, was facing two new inquiries today, one state and the other federal: 1. A state investigation because of his refusal to disclose the names of his close associates and assistants and information concerning his groups in Massachusetts outside Boston; 2. A federal investigation because of his vague explanation of his ability to acquire, below cost of publication, thousands of Nazi propaganda booklets which were among the many works of George Sylvester Viereck, seasoned and registered Nazi propagandist. He said he had received an indirect tip - from whom he could not remember - that these booklets could be purchased at a bargain.

Moran denied any association with the Social Justice publication which on Dec. 29, three weeks after America's entry into war, said: "We are inclined to believe there will be no victors emerging from the contest 15 or 20 years hence." In discussing "the Pearl Harbor debacle," Social Justice simply listed United States government officials and advisers with Jewish names. The National Legion of Mothers of America, a Coughlinite group, decided at Philadelphia on Dec. 8, the day Congress declared war against Japan, that an early peace should be sought because the war means that "Christians will spill their blood for the Jews."

GESTAPO DRAGS DUTCH JEWS FROM THEIR HOMES; VICTIMS DISAPPEAR WITHOUT TRACE

LONDON, Jan. 9. (JTA)-- Most of the Jews in German-occupied Holland sleep away from home in fear of Gestapo raids, but they are befriended by the Dutch population, a Jewish woman recently arrived from the Netherlands told the Netherlands Indies News Agency today.

"Worse for the Jews than having to give up all their money and being forbidden to mix openly with non-Jews is the fact that they are never sure of their lives," the woman stated. "Jews are picked up on the streets or dragged from their homes and just disappear."

The woman said she would hide her husband's clothes every evening and when the bell would ring, she would answer it, while her husband would go upstairs into a specially-constructed hiding place in the attic. Jews are not forced to wear yellow armlets or Stars of David, but their identity cards are marked with a large letter "J.", she added.

"The Gentiles are most helpful and extremely kind towards the Jews, who always find a welcome in the homes of non-Jews in order to listen to the radio from London," the Jewish woman said. "Jews themselves are not allowed to own radios. They have long ago given up walking on the streets on Friday evening because members of the Nazi N.S.B. have made it a practice to organize marches and riots on the Jewish sabbath, picking out Jews among the public and arresting them. The famous Jewish bank, Lipman-Rosenthal, is now in so-called Aryan hands, its main task being to collect the money which Jews are forced to hand over."

JEWISH WIDOWS AND ORPHANS IN GERMANY DEPRIVED OF PENSIONS UNDER NEW REGULATIONS

BERNE, Jan. 9. (JTA)-- New regulations which aim at depriving certain Jewish widows and orphans in Germany of the pensions to which they are entitled, were issued this week in Berlin jointly by the German Ministry of Interior and the Ministry of Finance, and published in the Juedisches Nachrichtenblatt of Jan. 6 which reached here today.

The regulations provide that Jewish widows and orphans will henceforth receive not more than half of what non-Jewish widows and orphans of Jewish pensioners are to receive, and only when it is established that "all other means of support are exhausted." While payments to these widows and orphans who fall in the non-Jewish categories is to start automatically with the death of the Jewish head of the family, the survivors classified as Jews, will, under the new regulations, not receive such payment before they submit a petition for the pension to proper authorities. The beneficiaries classified as Jews are also required to immediately give notice of any change in their circumstances which might justify reduction or cancellation of their benefits.

JEWISH DOCTOR, LEADER OF SERBIAN GUERRILLA UNIT, REPORTED CAPTURED BY NAZIS

LONDON, Jan. 9. (JTA)-- Dr. Mile Benvenisti, well-known Jewish physician from Belgrade, who for a long time has headed a unit of the Serbian guerilla army that is battling the Nazis in Yugoslavia, is reported to have been captured near Mladenovac, according to the Belgrade weekly, Ponedeljak.

N.Z.O. DELEGATION CONFERS WITH SOVIET AMBASSADOR IN WASHINGTON

WASHINGTON, Jan. 9. (JTA)-- Mr. Eri Jabotinsky and Dr. Harry Levy, representatives of the Presidency of the New Zionist Organization, were received today by the Soviet Ambassador, Maxim Litvinoff. It is understood that problems of Soviet-Zionist relations were discussed.

20TH ANNIVERSARY OF U.S. CONGRESS RESOLUTION ON PALESTINE TO BE CELEBRATED

NEW YORK, Jan. 9. (JTA)-- The 20th anniversary of the adoption by both Houses of Congress of the joint resolution favoring the establishment of a Jewish National Home in Palestine will be celebrated by 1,200 delegates from all parts of the nation at the National Conference for Palestine in Cleveland on January 17 and 18, it was announced today by Dr. Abba Hillel Silver, National Chairman of the United Palestine Appeal which is sponsoring the conference.

"The moral support extended to the reconstruction of Palestine by the American people through Congress, and the financial support extended by American Jewry through the United Palestine Appeal are now paying dividends to America at war," Dr. Silver said. "The 550,000 Jews in Palestine are maintaining a bastion of the anti-Axis forces in the Near East. Their young men are in the forefront of the Battle of Libya, their factories are turning out ever-increasing amounts of war material, and their modern farms are feeding the garrisons of the Near East. It is to mobilize the support of American Jewry for our allies in the Near East that this national conference has been called."

The Resolution on Palestine adopted twenty years ago by the 67th Congress stated: "Resolved by the Senate and the House of Representatives of the United States of America in Congress assembled that the United States of America favors the establishment in Palestine of a national home for the Jewish people, it being clearly understood that nothing shall be done which may prejudice the civil and religious rights of Christian and all other non-Jewish communities in Palestine, and that the holy places and religious buildings and sites in Palestine shall be adequately protected."

LEADER OF ARAB LEAGUE IN AMERICA COMMITS SUICIDE IN NEW YORK

NEW YORK, Jan. 9. (JTA)-- Dr. Fued Isa Shatara, president of the Arab National League of America, was listed by the police yesterday as a suicide after his body had been found in his offices, where he also lived, at 153 Clinton Street, Brooklyn. He was 48 years old. A note Dr. Shatara left for his wife, before taking poison, said: "My nerves are frayed, my health undermined, and I cannot go on any longer."

Dr. Shatara, whose organization represented some 10,000 persons of Arab and Syrian nationality or origin in this country, often spoke at meetings and forums. Born in Palestine, Shatara represented the Arab views on the Palestine question. A graduate of the New York College of Physicians and Surgeons, Dr. Shatara had been on the medical staff of the Cumberland Hospital for twenty years.

JEWISH R.A.F. FLYER HONORED FOR 53 BOMBINGS OF ENEMY TERRITORY

JOHANNESBURG, Jan. 9. (JTA)-- Flying Officer William Treger, a Jew, who has successfully completed 53 bombings of enemy territory, has been awarded the Distinguished Flying Cross, it was disclosed here today.

The citation accompanying the award to Treger, who is a member of the R.A.F. Volunteer Reserve of Southern Rhodesia, states: "Since July, 1940, Flying Officer Treger has completed 53 operational missions, involving some 320 hours' flying. During the period 25th June to 31st July, 1941, Flying Officer Treger carried out 16 missions with coolness and success. In an attack on Tripoli harbor, despite intense anti-aircraft fire, he succeeded in obtaining a direct hit on an 8,000-ton tanker, which was destroyed. Throughout, Flying Officer Treger has shown the utmost keenness and determination, and set a fine example to all."
