DEPORTATION OF JEWS FROM REICH HALTED; TRAINS DIVERTED TO CZECH PROTECTORATE

STOCKHOLM, Jen. 19. (JTA) -- Berlin correspondents of Swedish newspapers today reported that Mazi authorities in Germany suddenly issued an order during the week-end halting the deportation of Jews from the Reich to Poland and other occupied Eastern territories, which had been resumed during the past week. Transports of Jews on their way to Lodz, Riga, Minsk and Kaunas were held up and diverted to the Czech Protectorate.

The spread of epidemic diseases in Polend and the Beltic countries was given as the reason for stopping deportations of Jews, the correspondent stated. At the same time they also describe how the Jews, ordered to surrender their warm clothing for the army within twenty-four hours, were delivering their lest coats and underwear last Thursday to receiving stations. The order originally issued for the "ews of the Reich has been extended to the Jews of all occupied territories, the Berlin correspondent of the Swedish newspaper Social Demokraten informs. Very severe penalties have been exmounced for non-compliance with this order.

The Swedish newspaper Tidningen reports today that the Nazi authorities in Poland have issued supplementary regulations to the Special Penal Code far Poles and Jews. These regulations provide for severe punishment for victims sentenced under the new code to so-called "punitive camps" where conditions are even worse then in ordinary prisons. The punishment includes the reduction of bread and water rations for the internees, longer hours at hard labor, and complete isolation from other prisoners.

Jews In Poland Assigned To Manufacture Clothing For The German Army

The extent to which the Germans have depopulated Polish towns which formerly had large Jewish populations can be seen from an article in the bitzmannstaedter Zeitung, reaching here today.

In the town of Strykow in the Nazi-annexed section of Poland only 400 Jews remain of a pre-war Jewish population of 2,585, the Nazi paper reveals. These 400 are confined in a segregated quarter of the city and have been assigned to manufacture clothing for the German army. About 2,000 Jews were deported to the Government-General area shortly after the Nazis entered Strykow and about another 200 either died or were deported individually from the city, the article states.

Their places were taken by Volksdeutsche who now carry on all the trade and commerce in the city, while the Polish population has been put to work rebuilding roads and public and private structures, the German newspaper writes.

The Polish Legation in Stockholm today received a report confirming the fact that Jews in the ghettos are refused vaccination by the Mazi administration in Poland.

\$28,300,000 RAISED IN U.S. BY 252 JEWISH FEDERATIONS, WELFARE FUNDS AND APPEALS

NEW YORK, Jan. 13. (JTA) -- A total of \$28,500,000 was raised by 252 federations, welfere funds and United Jewish Appeals during the Fall of 1940 and the Spring and Summer of 1941, according to information released here today by the Council of Jewish Federation and Welfare Funds.

An analysis of the contributions received by 44 of the 252 fund-raising agencies, indicating the proportion of large and small gifts and the extent of perticipation in different-sized communities, has just been completed by the Council. The 44 federations and welfare funds, which reised \$12,070, 894, approximately 45 percent of the total realized by all the reporting organizations, held their compaigns in cities having about 65 percent of the estimated total Jewish population of the United States. The total raised in the 44 campaigns represents gifts from 230,395 contributors.

The enalysis shows that in both large and smell campaigns the largest proportion of the total is contributed by a relatively small number of "hig" contributors. Contributors of \$100 and over constituted only 9.5 percent of the total number of contributors to the 44 campaigns; the total contributed by them, however, amounted to 79.8 percent of the total raised. On the other hand, contributors of less than \$10, representing 54.1 percent of the total number of contributors, were responsible for 5.5 percent of the total attained.

For the 44 Ampaigns as a whole, the average contribution was \$52.39. In campaigns of \$500,000 and over, the average contribution amounted to \$60.39; in the smaller campaigns, it ranged from \$30.30 to \$45.70, the analysis establishes.

MASS-EXECUTIONS OF JEWS IN UKRAINE ATTRIBUTED TO CEN. REICHENAU

LONDOM, Jan. 19. (JTA) -- The charge that the cruellest pogroms carried out by German soldiers against Jews in the Nazi-occupied Ukraine were ordered by General Walter von Reichenau, whose death from "apoplexy" was announced in Berlin, is made today in London newspapers.

Articles in today's press declare that the messacre in Kiev, where thousands of Jess were driven to the Jesish cemetery and executed by Nazi soldiers, was conducted under Reichenau's direct command. Similarly, they state Reichenau was responsible for the murdering of Jesish civilians in Kharkov and other Ukrainian cities.

NES RESUMES RESETTLEMENT OF REFUGEES WITH APPROVAL OF FEDERAL AUTHORITIES

NEW YORK, Jan. 19. (JTA) -- The National Refugee Service today announced the resumption of its resettlement activities, following clarification by the United States Attorney for the Southern District of New York of the Federal regulations governing travel and change of abode, for Jewish refugees subject to "enemy alten" control.

During December the agency suspended resettlement plans for all refugees affected by the "enemy alien" regulations, but continued its activities for Polish, Czechoslovakian and other emigres from non-enemy countries. The NRS reports a continued interest by communities in resettlement, and at present plans are proceeding to resettle a number of families whose departure had been held back. Persons wishing to be resettled must fill out the customary travel form, stating as the reason for traveling the desire to change their permanent residence, and submit it to the U. S. Attorney. The National Refugee Service has been informed that permission will be given except in certain instances where the U.S. Attorney feels that it would be undesirable at this tire.

JEWISH BOARD OF DEPUTIES PREPARES DATA ON NAZI ATROCITIES AGAINST JEWS

LONDON, Jan. 19. (JTA) -- The Board of Deputies of British Jews, leading Jewish organization in England, is now preparing detailed data on Nazi atrocities against Jews for the purpose of submitting it to the Inter-Allied Committee formed here last week to secure proper punishment of Nazi officials responsible for terror against the civilian population in occupied territories.

in ennouncing the preparation of such data, Prof. Selig Brodetsky, president of the Board of Deputies, today disclosed that the Board was assured that "the fate of the Jews in Nazi-occupied Europe will not remain unavenged." This promise, Prof. Brodetsky said, was made by one of the members of the Inter-Allied Committee whose name he was not at liberty to disclose.

Referring to the fact that the communication on anti-Jewish atrocities sent by the Joint Foreign Committee of the Board of Deputies to the Inter-Allied Conference was not read at the opening session of the Conference, Prof. Brodetsky seid that letters of acknowledgment have been received from some members of the Conference. The communication, he revealed, was addressed to all governments perticipating in the Conference as well as to the Polish Premier Gen. Sikorski in his capacity as president of the Conference.

ANTI-JEWISH CAMPAIGNS IN RUMANIA, CROATIA INTENSIFIED; NEW RESTRICTIONS URGED

BERNE, Jan. 19. (JTA) -- Intensification of enti-Jewish measures in Rumania, Croatia and other Nasi-dominated states is reported here today from Bucharest. The reports state that practically all synagogues in Croatia have either been "liquidated" or converted into clubs for "Aryans," while in Rumania all Jews must again report for forced labor, including those who have already been released from labor camps after having completed their service there.

The Rumanian news egency Rador reported today that a movement to confiscate all Jewish property in Rumania has been launched by the anti-Semitic newspaper Porunka Vrer in Bucharest. The paper demands the outright expropriation of Jewish business enterprises by the government and the turning over of these enterprises to Rumanians. The anti-Semitic organ also insists that Jews in Bucharest should not be permitted to travel in street cars.

The Nazi-published newspaper Donau Zeitung of Belgrade reports that the Propaganda Ministry in Zagreb, capital of Croatia, issued an appeal to the Croatian population "inviting" them to submit to the authorities all books concerning Jews.

JEWISH RELIGIOUS ACTIVITIES IN WARSAW GHETTO GROWING DESPITE NAZI PERSECUTION

LONDON, Jan. 19. (JTA) -- Jewish religious activities in the Wersaw ghetto have been growing despite Mezi restrictions and oppression, it was disclosed today in information received by the Agudes Israel here from orthodox leaders in Poland.

The remaining synagogues in Warsaw are crowded, the report states. The Beth Jacob orthodox schools for girls are still functioning in all sections of the ghetto, and several thousand Jewish girls are attending. The orthodox teachers training college has a long waiting list of applicants. The Rabbinste is functioning in the ghetto and recently a conference was held to discuss future orthodox activities in Foland.

U.S. GOVERNMENT ASKED TO SUPPORT POST-WAR JEWISH COMMONWEALTH IN PALESTINE

CLEVELAND, Jan. 19. (JTA) -- The United States Government was asked to pledge itself to support the establishment of a self-governing Jewish Commonwealth in Palestine after the war in a resolution adopted last night at the closing session of the National Conference for Palestine, held here under the auspices of the United Palestine Appeal.

The resolution urged the Federal government to incorporate "into its post-war program, as outlined in the Atlantic Charter and the Declaration of the United Nations, ective support of the establishment of a self-governing Jewish Commonwealth of Pelestine to which Jews who need or wish to live there may freely return."

The conference also adopted a resolution asking the U. S. Government to aid in the formation of a Jewish army for the defense of Palestine and other parts of the Middle East. Rabbi Abba Hihlel Silver, national president of the United Palestine Appeal, was re-elected to that post for the fifth time at the conference. Tribute to Rabbi Silver for his work in behalf of Palestine was paid by Senator Alban Barkley, Henry Monsky, president of the B'nai B'rith; Mrs. Temer De Sola Pool, Hadassah president; Leon Gellmen, president of the Mizrachi and David Wertheim, secretary of the Poola Zion organization.

CHURCHILL'S ATTITUDE TOWARD JEWISH ARMY DISCLOSED BY BRITISH EMBASSY IN WASHINGTON

NEW YORK, Jan. 19. (JTA) -- The attitude of Winston Churchill towards the formation of a Jawish Army was made public here today in a message addressed in behalf of the British Prime Minister to the New Zionist Crganization of America by Sir Anthony Rumbold of the British Embassy in Washington.

The letter, which came as a reply to a communication sent by the NZO to Churchill during his stay in the United States, reads: "Your message raises the question of the recruitment of Jews for military service. You will be aware that certain proposals which were under consideration had to be dropped because the necessary equipment was not available. But this does not mean that there is no opportunity for the Jews to serve; on the contrary an active recruiting campaign is being conducted by the Jewish Agency among the Jews in Palestine, the results of which are awaited with interest. The entry of the United States into the wer will of course also provide American Jews with the possibility of serving the common cause in the armed forces of the United States, and Mr. Churchill is confident that they will do so with course are and determination."

LIBERAL IMMIGRATION POLICY EXPECTED IN BRAZIL UNDER NEW MINISTER OF LABOR

RIO DE JANEIRO, Jan. 19. (JTA) -- A more progressive immigration policy may be expected here as a result of the nomination of Dr. Alexandre Marcandes Filho, a Sao Paulo lawyer, as Minister of Labor, it was predicted today.

It was pointed out that the new Minister who, among other functions, will regulate immigration is known to support the theory that what Brazil needs is not only more capital but also a new influx of immigrants - not only agricultural laborers but all economically productive elements.

A sharp attack against any "racial discrimination" in the selection of prospective immigrants, published in a newspaper here close to the new Minister, supports the opinion that Brazil can be expected to adopt a more liberal immigration policy. The newspaper stressed the economic advantages which other countries had obtained as a result of giving haven to refugees persecuted on religious grounds.
