JEWISH MORTALITY MOUNTS IN WARSAW GHRTTO AS NAZIS REFUSE TO CHECK TYPHUS THERE

LONDON, Jan. 22. (JTA) -- An average of 750 Jews are dying daily in the Warsaw ghetto as a result of the spread of typhus, which the Nazi medical authorities refuse to check, it was reported by Polish circles here today.

The report, based on information received from Poland through underground channels there, says that mortality among Jews in Poland has increased sixteen-fold as compared with the year of 1938. This does not include Jews executed by the Nesis. Recently more than 1,000 Jewish typhus victims were shot in Warsaw by order of the German military authorities.

Not only does the Nazi administration refuse to give medical aid to the Jews in the Warsaw ghetto, but, according to the Polish report, they are constantly transporting Jews from all sections of the Reich to the ghettos in Poland with a view of having as many Jews as possible die of typhus. Ordinarily the form of typhus now prevalent in the Warsaw ghetto is fatal in only one of six cases, but the rate, according to the information from Poland, has risen to forty percent as the result of two years of starvation which have lowered the resistance of the Jews.

While all Jewish doctors and nurses in the ghetto have been mobilized to work in anti-plague centers in Warsaw, the Nazis are utilizing the spread of typhus as a wespon to bettle the growing sympathy of the Polish population for the persecuted Jews, the Polish report stated. Nazi propagandists are conducting agitation among the Poles accusing the Jews of being responsible for the spread of typhus. Bundreds of posters have been placed on the streets of Warsaw blaming the Jews for the plague. Similar posters have been placed on the ghetto walls. They read: "Jews-Lice-Spotted Typhus. Entrance and Exit Prohibited."

JEWS FORBIDDEN TO SELL NEWSPAPERS IN HUNGARY; ANTI-NAZI LEAFLETS IN BUDAPEST

STOCKHOLM, Jan. 22. (JTA)-- An order issued yesterday by the dungarian authorities in Budapest prohibits Jews from selling newspapers and orders all Jewish newsdealers to return their licenses, the Berlin correspondent of the Swedish newspaper Swenska Dagbladet reported today. The order deprives 300 Jewish families of their livelihood.

Reports reaching here from Hungary reveal that anti-German sentiments are ground manning among the Hungarian people. Illegal leaflets stating that the Hungarians do not trust the Germans are being spread in Bucharest. The leaflets charge the Germans with emslaving Hungary economically by scheming to take over Jewish firms and by exploiting the "Jewish Law" in Hungary for the benefit of Germans. At the same time it was reported here today from Slovakis that the Hungarians there have organized a secret eati-Mazi youth organization and that three of the organizers, including two Hungarian girls, were arrested.

N.Y. TIMES EDITORIAL OPPOSES FORMATION OF JEWISH ARMY AND POST-WAR ZIONIST STATE

NEW YORK, Jan. 22. (JTA) -- Asserting that "it would be unwise for the United States to attempt to bring pressure to bear upon the British Government" in the matter of the formation of a Jewish Army in Pelestine, the New York Times in its leading editorial today strongly opposes the formation of a "Zionist Army," and the post-war establishment of a "Zionist State."

"The hopes of the Jews," the editorial argues, "can be achieved only by the fulfillment of the Atlantic Charter - by winning of a new world in which Jews along with other religious and national minorities may live peacefully and happily in every nation, enjoying full rights of other citizens."

The editorial refers to the resolution introduced in the House of Representatives recently by Congressman Somers of New York requesting President Roosevelt to direct the State Department to petition Great Britain to permit the organization of all-Jewish military units in Palestine. Though no action has been taken on this resolution, the proposal which it advances has, according to the Times, "received the endorsement of some members of the Government, and a number of deeply sincere and well-meaning people" who are moved by sympathy for the suffering of Jews in Germany and the Axis-controlled lands.

Outlines Two Reasons For Its Opposition: One Practical, One Theoretical

"For two reasons," the editorial reads, "we believe that these well-meaning people are mistaken and that it would be unwise for the United States to attempt to bring pressure to beer upon the British Government in this matter. The first reason is practical. It is no secret that the British Government is opposed to the plan for creating separate Jewish military units, though it has welcomed the enlistment of Jews in the British forces and though thousands of Jews are now serving under British colors in Palestine and North Africa. The reason for the reluctance to create separate military units is, of course, the lang-standing hostility of the Arabs in the Middle East to the proposal to establish a Zionist state in Palestine and the consequent fear of the British Government that the creation of a separate Zionist erroy would provoke an Arab uprising precisely at a time when the defense of the whole Mediterranean area is already a difficult problem. True, the British Government itself is not free of responsibility for the situation that would be thus creeted. During the First World War it made contradictory promises to the Arabs and the Zionists, and these contradictions have lived to plague it ever since. But the unhappy record of the past is not in itself a sufficient reason for adding to the problems of the British Government now by attempting to bring pressure to bear on it to go against its better judgment."

The Times editorial then gives the second reason, as follows: "The primary reason for the creation of a separate Zionist army at this time would be, of course, to establish a Zionist state as one of the official war aims of the United Nations. Grant that Palestine has been a place of refuge for a large number of persecuted people, and that when the war is over, there may be some from Axis territories who will prefer to migrate to it or to other lands rather than face the unhappy memories associated with the pest. But the wisdom of the Zionist objective has been questioned by meny people, including many who are themselves of Jewish faith; and much misunderstanding may arise among people of other faiths if this objective comes to be regarded as an expression of the full hopes of Jews and of those who would right the wrongs done them. These hopes cannot be achieved by the creation of a Zionist state. They can be achieved only by the fulfillment of the Atlantic Charter - by the winning of a new world in which Jews along with other religious and national minorities may live peaceably and happily in every nation, enjoying the full rights of other citizens."

SALE OF CZECH NEWSPAPERS TO JEWS PROHIBITED IN THE PROTECTORATE BY NAZI ORDER

Recently the Mazis have resumed their propagands in the Protectorate bleming the "Jewish underground activities" for the execution of Czechs there. The pro-Nazi Prague newspaper Ceske Slowcoin an article says that "Jews are responsible for all Czech tears." The increased Mazi effort to alienate the sympathies which the Czech population feels for the Jews has failed, however, to bring any results, the Czech leaders in London were informed.

COLONIAL OFFICE PROBING PALESTINE CENSOR'S SUPPRESSION OF NEWS ON JEWISH RECRUITING

LONDON, Jan. 22. (JTA) -- The refusal of the Palestine censor to allow the publication in Jewish papers there of news of the parades, meetings and rallies held in Palestine to induce Jewish youth to volunteer in the British forces, is being investigated by the Colonial Office, it was disclosed today in the House of Commons by George Hall, Under-Secretary for Colonies.

Replying to a question on Palestine censorship voiced by Daniel Lipson, Independent Conservative M.P., Hall stated that Lord Moyne, the Colonial Secretary, had asked Sir Harold Mackincheal, High Commissioner for Palestine, to report as to why the censor had forbidden publication of the stories on Jewish recruiting. Machichael's reply, however, is not yet available, Hall stated.

PRIVATE HURIAL FOR DR. LOWENSTEIN; 1,500 ATTEND FUNERAL SERVICES

NEW YORK, Jan. 22. (JTA) -- Leaders in all walks of Jewish life and delegations from more than 100 institutions affiliated with the Federation for the Support of Jewish Philanthropic Societies attended the funeral services for Pr. Solomon Lowenstein held here today in the Central Synagogue. The burial was private.

The services were conducted by Rabbi Jonah B. Wise of the Central Synagogue and Rabbi Elius Margolis of Congregation Emmu-El, Mt. Vernon, a classmate of Dr. Lowenstein at the Hebrew Union College. The 1,500 persons who attended included all the officials of the Federation, of which Dr. Lowenstein was executive vice-president. The offices of the Federation remained closed all day. In keeping with the deceased's request, there were no honorary pellbearers.

SECOND POLICE OFFICER DIES IN TEL AVIV BOMB EXPLOSION

TEL AVIV, Jan. 22. (JTA) -- The time bomb which exploded in a Tel Aviv house on Tuesday took its second wickim last night when Nachum Goldman, one of the police officers injured by the explosion, died here. Both he and Shlomo Shiff, deputy superintendent of the Tel Aviv police who was killed instantly by the exploding bomb, were buried today with full police honors.

Representatives of the Palestine Government and Jewish leaders attended the funeral. Mayor Rokach of this city vigorously condemned the bombing as a "vile outrage."

MONUMENT ERECTED IN FLORIDA TO JUDAH P. BENJAMIN, CONFEDERATE SECRETARY OF STATE

MIANI, Jan. 22. (JTA) -- A monument to Judah P. Benjamin, the Jewish lawyer from Louisiana, who served as Secretary of State in the cabinet of the Confederate States of America, was unveiled in Sarasota today by the local chapter of the United Daughters of the Confederacy. A large crowd attending the dedication ceremonies in the Sarasota civic center park heard speakers praise Benjamin's services to the Confederace cause.

The monument, which is of pink Georgia merble, has carved into its stone face the inscription: "Near this spot on June 25, 1865, Judah P. Benjamin, Secretary of State of the United Confederacy, set sail for a foreign shore." Benjamin fled from here to escape Union troops who were pursuing him.

A senetor from Louisiana in the period immediately preceding the Civil War, Benjamin was a leading spokesman for the South, although personally opposed to secssion. When Louisiana did secede, however, and joined the Confederacy he threw in his lot with the South. He served successively as Attorney-General, Secretary of War and Secretary of State in President Jefferson Devis' cabinet. On April 2, 1865, when it became obvious that the rebellion of the South was doomed, he together with other government leaders left Richmond, the capital of the Confederacy, and proceeded southward.

Benjamin finally reached Florida after several narrow escapes from the Union soldiers and on June 25, 1865, sailed for Bimini in the West Indies from whence he eventually went to England. Although 54 years old at the time he fled from the United States and ill from diabetes and a weak heart, Benjamin re-established himself in England, was admitted to the Bar and for sixteen years practiced there, honored as a leader among English barristers. He died in Paris in 1884.
