### \$100,000,000 WORTH OF JEWISH PROPERTY REMOVED FROM WARSAW TO GERMANY

ZURICH, June 12. (JTA) -- Provisional estimates received here today from Nasi-occupied Poland establish that Jewish moveable property valued between \$100,000,000 and \$120,000,000 has been confiscated by the Nasis in Warsaw and removed to Germany. This includes merchandise, machinery, foodstuff, clothing and other valuables.

The Krakiwski Wisti, a Nasi newspaper in the Ukrainian language, which reached here today from Cracow, reports that the Gestape has executed six Jewish policemen in occupied Poland on the charge that they were aiding ghetto residents to illegally send letters to relatives abroad. Three of the policemen were executed in Warsaw, two in Kielce and one in Radom, the paper announces.

The Neue Tag, a Frague newspaper reaching here today, reports that the Prague police commissioner issued an order forbidding Jews to appear on sixteen of the principal streets in the city between this past Wednesday and this coming Monday morning. No reason is given for this order: It is assumed that the order also applies to those Jews who reside in these streets, and who will not be able to leave their homes during the entire week-end. The execution of two more Czech Jews in reprisal for the assessination of Reinherd Heydrich was also reported here today.

### FIRST GROUP OF POLISH-JEWISH REFUGEES REACH PALESTINE FROM RUSSIA

JERUSALEM, June 12. (JTA) -- The first group of Jewish refugees from Poland who were stranded in Russia reached here today by way of Taheran, Persia. Another group of 150 Polish Jews are expected to arrive here from Teheran in the next few days.

The Palestine press reports today that 11,000 Polish civiliens from Russia, Jews and non-Jews, are now in Persia en route to countries of the Middle East. They include 6,000 women and 1,500 children. They are all being taken care of by Polish welfare organisations which make no distinction emong the refugees.

Cabled advices received here today from the Jewish Relief Association in Bombay inform that 161 Polish children arrived there this week. There were only nine Jewish children among them.

The Palestine press states that the Iraqian premier, Muri Essaid, in the course of an address delivered before the Iraqian senate, is reported to have said: "I have good news. Palestine, Syria and all Arabs will attain their independence. I received a cable to this effect from the Iraqian minister in Washington, essuring me and every Arab with regard to the future of these territories. I cannot say more about it at present."

(A high official spokesman in Washington seid today that the U.S. Government has given no guarantees or assurences to Iraq regarding the post-war position of Near Eastern countries. The Iraqian minister, Ali Jaxdat, when questioned by the JTA about the statement, would say only: "I can not discuss it.")

### JEWS IN U.S. COVERNMENT SERVICE DO NOT EXCEED PROPORTION IN GENERAL POPULATION

NEW YORK, June 12: (JTA) -- The allegation voiced by some anti-Semitic groups that the proportion of Jews in the Government service is far in excess of the proportion of Jews in the general population is denied in the chapter on "Jews in Government," in the recently issued volume "Washington Is Like That" by W.H. Kiplinger, published by Harper & Brothers.

From his own observations, Kiplinger states that the number of Jews in the various Government departments in Washington constitute about four percent of all the employees, which is the proportion of Jews among the 150,000,000 Americans. Kiplinger explodes the myth that all the Jews in the Government act together so as to create a cohesive "Jewish influence." He reports that the Jews in the nation's capital, like every other religious group, are splitinto scores of different groups holding widely-varying philosophies.

He attributes the public impression that there are a tremendous amount of Jews employed by the Government to the fact that in certain agencies which come in contact with the public - such as the Securities and Exchange Commission, the Department of Labor, the National Labor Relations Board - there are a substantial number of Jews employed. These departments, he points out, employ statisticians, lawyers and economists.

Kiplinger reports that there is discrimination against Jews in some Government bureaus and also agitation against them fostered by some anti-Semitic Congressmen. Some Government officials, however, are seeking to stop the subtle discrimination that has been practical against Jews, he writes.

### AMERICAN PRO-FALASHA COMMITTEE RESUMES WORK AMONG NATIVE JEWS IN ETHIOPIA

TEL AVIV, June 12. (JTA) -- A farewell dinner was given here today to Dr. Jacques Fattlovitch, exhibiter and founder of the Jewish educational and welfare work among the Falashas, on the occasion of his return to Ethiopia to resume his work emong the Jews there.

The activities of Dr. Faitlovitch will be financed by the American Pro-Felsehe Committee which has been in existence for over twenty years. The committee, in 1925, established a Jewish school in Addis Ababa, capital of Ethiopis, where hundreds of Felsehes were given a Jewish education. Soon after the Italians were driven out of Ethiopia last year, Dr. Faitlovitch re-established contact with the Jewish tribe there. Information which he received from them reveals that they suffered greatly under the Italian occupation.

## HARRY BAUR, FILM STAR, ARRESTED IN BERLIN FOR HIDING JEWISH ANCESTRY

STOCKHOLM, June 12. (JTA) -- The well-known film actor, Harry Baur, was arrested in Berlin three weeks ago, charged with forging his certificate of ancestry to conceal a remote Jewish forebearer, it is reported today in the Svenska Dagbladet, a Swedish newspaper.

At the time of his arrest, Baur had just completed work in a new film which has now been banned by Propaganda Minister Goebbels "because Baur is tainted." Scrapping the film will cost the Tobis Co., the producer, about two-million marks, the paper said.

### LAYAL CHARGES DORIOT'S ANTI-SEMITIC PARTY IS PLOTTING AGAINST HIM; PROHIBITS MEETINGS

VICHY, June 12. (JTA) -- Suspecting that under the guise of organizing "direct anti-Jewish action," Jacques Doriot, the leader of the anti-Semitic Franch Popular Party, is preparing an organized force of uniformed Storm Troopers for the purpose of seizing control of the Vichy Covernment, Premier Level today announced that he will no longer permit Doriot's organization to hold political mess-meetings in uncocupied France.

Practicelly all mass-meetings held by Doriot's followers featured antiSemitic slogens and many of them were followed by violence against Jews. In today's
statement, Laval, as chief of the Vichy Government, declares that he has discovered
that the real aim of these meetings was to prepare the ground for Doriot to become
the diotator of France, utilizing the anti-Jewish propaganda and terror as a means
of strengthening the ranks of his uniformed Storm Troopers which are organized on
the model of the Brown Shirts in Germany.

"Doriot wants to take power for himself," Laval said, "but the power is the Government, and I am so far the Chief of the Government." Laval also disclosed that he and Doriot had a serious quarrel this week during a visit to Paris.

### Jewish Woman Attorney Appears in Paris Court with Yellow Badge on Robe

The Paris press sensationally features a story of how one of the two Jewish women still permitted to practice law in Paris appeared in a court there yesterday, prominently displaying a yellow Mogen David on her lawyer's robe. Her husband, a French officer, was killed in the war.

Refraining from disclosing the woman's name, the collaborationist press in Paris terms her silent demonstration in court "a reandal." Pro-German newspapers in Paris, in publishing the news, demand that Jews should be completely barred from practicing before French courts, irrespective of the services they may have rendered to France in the past.

### NAZIS THREATEN "EXTERMINATION" OF JEWS IN REPRISAL FOR BOMBING OF GERMAN CITIES

BERNE, June 12. (JTA) -- The Nexis will carry out a "mans-extermination of Jews" in reprisal for the bombing of German cities by the air force of the United Nations, the Berlin radio ennounced tonight, quoting an article written by Goebbels, the Mexi Minister of Propaganda.

In his article, published in Das Reich, Goebbels states that not only will the Jews of Europe be arterminated, but "even those beyond Europe" in retaliation for the heavy bombing of German cities.

Acknowledging that "the German population is suffering bitterly from the air raids," Goebbels writes that it was the Jews who incited England and America to bomb the German cities. His threat of "mess-extermination of Jews" was taken here to indicate that the Maxis are especially littery over the reports that Berlin will soon be heavily bombed by a mixed British-American air force.

#### RABBI LAZARON OUTLINES ATTITUDE TOWARDS ZIONISM AND PALESTINE JEWISH IMMIGRATION

BALTIMORE, June 12. (JTA) -- Dr. Morris S. Lazeron, one of the leading participants in the recent conference of Reform Rabbis in Atlantic City, today outlined to the representative of the Jewish Telegraphic Agency here his position with regard to the Zionist problem discussed at the conference.

"From the reports in certain sections of the Jewish press," Dr. Lazaron said, "one would gather that the conference in Atlantic City was anti-Palestine. This is not true. I appreciate the opportunity to re-state what I said there.

"We must not permit ourselves to be jockeyed into the position of being against Palestine. We are not. We should endorse a constructive program for the economic and cultural development of the Holy Land, but our work for Palestine must be from the viewpoint of the American Jewish community. Jewish ties with Palestine and the presence there of thousands of Jews will render easier the task of Jewish settlement in that land.

"There will be Jews in Central and Eastern Europe who will wish to emigrate, whilst in other countries - such as France and England and oven here - there are many who came as transmigrants and for whom a permanent home may have to be found. Palestine is an obvious home for many of these. We recognize with pride and edmiration the great pioneer work which has been done in that country and which makes further settlement on a substantial scale possible. We agree that if large-scale emigration is necessary immediately after the war, Palestine would be able to receive considerable numbers.

"For such settlement to be possible, it is not necessary to urge the creation of a Jawish State. To found a State based on race or creed is fundamentally wrong and indeed is the antithesis of one of the principles for which this war is being fought. We cannot imagine any basis for a Jawish State which is not wholly inconsistent with the principles of the Atlantic Charter. Apart from our fundamental objection on principle to this proposal, it clearly raises many practical obstacles. It must accentuate the difficulties in the way of arriving at friendship and cooperation with the Arabs, without which nothing can be achieved. Why mortages the future? Build the land and people it. All other things can take care of themselves.

"The British Government should be asked to take such steps as will make possible the fullest immigration into Palestine on satisfactory terms. It is obvious that such a policy can only be successfully carried through if the British Government make the necessary arrangements with the Arabs. The British Government should be asked to ensure that necessary changes be made in the constitution and administration of Palestine, and that wide powers, financial and others, are given to the local authorities, to enable them to provide whole-heartedly for the carrying out of the policy of facilitating Jawish immigration into Palestine and the highest development of which the country is capable. Nor is it necessary at this stage to set out in detail what changes or powers may be required. The difference, therefore, between our policy for Palestine and that of the Zionists is the difference between a policy fundamentally economic and cultural and one fundamentally political.

"We take our stand on the Four Freedoms and the Atlantic Charter and all that derive from them. The people who speak for freedom and democracy will speak for the Jews. With the acceptance of the Atlantic Charter it will follow that those of the Jewsh feith will be accepted as full citizens of the countries where they lived before the Masi persecution started. It is an essential foundation stone for a peaceful world that the policy of every civilized state shall be rigidly to exclude all differentiation between its citizens on the ground of race or religion and above all that no state shall have the right to drive its nationals from its territories because of racial or religious prejudices."
