#### GESTAFO KILLING ALL JEWISH CHILDREN IN POLAND, POLISH GOVERNMENT REPORTS

LONDON, Oct. 26.(JTA) -- The mass-extermination of all Jewish children in Poland by the German authorities was reported today in a message received by the Polish Government-in-Exile from the underground movement.

"There are practically no Jewish children left in Poland, the Germans are killing all of thom," the message said.

Thousands of Jewish children roaming the roads and the woods have been captured by German police and sent to gas chambers where they were asphyxiated, the report continued. Others have been deported together with their parents to unknown destinations believed to be "extermination camps."

The report adds that Polish peasants were warned by the Gestapo not to give shelter to Jewish children and to report their hideouts to local occupation authorities. Some of the Jewish youths who lost their parents succeeded in escaping the Nazis during the summer months by posing as Poles. They slept in the open fields and in the woods, and ate whatever they could pick up in gerdene and in orchards. With the approach of the rainy season these youngsters, lacking shelter and food, are falling into the hands of the Germans.

#### JEVISH AMENCY ALLOCATES \$2,000,000 FOR ECONOMIC ACTIVITIES IN TRANSITION PERIOD

JERUSALEM, Oct. 26.(JTA) -- The Jewish Agency today decided to allocate up to \$2,000,000 for the establishment of economic agencies which would make the transition period from war to peace easier for the Jewish population of Palestine. The funds will be used to encourage industry and agriculture. Long-term credits will also be granted for construction work.

The Agency today submitted to the Palestine Government its request for the immigration schedule for October-November-December. Nost of the visas received under this schedule will be alloted to Jewish refugees now in Turkey, Spain, North Africa and in the liberated parts of Italy. Hundreds of Jews are escaping from the German-held part of Italy into the section held by the Allies, the Agency was informed.

#### NURENBERG LA'S TO BE INTRODUCED IN GERMAN-HELD ITALY, MUSSOLINI'S MINISTER ANNOUNCES

STOCKHOLM, Oct. 26.(JTA) -- The full list of Nurenburg Laws, the basis for anti-Jewish legislation in Nazi-occupied Europe, will be introduced in the German-held section of Italy, which is nominally ruled by Mussclini's puppet government, the official German news agency DNB reports today. DNB quotes an announcement by Dr. Glovani Preziosi, Il Duce's Minister of State.

Reports reaching here today from Dequark state that 3,000 Gestape agents reinforced by Danish Nazis are scouring the woods and homes of Denmark in an attempt to apprehend fugitive Jews. The Germans have placed a strong coastal guard along the Sjaclland and Kattegat making it virtually impossible for anyone to flee the country. Only a small number of individual Jews succeed in escaping and reaching Sweden.

### REFORM RABBIS RATIFY ALL RESOLUTIONS OF AMERICAN JETISH CONFERENCE

NEW YORK, Oct. 26, (JTA) -- All the resolutions of the American Jewish Conference were ratified today by the executive committee of the Central Conference of American Rabbis at a meeting in Cincinnati which adopted the following resolution:

"Raving received the report of its delegates who attended the recent sessions of the American Jewish Conference, the Executive Board of the Central Conference of American Rabbis expresses its satisfaction with the outcome of this historic conference and with the contribution which our representatives made toward its deliberations. It ratifies the action of its delegates in supporting all the resolutions which were adopted at the conference. It expresses the hope that this great and democratically representative body of American Jewry will continue to function and to serve the cause of our people in these critical times."

The Mizrachi Organization of America, the Zionist Laborite Party and other Zionist groups today issued stetements criticizing the American Jewish Committee for withdrawing from the American Jewish Conference. A meeting of the executive of the American Zionist Emergency Council will be held tomorrow to decide on action to be taken by Zionist groups in the United States with regard to the situation which has developed as a result of the withdrawal of the American Jewish Committee from the Conference.

#### Hadassah Rasigns from the American Jewish Committee

Hadasach's twenty-minth annual convention, which opened last night at the Henry Hadasach Hetel, adopted a resolution to withdraw from membership in the American Jewish Committee. Pointing cut that the delegates of Hadasach "have learned with deep regret of the action of the American Jewish Committee, which has withdrawn from the American Jewish Conference, thus isolating itself from the united Jewish representation in that Conference and breaking the unity of American Jewry," the resolution says:

"We are concerned, too, that this decision was made by the executive committee of the American Jewish Committee despite the earnest plea of some of its "members that the metter be referred to the large annual meeting of the American Jewish Committee, where a wider base for discussion would have been possible,

Twhen the American Jewish Committee entered the American Jewish Conference ti reserved for itself the right to dissent from any decisions of the majority and in so dissenting to take separate action thereon. Their three representatives on the conference expressed their dissent from the Pelestine resolution as presented. This was reported in the press, so that the committee's position was made abundantly clear. However, there were large areas in which there was complete accordent the pert of the American Jewish Committee with the conference decisions, and we note that the committee continued in its full support of full immigration into Pelestine and in its opposition to the White Papers, we believe that these days of dark tragedy for our people demend the utmost effect on the part of American Jews to work together, and that unity of action can be achieved despite differences.

"Hadassah has been a constituent member of the American Jewish Committee for many years despite cortain ideological divergencies, because it was deeply conscicus of this meed for ecoperative effort in Jewish affairs. We believe that the action of the American Jewish Committee in withdrawing from the Conference has put a breach into that cooperative effort, rendering impossible Hadassah's continued membership as a constituent body of the American Jewish Committee."

#### LADASSAH CONVENTION PRESENTED WITH \$100,000 GIFT FOR CHILDREN'S VILLAGE IN PALESTINE

NEW YORK, Oct. 26.(JTA) -- Plans for the erection after the war of an undergraduate medical school in Palestine and for the training of personnel for administrative and executive health posts were reported at today's session of the Hadassah convention by Mrs. A. P. Schoolman, chairman of the Palestine committee of the organization.

Hadassan also intends to establish a neuropsychiatric institute in Palestine, Dr. L. M. Eluestone disclosed at the convention. "If our enemies must add mental disease to our burdens, we knall have to carry them and plan well ahead of the expected demand for such facilities," Dr. Eluestone said. He also revealed that a plan for the establishment of a tuberculosis wing at the Hadassah hospital in Jeruselem is now under consideration.

The launching of a land-buying campaign for Freedom Village, an industrial settlement for Jewish refugee children which is to be set up in Palestine, was an counced by Mrs. Samuel Inselbuch, Jewish National Fund chairman of Hadassah. A check for 100,000 raised by Frank Cohen of New York was turned over to Hadassah to provide housing, an industrial plant and equipment for the 100 children who will be settled in the community. Hadassah is pladging itself to raise \$500,000 for land reclamation and reforestration in Palestine next year, part of which will got toward the purchase of suitable acreage for Freedom Village.

#### BOSTON TRIAL RIVEALS POLD OF FOLICE TO LOCAL ANTI-JEVISH ASSAULTS

BOSTON, Oct. 26.(JTA) -- The trial of two Jewish boys, Marvin Blaustein and Jacob Hodes, charged with perticipating in an affray during attacks by anti-Semitic hoodlams on Jews here, opened today in the Dorchester Municipal Court. The trial is being watched by both Jewish leaders and non-Jews interested in checking the anti-Jewish assaults which have taken place in the Jewish-population sections of Loston.

The arrest of the two boys led to Jewish protests against the failure by the Boston police authorities to curb the anti-Semitic elements who have assaulted Jewish children and adults on the streets. At today's hearing, young Hodes charged a police sergeant with beating him at the police station.

The hearing, which lasted all day, will continue tomorrow when the court is expected to issue its verdict. The two Jewish boys are being defended by Herbert Ehrman and Albert Hurwitz, two Jewish lawyers who volunteered to prepare their defense in cooperation with the Central Advisory Committee, a Jewish body coordinating Jewish communal work in Greater Boston.

The Central Advisory Committee today issued a statement declaring that it "feels that the assaults upon Jewish residents in Dorchester is not a Jewish question, but are evidence of a serious menace to our democracy, which should be faced and solved by all Americans."

"Insofar as the lawlessness is a matter of hoodlumism, the problem is purely a police question in which all citizens are interested," the statement said. "To the extent, however, that these acts indicate the successful advance in Massachusetts of the anti-Semitic Mazi policy of 'divide and conquer,' the situation presents a sinister aspect, which can only be met by the united effort of all persons interested in preserving the safety and freedom of our country."

## PALESTINE JETS SEND THIRD SHIPMENT OF GIFTS TO RUSSIAN ARMY

JERUSALEM, Oct. 26.(JTA) -- The third consignment of Lifts for the Red Army collected by the Palestine Victory League for Soviet Russia is ready for shipment and will be sent to Russia shortly, it was announced here today. The consignment consists of three field operating units fully equipped with surgical instruments and medicaments. The total cost is over forty thousand dollars.

The mobile operating theaters were built on lines suggested by British military experts who were invited to examine the plans and methods of construction. Each theater is contained in a trailer and har two operating tables, a steel stretcher, dynamo, projectors, sterilizing equ ment and a water-heating apparatus. A tent which can be attached to the trailer provides reserve accommodation for nurses. The trailer with its wings covers an area of 70 square feet.

## BRITISH JEWS SENDING \$20,000 TO SWEDEN TO AID DANISH REFUGEES

LONDON, Oct. 26. (JTA) -- Twenty-thousand dollars will be sent to Swedish Jewish relief groups by the United Jewish Appeal Committee, for aid to Danish Jews who have found refuge in Sweden, it was announced here today. The Committee will also attempt to forward supplies to the Jews of Tripolitania, the announcement said.

Leonard Stein, president of the Anglo-Jewish Association, today cabled to Generals de Gaulle and Giraud congratulating them on the restoration of the Cremieux Decree by the French Committee of National Liberation, which, he said, merked the disappearance of racialism in liberated French territory.

# Jews in Montreal Present \$5,000 to Swedish Minister for Refugees in Sweden

MONTREAL, Oct. 26.(JTA) -- Local Jewry is forwarding through Per Wijkman, the Swedish Minister to Canada, the sum of \$5,000 for the relief of the Danish Jews who have found refuge in Sweden, it was announced here today.

# CANADIAN JEWISH OLYMPIC STAR LOSES EYE AS RESULT OF ARTI-SEMITIC RIOT

MONTREAL, Oct. 26.(JTA) -- Moe Herscovitch, former Canadian Olympic boxing star, has been compelled to have one eye removed as a result of injuries suffered during an attack by anti-Semitic hoodlums on a group of Jews in the summer resort of nearby Plage Leval on July 25, it was learned today.

Meanwhile, police authorities are again seeking Rene Bolduc, son of the police chief at Plage Laval and ringleader of the riots. Bolduc was acquitted last month of responsibility for the anti-Jewish disturbances, although a constable testified that he heard him urge a group of youths to attack the Jews. He is being sought at present in connection with another disturbance.

## MIKHOELS AND FEFFER FINALLY ARRIVE IN ENGLAND

LONDON, Oct. 26.(JTA) -- Prof. Solomon Mikhoels and Lieut.-Col. Itzik Feffer, the Jewish cultural delegation from the Soviet Union, arrived in London from the United States last night. The two delegates had been expected here some weeks ago and several meetings arranged for them were held although the guests of honor were absent. Transportation difficulties delayed their departure from New York.
