#### ROOSEVELT RECEIVES ZIONIST LEADERS; SAYS U.S. NEVER APPROVED WHITE PAPER

WASHINGTON, March 9. (JTA) -- President Roosevelt today received Dr. Stephen S. Wise and Dr. Abba Hillel Silver, the co-chairmen of the American Zionist Emergency Council, and told them that the Government of the United States have never approved the United Paper.

The two Zionist leaders were received by the President while an all-day conference of Christian leaders was taking place at the Statler Hotel here, called by the incrican Palestine Committee for the purpose of "mobilizing imerican Christian sentiment in favor of free entry of Jews into Palestine and the reconstruction of that country as a free and democratic commonwealth." Following their neeting with the President, the two Zionist leaders issued the following statement:

"The President authorized us to say that the American Government has never given its approval to the White Paper of 1939. The President is happy that the doors of Falestine are today open to Jewish refugees, and that when future decisions are resched, full justice will be done to those who seek a Jewish Mational Home for which our government and the American people have always had the deepest sympathy, and today more than ever in view of the tragic plight of hundreds of thousands of Jewish refugees."

### White Paper Conflicts With American Interests, Conference Hears

Leaders in the field of government, education, labor, industry and religion who came from all ower the country to attend the conference of the American Palestine Committee, were told by Dr. Henry A. Attinson, who presided, that "we are not going beyond our rights in stating to our government our conviction that the White Paper conflicts with American sentiment and American interests."

Emphasizing that as chairman of the Christian Council for Falestine, he represented "the mature judgment of more than 1,000 elergymen," Dr. Atkinson continued: "We are here to urge the passage of the bills now before Congress, which in affect call for the withdrawal of the White Paper and the complete fulfilment of the criginal intent and purpose of the Balfour Declaration. We are thoroughly appreciative of the responsibility of the military and naval authorities in efforts to win the war, but we are equally determined not to lose the peace after we win the war."

# Resolution Asks Maximum Immigration, Jewish Commonwealth

After hearing several speakers, including Assistant Attorney General Norman & Littel, Dr. Walter C. Lowdermilk, Assistant Chief of the Soil Conservation Service of the U. S. Department of Agriculture, and Dr. William F. Albright, president of Libra Hopkins University, the conference adopted the following resolution:

"We reaffirm our faith in the spirit as well as the letter of the Balfour Beclaration and ask for a maximum Jewish immigration into Palestine and full opportumity for colonization and economic development.

"We reaffirm the traditional policy of our government and ask for all

effective measures to the end that Palestine may be reconstituted by the Jewish people as a free and democratic Jewish Commonwealth,

"We urge passage at the earliest opportunity by the Senate and the House of Representatives of the Wagner-Taft-Wright-Compton Assolution now under discussion in committee so that these objectives may be the more speedily realized."

#### U. S. Agricultural Expert Speaks of Jewish Progress in Palestine

Pr. Lowdermilk, demonstrated with colored slides the progress made by Jewish settlers in Pelestine. "Palestine," he said, "may serve as a demonstration for the whole Bear East how land may become restored." He outlined a project for developing the Jordan Valley which, if carried out, would enable the absorption by Palestine of four million people.

Assistant Attorney General Littal appealed to Americans for "candid, realistic recognition" of the fact that Jews face persecution. "Americans must fight Jewish persecution at home the way Americans traditionally fight everything - with a head-on stark. "e've got to stop this thing in its tracks," he said.

pr. Albright told the conference that he regards the continued development and expension of the Zionist program for Palestine as by for the most promising factor in the future economic and cultural development of the Arab world as a whole. "Planted in the midst of the Arab world, Jewish Palestine cannot fail to be a most potent source of benefit to all surrounding lands," he said.

#### Dr. Silver Assails Arab Protests Against Palestine Resolution

Speaking at a dinner which climaxed the conference, and which was attended by many members of the Equae and the Senate, Dr. Abba Hilled Silver assailed the presents by Arab countries against the Polestine resolution. He expressed the hope that U. S. military authorities "will soon find it possible, consistent with the remlities of the situation, to withdraw their objections to the resolution, so that the Congress of the United States may be given the opportunity to speak its mind on this tremendously important question."

"To those who say that the Jewish people should wait for the end of the war before they waise the question of the abrogation of the White Paper, the answer must be given that wital political decisions affecting many countries are even now being made, and palestine and the Bear East are quite definitely today within the field where political activities looking towards ultimate arrangements are being vigorously prescuted." Dr. Silver continued. He charged that the "White Paper is not a product the war and the return of peace will not automatically abrogate it. It is clear that unless there is a revision of attitude and change of heart, the Golomial Office of Great Britain will be able to discover after the war as many insurmountable difficulties in the way of fulfilling the clear intent and purpose of the mandate as they discovered before the war."

Senator Robert Wagner, speaking at the dinner, asserted that there was a greater need for Congressional action now than in 1922, The Jewish people have long been denied their rights; he said, adding that "Europe today is a vast graveyard for been dead. They have a right to ask us that they be counted in the ranks of temperows society of free nations."

#### BRITISH DECISION ON PALESTINE IS NOT TO BE EXPECTED SOON, NAHUM GOLDMANN SAYS

LONDON, March 9. (JTA) -- The British Government is not likely to make any decision on the Palestine question shortly, although responsible British circles are becoming convinced that the present state of affairs cannot convince and that a fundamental solution must be found, Dr. Nahum Goldmann, head of the Washington office of the Jewish Agency, told the Jewish Telegraphic Agency today prior to returning to the United States.

The postponement of action on the Palestine resolution by the Congressional committees in Weshington is no major political blow to the Zionist demands, Dr. Goldman said. In their consultations in London, the Zionist leaders have schieved unity with regard to the Miltmore Declaration, he added. He said that during his stay in london he conferred with representatives of the British, Soviet and other Allied governments with regard to the resone of Jews from Burope and that "practical schemes have been evolved with the help of these governments."

#### JEWISE AGENCY FREPARES MEMORANDUM TO BRITISH GOVERNMENT; 12-POINT PROGRAM FORMULATED

JERUSALEM, March 9. (JTA) - A 12-point program based on the Biltmore Declaration was drafted by Devid Ben-Gurion, upon resuming his post as chairman of the executive of the Jewish Agency this week, it was learned here today. This program will be included in a memorandum which the Jewish Agency in London will submit soon to the British Government, it was stated here.

It is understood that since Ben-Gurion and Dr. Weismann have reconciled their differences, the former will not proceed to London. The reconcilistics was reached on the bests that Dr. Weismann's sphere of action is in London and Ben-Gurion's remains in Jerusalem. The delegation sent to London by the executive of the Jewish Agency in Jerusalem is expected to return to Falestine at the end of this month.

A convention of Jewish ex-servicemen held in Tel Aviv today adopted a resolution supporting the Biltmore Declaration which demands the establishment of a Jewish Communealth in Relactine. The convention also addressed an appeal to the United Distance to speed the resous of Jews from Europe. It called upon Jewish institutions to take better care of ex-servicemen and asked the Pelestine administration for pwarment land to be given to Jewish war veterans for colonization.

# MATT, ENCOURAGED BY WASHINGTON DEVELOPMENTS, ASKS ARABE FOR MORE ANTI-JENIER ACTION

JERUSALEM, March 9. (JTA) — Encouraged by the opposition of the War and State Departments in Machington to the Pelestine resolution, the Arch press in Egypt calls for Murther Arch action against Jews. The newspaper Al Balagh, organ of the Egyptian Chinat, ways that "who whelving of the Pelestine resolution in the American Congress similar stimulate the Arch countries to further solidarity," especially in the field of communic activities, "in order to prevent the Lionists from dominating any markets in the Middle Rest."

The Arch press in Pelestine continues to feature reports on the developments in Radhington with regard to the Pelestine resolution. The Hasseini faction, which topesonts the Pelestine Arch Party, submitted a memorandum to U. S. Consul-General levell C. Pinkerton in Jerusalem declaring that the Pelestine resolution "threatens the majority of the Pelestine Archs and prejudices their interests."

The Hebrew press in Palestine also comments extensively on the Washington awaloments. Hearets, one of the leading Hebrew newspapers, points out that "the dissummines have been postponed, but the problem remains and constitutes part of the intermetional problems facing the world after the war."

# WAR CORRESPONDENT REPORTS NAZI EXTERMINATION OF ALL JEWS IN KRASNOTAV

MOSCOW, March 9. (JTA) -- The methodical extermination of the entire Jewish population of the city of Krasnotav, in the Ukraine, by German occupation troops is reported today by the Soviet press in a dispatch from a front correspondent based on affedavits given him by four non-Jewish eye-witnesses of the massances.

Immediately after the Germans seized Krasnotav in August, 1941, 47 Jewish men were taken to the woods on the pretext that they were to be used for forced labor. Then they reached a spot near the village of Senigov, however, they were all shot. I week later a German punitive detachment came to Krasnotav, rounded up several hundred men, women and children and loaded them into trucks which took them to the woods near the village of Guta. There two large pits were already waiting, and 755 lews were machinegunned and dumped into the mass graves. Many persons who were wounded, but still alive, were buried there. The property of the massacred Jews was locked by the German soldiers.

From time to time during the subsequent six months Mazi detachments raided the village to massacre any remaining Jews who had found shelter in the homes of non-Jewish friends. In March, 1942, these raids were climaxed by the visit of the regional commandant of the German police, under whose supervision 175 Jews were captured and tortured. Survivors were driven half-naked to a camp at Berezov, from where they were taken a short time afterwards to the notorious Slavuta Camp, where thousands of Russian war prisoners had been tortured to death. None of the Jews ever left Slavuta. Eventually, all of them were shot and their bodies buried near a water tower in the village of Slavuta proper.

#### SCHWEITZER DISCUSSES JEWISH IMMIGRATION PROBLEMS WITH PALESTINE HIGH COMMISSIONER

JERUSALEM, March 9. (JTA) -- David J. Schweitzer, special representative of the Hias-Ica Emigration Association who is now in Palestine, was received today . . by High Commissioner Sir Harold MacMichael with whom he discussed Jewish immigration problems for an hour.

The Jewish Agency executive today announced the establishment of a Zionist Veterans Loan Fund which will carry the name of Dr. Arthur Hantke, director of the Leren Hayesod, whose 70th birthday was observed in Palestine this week.

# BILL OUTLAWING DISCRIMINATION IN EMPLOYMENT INTRODUCED IN NEW YORK STATE SENATE

ALBANY, March 9. (JTA) -- Two measures designed to prohibit discrimination in employment and to increase civil rights protection were introduced in the New York State Senate today by Senator Wicks. One bill would set up a state Fair Employment Commission empowered to compel employers to cease discriminating against any workers because of race, creed or color. The other bill would create a "Civil Rights Dureau" in the Attorney-General's office to probe all complaints of violations of civil rights.

The bill to bar employment discrimination defines the following practices as illegal: 1. Advertising or use of any printed form which contains specification or limitation as to race, color, creed or national origin; 2. inquiry of any employment agency about race, color, creed or national origin.
