HUGE OPEN-AIR DEMONSTRATION IN NEW YORK DEMANDS RESCUE OF JETS FROM EUROPE

MEN YORK, July 31. (JTA) -- Tens of thousands of Jews and non-Jews crowded Midison Square Park today at an open-air mass-demonstration in behalf of the Jews of Mungary and other parts of Mazi Europe sponsored by the 64 affiliated agencies of the American Jewish Conference with the cooperation of the American Jewish Committee and other national organizations.

Speakers at the demonstration included Assistant U. S. Attorney General Norman M. Littell, who is scoretary of the National Committee Against Perscution of Jews;
Dr. Stephen S. Wise, president of the American Jewish Congress and oc-chairman of the American Jewish Conference; Judge Joseph M. Prodkauer, president of the American Jewish Conference; Adolph Held, president of Blani Birith and co-chairman of the American Jewish Conference; Adolph Held, president of the Jewish Labor Committee, and many other noted Jewish and Christian leaders.

The huge mass-meeting in which Jews from all walks of life participated adopted a declaration stating that it is not yet too late "to save thousands upon thousands" of Jews for the day of liberation. The meeting appealed in the first instance to President Roosevelt and the Government of the United States, and through them to the United Nations and to the neutral states, to employ the following measures of rescue "without further delay."

- 1) By means of warnings, broadcasts and all other forms of communication, the umgarian Government and people should be made to realize that they will not be allowed to escape full responsibility for the crimes now being committed on their territory; and that they themselves must make every possible effort to halt the death march and protect the Jews under their control.
- 2) In the light of Admiral Horthy's recent offer to the International Red Cross to release all Jewish children under ten who can obtain foreign visas, as well as adults with Peleatine visas, we urge the United Nations to adopt immediately all measures leading to the evacuation of these people.
- 3) The protection of the United States and the other United Mations should be formally and openly extended to the helpless victims of Nazi persecution within the occupied territories.
- 4) Appropriate measures should be taken to induce the Axis government to equalize the status of Jews in Mazi-occupied territories, who are deprived of freedom of movement, with that of prisoners of war, military or civilian, in accordance with the Geneva Convention of 1929.
- 5) Since Palestine is the nearest country of refuge for Jews in the Balkan countries, its doors should be fully opened to them by the Mandatory power, and Turkey, which is the most available country of transit, should be induced to open its frontiers.
- 6) The United States and the other United Nations should declare that all territories under their administration are open to all Jews who can be rescued and

the neutral nations shall likewise declare that they will facilitate the transit of these people to the aforementioned territories.

- 7) Since starvation continues to be one of Hitler's most effective weapons of destruction, all means should be taken by the United Mations, consistent with the war effort, to bring food and medicaments to the endangered Jews under the auspices of the International Red Cross.
- 8) All measures should be taken by the military authorities, with the help of the underground forces, to destroy the implements, facilities, and places where the Maris have carried out their mass executions.

"Wo solemnly declare that every hour of delay in implementing these measures increases the agony and suffering of those Jews who are still under Azis domination and adds new thousands to the death toll," the declaration said. "We cannot remain silent. We demand and confidently expect that the United States and the other United Nations will move swiftly to resoue those who can still be saved, and punish the guilty for their inhuman orimes."

#### President Roosevelt Sends Message Pledging Post-War Punishment

A message from President Roosevelt, addressed to Dr. Stephen S. Wise, was read at the demonstration. "Please express to those gathered at the meeting to protest the deportations and cruelties visited upon the remaining Jewish community of Europe my feelings of abhorrence of these desperate acts of the enemy. I repeat to all concerned my earlier warning that those who participate in these acts of savagery shall not go unpunished," the President's message said.

Mr. Littcll pointed out that the meeting was called not only to consider the fate of the 400,000 surviving Jews in Hungary. "Hungary is only one of the satellite and conquered powers," he said. "What has transpired in respect to the balance of about 1,000,000 Jews in pre-war Hungary merely repeats what has occurred in other satellite and conquered countries from the Legean to the Baltic Sca."

Reviewing the Nazi atrocities against Jews, he spoke in detail of the "Jewish extermination camps" established by the Germans where hundreds of thousands of Jews were killed in gas chambers. The Assistant Attorney General emphasized that "certain Junker generals are differing with Hitler now on technical military grounds, because their estates are threatened by the Russian tidal wave in the East," but not because they disagree with Hitler's objectives or his determination to slaughter all the Jews. He warned the many thousands of German prison-keepers in Europe that their names and their deeds are known and that the U. S. Government is compiling lists of these war criminals in order to deal with them at the conclusion of the war.

## Proskauer Presents Bill of Indictment Against Hitler

A "bill of indictment" against the Hitler government was presented at the meeting by Judge Proskauer. Among other orimes, Judge Proskauer charged that "Hitler desecrated the shrines of religion with ruthless blasphemy, turning monastery and abovy, athedral and church, symagogue and temple into ashes and rubble under his blasphemous onslaught;" that Hitler has "visited on the Jewish people, without even the faint trace of the shame and humanity of the common hangans, the most unabashed and calculated cruelty since the Jews wept by the waters of Babylon;" and that "he has not only sought to destroy merely the religion of the Jews, but religion itself, and to substitute for the sublime cadences of the Decalogue and the Sermon on the Journ the raucous dissonances of a hymn of universal hate."

Judge Prosknuer gave thanks to the churchmen of the world -- to Pope Pius XII, the Archbishop of Conterbury, Archbishop Francis J. Spellman, Presiding Bishop Henry St. George Tucker, and Bishop Francis J. McConnell, who "with scores of others are

valiantly enlisting all the forces of Christianity in this holy cause of ameliorating the plight of the sufferers from Hitlerism." He also praised "the stalwart endeavors of our great Allies."

#### Misc Appeals to Roosevelt, Churchill and Stalin to Save Hungarian Jewry

Dr. Wise pointed out that American Jewry stands united as never before in its history of three centuries. "Faction and schism have been cancelled in the consuming desire to serve our brothers in Hungary threatened by hurt and crime and death," he declared. He appealed to Rossevelt, Churchill and Stalin "to urge, to warn, to demand" that the Jews in Hungary be left alive.

"It is not the people of Hungary to whom warning and threat should be spoken, but Hitler's Hungarian Quislings, covetous and murderous," Rabbi Wise said. "This is their final test and they will be adjudged by their conduct in this hour. Mercy will not be shown to the merciless. To the plain people of Hungary we cry out - Save your proud country from this shame, help the Jews of your land to find refuge, be to them shelter and shield until the day of your liberation, which will be the day of victory for the United Nations."

#### Monsky Louds Hungarian People Who Risk Life to Shield Jews

The belief that the U. S. Government and its Allies are responsible for the most recent reports that the Hungarian Government will permit no more deportations and will grant visas to Jows, was expressed at the meeting by Henry Monsky.

"Except for Mazi control and artificial stimulation, Hungary and its people would be expected to respond to an appeal based upon the principles of decemby and morelity," it. Monsky said. "Proof of this appears from the reports of the mobile and heroic efforts of so many Hungarians, at the risk of their own lives, to shield, protet, conceal and aid their Jewish neighbors against devastation, confiscation of property, and murder."

#### Adolph Held Demands Allied Citizenship for Jews in Nazi Europe

The demand that Jews who are threatened with extinction must be declared temparary citizens of the Allied countries, was voiced at the meeting by Adolph Held, president of the Jewish Labor Committee.

"We cannot fail to admit the prinful truth that not everything possible was done for the rescue of our brothers and sisters oversons," Mr. Held stated. "It is our belief that the United Nations have not performed their duty and obligation to the worst victims of Hitlerian -- the Jowish people!

"We believe that tens and hundreds of thousands of Jows are still alive. Jows are still to be found in Hungary, Rumania, and Poland. The Mazis, however, have problaimed it their mission to slaughter the last remaining Jow before their inevitable defeat. We must rescue the surviving Jows from the clutches of the butchers. The leath march must be helted!

"We know that in the Mazi-occupied countries labor people, trade-unionists, and friends of a democratic world order are still alive. To these people we appeal, perend the surviving Jews, protect their children, save the women and aged. To the burgarian people and to the Eungarian labor movement we say, Rise up against the marderers, and massacres of hundreds of thousands of Jews still living among you; resist the Mazi beasts:

"We call upon President Roosevelt, our Government, and the governments of the mited Nations: Open the doors of your countries for the Nai victims who may still be saved; provide the necessary transportation facilities so as to accelerate their resue."

#### RESCUE BOARD FORMED IN TURKEY TO SAVE JET'S FROM HUNGARY AND BALKAN COUNTRIES

NEW YORK, July 31. (JTA) -- The Has-Ica Emigration Association today reported that a Rescue Board has been established in Turkey to facilitate rescuing Jows from Rungary and the Balkan countries and arranging their transportation to Palestine and other overseas havens. The Board is composed of two members of the Jewish Agency for palestine and of one member from the Mar Refugee Board, the Joint Distribution Committee and the Hias-Ica Emigration Association.

Dr. James Bernstein, European director of the Hias-Ica, today informed the headquarters of his organization here by cable from Lisbon that the Hungarian Legation in Portugal received a message from its government in Budapest containing the following information:

- 1) Responding to an appeal from the Swedish Government, the government of limgary agreed to permit the emigration to Sweden or Palestine of Jews who have relatives living in Sweden, or who have business connections there.
- 2) In reply to a British appeal made through the Swiss Government, the government of Bungary has agreed to renew the exit visas of Jews possessing valid Pelestine vises.
- 3) Responding to an appeal by the har Refugee Board by way of Switzerland, the Hungarian Government agreed to admit assistance by the International Red Cross for Jews in camps or ghettes in Hungary and to permit the emigration of Jewish children under ten years of age.

Dr. Bernstein also reported that the Hungarian Legation in Lisbon has been notified by its Lovernment that while the above measures are being carried out, further deportations of Jews from Hungary have been suspended.

#### JERISH CONTRIBUTIONS TO AMERICAN RED CROSS LAUDED BY NEW HEAD OF ORGANIZATION

MASHINGTON, July 51. (JTA) -- Acknowledging the great contributions of American Jewry to Red Cross accomplishments, Easil O'Connor, newly appointed chairman of the American Red Cross, today expressed his deep appreciation for the work done, at the same time calling upon the Jewish people the country over for a continuation of their efforts on behalf of the Red Cross. Mr. O'Connor, who is a member of the executive connittee of the National Conference of Christians and Jews, and who succeeds the late Norman H. Davis as Red Cross chairman, arrived in Mashington to take up his new humaniterien duties.

"Reports from every part of the country which I have recently examined all indicate the widespread and valuable participation of Jewish organizations and individuals in Red Cross work," he declared. "It is with utnest gratification that I have reviewed these reports. The contributions which the Jewish people have made through the Red Cross to humanity, the single-minded purpose with which they have arrived task of relieving distress and suffering, and the energy which they have displayed at all times, form an outstanding and glorious records

"The American Red Cross is fully aware of the debt which it owes to these men and women, both as individuals and groups, and is grateful indeed for the splendid work they are doing. They have contributed to the successful accomplishment of Red Cross tasks, and I sincerely hope these efforts will be continued without let-up."

### -BIZMANN MAKES LAST-MINUTE EFFORT TO AVOID CRISIS IN TODAY'S ELECTIONS IN PALESTINE

IOHDOH, July 31. (JTh) -- With elections for the Jewish Hational Assembly of Pelestine taking place tomorrow, Dr. Chain Weizmann, president of the Jewish Agency for Pelestine, today cabled an appeal for unity to Jewish groups there urging them the reise the fundamental aims of our national struckle above party strife."

The appeal was cabled in connection with the fact that five right-wing parties are boycotting the elections as a result of internal dissension in the Yishuv. The five groups were still refusing today to participate in the ballotting despite efforts by writus Jewish landers to convince then that it was essential for Jewish interests in palestine that they call off their boycott.

"I confidently hope," Dr. Weismann cobled, "that all parties will stand together in an impressive manifestation of the Yishur's civil and national unity. The Jews of the world, the enslaved and the free, in full admiration of the achievements of the Yishuv during the time of peace and of war, look for the Jews of Palestine to set an example in international cohesion and driving power.

"Crucial responsibilities await the new Assembly. The unprecedented catastrophe of the Jews in Europe has imposed a amique role upon the rishuv in the regeneration of our martyred people. I appeal to all sections to raise the fundamental aims of our national struggle above party strife and to rally around the Zionit leadership in order to achieve our historic goal which is the establishment of pelestine as a Jewish Commonwealth open to all Jews in need of a homeland and a living in fruitful collaboration with all countries neighboring Palestine."

It was believed in zionist circles here today that Dr. Meizmann's appeal may evert the election crisis in Palestine. The groups refusing to participate in the elections include the influential Jewish Farners Association, the Jewish Landlords Association, the General Zionists "B" group, the Zionist-Revisionist Party and the Association of Sephardic Jews. They charge that the Yishuw is being ruled by a "totalitarian regime."

## PALESTINE GOVERNMENT INVITES 15,000 LIBORERS FROM EGYPT TO WORK ON PUBLIC PROJECTS

JERUSAIEM, July 31. (JTA) -- The Palestine Government has invited 15,000 laborers from Egypt to come here to build a series of public works, it was reported in the press today.

The report said that the Egyptian Government is planning to send a special committee to Jerusalen to examine the conditions under which the Egyptians will have to work,

The Hebrew University here today learned that a novement has been started in Algiers to establish a Hebrew chair in the Algiers university. The Hebrew University will be asked to assist in the necessary arrangements.

## LATIN-AMERICAN ARABS RALLY TO SUPPORT OF ARGENTINE GOVERNMENT IN CONFLICT WITH U. S.

MONTEVIDEO, July 31. (JTA) -- The only non-Argentine group which has sent a message to the Farrell Government supporting it in its conflict with the United States is the Pan-Arab Congress, it was learned here today. The Congress was established in 1940 at a meeting of representatives of Arab communities in Argentina, Brazil, Bruguay, Chile and Colombia. A few months ago it sent a memorandum to the foreign ministers of all Mestern Hemisphere countries asking support of the Arab position on Palestine.
