JERS IN RUMANIA RESUME CONTROL OVER THEIR CONFISCATED PROPERTY; NEW DECREE ENFORCED

BUCHARRST, Jan. 1. (JTA) -- The Director of the Office to Liquidate the Matignal Center for Rumanisation today amounced that tenants or lease-holders of confiscated, Jewish property must settle all matters concerning such property with the original owners. The announcement pointed out that on the basis of the cabinet decree issued December 19, returning expropriated Jewish property, supervision of Jewish-owned buildings has been transferred from the government to the owners.

A military court here has begun the trial of two members of the anti-Semitic Irenguard organisation charged with "inciting hatred of persons of the Jewish religion." The proscoution was ordered by Minister of Justice Ducrettu Patrescam.

FRANCE STARTS ACTION TO DISSOLVE GROUPS FIGHTIND RETURN OF PROPERTY TO JEWS

PARIS, Jan. 1. (JTA) -- Acting on the decision of the French Cabinet to dissolve the two organizations which have been conducting propaganda to prevent the return to Jews of property seized under vichy laws, which was announced Friday, the Attorney General today opened an investigation into the activities of the directors of the two groups, while the State Prosecutor began a civil action for the immediate dissolution of the organisations.

The case will be argued in a sivil court here on Jamuary 10. The organizations affected are the National Inter-corporative Association of Commerce, Industry and artisanry, which is composed of purchasers of Jewish businesses under Vichy, and the Association of Administrators of France, composed of men appointed to manage select Jewish enterprises by the yiely commissariat of Jewish Affairs.

JTA CORRESPONDENT VISITS "DMATH CAMP" IN YUGOSLAVIA WHERE GERMANS MASSACRED 16,000 JEMS

SOFIA. Jan. 1. (JTA) - The Government radio station today broadcast a report by the Jewish Telegraphic agency correspondent, Welvel Pomeranies, on Jewish death camps" in Tugoslavia, built by the Germans in the village of Yanki, eight miles from Belgrade from which Pomeronies has just returned.

The correspondent was taken by the Jugoslav authorities to a large femed yard which was used before the war by the Yugoslav Army to train suipers. The Gerhans converted it into a senior for the execution of Jews. The Jews were brought to the yard in closed wans called "Maritzan" by the local people. They were then ordered to take off their clothes and to dig ditches while maked. Then the ditches were dug, the Jows were forced into them and were machine-gunned by soldiers of the notorious German Prinze Eugen Divicion.

Erre than 16,000 jugoslav Jews were slaughtered in this way at the Yanki "gatermination campa the STA correspondent established. He spoke to some of the surviving Jews in Belgrade who expressed thanks for food parcels sept to them from Palestine. A delegation of the reconstituted Jewish community in Belgrade is planning to present to Sofia in order to establish contact between the surviving Jews in pugoslavia and those of Bulgaria

DR. SILVER TAKES ISSUE WITH DR. WISE; CHARGES HIM WITH RESENTING NEW LEADERSHIP

CIEVELAND, Jan. 1. (JTA) -- Dr. Abba Hillel Silver, who resigned last week from leadership of the American Zionist Emergency Council, today took issue with a statement issued by Dr. Stephen S. Wise last Tuesday, in which it was charged that Dr. Silver which deliberately and persistently contravened the decisions of the Council in a matter of supreme importance to the lasting hurt of our scored cause.

Dr. Silver's statement reads:

"The statement of Dr. Stephen S. Wise, which appeared in the JTA Bulletin of Wednesday, December 27, explaining his so-colled resignation emused me greatly. No officer of the American Zionist Emergency Council has so frequently and so flagrantly contravened its decisions as Dr. Wise. The minutes of the Council will show that Dr. Wise was time and again criticised for his unauthorized conduct and undisciplined actions. The worst and most recent instance was the fatal telegrem which he dispatched without my knowledge to the Scoretary of State on the very eve when Semator Wagner and I were scheduled to see him in order to persuade the State Department and the President to withdraw their objections to passage of the Palestine Resolution.

"In this telegram, which Dr. Wise sent on his own without consulting the Council, he stated that while he would be happy if approval were given to the Resolution, he and many of his associates do not wish to have action taken contrary to the recommendation of the State Department and the President. This, of course, completely nullified the whole purpose of our visit and more than any other factor was responsible for the shelving of the Palestine Resolution.

"All too often Dr. Wise treated the Zionist movement of the United States as a piece of personal property and has bitterly resented any new leadership which threatened his monopoly. Bis 'shtadlamuth' in Washington has been an egregious failure for many years, and not only as far as Zionism is concerned.—This weak-knee thadlanuth' policy has accomplished next to nothing for our people during these tragic years of slaughter and annihilation.

Dr. Wise Says He Has No Personal Controversy With Dr. Silver

NEW YORK, Jan. 1. (JTA) — Asked to comment on D_T . Silver's statement, D_T . Wise declared:

"As regards Dr. Silver's attack upon me, I have had and I shall have no personal controversy with him. The Zionist Emergency Council has passed judgement upon the issue involved by acceptance of Dr. Silver's resignation."

Dr. Israel Coldstein, president of the Zionist Organization of America, issued a statement today disclosing that the Zionist Emergency Council had decided unanimously not to press for passage of the Palestine Resolutions by the Committees of the House and the Senate of the Congress of the United States "unless and until the pre-liminary approval of the Executive branch of the Covernment would have been secured."

such approval, Dr. Goldstein stated, was not received, nevertheless Dr. Silver went to washington and "without the knowledge or consent of the Emergency Council, personally interviewed Representatives and Sanators, especially those in key positions, to urgo them to put the Resolutions through as quickly as possible," the ZOA president charges.

Another charge made by Dr. Goldstein is that Dr. Silver ment a formal written inquiry to the Scoretary of State to check on the versality of a report given by Dr. Rahum Goldmann to the Zionist Emergency Council on "certain important statements" made verbally by the Scoretary of State during a visit to him by Dr. Wise and Dr. Goldmann,

POLISH JEWISH LEADERS PUZZLED OVER DROPPING OF SOMERSTEIN BY LUBLIN GOVERNMENT

LONDON, Jan. 1. (JTA) - Polish Jewish leaders here expressed puzzlement today over the fact that pr. Emil Sommerstein, Jewish member of the Polish Liberation Committee in Lublin, is not included in the new Provisional Government established there yesterday, composed of members of the Liberation Committee.

It was pointed out that members of the Committee who were less important than Dr. Sommerstein were given portfolios in the Government. This was interpreted to mean that Dr. Sommerstein was dropped because of his Zionism.

The Central Committee of Polish Jews in Lublin is making arrangements to establish homes for Jewish war-orphans in Otwook, Lublin, Bielystok and Przemysl, it was learned here today. The institutions will also home child survivors from the Maidanek extermination camp.

TWO MORE JEWS KIDNAPPED IN PALESTINE; KIDNAPPERS POSE AS BRITISH POLICEMEN

JERUSALEM, Jan, 1. (JTA) -- Two members of the Revisionist Organization were kidnapped over the week-end by armed men who invaded their homes. The abductions brought to seven the number of persons kidnapped in recent weeks.

The first kidnapping occurred Saturday afternoon, when Daniel Janowsky, an employee of the Jerusalem Jewish Community Council, and an active member of the Revisionist Organization, was taken from his home by three men, two of whom were disguised as British policemen.

The second victim was Mordechai Korngold, 17, a member of the Revisionist Orthodox Youth Organization. Young Korngold was forced from his home by a group of three men, all of whom were dressed as British policemen.

250,000 NEW YORK JEWISH MEN AND WOMEN SERVE IN U.S. ARMED FORCES, MEDALIE REVEALS

NEW YORK, Jan. 1. (JTA) -- More than 250,000 Jewish men and women from New York City are serving in the U. S. armed forces, it was revealed today by George Z. Medalic, president of the Federation of Jewish Philauthropies, in connection with a conference called by the Committee for Coordinating Jewish Community Services for Veterans which is to be held here on January 11, with several thousand representatives of New York Jewish groups and organizations in attendance.

Federation funds and agencies will be placed at the disposal of the committee, Mr. Medalie said. The committee, which is also appeared by the National Jewish Welfars Borrd, is preparing to facilitate matters currounding the emobilization of Jewish veterans in four major ways, Mr. Medalie revealed. These will be vocational counseling and a job-finding compaign; adaption of family and case work services to fit the needs of veterans and to speed their readjurtment to civilial life; stimulation of the extension of social outlets for veterans through neighborhood community centers; "setting up a physicians' panel through hespitals affiliated with the federation." The committee plans also to supplement "what is provided through the Veterans Administration, Selective Service and the War Manpower Commission."

THOUSANDS OF JEWS TORTURED TO DEATH BY GEPLAN "SCIENTISTS" IN ALSACE CAMP

NEW YORK, Jan. 1. (JTA) -- The New York Herald-Tribune today reports from Paris that a French investigation commission has published a report stating that 20,000 persons, most of them Jews, were tortured to death at the Struthof camp in Alsaes, in the course of "experiments" by German scientists who used the interness as guinea pigs for tests of poison gas and anti-plague and leprosy vaccines.

AMERICAN JEWISH CONFERENCE APPEALS TO ROOSEVELT TO CONTINUE RESCUE OF JEWS IN EUROPE

MEW YORK, Jan. 1. (JTA) -- The American Jewish Conference today announced that it has appealed to President Rossevelt to extend the term of the War Refugee Board so that the work of rescuing Jews from occupied European territories may continue.

At the same time, the Conference announced that it has received reports which make it clear that war conditions notwithstanding, there is still a good possibility of saving tens of thousands of Jewish lives now in Maxi-occupied territory, if appropriate measures are taken without delay by Jews in this country, with the support of the Allied governments.

"Figures on the exact number of Jews who survived in Europe vary, but it appears that with the exception of the Sowiet Union, over 1,200,000 Jews still live in Europe, of whom about fifty percent are under Razi domination," the announcement said, enumerating the following ways and means of resouing the Jews in Axis-controlled areas:

- *11. Some can be saved by arranging an exchange of Jows detained in concentration camps, for German civilian prisoners in the hands of the Allied powers. Thus far, very little has been done to exploit this evenue of resous.
- 82. Neutral powers could issue protective passports to Jews in Axis countriest Sweden has promised to grant some 10,000 protective passports and in fact, has already issued 6,000. Much more could be done if the Allied powers intervened with the neutral states and encouraged them to give similar protection to Jewish victims.
- "3. There are today many Jewish refugees in Palestine, allied and neutral countries, whose wives and shildren are still in Mazi-cocupied countries. The intervention of the protecting powers could bring about the evacuation of their families from the danger zones, and their transportation to the countries where their heads reside. An attempt in this direction was made on behalf of Jewish refugees who settled in Palestine but the powers in charge, while promising aid, have done nothing for them, and in the meantime many of the families who could have been saved have perished.
- "4. The underground movements could be aided in the rescue of families and groups. In many cases the underground movements have brought women and children across guarded frontiers.
- "5. The International Red Cross, the League of Red Cross Societies and the American Red Cross could, by extending their protection to Jewish internees, save thousands of families from death. For reagons that can scarcely be considered valid, in matters of life and death, the Red Cross organisations do little to protect and feed Jewish internees. When it was done, as in the case of Rungary, many lives were saved.
- "6. Food and elothing should be rushed at once to Jews detained in concentration and labor camps. It is an underhable fact that millions of dollars and thousands of tons of food were sent to the Aris countries for civilian prisoners and non-Jews, with the consent of the Allied powers. But none of these measures was applied to Jews under Bitler's domination. Whether or not the Jews in concentration and labor camps can be transported to safer somes, their clothing and feeding is of paramount and immediate importance."

"There are many other possibilities of rescuing Jowish lives, but the prevailing erronsous impression that incling can be done any more! or that the thattle of rescue was lost; which results in the inactivity and lack of cooperation on the part of the Allied powers, must not stand in the way of continuing the rescue battle," the statement added.
