FIVE JEWS KILLED, MAINY INJURED, HOMES LOOTED WHEN FASCIST BAND RAIDS POLISH TOWN

WARSAW, Feb. 18. (JTA) -- Five Jews were killed and many injured last week when an armed fascist band invaded the town of Parczew, in Warsaw province, and organized a systematic hunt for Jews, it was learned today.

The fascist gnerrillas, of whom there were about 200, were commanded by a major and a captain. They disarmed the local militia, took over complete control of the town and organized a house-to-house search for Jews. Those who were unable to hide or flee were assulted.

Jewish homes were looted by the bandits, who were ordered by their leaders to destroy anything they could not carry away with them. Government security police are now hunting for the band.

LEADERS OF JEWISH COLLABORATIONIST ORGANIZATION IN RUMANIA GET LONG PRISON TERMS

BUCHAREST, Feb. 18. (JTA) -- Five leaders of the collaborationist "Central Union of Rumanian Jevs" were today sentenced to terms ranging from life imprisonment to tvelve years at hard labor, after being found guilty by a peoples court of having sided the pro-Maxi Antonescu Government in carrying out its anti-Jewish measures.

Mandor Ghingold, who headed the organization, was sentenced to life imprisonment, as was M. Heachsenu. H. William received a 20-year term; S. Grossman, 15 years; and T. Jackleon, 12 years. All the defendants suffered loss of civil rights and confiscation of their property. The sentences are being appealed.

Among the vitnesses heard during the trial, which began last week, were Zionist leaders A.L. Zissu and M. Benvenisti, who described the anti-Zionist activities of the Tentral Union: William Fildersen, who was president of the Union of Rumanian Jews, which was liquidated when the collaborationist organization was formed, testified for the defense, stating that the situation of the Jews in Rumania was better in some respects after the "Central Union" was set up, than previously.

ANGO-AMERICAN INVESTIGATORS CONVER WITH JDC AND UNRRA ON SITUATION OF JEMS IN AUSTRIA

VIRMA, Feb. 16. (JTA) -- The Anglo-American Committee of Inquiry on Palestine today conferred with local directors of the Joint Distribution Committee, UMRRA and the Red Cross in an effort to obtain a picture of the situation of the Jews in Austria.

Tomorrow, a sub-committee commissing of Wilfred Crick, Frank Button and Major Reginald Manningham-Buller will leave for a four-day tour of the campe in the American one in Austria. POLITICAL SITUATION DOES NOT FAVOR ZIONISTS, SILVER TELLS AMERICAN JENISH CONFERENCE

CLEVELAND, Feb. 18. (JTA) -- Emphasizing that "the present political constellation is not very favorable" to Zionist aims in Palestine, Dr. Abba Tillel Silver, in a powerful address which was frequently interrupted by stormy applause, today bitterly estatacked the British Government, expressed the hope that the U.S. Government will be firm in demanding the implementation of the Palestine Resolution adopted by the Congress, and appealed to the Soviet Government not to side with Arabs on the Palestine issue.

"The political situation," he said, addressing the American Jewish Conference, "is being complicated for us also by the developing rivalry between Great Britain and the Soviet Union, which has now come to embrace the Middle East. From stray and, as yet, inconclusive incidents, it might be inferred that the Joviet Union like Great Britain, may also be interested in winning over the Arab world to its side by offering up our legitimate national rights in Palestine as part payment for such an alignment.

"We hope that this is not so. We have no quarrel with the Soviet Union. We do not and cannot take sides in imperial conflicts. We do not wish to be made the shuttle-cock of power politics. We do not wish to be crushed between the upper and the lower milistones."

Declaring that the Zionist cause is a "moral cause," Dr. Silver pointed out that the Zionists appeal for sympathy and support to all governments which can be moved to assist the re-establishment of Jevish national life "in the historic home" of the Jevish people. "Why should a clear, homest purpose sanctioned by the nations of the world after the last war, and now in the process of filfillment, be permitted to become entangled in the tortuous folds of competitive imperial maneuvers?" he asked.

"Great Britain does not require for its survival the cremping and constricting or the total extinction of the Jevish national home in Palestine. Its position in the Middle East is not and cannot be endangered by the presence of a Jevish state in that small notch of 10,000 square miles in that wast Arab world. Nor does the Soviet Union, strong and victorious, covering, as it does, one-sixth of the globe, need such a sacrifice. Why should the Jevish people again be made the scapegoats?"

Scores Critics of Zionist Attempts to Win Soviet Surport

Dr. Silver took issue with times "who resent every approach made to win over the sympathy of the Soviet Government to the Zionist cause. They call it flirting," he said, "and they point the finger of derision at Zionists whenever some anti-Zionist statement or act memates from Soviet or pro-Soviet sources. This is an emailing phenumenon in Jevish life, which can only be attributed to a hind and sitter partisanship, which carries over from an area which is not related to Jevish life to a specifically Jevish issue of greatest account."

He emphasized that he was not asking the Zionist movement to align itself with the Soviet Union, but, he said, the Zioniste were not discouraged in their efforts to the Soviet Union, but, he said, the Zioniste were not discouraged in their efforts to the over thest Britain even though they have been grievously disappointed time and again; nor were they discouraged in attempts to win over the President and the State Department, even though they have encountered considerable misunderstanding and resistance there; and, therefore, he say no reason why the Zionist movement should regard itself as being in any way inhibited from trying to win understanding and friendship from the Soviet Union.

"The Arabs," he pointed out, "are certainly not adverse to carrying on their propaganda both in the direction of Great Britain and of the Soviet Union. My regret

is not that we have tried, but that we have not tried hard enough, or soon enough. At the moment, the attitude of the Soviet Government does not seem to be favorable to us, but there is nothing final about it. Some of us recall that up to a few months ago definite ordence seemed to point to a favorable and friendly attitude. The present attitude may, or may not, change again in the future. We may not succeed, but we certainly ove it to ourselves to do everything in our power to see that that attitude does change, and in our favor."

Dr. Silver insisted that the Jews should have a voice in the Assembly of the UMO, and said that the strength and the hope of the Jews lie in the good will and the sympathy of the democratic peoples of the world. He called for unification of American Jevish groups to urge the American Government to demand the implementation of the Congressional resolution on Palestine, which, he said, expressed the will of the overwhelming majority of the American people.

At the same time, Dr. Silver warned the Jews of America to be on guard "against accepting substitutes or appeasement gifts from the Administration in lieu of the great service which it can and should render to the Jewish people." To appoint a Jew to an important government post, he said, or to make "inexpensive goodwill gestures" in the direction of the Jews is of little value to the Jewish people. "They are neither commensurate with the tragic magnitude of our problem, nor in any way related to its solution." he added.

Dr. Silver predicted that the British members of the Anglo-American Committee of Inquiry on Palestine will almost all follow the line of the Colonial Office-"the Bevin line"--and that only a few American members, at best, will sharply deviate from it. He attacked the British Government for readmitting to Palestine Jamal Husseini, "the pogrom-maker of 1936," while not permitting the immigration of Jewish survivors from Europe. "Presumably the return of the Mufti will be the next step," he said. This is how the membatory government plane for the peace of Palestine.

Resolution Appeals to Inquiry Commission To Approve Jewish Palestine

The Conference today voted to send a cable to the Anglo-American commission, appealing for a decision in favor of a Joviah Palestine, open to unrestricted Joviah imagration from Europe. At the same time, the Conference adopted a resolution reaffirming the determination of the Jeviah people "to establish relations of amity and cooperation with the Arah-speaking people of Palestine." The resolution stressed that the Conference sees no incompatability between Jeviah national aspirations in Palestine and the rights and welfare of the Arahs who reside there. The resolution deplored the fact that the British Government has allied itself with extremist and reactionary Arab elements.

Another resolution passed today protests against the unilateral decision of the British Government to sever Transjordan from the Pelestine Mandate and proclaim it an independent state. The resolution points out that Transjordan is geographically and historically a part of Pelestine and subject to the same mandatory administration. The amouncement of the British Government, made without consultation with the United States is "a further attempt to prejudice the just and total solution of the Pelestine problem," the resolution charged.

Still another resolution protested against "the brutal violation of civil rights in Palestine." It asserted that the Jews of Palestine are subjected to gross indignities and are arrested vithout cause. "Civilized and peace-loving persons are tept in a state of virtual imprisonment, under what is substantially martial law," the resolution says. "Deportations are carried out in direct violation of the Palestine

courts' decision. We demand that these practices, which are in fundamental contradiction to Anglo-Saxon law, and to the best tradition of the English and the American becole, shall be discontinued forthwith."

A final resolution on Palestine declared that American Jews "will never accede to any arrangement in Palestine which will in any manner abrogate, or impair, the rights that the Jewish people now have to that country under the terms of the Balfour Declaration."

Delegates Authorize Study of Possibility of Forming Permanent Body

Following a heated debate, in which many delegates took the floor to demand a clear-cut statement on the advisshility of the establishment of the Conference as a permanent body, today's plemary session adopted a resolution authorizing the interim committee to continue and intensify its work, and to call a fourth session "at such time and place as it deems advisable, but not later than fifteen months from the date of this session." The resolution said further:

"It is recognized that there is a wide-spread demand for an American Jevish organization, competent to speak authoritatively for the Jevish community, and since this conference was not designed as a permanent body, the interfun committee is directed to explore the possibility of establishing a permanent, democratic, representative Jevish body, in consultation with representative community organizations, and through agreement as to the nature and scope of such an organization with existing national organizations, and, subject to such agreement, to propose ways and means for bringing such a body into eristence." The resolution was adopted \$5 to 8 by the organization committee, prior to its presentation to the plenary scision.

A moving report on conditions of life of the displaced Jews in Germany was given at the evening session by Dr. Zalman Grinberg, president of the Council of Liberated Jews in Germany. Dr. Grinberg appealed for the transfer of all the displaced Jews to Palestine. He pointed out that a plebiscite taken among the Jewish DP's recently showed that 98 percent of them wanted to go to Palestine.

Dr. Grinberg demanded that a "Jewish passport," to be granted by his committee, and approved by the military government, should be issued to every displaced Jew as an identity document, the validity of which should be recognized for travelling permits and yleas. "It is our hope that such passports in the near future will be equivalent to a Palestinian passport," he stated.

Jewish DP Leader Warns Anti-Semitian Is Strong in Europe

He stressed that "the seed of anti-Semitium, sown by Hitlerium, is bearing fruit in liberated Europe as never before, and it appears that for a long time to come it will remain in Europe as an inheritance of Marium." That is the reason, he added, the the sews Europe.

Dr. Jacob Robinson, who is acting as a Jewish adviser at the Euromberg triale, reported last night on the proceedings there, and paid high tribute to Justice Robert Jackson, American prosecutor, for his special interest in the Jewish case. JEWISH NATIONAL COUNCIL NAMES COMMITTEES TO PREPARE DATA FOR INQUIRY GROUP

JENEALEM, Feb. 18. (JTA) -- The new Jevish National Council, which was elected last week by the Jevish National Assembly, voted today to establish its own economic and political departments, which will work with similar bureaus in the Jevish Agency.

The Council also approved the decision of Jewish institutions to testify before the Anglo-American inquiry committee, and special committees were set up to prepare material to be submitted to the inquiry group.

The Palestine Government, it was learned today, has already completed preparation of the documents it will submit to the committee. They will be printed in a 2000page volume, which will also contein memorandums by the Jovish and Arab communities in Palestine and the British Government on various problems. In addition, the Government is preparing another memorandum for the committee, which will be mimeographed in order to prevent leakage of its contents.

The Council also decided today to call a conference of the mayors and heads of local councile of Jewish towns and villages to discuss the recently promulgated Government budget estimates, which allocate negligible sums for Jewish education and welfare activities.

POLISH GOVERNMENT ASKED TO FACILITATE EMIGRATION TO PALESTINE OF 600 JEWS IN USER

MOSCOW, Feb. 18. (JTA) -- The Jewish Agency has appealed to the Polish Government to facilitate the emigration to Palestine of 600 Polish Jews now in the Soviet Union, to whom immigration certificates were allotted in 1941 and 1942. The visas were nover used because of wartime transportation difficulties.

The appeal, which was sent through the Polish charge d'affaires in Teheran to the Polish Embassy here, for forwarding to Warsaw, asks whether in view of the changed conditions and the Government's expressed villingness to allow legal emigration to Palestine, it would facilitate the transfer of these 600 Jews. It points out that the certificates will be wested if the Jews to whom they were assigned cannot use them. The Agency said that it would assume transportation and other costs.

ONE-FOURTH OF BOHRMAN, MORAYIAN JENS RECISITERED FOR INVIGRATION TO PALESTINE

PRAGUE, feb. 18. (JTA) -- Over 4,000 Jews in Bohemia and Moravia, representing more than one-fourth of the Jewish population of these provinces, have applied to the Palestine Office here for immigration to Palestine, M.Friedl, head of the Office, told a JTA correspondent today. Friedl added that the number of applications being filed was increasing steadily.

Akiba Neufeld, a leader of the Hechalutz movement in Bratislava, has estimated that 6,000 Slovakian Jews wish to emigrate to Palestine. He also said that the Hechalutz was operating nine children's homes and seven training units where some 500 Jewish Jouthe, half of them orphans, were being prepared for emigration.

Chaim Barlas, director of the immigration department of the Jevish Agency, who is visiting here, expressed great hope for the immigration of Jews to Palestine, and pointed out that the Agency was especially interested in the plight of the Jews in Car-Patho-Russia. Barlas, who is scheduled to proceed to Budapest and Vienna, said that his mission was to smooth out difficulties being encountered in countries where new Palestine immigration offices have recently been opened.

CERMANS REPORTED TRYING TO CLAIM JEWISH BLOOD IN ORDER TO GET EXTRA FOOD RATIONS

According to the Express, the price of bogus documents showing that the bearer's grandmother was Jewish is four cartons of cigarettes. The paper comments editorially: "Could irony go further?"

JEC ARRANGES FOR SHIPMENT OF PASSOVER MATZORS, WINE TO U.S. ZONES IN GERMANY, AUSTRIA

PARIS, Feb. 18.(JTA).-The Joint Distribution Committee has completed arrangements for the shipment of 1,000,000 pounds of matzohs to the U.S. zones in Germany and Austria for Passover, European headquarters of the JDC amounced today. An order has been placed in Palestine for 50,000 quarts of Passover wine, which will be transshipped through a French port.

FULL SUFFORT OF UJA \$100,000,000 DRIVE PLEDGED AT CONFERENCE OF WESTERN JEWISH LEADERS

IOS ANGELES, Feb. 18.(JTA) -- A two-day session of the Western States Conference for the United Jewish Appeal opened here yesterday at a large meeting attended by more than 600 Jewish leaders. One hundred percent support of the UJA national drive for \$100,000,000 for refugee, overseas and Falestine needs was pledged.

Speakers included Eddie Cantor; Rabbi Jonah Wise, co-chairman of the UVA; Command Joshus L. Goldberg of the Third Navai District; Saul Elgart, JDC director in Germany; Rabbi Edgar F. Magnin of Los Angeles; and Judge Isaac Pacht of Los Angeles. Other speakers were Capt. Robert Gemzon, French partisan leader; Reuben Rosnik, Wartime JDC director in Italy; and Leo Herman, secretary general of the Karen Hayesod.

JENS IN ROME MARK 50th ANNIVERSARY OF HERZL'S "JUDENSTAAT;" CALL FOR JENISH STATE

ROME, Feb. 18.(JTA)=-A public meeting of Italian Jews and Jewish refugees residing in Italy was held here to mark the 50th anniversary of the publication of Theodor Herzl's "Judenstaat."

Resolutions adopted at the relly called for the establishment of an independent Jevish state in Palestine, and demanded that unrestricted immigration of Jews be permitted.
