JEWISH AGENCY LEADERS REPORTED RELEASED: TROOPS EVACUATE AGENCY HEADQUARTERS

JERUSALIM, July 10. (JTA) -- Four leaders of the Jewish Agency have been released from Latrum prison, where they have been since June 29, it was reported tonight.

It was impossible to secure immediate confirmation of the report.

Earlier British troops and police had evacuated the building of the Jewish Agency, ending an occupation of twelve days. The curfew which has been in force in the area surrounding the building was lifted.

When the troops and police cleared the Agency building, Dr. Fmil Shmorak, one of the unarrested members of the executive, told reporters that the authorities had invited the Agency staff to return to the building while it was still occupied, but they refused. He said that as yet it is impossible to estimate the damages or ascertain what documents were missing.

The Palestine Arab Higher Committee today handed High Commissioner Sir Alan C. Cumninghan a note demanding the immediate dissolution of the Jevish Agency. The Arabs made their request on the basis of alleged "incriminating evidence available of the Jewish Agency's direct relations with Jewish terrorists and its activities in arms smuggling and illegal immigration."

The Haganah's secret radio, "Voice of Israel," denied that the resistance move-ment was controlled by the Agency. It declared that the Haganah had a "secret and independent command," and that "as long as there is a power preventing our redemption. a nation opposing our will to build up Palestine, there will be a resistance movement."

A police communique announced tonight that Jacob Abraham Levi, who is suspected of being a member of the Stern Group, has been arrested in Sarafand, following his discharge from the British Army.

TRUMAN'S IDEAS RECARDING IMMIGRATION OF 100.000 WILL GUIDE U.S. CONFEREES IN LONDON

WASHINGTON, July 10. (JTA) -- President Truman's ideas regarding United States responsibilities in connection with the proposed immigration of 100,000 European Jews to Palestine will be the guiding and controlling factors for the Cabinet committee alternates in their forthcoming discussions with British officials in London, Acting Secretary of State Dean Acheson said today.

Mr. Acheson made this statement at his press conference in reply to a question as to whether the Cabinet committee deputies, who left today for London, carried with them any specific outline of United States proposals as to the responsibilities this government would be willing to undertake to facilitate admission to Palestine of the 100,000.

LEADING ZIONISTS FROM U.S., EUROPE EXPECTED AT PARIS MEETING OF JEWISH AGENCY NEXT WEEK

NEW YORK, July 10. (JTA) -- Leading Zionists from the United States and European countries will be invited to attend the emergency meeting of the Jewish Agency scheduled to be held in Paris next week, it was learned here today.

They will discuss with American, British and Palestinian members of the Agency the situation resulting from recent British actions in Palestine and the activities of the Zionist organizations in various countries.

The four U.S. members of the Jewish Agency--Drs. Stephen S. Wise, Abba H. Silver and Nahum Goldmann and Louis Lipsky--are expected to attend.

COLONIAL SECRETARY TELLS COMMONS PALESTINE PAIDS JUSTIFIED BY RESULTS OBTAINED

LONDON, July 10. (JTA) -- Colonial Secretary George Hall told the House of Commons today that the British raid on the Jewish Agency and the arrest of its members on the Sabbath was justified by the results obtained.

Hall's statement came in reply to a question by Squadron Leader Samuel Segal, Labor, who asked the Colonial Secretary whether he was aware that this "debasing" of religious and administrative standards could be justified in time of war only and that no action by the British Government could have done more to convince Palestine Jews that they were engaged in a "hely war." Hall replied that it was necessary to carry out the action "with the least possible inconventance" and to leave the matter in the hands of the local authorities was were most competent to make a judgment.

Laborite Sydney S. Silverman said that as the local authorities had picked on an entirely unsuitable time for whear raids, the House should be given information why the early hours of Saturday wave chosen. Hall declined, adding that no explanation had been called for from Pelastine.

To another query by Segal as to what damage had been done at Yagour during searches for arms, Hall said that as far as he has been informed 25 vines were damaged. He added that troops had 619covered in 35 caches 92 mortars of two-inch caliber, 5,267 mortar bombs, 5,616 groundes, ten machine guns, 321 rifles, 1,404 magazines and 420,000 rounds of arquitition.

Hall promised another questioner he would ask for a report from Palestine on the number of leaders of the Jevish trade unions and Socialist Party and of the cooperative societies who were arrested.

Both the Conservative London Times and the liberal Manchester Guardian today propose partition as the best solution of the Palestine problem. The two papers praise Dr. Chaim Weizmann for his attempt to restrain the Jews of Palestine.

SOVIET BROADCASTER HOLDS PALESTINE UP TO SMALL NATIONS AS "LESSON" IN IMPERIALISM

MOSCOW, July 10. (JTA) -- Palestine was today held up as an "object lesson in what small nations can expect from the imperialistic policies of certain big powers pursuing their selfish sims" by Mikhail Mikhailov, Soviet radio commentator, speaking on an English language broadcast.

Referring to Palestine as "the bastion of the British in the Middle East, particularly now that they must withdraw from Egypt," Mikhailov declared that "the British hope to control the whole of Northeast Africa and Asia Minor" from their bases there.

He charged that the leaders of the two leading American parties are "always free with policies supporting Zionist claims in Palestine" because they hope to gain support of Jewish circles in the United States.

LAGUARDIA HOPES BRITAIN WILL ADMIT 100,000 TO PALESTINE; ASKS POOLING OF U.S. QUOTAS

MASHINGTON, July 10. (JTA) -- UNRRA Director-General Fiorello LaGuardia today made public a letter he sent to Secretary of State Byrnes on June 26 in which he expressed the hope that if the U.S. took the lead in admitting immigrants, Britain would reconsider its decisions, "as recently expressed by Minister of Foreign Affairs Ernest Bevin," in regard to the recommendations of the Anglo-American Committee of Inquiry on Palestine.

Asked at a press conference today how many displaced Jews from Europe should go to Palestine, he replied: "If you're trying to get me to say 100,000, I say that 100,000 of them should go to Palestine forthwith. I say that as an American."

In his letter to Byrnes, LaGuardia also proposed that the United States pool all unused immigration quotas from all countries and use them for any DP's who wished to enter the United States, regardless of their country of origin. He said today that he did not believe his plan would in any way disrupt the quota system, and suggested that Congress give President Truman authority to pool quotas for a limited period.

He said that the plan was already being worked on by the War Department and that he had had "splendid cooperation" from Secretary of War Patterson and the army in Germany.

LaGuardia mentioned Brazil, Venezuela, and Bolivia as countries which had already shown their interest in the plan and suggested that Canada would be inclined to consider such a plan.

CHRISTIAN, NEGRO, JEWISH GROUPS JOIN IN ASKING N.Y. COUNCIL TO PROBE COLLEGE BIAS

NEW YORK, July 10. (JTA) -- Investigation of "discrimination and inequalities of opportunity in schools of higher education" was urged today upon the City Council in a letter addressed today to City Councilman Joseph T. Sharkey, vice-chairman, and Walter Hart. chairman of its Rules Committee, by ten leading civic agencies.

The signatures include the American Jewish Committee, American Jewish Congress, Anti-Defamation League of Binai Birith, Brooklyn Church and Mission Federation, Order of the Sons of Italy in America, Jewish Labor Committee, Jewish War Veterans of the U.S., National Association for the Advancement of Colored People, Association of Business and Professional Men, Urban League of Greater New York.

The letter cited the recent "Report on Inequality of Opportunity in Higher Education" issued by the Mayor's Committee on Unity as declaring: "Discrimination on the basis of race, creed, color or national origin affecting opportunities for education is a denial of the American creed of equality of opportunity at a most sensitive point. Freedom of opportunity to enjoy the full educational advantages for which a person is qualified...should be regarded as fundamental. The consequence of its denials are a grave injury not only to the persons discriminated against but to the welfare of the community."

Noting that the Mayor's Committee on Unity has recommended the need for an official city investigation of the causes underlying the difficulty which graduates of the city-maintained colleges have in obtaining graduate and professional education, the organizations call upon the City Council to order such an investigation.

FMIGRE GERMAN JEWS MAY RECOVER PROPERTY IN THURINGIAN PROVINCE OF SOVIET-HELD GERMANY

BERLIN, July 10. (JTA) -- Emigre German Jews who sold their property during the Nazi regime may now recover it in at least one province of Russian-held Germany, a Jewish Talegraphic Agency correspondent learned during a tour of the Soviet zone.

Following an order by Marshal Gregory Zhukov last September, the provincial government of Thuringia issued a decree ordering the immediate return of all former Jewish property to the original owners. It was automatically assumed under the law that all property sales by Jews during the reign of the Nazis were made under duress and therefore subject to restitution.

In the case of Jews who returned to their homes in the province, each made application for recovery to the local Jewish community, supplying all data pertinent to the property transfer. Where the property is in the possession of a known active Nazi, it is returned to the Jew and no compensation is allowed the cwner. If, however, the present owner is not a Nazi, he is compensated by the German Government which pays him the same sum which the Jew originally received.

Jews who fled Germany and have not returned must write the Thuringian Government requesting return of their property and giving full details of the sale. Letters should be addressed to President Rudolf Paul at Weimar. The government turns the claim over to the Jewish community in the locality where the property was sold and the community makes the investigation. If the findings are in favor of the emigre claimant he may recover his property by paying the present owner the price which he originally received.

At present the law is in operation only in Thuringia, but other states in the Soviet zone are preparing similar legislation. Final disposition of the property of Jews who died heirless has not yet been decided upon. At present such property is handed over to the local Jewish community, and it is expected that it will remain in the community's possession permanently.

Upon the return of the Jewish Telegraphic Agency correspondent to the American zone, he interviewed American military government officials who expressed great interest in the law and admitted that no similar decrees are in effect in Western Germany. When the officials inquired for details the correspondent told them where to write for a copy of the law.

The American authorities said that at present three German provincial presidents were meeting at Stuttgart and some kind of action on Jewish property restitution could be expected soon.

JESS IN GERMAN PROVINCE WHO PAID NAZI "FINE" FOR KILLING OF DIPLOMAT WILL RECEIVE REFUND

FRANKFURT, July 10. (JTA) -- Jews wher paid a 25 percent property tax to the Nazis in 1938 as a "fine" following the assassination of Ernst vom Rath in Paris will receive a complete refund according to a decree promulgated in Greater Hesse, it was reported here today. The measure provides that persons who paid the tax or their heirs now living in Greater Hesse, must apply to the provincial finance office where, after proving that they paid the assessment, they will receive a rebate.

Jewish leaders here have requested the U.S. Army to provide additional accommodations for the large number of Jewish refugees from Eastern Europe who have arrived within recent weeks, it was learned today. Officials of the voluntary relief agencies say they are unable to properly feed, clothe and house new arrivals unless more space is obtained.

POLISH DESERTERS FROM ANDERS ARMY TRAINING SYRIAN ARABS FOR ATTACKS ON PALESTINE JEWS

IONDON, July 10. (JTA) -- A number of Polish officers and men, who either lived as civiliens in the Middle East or who deserted from the army of Gen. Wladislaw Anders, have in recent days joined the newly organized bands of Fawki el Kawkaji, in Syria, where they are assisting in training Arab guerrillas for future anti-Jewish operations in Palestine, according to Polish circles in London. Kawkaji gained wide notoriety for his acts of bloodshed in the Palestine riots of 1936.

These sources added that the Poles going over to Kawkaji, whose number is unknown, did so chiefly because of the high rate of pay offered them. (Many thousands of Poles left Russia with Gen. Anders and went subsequently to Palestine, including severel hundred criminals who had escaped from Polend to Russia. Most of the criminals were weeded out from Gen. Anders' ranks but they remained in Palestine.)

SURVIVORS OF KIEICE POGROM ARE TO BE EVACUATED TO LODZ AND LOWER SILESIA

NEW YORK, July 10. (JTA) -- The more than 150 survivors of the Kielce pogrom will be evacuated to Lodz and Lower Silesia, the JDC announced today on the basis of a cable received from its director in Poland. The Central Jewish Committee of Poland and the government will cooperate in the transfer.

The JDC representative, William Bein, said that the Polish Government had taken immediate action to aid the survivors and disclosed that the JDC has made special grants of cash, food and clothing.

(A cable from Kielce today said that the trial of twelve persons being tried for instigating the pogrom will probably end next Tuesday. It began yesterday. At the opening session several of the defendants admitted that they had assaulted the Jews.)

A memorial meeting for the Kielce Jews will be held on Thursday night at the Hotel New Yorker, with Dr. Emil Sommerstein, chairmen of the Central Jewish Committee of Poland, and Dr. Joseph Tenenbeum, president of the American Federation of Polish Jews, as principal speakers.

Dr. Tenenbaum revealed today that he has cabled to Prime Minister Attlee charging that the anti-Semitic outbreaks in Folend were instigated by "underground forces organized, equipped and commanded by agents of General Anders, with British support, British arms and British money."

AGENCY MEMBER APPEALS TO U.S. YOUTHS TO COME TO PALESTINE TO DEFEND JEWISH COMMUNITY

HUNTER, New York, July 10. (JTA) -- An appeal for American chalutzim to come to Palestine to help defend and build the Jewish national home was voiced here today by Moshe Shapiro, a member of the Jewish Agency executive, addressing the national convention of the Rabbinical Council of America.

He said that the British wanted to dissolve the Agency and disarm the Haganah and denied that the Agency directed the Haganah. Shapiro said he expected that the 100,000 Jows from Europe would be admitted, but stressed only a Jewish commonwealth would be in a position to give adequate assistance to European Jews.

The Council voted today to establish a pension plan for the rabbis who are members of the organization.

TRUMAN PRAISES HILIMAN AS DEVOTED FIGHTER FOR DEMOCRACY AND GREAT HUMANITARIAN

WASHINGTON, July 10. (JTA) -- Sidney Hillman, president of the Amalgamated Clothing Workers and chairman of the Political Action. Committee, who died this morning at his summer home on Long Island, was described today by President Truman as one of the "most efficient and devoted exponents" of the cause of democracy in this country.

In a statement issued here the President said: "Sidney Hillman was more than a distinguished labor leader; he was a great humanitarian and an outstanding statesman in the field of labor-management relations. That he, an immigrant youth, could rise to eminence in the land of his adoption is a tribute at once to his own ability and character and to the democratic ideals for which he fought."

DETROIT, MILWAUKEE AMONG CITIES SURPASSING GOAL IN DRIVE FOR LOCAL AND FOREIGN RELIEF

NEW YORK, July 10. (JTA) -- Detroit and Milwaukee are among the larger Jewish communities which have already surpassed their goals in the current drive for local and overseas needs, it was reported today by the United Jewish Appeal.

Detroit raised more than \$3,200,000, which exceeded its campaign goal of \$2,000,000 by \$1,200,000. Milwaukee has also surpassed its goal by raising more than the \$1,000,000 aimed for, which was three times the amount raised last year.

Kansas City has gone above its \$825,000 goal and funds are still coming in. Cincinnati has raised \$763,000, which is \$82,000 more than it aimed at. Many other cities throughout the country are doing proportionately as well, the UJA said.

BERLIN, July 10. (JTA) -- Emigre German Jews who sold their property during the Nazi regime may now recover it in at least one province of Russian-held Germany, a Jewish Telegraphic Agency correspondent learned during a tour of the Soviet zone.

Following an order by Marshal Gregory Zhukov last September, the provincial government of Thuringia issued a decree ordering the immediate return of all former Jevish property to the original owners. It was automatically assumed under the law that all property sales by Jews during the reign of the Nazis were made under duress and therefore subject to restitution.

In the case of Jews who returned to their homes in the province, each made application for recovery to the local Jewish community, supplying all data pertinent to the property transfer. Where the property is in the possession of a known active Nazi, it is returned to the Jew and no compensation is allowed the cwner. If, however, the present owner is not a Nazi, he is compensated by the German Government which pays him the same sum which the Jew originally received.

Jews who fled Germany and have not returned must write the Thuringian Gevernment requesting return of their property and giving full details of the sale. Letters should be addressed to President Rudolf Paul at Weimar. The government turns the claim over to the Jewish community in the locality where the property was sold and the community makes the investigation. If the findings are in favor of the emigre claimant he may recover his property by paying the present owner the price which he originally received.

At present the law is in operation only in Thuringia, but other states in the Soviet zone are preparing similar legislation. Final disposition of the property of Jevs who died heirless has not yet been decided upon. At present such property is handed over to the local Jevish community, and it is expected that it will remain in the community's possession permanently.

Upon the return of the Jewish Telegraphic Agency correspondent to the American zone, he interviewed American military government officials who expressed great interest in the law and admitted that no similar decrees are in effect in Western Germany. When the officials inquired for details the correspondent told them where to write for a copy of the law.

The American authorities said that at present three German provincial presidents were meeting at Stuttgart and some kind of action on Jewish property restitution could be expected soon.

JENS IN GERMAN PROVINCE WHO PAID NAZI "FINE" FOR KILLING OF DIPLOMAT WILL RECEIVE REFUND

FRANKFURT, July 10. (JTA) -- Jews who paid a 25 percent property tax to the Nazis in 1938 as a "fine" following the assassination of Ernst vom Rath in Paris will receive a complete refund according to a decree promulgated in Greater Hesse, it was reported here today. The measure provides that persons who paid the tax or their heirs now living in Greater Hesse, must apply to the provincial finance office where, after proving that they paid the assessment, they will receive a rebate.

Jevish leaders here have requested the U.S. Army to provide additional accommodations for the large number of Jewish refugees from Eastern Europe who have arrived within recent weeks, it was learned today. Officials of the voluntary relief agencies say they are unable to properly feed, clothe and house new arrivals unless more space is obtained.

POLISH DESERTERS FROM ANDERS ARMY TRAINING SYRIAN ARABS FOR ATTACKS ON PALESTINE JEWS

LONDON, July 10. (JTA) -- A number of Polish officers and men, who either lived as civilians in the Middle East or who deserted from the army of Gen. Wladislaw Anders, have in recent days joined the newly organized bands of Fawki el Kawkaji, in Syria, where they are assisting in training Arab guerrillas for future anti-Jewish operations in Palestine, according to Polish circles in London. Kawkaji gained wide notoriety for his acts of bloodshed in the Palestine riots of 1936.

These sources added that the Poles going over to Kawkaji, whose number is unknown, did so chiefly because of the high rate of pay offered them. (Many thousands of Poles left Russia with Gen. Anders and went subsequently to Palestine, including several hundred criminals who had escaped from Poland to Russia. Most of the criminals were weeded out from Gen. Anders' ranks but they remained in Palestine.)

SURVIVORS OF KIEICE POGROM ARE TO BE EVACUATED TO LODZ AND LOWER SILESIA

NEW YORK, July 10. (JTA) -- The more than 150 survivors of the Kielce pogrom will be evacuated to Lodz and Lower Silesia, the JDC announced today on the basis of a cable received from its director in Poland. The Central Jewish Committee of Poland and the government will cooperate in the transfer.

The JDC representative, William Bein, said that the Polish Government had taken immediate action to aid the survivors and disclosed that the JDC has made special grants of cash, food and clothing.

(A cable from Kielce today said that the trial of twelve persons being tried for instigating the pogrom will probably end next Tuesday. It began yesterday. At the opening session several of the defendants admitted that they had assaulted the Jews.)

A memorial meeting for the Kielce Jews will be held on Thursday night at the Hotel New Yorker, with Dr. Emil Sommerstein, chairman of the Central Jewish Committee of Poland, and Dr. Joseph Tenenbeum, president of the American Federation of Polish Jews, as principal speakers.

Dr. Tenenbaum revealed today that he has cabled to Prime Minister Attlee charging that the anti-Semitic outbreaks in Polend were instigated by "underground forces organized, equipped and commanded by agents of General Anders, with British support, British arms and British money."

AGENCY MEMBER APPEALS TO U.S. YOUTHS TO COME TO PALESTINE TO DEFEND JEWISH COMMUNITY

HUNTER, New York, July 10. (JTA) -- An appeal for American chalutzim to come to Palestine to help defend and build the Jewish national home was voiced here today by Moshe Shapiro, a member of the Jewish Agency executive, addressing the national convention of the Rabbinical Council of America.

He said that the British wanted to dissolve the Agency and disarm the Haganah and denied that the Agency directed the Haganah. Shapiro said he expected that the 100,000 Jews from Europe would be admitted, but stressed only a Jewish commonwealth would be in a position to give adequate assistance to European Jews.

The Council voted today to establish a pension plan for the rabbis who are members of the organization.

TRIMAN PRAISES HILIMAN AS DEVOTED FIGHTER FOR DEMOCRACY AND GREAT HUMANITARIAN

WASHINGTON, July 10. (JTA) -- Sidney Hillman, president of the Amalgamated Clothing Workers and chairman of the Political Action. Committee, who died this morning at his summer home on Long Island, was described today by President Truman as one of the "most efficient and devoted exponents" of the cause of democracy in this country.

In a statement issued here the President said: "Sidney Hillman was more than a distinguished labor leader; he was a great humanitarian and an outstanding statesman in the field of labor-management relations. That he, an immigrant youth, could rise to eminence in the land of his adoption is a tribute at once to his own ability and character and to the democratic ideals for which he fought."

DETROIT, MILWAUKEE AMONG CITIES SURPASSING GOAL IN DRIVE FOR LOCAL AND FOREIGN RELIEF

NEW YORK, July 10: (JTA) -- Detroit and Milwaukee are among the larger Jewish communities which have already surpassed their goals in the current drive for local and overseas needs, it was reported today by the United Jewish Appeal.

Detroit raised more than \$3,200,000, which exceeded its campaign goal of \$2,000,000 by \$1,200,000. Milwaukee has also surpassed its goal by raising more than the \$1,000,000 aimed for, which was three times the amount raised last year.

Kansas City has gone above its \$825,000 goal and funds are still coming in. Cincinnati has raised \$783,000, which is \$82,000 more than it aimed at. Many other cities throughout the country are doing proportionately as well, the UVA said.

AMERICAN COUNCIL FOR JUDAISM ASKS SEPARATION OF PALESTINE ISSUE AND HRITISH LOAN

NEW YORK, July 10. (JTA) -- The American Council for Judaism, through its president, Lessing J. Rosenwald, in a statement today, said that consideration of the loan to Great Britain is being complicated by the "extraneous Palestinian issue" and urged members of the Congress to consider it "solely on its merits, the fundamental American interests that are involved -- and on no other basis." The statement was sent to Congressional leaders and was made public by Mr. Rosenwald.

NATIONAL CONFERENCE ON PROBLEMS OF MINORITY GROUP VETERANS WILL BE HELD IN NEW YORK

NEW YORK, July 10. (JTA) -- A National Action Conference on Minority Veterans will be held here on Friday, it was announced today by the American Council on Race Relations. The American Jewish Committee and the American Jewish Congress are emong the veteran civic and religious organizations represented.

B'MAI B'EITH YOUNG MEN ORGANIZATION FORMED; OFFICERS ELECTED, CONSTITUTION WRITTEN

PORT JERVIS, N.Y., July 10. (JTA) -- The formation of a B'nai B'rith Young Men organization at a nation-wide conference here of delegates from B'nai B'rith youth chapters was amnounced today.

The convention wrote a constitution for the group and elected national officers. Harold Rhein of Chicago was chosen as the first president of the organization.
