TEL AVIV TENSE AFTER SECOND NIGHT OF POLICE RIOTING; 40 JEWS INJURED, MANY HOSPITALIZED

TEL AVIV, Nov. 18. (JTA) -- Tel Aviv was still tense today following the second night of rioting by British police, during which at least 40 persons were injured, several of them so seriously that they required hospitalization.

Last night's outbreaks, which were on a wider scale than those of the previous evening, began when members of the Mobile Police Force, all of whom are Britons, suddenly swept into the city, assaulting passers-by at random, shooting into houses, raiding cafes, theatres, hotels and clubs and overturning taxicabs. They destroyed furniture, fixtures and anything else that they encountered. The rioting helted only after the belated arrival of military police.

Even Jewish members of the Tel Aviv police force were not spared. Several were shot at and beaten, resulting in an order confining them to their stations. Mayor Israel Rokach impediately protessed to the British civil authorities who promised to arrest the rioters and prevent further incidents.

A Jewish detective was shot dead this morning while standing in a bus queue on a main street of the city. His assailants, who escaped, are reported to have taken careful aim at their victim, M. Ben. Bezalel, after scattering the queue. However, a man who was standing next to him was slightly wounded in the leg. Ben Bezalel is understood to have been a police expert on the autivities of the Jewish extremists.

An official communique issued tonight confirms that considerable damage was caused by the ricters and admits 32 cases of assault, five of which required hospitalization. It says that a number of cars were stolen, three of which were later discovered abandoned and undamaged, while three others were overturned. The communique says that an investigation is going on and "appropriate steps" will be taken against those responsible for the outbreaks.

The inquiry commission consisting of representatives of the High Commissioner and military and civil authorities has already been dispatched to Sarona, scene of the blasting of a jeep on Sunday night, which was the incident which set off the riots. The commission will probe both the explosion and the rioting.

Haganah Werns Palestine Jews Will Resist "British Pogromists"

The Haganah radio today warned the authorities that "Palestine Jows will not allow themselves to be delivered into the hands of British pogromists. The Jows do not see any enemy in every British soldier and policeman who might have attacked Palestine Jows," the broadcast said, "nor do they countenance terror, considering terrorists enemies of their land, but they will not bend their back to British pogromists sowing terror through the streets of a Jewish city. We warn the authorities that if

they do not tame these policemen, their victims will do so." A Jewish Agency spokesman stated that while "it was impossible not to appreciate that tempers and passions may sibe rising, it is quite clear that the police must always remain the guardians of law new do order, and protect citizens." It also stressed that actions must be taken to pre-arout recurrence of the rioting.

Jerusalem Shaken When Land Mine Destroys Truck; Some Casualties Reported

JERUSALEM, Nov. 19. (JTA) -- An unidentified truck was blown up shortly after 9 o'clock this evening a few yards from the Jevish Agency building on King George Avenue. Preliminary reports said that there were a number of casualties.

The blast shock the center of the city and police cars rushed to the scene, Radio patrol cars were warned to be on the look-out for a light brown truck believed to be connected with the explosion,

U.N. GENERAL ASSEMBLY ADOPTS RESOLUTION AGAINST RACIAL AND RELIGIOUS DISCRIMINATION

NEW YORK, Nov. 19. (JTA) -- The Egyptian resolution calling upon all members of the United Nations to confirm to "the letter end the spirit" of the U.N. Charter by putting an immediate end to "religious and so-called racial persecutions and discrimination" was today unanimously adopted by the U.N. General Assembly.

The resolution, which originally referred to persecution "in Central Europe," was aimed at lessening emigration from European countries to Palestine. However, this provision was emitted after a controversial debate in the U.N. General Committee. Today the Egyptian delegate explained that the proposal now refers "to any kind of persecution."

The text of the resolution reads as follows: "The General Assebmly of the United Nations declares that it is in the higher interests of humanity to put an immediate end to religious and so-called racial persecutions and discrimination, and calls on the governments and responsible authorities to conform both to the letter and to the spirit of the Charter of the United Nations, and to take the most prompt and energetic steps to that end."

The resolution was supported by the "Big Five" nations as well as smaller cointries during 50 minutes of favorable speeches. Andrei Vishinsky of Russia, although speeking in favor of the proposal, criticized it on grounds that it was too general and did not contain precise data. "Discrimination and persecution will swist" he emphssized, "and himmediate steps are necessary to put an end to them." He said the resolution could have been strengthened by the addition of concrete proposals.

His stand was echoed by Sir Hartley Shawcross of Britain, who wrged the setting up of the U.N. Human Rights Commission which he said has the duty of drawing up a "Bill of Rights of Man" and providing machinery to protect those rights. He disclosed that Britain will press for the creation of the Commission at this session and will ask that it prepare a code of human rights for presentation at the next session.

C.I.O. CONVENTION CALLS FOR LEGISLATION OUTLAWING ANTI-SEMITISM, ADMITTING DP'S TO U.S.

ATLANTIC CITY, Nov. 19. (JTA) -- The eighth national convention of the C.I.O. today unanimously adopted a resolution calling for Federal legislation outlawing "anti-Semitism and other forms of anti-racial prejudice." The delegates also demanded that the government "stop quibbling" and open the "doors to the thousands of homeless and desperate Jows in Europe."

EGYPTIAN EFFORTS TO BLOCK RESETTLEMENT OF JEWS . PALESTINE DEFEATED AT U.N.

IAKE SUCCESS, N.Y., Nov. 19. (JTA) -- An Egyptian amendment to the draft constitution of the International Refugee Organization aimed at blocking the resettle-Them in Palestine of displaced Jews from Europe was defeated today by the U.N. Social and Cultural Committee following strong opposition by Mrs. Franklin D. Roosevelt, U.S. delegate.

Mrs. Roosevelt pointed out that if the Egyptian amendment were adopted, it would have the effect of making the resettlement of Jevish refugees impossible and would make their repatriation to their native lands obligatory. Certain classes of Jevish refugees, she argued, could not be repatriated.

Mrs. Roosevelt also opposed a Soviet motion to eliminate a paragraph defining DP's as those "unable or unwilling" to avail themselves of the protection of their countries of origin, pointing out that its deletion might affect Polish Jews who do not want to return to Ioland.

The Committee also took steps today to redraft a proposal that might have been interpreted as permitting Arab states to prevent the IRO from assisting in the resettlement of Jewish refugees in Palestine. The proposal, offered in the form of an amendment to the IRO constitution, by Yugoslav delegate, Leon Mattes, would force the IRO "to refrain from any temporary or permenent location of refugees and displaced persons in a territory if any of the neighboring countries submit a formal objection based on the endeuvor to preserve friendly relations between nations."

Mattes explained that this proposal was directed only at fascist elements in Europe and he asked the delegates to accept it in that spirit. Realizing the interpretation that might be placed on it, the Denieh delegate suggested a change that would eliminate Palestine. His proposal was for the IRO "to avoid resettlement and reestablishment of refugees and displaced persons on adjoining territories of their countries of origin if a formal objection is raised by such a country." The phrase "country of origin" would avoid application to Palestine.

The committee then voted to send both versions to a drafting committee of Yugoslavia, Denmark, Egypt and the United States, together with an Egyptian proposal that would amend the same paragraph to prevent resettlement against "the freely expressed aspirations and wishes of the indigenous population in the receiving countries."

The Egyptian delegate, Saad Kamel, raised violent objection to the committee's action. First, he announced that if the original Yugoslav proposal is changed he would adopt it as his own. Further, he insisted that his amendment should not be included with the other two. In this he was overruled by the chairman. The expectation is that Egypt's views will be rejected by the other three states and that the rayised amendment will not concern Jews,

The committee defeated another Yugoslav emendment that would have put European Jews under the jurisdiction of the IRO only if they left their hameland before the creation of the IRO.

JEWISH AND ARAB RAIL EMPLOYEES CO ON STRIKE IN PALESTINE; PASSENGER SERVICE HALTED

JERUSALEM, Nov. 19. (JTA) -- All employees of the Pelestine railway system, Jewish and Arab alike, today went on strike to protest the danger resulting from the mining of tracks and bridges by Jewish extremists.

Passenger traffic throughout Palestine halted immediately and this afternoon the rail system management announced discontinuance of service.

FIVE JEWS ARRESTED IN ITALY IN CONNECTION WITH BOMBING OF BRITISH EMBASSY

ROME, Nov. 19. (JTA) -- Five Jews have been detained here in recent days in connection with the bombing last month of the British embassy, it was reported today. The newspaper Il Tiempo says that one of the five is a Palestinian.

The embassy today told a Reuters correspondent that French police have turned over to British and Italian authorities a list of persons allegedly implicated in the bombing. The list is purported to have been handed to police in Alsace during the week-end by an unidentified man.

ANTI-SEMITIC DEMONSTRATION AT SOCCER GAME IN HUNGARY; AUTHORITIES ORDER PROBE

BUDAPEST, Nov. 19. (JTA) -- An anti-Semitic demonstration occurred on Sunday during a soccer game at Szolnok, south-east of Budapest, it was reported today by the Budapest daily Vilag.

The match, which was between a Budapest team, many of whose players were Jews, and a local aggregation, was suspended for five minutes until police reinforcements restored order. Spectators cried out threats against Jews and accused them of black-marketing.

Minister of Justice Istvan Ries, who is president of the Hungarian Football Association, has prohibited further matches at Szolnok pending an investigation into the disturbances. A similar incident took place several weeks ago at a soccer game here.

40 RUMANIANS SENTENCED FOR PLOTTING TO MURDER JE 3, OVERTHROW GOVERNMENT

BUCHAREST, Nov. 19. (JTA) -- A Rumanian military court today sentenced 40 members of a fascist band, which planned to murder Jews and overthrow the government, to prison terms ranging up to life imprisonment. Twelve persons were acquitted.

The 52 defendants were headed by Gen. Aurel Aldea, who was the first Minister of the Interior in the government which overthrew the Antonescu regime just prior to the Rumanian capitulation to the Russian forces. The trial aroused great interest in Runharest.

POLISH OFFICIAL SAYS JEWS HAVE FUTURE IN POLAND; PROMISES GOVERNMENT WILL AID THEM

WARSAW, Nov. 19. (JTA) -- Addressing a conference of Jewish social workers in Cracow, the Commissioner for Productivization today declared that the Jews have a future in Poland and that the government is ready to aid them in the reconstruction of their social, economic and cultural institutions and to assure them full civic rights.

The Central Jewish Committee announced that it has allotted 250,000 zlotys for the evacuation of the Jewish community of Miedzyrzec to Lover Silesia. The Jews of Miedzyrzec decided to leave the town after receiving numerous threats against their lives and property.

A district court at Czestochowa has sentenced four Polish youths, ages 17-19, to terms ranging from three to ten years for murdering and robbing a Jewish couple named Herckowicz. The couple were returning to Czestochowa from a concentration camp.

AMERICAN MILITARY GOVERNMENT IN GERMANY INTRODUCES NEW DIET FOR DISPLACED JEWS

MUNICH, Nov. 19. (JTA) -- Displaced Jews in the American zone of Germany today went on a new diet, receiving greater quantities of starchy foods such as potatoes and bread and less sugar and fats, as a result of Gen. Joseph T. McNarney's recent order that they be given food from indigenous sources. The DP's received the new diet with a noticeable ? ok of enthusiasm and medical authorities are studying its effects on their health.

Highly placed military authorities in the DP administration today told the Jewish Telegraphic Agency that Gen. McNarney's report which stated that the displaced Jews would not continue to receive imported foods, did not mean that the DP's would have to rely entirely on German-produced food, but would have to draw more heavily upon local stocks because of shortage of army funds with which to purchase food. They emphasized that the DP's would continue to have "top priority" and would get whatever they needed.

The Committee of Nazi Persecutees of Greater Hesse has protested to the four-power Allied Commission against the fact that imprisoned Nazis receive food rations of 1,700 calories daily while the German population gets only 1,550. The local persecutees' committees of four provinces in the American zone have met in Stuttgart and formed a zone-wide organization with headquarters in that city to study legislation to aid victims of Nazism.

SOLE JEWISH FAMILY IN GERMAN TOWN PERSECUTED BY FORMER NAZIS, HOME DEFACED

BERLIN, Nov. 19. (JTA) -- British authorities are investigating an attack by anti-Semitic Germans against the only Jewish family remaining in the city of Rahden in the British zone.

According to the authorities the home of Richard Franck, a shopkeeper, who spent five years in Buchenwald, was daubed with large swastikas in tar, and a car outside the house was set afire.

The chief suspects are two former Nazis who are believed to have been responsible for Franck's being sent to a concentration camp during the Nov. 9, 1938 pogroms.

A member of the Franck family said that the people of Rahden had been unfriendly since they returned. He said that the feeling against the Jews seems to be as bad as during Hitler days.

THERESIENSTADT DEPUTY COMMANDER EXECUTED FOR CRIMES AGAINST JEWS AND CZECHS

PRAGUE, Nov. 19. (JTA) -- Wilhelm Schmidt, a former deputy commandant at the Theresienstadt concentration camp, was executed at Litomerice today shortly after he was convicted on charges of the murder and torture of thousands of Jewish and Czechoslovak prisoners. He was an assistant to Heinrich Joekels who was hanged three weeks ago for similar crimes.

The same court found Theodor 'Hochhaus go lty of membership in the S.S. corps, but imposed no punishment. Twenty-five Jevish and Czechoslovak prisoners testified in Hochhaus' defense asserting that he had treated prisoners "humanely,"

CONFERENCE ON HIGHER EDUCATION FOR JEWS RECOMMENDS PROGRAM TO FIGHT DISCRIMINATION

NEW YORK, Nov. 19. (JTA) -- A six-point program aimed at combatting anti-Jewish discrimination in higher education was formulated here at a two-day conference on Higher Education for Jews convened by the American Jewish Committee, Recognizing the existence of "wide-apread racial and religious discrimination" practiced by institutions of higher education, the conference recommended:

- I. An appropriate impartial agency, preferably a foundation, should be commissioned to undertake a thorough study of the problem.
- 2. Steps should be taken to consult directly with authorities of institutions, and educational organizations should be encouraged to study discrimination and seek means of compatting it.
- 3. The public should be acquainted with the deleterious effects of discrimination, as well as with those institutions which have achieved desirable practices.
- 4. When necessary, undesirable practices of particular institutions should be called to the attention of appropriate groups.
- 5. The American Jevish Committee should support and sponsor federal legislation making non-discrimination a condition for federal grants to institutions.
- 6. The American Jevish Committee support the proposal to create a State University in New York and give serious consideration to sponsoring the establishment of state medical schools in states where present apportunities are insufficient.

One day of the conference was devoted to a discussion of the feasibility and desirability of the establishment of one or more institutions of higher education spensored and supported by Jews. The proposals were considered partly as a commercial contribution, but mainly on the broader basis of an actual contribution to intercultural understanding. Widely diverse opinions on this topic were expressed, and the conference appointed a committee to prepare a report on the problems involved.

ALFRED SMITH FOUNDATION GIVES \$10,000 GIFT TO UNITED JEWISH AFFEAL

NEW YORK, Nov. 19. (JTA) -- A \$10,000 gift to the United Jovish Appeal has been made by the Alfred E. Smith Memorial Foundation, it was announced here today. A check for that sum was presented to William Rosenwald, U.J.A. rational charman, by Charles H. Silver, vice-president of the Foundation of which Cardinal Spellmen is president.

NEW YORK COURT ORDERS VANDALS WHO FIRED JEWISH CENTER HELD FOR GRAND JURY ACTION

NEW YORK, Nov. 19. (JTA) -- Two youths accused of setting fire to and looting the Corona Jewish Center last September were ordered held for grand jury action yesterday. Ball was set at \$2,500 each.
