WEIZMANN WILL DEAL WITH TERRORISM AND ARAB-JEWISH RELATIONS AT OPENING OF CONGRESS

BASIE. Dec. 5. (JTA) -- The problem of terrorism in Palestine will be dealt with at great length by Dr. Chaim Weizmann, president of the World Zionist Organization, in his address to the first session of the 22nd World Zionist Congress which will open here on Monday, it was learned today. The leader of the World Zionist movement will warn that the activities of the small extremist groups in Palestine are a challenge to Zionist authority.

Dr. Weizmann will also discuss Arab-Jewish relations, He will indicate more definitely than ever before his attitude on relations between the Jews of Palestine and the peoples of the Middle East.

A spokesman for the world Zionist executive today said that the Revisionist delegates will be admitted to the Congress only if the New Zionist Organization with which they are affiliated is dissolved prior to the opening of the Congress. This is in accordance with the existing regulations that no delegate can be a member of a Zionist group which is outside of the World Zionist Organization, the spokesman explained.

Plans for Composition of Jewish Agency Executive Offered in Basle

Meanwhile, the leaders of the various Zionist groups have begun bargaining among themselves over the composition of the Jewish Agency executive, which will be set up following the election by the Congress of a world Zionist executive. The leaders of the General Zionists offered a proposal under which there would be no president of the Jevish Agercy in the future, but a du-unvirate composed of a representative of the General Zionists and of the Laborites.

This proposal was considered today by the Laborite delegation which, after many hours of discussion, offered a counter-proposal suggesting the following compromise:

Dr. Weizmann is to become honorary president, while the executive is to be divided into three sections, each electing its own president. One section of the executive would have its headquarters in Washington, the second in Jerusalem and the third in London. It is suggested that Dr. Abba Hillel Silver become the head of the American section of the executive; David Ben Gurion be the head of the Jerusalem section, and Moshe Shertok president of the London section.

The Laborite counter-proposal was unfavorably received by the General Zionist leaders since they consider that this would give Dr. Weizmann an opportunity to remain the actual head of the Jewish Agency and also, because the Laborites would under this plan retain two-thirds of the leadership in the executive. The Mizrachi leaders also opposed this proposal, since it would leave them completely out of the leadership.

PALESTINE TERRORISTS PENETRATE INTO BRITISH MILITARY CAMP; BLAST KILLS TWO BRITONS

HML AVIV, Dec. 5. (JTA) -- A British officer and one soldier were killed and four officers seriously injured today when a truck containing explosives blew up at the Sarafand army camp near Tel Aviv.

The truck was driven into the camp at noon by terrorists disguised as soldiers and parked near cantonment headquarters. It exploded about 15 minutes later, virtually destroying the headquarters. Many civilian and army personnel were taken to hospitals for first aid, in addition to the officers who were badly wounded.

The penetration of the Sarafand camp, which is the largest and most carefully guarded in the country, followed on the heels of a conference -- the second this week -- between High Commissioner Sir Alan Cunningham and Isaac Ben Zvi, president of the Jewish National Council. Sir Alan met with Ben Zvi this morning for continued discussions on the current wave of terrorism. He is believed to be pressing for a "proclemation of war" by Jewish leaders against the extremists.

Persistent reports that the authorities are preparing drastic reprisals if the violence does not cease led the Haganah today to issue a warning both to the extremists and the military. In a broadcast over the "Voice of Israel," the Haganah said that the extremists were stabbing the Yishuv in the back" and endangering Zionist enterprises by their "irresponsible murderous acts." At the same time, the broadcast warned the military authorities not to launch their own terrorist campaign, since rather than calming the country it will "deepen the bitterness and pour oil on the flames of terror and frustrate efforts to isolate the dissidents."

The newspaper Hamashkiff reports today that direct action to halt terrorism was decided upon yesterday at a secret meeting of tcp leaders of the Jewish Agency.

GERMANS IN PALESTINE PLAN MOVE TO TRANSJORDAN; CONTEMPLATE SALE OF THEIR HOLDINGS

JERUSALEM, Dec. 5. (JTA) -- Germans living in Palestine for many generations are reported today to be considering the sale of their extensive holdings in Sarona and other German-populated settlements in the belief that there is no longer any future for them in the country. Most of them are planning to seek settlement in Transjordan.

The British Government is supporting the negotiations, which leaders of the German settlers in Palestine are conducting with the Transjordan Government, for mass migration to Transjordan, the Hebrew newspaper Hearetz reports. It estimates that German holdings in urban and rural real estate are now worth about \$200,000,000.

DIVISION OF JERUSALEM INTO THREE ZONES RECOMMENDED; ARAB, JEWISH MAYORS TO ALL'ERNATE

JERUSALEM, Dec. 5. (JTA) -- Division of Jerusalem into three separate zones is suggested in a report prepared by Chief Justice Sir William Fitzgereld, who was named last year to draft a recommendation for solution of the impasse regulting from Arab refusal to rotate the Jerusalem mayoralty with Jews.

Under the Fitzgerald plan, which will be made public next week, there will be a Jewish zone, an Arab zone and the Old City, which will be under the administration of representatives of all three faiths, headed by a government official. The Jewish and Arab zones will be administered by elected assemblies, from which a joint municipal authority will be selected to deal with matters affecting the city as a whole. The mayoralty will be rotated between Jews and Arabs.

JERUSALEM ERUPTS IN NEW OUTBURST OF VIOLENCE; POLICE BATTLE TERRORISTS IN STREETS

JERUSALEM, Dec. 5. (JTA) -- Jerusalem was the scene of a pitched battle tonight between British troops and Jewish terrorists -- the second such encounter in the last five days.

Sirens were sounded throughout the city as the skies above the Jewish quarter were lit by flares. Police making house to house searches exchanged shots with lurking terrorists. A curfew was claumed down on the entire area.

The incident began with the blasting of a taxi in the Street of the Prophets in the Jevish quarter, killing two riders. The explosion was followed by two other blasts in adjoining streets, one of which occurred near the Machne Yehuda police station. A hand grenade was thrown at Arab Legichnaires guarding the residence of Sir Evelyn Barkor, British commander-in-chief, and reinforcements were rushed there.

At a late hour tonight, sporadic shooting could still be heard and police cars dashed through the streets. The extent of the damage or the number of casualties was not known.

ZIONIST CONGRESS WILL DECIDE ON PARTICIPATION IN LONDON CONFERENCE ON PALESTINE

LONDON, Dec. 5. (JTA) -- The World Zionist Congress will probably decide in favor of Jewish participation in the London conference on Palestine, it was predicted today by a spokesman of the Jewish Agency executive at a press conference here.

Outlining the major problems which will be discussed by the Congress, the spokesman stressed the fact that no specific proposal for the future of Palestine will be made by the Jewish Agency executive to the Congress. He strongly denied that any informal communication containing such a proposal has been received by any member of the executive from the British Government.

The spokesman pointed out that partition was originally a British proposal and not a Jewish plan. Nevertheless, he said, the Jewish Agency is ready to discuss partition as "an act of sacrifice and compromise actuated by a sense of urgency." He explained that the term "viable state" means the borders outlined in the report of Lord Peel with rectifications in Northern Palestine and the inclusion of the Negev and the Jewish part of Jerusalem.

BRITISH HIGH COURT RULES PALESTINE GOVERNMENT MAY DEPORT CUTIZENS TO ERITREA

LONDON, Dec. 5. (JTA) -- The Privy Council, Britain's highest appeals court, today dismissed an appeal by attorneys for Artoh Ben Eliezer, who was deported to Eritree by the Palestine Government. The attorneys had charged that deportation of Palestinian citizens outside the borders of the cruatry was illegal.

Max Seligman, chief defense counsel, predicted that the verdict would cause increased bitterness in Palestine, since it effects several hundred young Jevs who have been imprisoned in Eritrea. He said that the families of the imprisoned men had looked to the Privy Council to correct a system under which Jews can be sent outside their country without any redress from the courts. He pledged that further legal steps would be taken both here and in Palestine.

A.M.G. LEGAL OFFICER RECOMMENDS DP COURTS MORE SELF-COVERNMENT FOR JENS IN CAMPS

MUNICH, Dec. 5. (JTA) -- A report recommending the establishment of a DP court system and a greater degree of self-government in camps for displaced Jews has just been completed by Capt. Abraham Hyman, legal aids to Rabbi Philip S. Bewnstein, advisor on Jewish affairs to U.S. forces in Germany, it was learned here today.

The report, which will be released soon, was prepared on the basis of an intensive study of the legal and disciplinary picture in the DP camps. The DP courts were ordered to cease functioning last week following an Army investigation into one case of malfeasance on the part of a DP judge in the Foehrenwald camp near here.

A special Swiss health commission which recently completed examinations for tuberculosis among DP's in Munich reports that only two and one-helf percent of the displaced Jews are now suffering from the disease compared to 12 percent found shortly after the liberation. The fairly good treatment and hospitalization given to present tuberculosis patients, in addition to cures effected of the mild cases found at that time, are credited with responsibility for the reduced incidence of the disease.

GERMAN COURT SENTENCES SEVEN TO JAIL TERMS FOR SETTING SYNAGOGUES ABLAZE

FRANKFURT, Dec. 5. (JTA) -- Seven Germans charged with setting synagogues ablaze have been sentenced to terms ranging from nine months imprisonment to seven years by a German court at Bamberg, it was reported here today.

The Greater Hesse Ministerial Council today announced creation of welfare agencies for racial and political persecutees. At the same time, it appointed an advisory board to represent persecutees in the Ministry for Political Liberation, which tries persons charged with being Nazis.

According to incomplete figures for November which were released here today, more emigrants left Bremen for the United States in November than in the previous month, although less than had been scheduled to depart. With the departure of some of the DP's who had been piling up in Bremen for several months, 375 from the Munich area were allowed to come to Bremen in November.

HUNGARIAN JEWS PROTEST AGAINST ANNULMENT OF DEATH SENTENCES IMPOSED ON POGROMISIS

BUDAPEST, Dec. 5. (JTA) -- The Jews of Hungary are bitterly resentful of the action of the Court of Appeals, which last week sharply reduced death sentences imposed on persons responsible for the Kunmadaras pogrom, which cost the lives of four Jews, and strong protests are contemplated, including street demonstrations, Lazlo Stockler, president of the Jewish Community Council said today.

Stoeckler told the Jewish Telegraphic Agency that the cancellation of the death sentences places the country's Jews at the mercy of anti-Semitic mobs. He attributed the Appeals Court verdict to the efforts of reactionary forces. Left-wing news; apers also attacked the court today.

TUBERCULOSIS SANATORIUM FOR JEWISH REFUGEES OPENED IN NORTHERN ITALY

ROME, Dec. 5. (JIA) -- A tuberculosis sanatorium for Jewish refugees in Italy was opened today in Merano, in north central Italy. It has a 140 bed capacity and modern equipment and facilities.

WAR CRIMINAL CHARGED WITH EXTERMINATING JEWS ESCAPES IN WARSAW ON WAY TO HIS TRIAL

WARSAW, Dec. 5. (JTA) -- Janusz Fitkan, a Polish war criminal charged with participating in the extermination of Jews in the Troblinka death camp, escaped this week while en route from jail to the courtroom where he was to be tried, it was revealed here today.

The Czenstochowa district court today sentenced three young Poles to various terms of imprisonment for murdering a Jewish family named Hershkowitz in Czenstochowa. Those sentenced were Feliks Walarpwski, 17, Janusz Szewczyk, 19, and Zyg-fried Sikorski, 19. The murdered family was one of a group of repatriated Jews who had returned to their pre-war homes in Czenstochowa.

A hitherto unknown mass-grave of 18,000 Jews massacred by the Nazis has been discovered in the vicinity of Walbrzych, formerly the German city of Waldenburg, in Silesia

BRITAIN PLEDGES IT WILL SUPPORT FULL CIVIL RIGHTS FOR NATIONAL MINORITIES

LONDON, Dec. 5. (JTA) -- The British Government today pledged itself in the House of Lords to do everything possible to secure the civil and religious rights of national minorities. The pledge was given by Lord Chancellor Lord Jovitt in reply to a demand by the Archishop of York, Dr. Cyril Garbett, who asked the government to instruct its representatives at international conferences to press for equal rights for minorities.

Emphasizing that the British Government views the national minority problem with great anxiety", the Lord Chancellor said that Britain "will go as far as it possibly can" in securing equal rights for minorities and "will only be deterred from going to greater lengths by practical realism which will make the government understand that if it goes too far, it may lose what it would otherwise obtain."

Pointing out that under the United Nations a commission had been appointed to draft an International Bill of Rights, the Lord Chancellor told the House of Lords: "The protection of minorities must depend on action by the United Nations, and it is a proposition for fulfilment of the relevant provisions of the United Nations Charter. Until that bill of rights is drawn up, there is no standard of rights under the Charter and it would be impossible to enforce action against any state unless and until machinery had been created by the United Nations to which appeals might be directed. It is the desire of the government that there should be some body to whom such appeals could be brought so that if anyone is ill-treating minorities he may be arraigned before the bar of international opinion."

ERITISH COUNCIL OF CHRISTIANS AND JEWS APPEALS TO U.N. FOR SETTLEMENT OF JEWISH DP'S

LONDON, Dec. 5. (JTA) -- The British Council of Christians and Jews today adopted a resolution urging the United Nations to take measures to resettle displaced Jows in Jewish committies and to safeguard the civil and political rights of refugees. The resolution expressed concern at the uncertain future facing the displaced Jews.

Another resolution proposed by the Archbishop of Centerbury syndemned terrorist activities in Felestine as a "fundamental yielation of the spiritual and ethical principles common to Judaism and Christianity." An amendment to the resolution offered by the Vicar of Leads saying that Felestine terrorism "is doing great harm to the relations between Jews and Gentiles" in Britain, was withdrawn after a heated debate.
