RMISTICE IN JERUSALEM EFFECTIVE TODAY; JEWS TAKE CONTROL OF TIBERIAS AND SAFAD

JERUSALEM. May 7. (JTA) -- Arab League leaders today agreed to a truce in perisalem effective at noon tomorrow on the condition that the Jews cease fire. The Faganah tonight gave orders to all its members to hold their fire, although the sound of mortars and machine guns were heard in the Yemin Moshe quarter of the Old City at the very moment that an official communique announced the Arab leaders' agreement.

The accord was reached after Sir Henry L. Gurney, Palestine Chief Secretary, towneyed to Jericho to confer with Arab leaders including Arab League secretary Abdul Rahman Azzam Pasha. Gurney carried proposals from High Commissioner Sir Alan G. Cunningham to the Arabs.

The Jews today gained virtual control of Upper Galilee following the retreat of armed Arabs from Tiberias and surrounding Arab villages today. Sejera, strongpoint west of Tiberias, was among the occupied villages. Most of the major roaming Arab bands in the district have been beaten off or subdued, particularly after the almost complete occupation of Safad during the past few days.

Three Arab strongholds in the vicinity of Safad, including the important village of Ein Zeitim, are now in the hands of the Jews who also have complete control of all roads and communications between the towns and villages. The major part of Safad's 8.000 Arabs have left for Transfordan and the 3.000 Jews in the town appear to be in the majority.

A Jewish Agency spokesman today presented a picture of the preparations which the Jews have made for taking over the normal activities and facilities of the state after May 15. Some of the activities -- such as the issuance of domestic postage stamps -- have already begun. Programs which have been mostly independent of governmental control, such as health, education and social services, will continue to function as they always have.

Among the planned activities is the floating of a \$20,000,000 internal loan to support the Jewish national administration, and other fiscal measures including the imposition and collection of an income tax. The spokesman also announced that the Agency has established an export-import license office which has already granted licenses for the \$25,000,000 worth of imports and exports to and from 36 countries, including 12 countries in the sterling bloc.

U.S. CEARGES BRITAIN WITH NON-COOPERATION ON PALESTINE; BEVIN EMBARRASSES U.N. ASSEMBLY

LAKE SUCCESS. May 8. (JTA) -- The United States today charged the British meent with refusal to cooperate in a United Nations solution of the Palestine maing the U.S. that Britain can find no suitable neutral commissioner for Jeruelem, following receipt of a message from British Foreign Secretary Ernest Bevin

Bevin's message, which was addressed to U.N. Secretary General Trygve Lie, wild great onberrassment to the American and other delegations, who only less than hours ago at the General Assembly voted authorization for Britain to appoint a mission to administer the city of Jerusalea after the expiration of the Palestine date on May 15. Bevin requested the U.N. to suggest names of candidates in consistent with the Jevish Agency and the Arab Higher Committee at Lake Success.

"This is still another striking example of the lack of British cooperation in the whole Palestine issue," a U.S. spokesman said. Another member of the U.S. stepation bluntly accused the British of refusing to make the appointment they had becoming at the General Assembly only 18 hours previously on the grounds that the enhalest commissioner, shorn of enforcement powers, was bound to fail in his task, and British wanted the U.N. to be responsible for that failure.

After the U.S. declaration had been made public, the British delegation alled a press conference at which an official spokesman said the text which had been classed by the U.N. came from Colonial Secretary Arthur Creech-Jones, not from the conference of the U.S. Alan G. Cumningham in Jerusalem,

The High Commissioner's message said there is no one in Palestine who now an be considered a suitable candidate and that it would be impossible to secure rab-Jevish agreement on the spot. It was Creech-Jones, the spokeman added, who maggested that Secretary General Lie might consult with Arab and Jewish representatives at Lake Success. He then reported that a new message had arrived this aftercon from the Foreign Office advising the British delegation that Britain is still rying to find a candidate for the post of Jerusalem Commissioner.

U.N. Starts Consultations with Jews, Arabs on Commissioner

Immediately after the British announcement a meeting with Jewish and Arab representatives was called by Lie and Dr. Joss Arce, president of the General Assembly. It is expected that an agreement will be reached on a man acceptable to both parties within the next 24 hours, particularly in view of the announced truce agreement in Jerusalem.

Major Aubrey Eban, of the Jewish Agency, today called upon the Security Council to take immediate action against Arab armies poised to inwade Palestine when the Mandate expires. Pointing out that responsible ministers of the Arab League states had never bothered to deny press reports of their intention to launch an agressive war against the Jews of Palestine, Eban warned that truce talks could achieve nothing until that threat is removed.

Sir Alexander Cadegan of Britain, in reply to a question asking if Britain could assist in providing better communications facilities for the U.W. truce Commission in Jerusalem, announced that the British Cable and Wireless Company would soon transfer its transmitters to Amman in Transjordan, leaving only a mobile transmitter in Palestine. He saw no prospect of resuming the suspended airmail service since further use of both Lydda and Haifa airports was "highly speculative."

Crosch-Jones, testifying today before the 12-member Political Committee subcommittee studying the problem of establishing a provisional regime in Palestine, shifted that partition has taken deep root, but warned that the Jewish state could not live in isolation from the rest of the country. For the composition of the interia regime he proposed the members of the Consular Truce Commission—the Jerusalem counts of the U.S., France and Bergium—plus two more individuals, one of whom might be known in the U.S., present of the U.S. Palestine Commission.

LOUIS RABBI DISCUSSES PALESTINE WITH TRUMAN; SAYS PRESIDENT BELIEVES IN PARTITION

WASHINGTON, May 7. (JTA) -- Rebbi Semuel Thurman, of the United Hebrew Temple St. Louis, discussed Palestine with President Trumen today and said he was "very the encouraged" as a result of the talk. He told reporters that he did not think to President had really departed from pertition as the ultimate solution for the Palestine problem.

In response to questions, Rabbi Thurran said he thought the Jevish State and be established on May 16, but said he did not know whether the United States hald recognize the new state. He said he thought a declaration of independence by he new state on May 16 would put things "in focus."

Asked if he thought the President would lift the arms embargo, Rabbi Thurman aid the subject did not come up, but said he thought such a move would be only fair ince "we know for a fact" that the Arabs are getting arms from the British.

Thirty-six House Republicans from 15 states today wrote President Truman and he nine members of his Cabinet urging that the U.S. Government work towards estabishing "a truce under fair conditions which could lead to a permanent settlement in abstine." To obtain these objectives they urged that the U.S. Government:

 Lift the arms embargo until the truce is obtained or until the Arab lores from neighboring states are withdrawn and "foreign arms are no longer a factor in the Palestine fighting."

 Prepare to participate in any effective measures to protect Jerusalem mi its environs and to put these areas under international control as already proposed by the U.S. representative at the U.H.

3. Support all U.N. efforts to apply such sanctions that are provided for in the Charter in order to bring about "compliance" with the General Assembly's resolution to partition Palestine.

The 36 Congressmen--substentially the same group that has several times in the past petitioned Secretary Marshall to clarify America's Palestine policy--said they were writing the letter at present because the Palestine crisis affects "so many interests vital to the U.S. and the world's hopes for peace." They said that the continued and accelerated pace of the warfare in Palestine, the reported and admitted incursions into Palestine on a large scale of non-Palestinian Arabs and the de facts establishment of a Jewish state in Palestine" required the taking of the steps they omilined.

Moshe Shertok, Jewish Agency leader, told a meeting of the United Jewish Appeal here last night that partition was the only solution to the Palestine problem. Delaring the birth of a Jewish state "is inevitable," Shertok told the 5,000 people to attended the meeting that "if the United Nations does not come to the aid of Palestine to prevent a threat to world peace, we will take up the challenge and fight almo." Rabbi Jonah B. Wise and William Rosenwald, national co-chairmen of the U.J.A., also spoke.

A rally sponsored by the American Council for Judaism here, which was attended by 300 persons, heard Kermit Roosevelt, executive director of the Committee for Justice and Peace in Palestine, change that the Jevish Agency allocated a very small Preentage of the Palestine immigration certificates to European refugees. He said the Zionists repudiated the DP's after having claimed that Zionism "would solve the Problem." Rabis Merris Lazaron, of Baltimore, and Irving E Reichert, of San Paucisco, were among the other speakers at the meeting.

MS IN FOUR DP CAMPS IN ITALY JOIN HUNGER STRIKE IN PROTEST AGAINST I.R.O. ACTION

ROME, May 7. (JTA) -- Displaced Jews in four camps in Northern Italy -tola Cadorna, Cremona, Grightasco and Rivoli -- today joined in a hunger strike prolaimed yesterday by Jewish DPs in a refugee conter near Milan maintained by the Inimational Refugee Organization.

The strike was called in protest against the cancellation by the I.R.O. of he ration books of 500 Jewish refugees as punishment for their refusal to comply ith an order to move from the center to another I.R.O. camp.

S. OFFICIAL DENIES DP'S ARE NO LONGER ANXIOUS TO EMIGRATE TO PALESTINE

RANKFURT, May 7. (JTA) -- A report published in New York alleging that the ajority of the displaced Jews in Germany have lost interest in Palestine because of the "uncertain future" there, and that about 80 percent of them prefer to emigrate to the United States, was denied here today.

In a statement to the Jevish Telegraphic Agency, Dr. William Haber, advisor a Jevish affairs at the J.S. military headquarters, declared that he is convinced that even under the existing unsettled conditions, the vast majority of displaced Jevs in Germany and Austria would emigrate to Palestine when legal immigration is muthorized.

"They are tired of endless waiting in DP camps and would gladly sacrifice temporary security in these camps for the hazards of life in Palestine," Dr. Haber stated.

RITAIN EXTRADITES POLISH DOCTOR WHO TORTURED JEWISH WOMEN AT OSWIECIM CAMP

LONDON, May 7. (JTA) -- The British Government agreed today to extradite Dr. Wladielaw Nehring, Polish war criminal, who, as Nazi-appointed chief surgeon at Gwiecim, is allegedly responsible for performing 18,000 "experimental operations" on the camp's immates, most of whom were Jewish women.

After the war, Nehring joined Gen. Anders' Polish army in Italy and later arrived in England as an army physician. He was arrested in 1947 following publication of the U.N.War Commission list of unapprehended war criminals. He is wanted not only in Poland but also in France and Czechoslovakia.

QUESTION OF SABBATH OBSERVANCE IMPEDES MERGER OF LEADING JEWISH GROUPS IN POLAND

WARRAW, May 7. (JTA) -- Negotiations for a merger of the Central Jewish Committee and the Federation of Jewish Communities of Poland hit a snag today when the Central Committee declined to accept the principle of Sabbath observance, offered by the Chief Rabbinate, an affiliate of the Federation, as one of five points to be discussed during the current talks. The Committee, however, has accepted in principle the other four points. They are:

1. Kosher food shall be served in all Committee-sponsored kitchens; 2. Automony for all religious children's homes shall be preserved; 3. Financial independence for the Federation; 4. Continuation of the "Talmud Torah" method in the country's Jewish educational system.

A spokesman for the two organizations announced today that agreement had been reached on the questions of restitution of Jevish communal real property; the elumation of Jevish mertyrs and their reburial in Jevish commeteries; and the provision of adequate supervision for Jevish burial places. He pointed out that the purpose of the merger discussions is to set up a unified Jevish representative body.

CHICAGO, May 7. (JTA) -- "Admiration of the high cheracter" of the work connected by the National Jewish Welfare Board was expressed today by President Truman in a message to the annual conference of the organization which opens here tomorrow at the Hotel Stevens. Delegatos from 314 Jewish Community Centers and YM-YWHA's, as well as representatives of the agency's 282 Army-Nevy committees, will attend.

The President's message, addressed to Frank L. Weil, president of the J.W.B., sailed the Jevish Community Center movement as a "magnificient symbol of service." This movement, he said, is "in effect a trusteeship, and the Jevish Welfare Board has splendidly borne the burdens and carried the responsibilities inherent in a proper shiftilment of that trust."

President Truman also praised the two-fold serwice conducted by the Jewish Welfare Board--"service in the realms of recreation, culture and morale to the 500,000 young people and adults who find Jewish Community Center an attractive and helpful institution, and of continued service, as well, to the men and women wearing the uniform of the United States and to hospitalized veterans."

The major business before the conference will be to formulate a statement of miniples on the aims and objectives of a Jevish Community Center. Another important subject on the meeting's agenda is the question of the new responsibilities which the J.W.B. may be required to undertake in view of possible enactment of selective or universal training legislation. The J.W.B. is officially authorized by the government to serve the religious, recreational and morale needs of Jevish servicemen and wasen in military installations and Veterans Administration hospitals.

ANTI-DEFAMATION LEAGUE CONFERENCE ENDS; RE-ELECTS STEINERINK NATIONAL CHAIRMAN

LOS ANGELES, May 7. (JTA) -- Justice Steinbrink, of New York, was re-elected national chairman of the Anti-Defanation League today at the closing session of the organization's three-day annual meeting here at which a broad program for combatting bigotry and prejudice in the United States was presented to the 500 delegates.

Pointing out that "excellent as the Bill of Rights is, it is not self-enforcing," Justice Steinbrink, who has served as head of the ADJL. since 1936, stressed that "bigotry has injured and still injures in the most tragic way more people more seriously than forest fires or train wrecks or hurricanes or floods."

Benjamin R. Epstein, who was re-elected secretary and national director of the organization, asserted that enti-Semitism cannot be fought merely by pronouncements that "democracy is good, or that Protestants, Catholics and Jews must work together. We must go further than that. We must show specific cases in which democracy is falling down."

Posing the question on "how shall we combat anti-Semitism today?" Epstein said: "Obviously the soundest method of all is to fight for a healthy society, full employment, adequate higher education and sample housing. Where there is scarcity and am must compete desperately for the basic necessities of life, minorities are bound to be at the mercy of those who stir up hatred and fear."

Judge David Rose, chairman of the A.D.L.'s civil liberties committee, charged that many Americans had begun to look "with an unjaunalized eye" on anti-Denitic prepations expressed by public figures; that certain universities, were still discriminating against Jewish students and that there was a continuing influx into the U.S. of alien fasciets and Mazis.

Others re-elected today to A.D.L. posts include Jacob Olson, treasurer, and Richard E. Goodstadt, executive vice-chairman.

MERICAN JEWISH CONGRESS URGES U.S. COVEREMENT TO RECOGNIZE JEWISH STATE MAY 16

NEW YORK, May 7. (JTA) -- A resolution calling upon the United States to attend formal recognition to the Jewish state in Palestine, which will be proclaimed fay 16, was adopted here last night at a meeting of the executive committee of the

Describing the present United Nations deliberations at Lake Success as "a futile and last-minute effort to thwart the establishment of the Jewish state on the fee of the fulfillment of the age-old aspiration of our people," the resolution might be U.S. Government, in granting recognition to the Jewish state, "to render it, in a spirit of fellowship and cooperation, all assistance in establishing itself, in equality and dignify, among the democratic nations of the world."

CHADLAN ZIONIST COUNCIL WARNS AGAINST SUPPORTING "MAPLE LEAF LEGION FOR PALESTINE"

MONTREAL, May 7. (JTA) -- The Canadian League for a Free Palestine was sharply criticized today by the United Zionist Council of Cenada, meeting here, for amounting the formation of a "Maple Leaf Legion for Palestine."

"We are most anxious that the Canadian public be made aware that the Maple Leaf Legion has not been authorized and does not have the support of any representative Zionist body," the resolution said. "We, therefore, find it necessary to repeat previous varnings to Canadian Zionists against the desirability of lending any support to dissident and divisive movements which can only lead to confusion."

FREEDMAN TELLS COURT OF HIS EFFORTS TO INFLUENCE 52 CONCRESSMEN AGAINST ZIONISM

NEW YORK, May 7. (JTA) -- Benjamin Freedman, founder of the League for Peace with Justice in Palestine, revealed today that, several days after the U.N. General Assembly adopted the Palestine partition decision, he addressed a private dinner of 2 Congressmen at the Mayflower Hotel in Washington on the subject of Palestine during which he outlined his group's anti-Zionist views. All expenses for the dinner were paid by him, Freedman said.

Appearing as a principal witness in a libel suit hearing brought against the Non-Setarian Anti-Nazi League by an attorney for the League for Peace with Justice in Palestine, Freedman said he contacted Rep. Ed Cossett, of Texas, early in December after the latter said on the floor of the House that that day when the U.N. partition decision was announced was. "the blackest day in American history."

During today's cross-examination Freedman in inleged in anti-Zionist unterances. The court asked him several times to refrain from using the term, 'Jev state,' in reference to Falestine, a term which he described as conceived by Dr. Theodore Herzl in his pamphlet, "Judenstaat."
