### ISRAEL VOICES CHARCES AGAINST SYNTA AT U.N. SECURITY COUNCIL; APOLOGIZES FOR BOMBING

IAME SUCCESS, April 25. (JTA) -- In a fighting speech today before the United Nations Security Council, ambassador Abba Eban, head of the Israeli delegation to the U.N., charged Syria with attempting to carry out a preconceived plan to greb Israeli territory. "The same tenacity we showed in defending our deserts we will show again in defending our swamps," he warmed.

In an address lasting for about one hour, Mr. Evan defended Israel's right to drain the Ruleh swamps. He pointed out that the Ruleh reclamation project is an integral part of Israel's development because of its importance as a source of irrigation for the ards regions of the Javieh state.

At the same time, the Israeli representative publicly apologized to the United Nations for the recent retaliatory bombing of Syrian positions after the murder of seven Israeli policemen by Syrian troops who invaded Israeli territory in the deminitarized zone. "Israel regrets that it felt constrained to take action which may not have been compatible with the terms of the armistice agreement," he said.

Ar. Evan asked the Security Council to accept Israel's sincere expression of regret and assurances that it was only the result of extreme provocation and feeling that there was need for supersetic self-defense that notivated the bombines. "This provocation has gone on and has indeed assumed a more systematic and scarcely less marrierous aspect," he declared.

### Eban Insists on Israel's Sovereignty Over Its Demilitarized Zone

The Scourity Council, which met to discuss the Israeli-Syrian conflict, was told by Mr. Eban that Israel rejects in its entirety the contention made by Syria and backed by U.N. Chief of Skaff Maj. Gen. William E. Riley that under the Israeli-Syrian struistice agreement there was any limitation put on the signatories in respect to a demilitarized zone other than the purely military requirements of keeping the zone free of military forces.

The Israeli delegate blasted the Riley thesis, expressed in a memorandum to the Security Council several weeks aso, that sovereignty was affected in any way by the demilitarization of an area. He told the Council that in meetings and in letters U.N. mediator Ralph J. Bunche had given that concrete assurance to the Israe Government before the latter signed the armistice agreement.

"I solemnly swear to the Security Council that my government would never have set its hank to an agreement which limited its sovereignty in any way," Eban said. He asserted that Riley had read into the armistice agreement with Syria what was not there.

In the course of his address, Mr. Eban emphasized repeatedly Israel's contention that the armistice agreements were purely military downments—which he noted was why they were supervised by military men—and that they carried no political, eccomic or social remifications. On the contrary, he said, it had been Israel's clear understanding with Dr. Bunche that Israel had a moral obligation to develop the demilitarized zone comprising the Euleh region, not to let it languish. Be traced the history of the Haleh concession, and said that Gen. Riley exceeded his powers in questioning the legality of the concession.

### "There Can Be No Israel Mithout the Precious Sources of the Jordan," Eban Sage

"There can be no Israel without the precious sources of the Jordan," the Israeli diplomat stated. "We shall sizm no peace under which they are abendoned. "Be shall preserve our swamps and we shall make them into healthy and fruitful regions as we are making the desert bloom." He concluded his speech by stressing, as he has often before, that the fundamental and chronic violation of the armistice agreements is the refusal by the Arab states to end the uncertain and temporary period of the armistice by signific a permanent peace. He reaffirmed the desire and willingness of Israel to conclude that peace.

Gen. Riley, who followed Mr. Eban with a statement to the Council, declared that the machinery of the Mired Armistics Commission was "entirely adequate" to deal with the current dispute and expressed his regrets to the Council that it had been brought into the case. He asked the Council, since the case had come before it, for clarification and guidance on "the troublesoms question of admiristrative authority in the demilitarized zone."

Gen. Riley defended the position he had taken in the memorandum attacked by Israel—a memorandum that had ordered Israel to cease its work on the Hulah drainage project—by quoting Dr. Bunche. He said that Dr. Bunche had authorized him to make a statement which included the following, quoted from Dr. Eunche: "It was recognized that the gradual restoration of normal civilian life in the demilitarized zone could neither be automatic nor left to the discretion of the conflicting parties. It was provided, therefore, that the chairman of the Mixed Armistice Commission should be the responsible agent for guiding this process."

Gen. Riley also quoted from a Bunche communication of June 26, 1949, which Riley claimed was the only authoritative declaration by Dr. Bunche on the question at issue, since both Israel and Syria had accepted it as an authoritative interpretation. "As civilian life is gradually restored (in the demilitarized zone)," Dr. Bunche wrote, "administration will take shape on a local basis under the general supervision of the chairman of the Mired Armistice Commission. The chairman of the Mired Armistice Commission, in consultation and cooperation with the local communities, will be in a position to authorize all necessary arrangements for the restoration and protection of civilian life. He will not assume responsibility for direct administration of the zone."

Gen. Riley said that Dr. Bunche shared his view that no other communications between Bunche and the reverments concerned could be considered to have any official standing as a basis for interpreting Article Five of the armietic excession, "since it was this note of June 26, alone which the parties themselves accepted for this purpose." After Gen. Riley concluded his statement, the Security Council adjourned its season until May 2.

TEL AVIV. April 25. (JTA) -- General Zionist delegations from all over Israel met Dr. Abba Hillel Silver at the Lydda airport today upon his arrival from the United States. The Maccabi brass band played the Israel national anthem when the American Zionist leader stepped down from the airplane.

Dr. Silver was greeted by Dr. Peretz Bernstein, president of the General Zionist Party of Israel, and by a representative of Mayor Israel Rokach, on behalf of the largest city in the Jewish state. Mayor Rokach himself could not be at the airport because he is convalescing in Gelilee. Visibly moved by the enthusiastic reception, Dr. Silver said he came to Israel after an absence of more than two years to renew contact with the people and to stress American Jewry's unshakeable support of Israel's development.

Preceded by a mounted guard of honor, Dr. Silver left the airport in a motorcade which drove through Petach Tikyah and Remat Can, where special ceremonies awaited the guest. The parade later proceeded along Tel Aviv's main streets lined with cheering crowds and halted at the Second of November Square where a group of children presented Dr. Silver with flowers on behalf of the youth of Tel Aviv.

### BEN GURION WILL ERING GREETINGS TO TRUMAN; IS DUE TO ARRIVE IN NEW YORK ON MAY 3RD

WASHINGTON, April 25. (JTA) -- Israel Prime Minister David Ben Durion will bring Israel's greetings to President Truman and will meet with leading officials of the American Government during his stay in Washington, the Israel Embassy announced today. He will arrive in New York with his wife on May 3rd for a three-week visit.

The Babassy said Mr. Ben Gurion will convey to President Truman and the American people an expression of gratitude from the people of Israel for the sympathy and support extended to them in their struggle for independence. The Israeli Premier will convey Israel's appreciation to American Jewry for its moral and material aid.

The State of Israel "Independence Bond Issue" will be launched with the Prime Minister's participation during his visit, which will cover Washington, New York, Philadelphia, Boston, Pittsburgh, Chicago, Detroit, Cleveland, and Los Angeles. Mr. Ben Gurion will view verious American development projects during the visit.

### ISBARL SPOKESMAN DENIES CHARGES CATROLIC ACTIVITIES HAMPERED BY VISA POLICY

JERUSAISM, April 25. (JTA) -- An Israeli spokesman today denied allegations that the Jevish state "seriously interferes with Catholic activities" in this country by not granting visas for a permanent stay in Israel.

The charge was contained in a statement allegedly made in Rome by Monsiemor MacMahon, head of the Pontifical Mission for Relief in the Middle East. The Israel spokesman pointed out that Israel does not yet have a nationality law regulating the admittance of foreigners who desire to become permanent residents. However, he pointed out, pending enactment of such regulations the Israel Government has "freely granted" visas to the clergy.

### U.P.A. AGENCIES SPEET \$431,450,000 IN ISRAEL; SYIK NAMED CHAIRMAN OF U.P.A. BOARD

MANAJORE, April 25. (JTA) -- Punds totalling \$431,450,000, provided with the aid of American dews, were spent by United Palestine Appeal agencies for an over-all program of immigration, resettlement and upbuilding in the three years since the establishment of the State of Israel, Rudolf G. Sonneborn, U.P.A. national chairman, reported to a board of directors' meeting at the Biltmore Extel here tonight. William D. Sylk, of Philadelphia, was installed as chairman of the U.P.A. board codirectors.

### WHERITE GERG-BADEN READY TO MAKE "GLOBAL" SETTIMENT FOR RETRIESS JENISE PROPERTY

FRANKFURT, April 25. (JTA) -- Reinhold Maier, Premier of the province of Whertemberz-Baden, today announced that his administration is prepared to make a "global" settlement for heirless Jewish property with the Jewish Restitution Successor Organization, which represents the major Jewish groups throughout the world-

Premier Maier indicated, however, that he is prepared to complete transactions only in cases where the courts have already ruled on the validity of the Jewish claims. He refused to act on undecided cases because of the possibility that the government will assume responsibility for the claim by paying the JRSO and then find itself involved in a legal dispute with its own citizens.

#### JEWISH INVALIDS SEEK INTERVENTION AGAINST FREEZING OF RESTITUTION PAYMENTS IN BAVARIA

MNICH, April 25. (JTA) -- The Association of Jewish Invalids in Germany has appealed to the World Jewish Congress to intervene with the Bavarian Government exainst the freezing of all payments by the state Restitution Office, formerly headed by Dr. Philip American who is presently in Jall facing charges of frence. The memorandum points out that despite all appeals the office has made no cash payments nor has provided medical care for any of the victims of Mazism entitled to such payments or eservices since the American affair.

Bavarian Premier Hans Ehard, speaking in the State Parliament today, promised that the state of Bavaria would make every effort to carry out the payment of Smidemification to victime of Maxism. He told the Parliament that since special funds allocated for indemnification payments had been exhausted and that the State's financial position was difficult, further indemnification payments would have to depend on the sale by the Government of property confiscated from Nazis during the demaification proceedings.

The Premier, who replied to numerous questions on the indemnification progressively a session of the Legislative body devoted to marking the sixth ammierosary of the liberation of prisoners from Wair concentration camps, asserted that two-thirds of the entire restitution program in Bavaria had been carried out and that 12,000 indemnification cases had been estimed. Since the German currency reform, he said, Leweria had peid out 60,000,000 Devischemarks to victime of the Wair regime.

"Despite these enormous payments," he added, "only a beginning has been made." He declared the Government was now preparing a special ordinance providing for indemnification to those whose professional careers had suffered as a result of Bari measures.

In a pointed reference to the activities of neo-Maxi creanizations in the country, Francer Enerd said there were people trying to takeify history and the records of what had happened in the concentration camps. Anyone tessorating the remembrance of victims of Maxima, he warned, was also descrating democracy and striking at the foundation of the State.

Dr. Georg Stang, President of the Parliament, in opening the sension, assured victims of the Main regime that Parliament sincerely intended to rectify the injustices committed by the Maxis. He called on the people of Ravaria not to force the horrors of the part.

# AMERICAN CRAIN IN GERMANT DEMANDS SUPPRESSION OF GROUP SUCCEEDING THE NAZI PARTY

FRANKFURT, April 25. (JEA) -- A demand that the German Socialist Party be suppressed as a "successor to the Nazi Party" was made here today by the News Zeitung, official American paper in Germany.

The newspaper attacked the party, which is headed by former Nazi General Otto Remer, and criticized the West German Government and the Allied High Commission for not using various security laws to "prevent further activities directed against the German Constitution." It pointed out that in program, publications and official statements the party patterns itself on the lines of the Nazi movement.

The Federal Office for the Protection of the Constitution today banned a public meeting of the right-wing Dautscher Bloc, headed by Earl Meisener. It also dissolved his 300-man bodyward on the grounds that its members were a uniform similar to that of the Nazi Party.

A powerful nec-Wazi movement aimed at restoration of a dictatorship in Germany was under ban in the state of Bewaria today as the Federal Office for Protection of the Constitution drew attention to a second powerful nec-Wazi organization new active in Schlesmin-Holstein in the British zone of Germany.

Dr. Wilhelm Hoemer, Bevarian Minister of the Interior, announced that activities by the "Rationale Sammelbewgung Deutschlands"—the "Rational Unification Movement"—beaded by Erwin Beorner; would be benned in Bavaria. Bearner recently founded his organization in Stuttmart and Munich and proclaimed a lo-point program calling for a return to a national dictatorship "for the national renaissance of Greater Germany." He denounced the present German government as traitors who are preventing the national wakening of Germany.

The report issued by the federal agency warned of the activities of Karl Meisener, leader of the "Deutscher Block," who is now acgive in Schlesvig-Holstein organizing semi-military nationalist groups. Meisener's organization, which has not yet received the status of a political party, puts its members into uniform. The federal office said today that Meisener's meetings in Flenoburg and Kiel were "similar to former Mazi Party meetings with only the Swastika missing."

### TWO ANTI-SEMITIC WEEKLES CLOSED IN TURKET; FUBLISHED MATERIAL INSPIRED BY "STUESMER"

ISTAMBUL, April 25. (JTA) -- Two Turkish weeklies which have recently been publishing large quantities of anti-Sentitio propaganda have been closed by the authorities on the grounds that their editorial line is "hostile" to the principles laid down by Remal Attaturk, founder of the Turkish Republic.

The ultra-mationalist publications have been charging the Jews with being "internationalists," "Communists" and "imperialists." They have published much material inspired by the Magi hate sheet "Der Stuerner."

### ONTARIO DEPARTMENT OF TRAVEL WILL NOT SANCTION HOTELS SEEKING "RESTRICTED" CLIENTELE

TONOWIO, April 25. (JTA) -- Operators of hotels and tourist campe advertising "selected" or "restricted" clientels will be blackhalled by the Ontario Department of Travel and Pablicity, the third annual Ontario Tourist Conference was informed. J.E. Wright, director of the Department, said to sanction such establishments would be contrary to recent lagislation outlaving property or employment restrictions based on race, color or oreed.

Establishments discriminating on the basis of race, other or creed will be cut out of e \$100,000 advertising campaign carried by newspapers and periodicals through most of the N.S. and including a New York television show, sponsored by the Ontario Department of Travel and Publicity to attract U.S. tourists to Ontario resorts.

### CATHOLIC ORIAN IN SPRINGFIELD, MASSACHUSETTS, VOICES CRITICISM OF ANTI-SEMITISM

SPRIMGFIED, Mass. April 25. (JTA) -- The official organ of the Springfield Roman Catholio diocese, the Catholio Mirror, this week criticized those who blame the Jews for evils afflicting society. The paper told its readers that "you cannot imight a whole nation." It drew attention to the citation given by the Pope to a pringfield Jewish nurse, Col. Jeanette Elech, for her kindness to a group of nums in Germany.

### J.T.A. CORRESPONDENT HONORED BY CUBAN GOVERNMENT; ZIONIST PRINERATION RECEIVES MEDAL

ENVARA, April 25. (JTA) -- The Zionist Federation of Cube and the Jewish Center here were awarded medals by the government for arranging special celebrations in connection with the 100th anniversary of the Cuban flag.

Abraham J. Dubelman, correspondent of the Jewish Telegraphic Agency in Hevans, who is also an associate editor of the local Jewish newspaper Havaner Leben, was decorated by the government on the occasion of the annivarsary. S.M. Kaplan, editor of the Havaner Leben, was similarly decorated.

### SOUTH AFRICAN JEWISH LEADER REPORTS IN ARCENTINA ON JEWISH ACTIVITIES IN HIS COUNTRY

BURNOS AIRES, April 25. (JTA) -- Jevish life in South Africa was described here at a press conference for the first time by a South African Jevish leader, Mr. Abel Shaban, who is now visiting Appenting in tebals of the ORT.

Mr. Shaban, a well-known industrialist, revealed that during the war for Israel's independence, his airplanes carried 400 Jewish youths from South Africa who volunteered in 1948 to fight in the ranks of the Hagangh. A member of the world erecutive of ONT, Mr. Shaban came to Buenos Aires to negotiate this year's allocation for the ONT from the United Jewish Campaign here.
