BEN GURION SEEKS INCREASED SECURITY FOR ISRAEL; OPPOSES COMPROMISE WITH CHITERISTS, MAT

TEL AVIV, July 8. (JTA) -- A demand for increased security efforts by the people and Government of Israel was voiced here last night by Franier David Ben Gurion at an election gally of Mapai political workers. The Fresher twosed that the Arab refusal to conclude a peace with Israel and their refusal to recognize the Jewish state made it imperative that the state's security position be guarded and improved.

He declared that it is not the aim of the Farael Labor Party to achieve the "whole Zionist and Socialist vision" in the four years of the next administration, but that the Mapai's aim is to increase the Jevish population of the country to 2,000, "000 by the end of that time and, at the same time, to attend then the position of the workers. He stated flatly that there would be no compromise with the Mapam, which he charged with desiring to include Egreel in the Cominform, nor with the General Zionists, whom he accused of wanting free enterprise so that individuals could be enriched at the expense of the state.

Finally, Mr. Ben Gurion praised the collaboration between Israel and the Jewish people and said that the next four years would be decisive for that relationship as well as for the world at large and the nation as a whole.

In the township of Majdal left-wing demonstrators interrupted a speech by Premier Een Gürion with shouts of "American Fascist." The Premier quieted the crowd and, addressing the demonstrators, said: "This is a democratic country and anyons may say what he wants. But would the friends of the Cominform dare to demonstrate the Baoule's Republics for the immigration of their friends?"

As a result of the Israel polling for delegates to the World Zionist Congress to be held here next month, the Mapai Party will have 104 seats of the total alloted to Israel. The Mapam Party will have 46; the Happel Hamisrachi, 26; Herst Party, 22, and the Progressive Party, 12. The General Zionist Party and the Mizrachi boycotted the election.

Israeli Warships Welcomed Upon Return from American Goodwill Tour

HAIFA, July 8. (JTA) -- Two Israel warships, the Misgav and the Haganah, returned to their home port this week-end after a 14,000 mile goodwill and training tour in United States waters. The two vessels were greeted by the Chief of Staff and by Minister of Transportation Day Joseph. Premier David Ben Gurión sent a message welcoming the ships and crews and expressing regret that he was unable to be present at their velcome.

Israeli air and naval units met the two ships as they entered Israeli waters and provided a guard of honor as they moved fato the port. Army units saluted the ships and paraded.

AMERICAN JEWISH COMMITTEE PRESIDENT CONFERS IN WASHINGTON ON MIDDLE EAST PROBLEMS

WASHINGTON, July 8. (JTA) -- In two separate conferences here during the weekold Jacob Blaustein, president of the American Jewish Committee, conferred with Assistant Secretary of State George C. McGhee and with French Ambassador Henri Bonnet. In the meeting with Sec. McGhee various matters pertaining to the Middle East were considered. The meeting with Ambassador Bonnet concerned, among other things, situstions affecting North Africa.

STATE DEPAREMENT VIEWS ANTI-JEWISH DEVELOPMENTS IN EAST BURGPE WITH MOUNTING CONCERN

NEW YORK, July 8. (JTA) -- The State Department has voiced its "increasing concern" over the "brutel and inoxcuseble denial of human rights in the Soviet Union, Poland, Joschoslovekier, Rumania, Rumany and Bulgaria with respect to the cultural and spiritual life of the Jewish people in these countries" and commended the Jewish Labor Committee for its efforts to focus world attention on the "cultural and spiritual senceids evstewatically unresued" in these countries against the Jews.

Willard L. Thorp, Assistant Secretary of State, in a letter to Adolph Held, president of the Jewish Labor Committee, praised the J.L.C. for its submission to the Euran Rights Division of the United Nations of a petition wrains an inquiry into charges of cultural and spiritual genocide by the Soviet Union and its satellite nations against Jows, the Committee disclosed today.

"Although there are no appropriate means at the present time in the United Nations for the adequate consideration of this petition, we support the desirability of repeatedly calling these conditions to the attention of the civilized world," the Assistant Secretary declared. He emphasized that "no opportunity should be lost to press for the observance in the USSR and the other eastern European countries of the wrinciple of respect for human rights and fundamental freedoms."

U.S. MILITARY INTELLIGENCE INVESTIGATE USE OF ITS NAME ON "EIDERS OF ZION" FORGERY

WASHINGTON, July 8. (JTA) -- Military intelligence in Washington is investigating the fraudulent use of its name in connection with a new version of the "Protocols of the Elders of Zion" forgary. The new version carries a note which alleges that the material is based on information in possession of the U.S. Army's G-2 (Intelligence Section).

Meanwhile, the United States Military Academy at West Point, N.T., has been requested by the Anti-Defamation League of B'nai B'rith to look into the Academy's applications forms which now require applicants to state their religion.

JEWISH CONCRESS SUBMITS COMPIAINTS AGAINST SUMMER RESORTS PRACTICING DISCRIMINATION

NEW YORK, July 8. (JTA) -- A complaint that summer resorts in New York, New Jersey and New England are violating the civil rights law of this state was lodged by the American Jewish Congress with the New York State Commission Against Discrimination. In its complaint, the A.J.C. allessed that 49 resorts were circumventing the advertising policies of New York City newspapers by substituting the phrases "near churches," "near Christian churches," and "Protestant and Catholic churches nearby" for the terms "selected clientele," restricted clientele" and other phrases declared unlawful.

Similar complaints were directed to the New Jersey Civil Richte Commission, the Massachusetts Committee Academ Discrimination, the Commerciant Courieston, on Civil Richts and the Rhode Island Fair Employment Practices Commission, urging them to investigate and take action against hotels over which they have jurisdiction.

U.J.A. AGENCIES BUDGETED \$75,000,000 DURING FIRST HALF OF 1951; ATDED 628,000 JEWS

NEW YORK, July 8. (JTA) -- More than 628,000 Jews in Israel, Europe, Moslem lands and this country were aided to begin new lives or spaced suffering as a result of immigration, settlement and rehabilitation aid during the first six months of 1951 extended by agencies which receive their funds through the nationwide campaign of the United Jewish Appeal, Edward M. M. Warburg, U.J.A. general chairman reported today.

At the same time, Mr. Warburg revealed that while the United Jewish Appeal campaign was proceeding favorably in most communities, the U.J.A.'s constituent agencies—the United Palestine Appeal, Joint Distribution Committee and United Service for New Americans—were forced to earmark sums far in excess of U.J.A.'s cash income to carry out urgent settlement and absorption programs for homeless Jews arriving in Ierael, relief and welfare services in Europe and Moslem lands and aid to newcomers in this country. In all, during the six months, the U.J.A. agencies budgeted \$74,994,000 for their work, about one-third more than the cash funds received by the U.J.A.

"The discrepancy between what we have received and what U.J.A.'s agencies have found it necessary to devote to the critical situations facing them must serve to spur the communities still engaged in spring campaigns to strive to put these 'over the top' now, and to realize maximum cash on pledges in the shortest possible order," Mr. Warburg said. He called the current plight of Hungarian Jerry "alarming," and declared that the Jews of America must continue to keep more than 45,000 Jews alive in Hungary, through the aid we can provide through the Joint Distribution Committee.

Mr. Warburg also declared that Rumania will head the list of countries from which U.J.A. funds must help Jeve to emigrate to Israel in the next six months, though large numbers of Jevus would still have to be moved from critical areas in certain Moslem countries. "We have the opportunity," he said, "to take out about 8,000 Jews monthly from Rumania. We must bring them to Israel while there is still time."

In addition to the mass transfer of homeless Jews to Israel, Mr. Warburg reported, 250,000 distressed Jews received relief and welfare assistance in Europe, Worth Africa and the meat East in the past six months; and 6,740 displaced Jews from Europe were helped in entering the United States whils another 12,000 were aided in resetablishing themselves here.

WESTERN DIVISION OF CANADIAN JEHISH CONGRESS OUSTS LEFT-WING ORGANIZATION

TORONTO, July 8. (JTA) -- The Western Division of the Dominion Council of the Canadian Jewish Congress has endorsed the ounter of the United Jewish Repulse Order-a left-wing organization--from the Congress. The Western vote followed similar action by the Eastern and Central Divisions of the Congress.

Under terms of the approved resolution, the left-wing organizations are not to be "invited to send delogates to" this fall's national convention of the Congress, and are to be "refused permission to participate as electors of plenary session delogates." It also provides further "that appropriate steps be taken as of this day to terminate the affiliation and participation of the left-wing organizations, including the United Joyden Republe's Order" with the Congress.

The left-ring organizations were accused of violating Congress discipline on such major policy matters as the stand on the Stockholm Feace Appeal and Canadian participation in the Korean War.

JEWISH GROUPS IN ARGENTINA ASK PERON TO HUN FOR RE-ELECTION AS PRESIDENT OF COUNTRY

BURNOS AIRES, July 8. (JTA) -- A delegation of some 300 Jews representing various groups in the Jewish population of Argentina this week-end called upon General Juan Peron to urge him to accept the candidacy for re-election as President.

Among the delegation were representatives of banking houses, commerce, industry and the professions. The spokesmen for the group were: Moises Hyderman, secretary of Banco Israelita Rio de Ia Plata, the largest Jewish bank in the country; Jose Ventura, representing the Sephardic community and a co-president of the United Israel Appeal; and, Dr. Moises Slinin, president of the Ashkenazi community of Buenos Aires.

In reply to the statements of the Jewish leaders, President Peron said: "I feal that I am understood by you because you are intelligent and just and realistic, and because you contribute greatly to the welfare of this country by your activities. Nobody is more capelle of judging my government's work than you, a people who have suffered and endured. Therefore I am doubly appreciative of your humble comportment and pladae you justice and tolerance. I slowly rooted out all racial excesses," the President continued. "I not only appreciate your community, but I have come to love it for your sincerity and goodwill.

"We await your active collaboration in the political life of this country," the General said. "The party I lead pledges to acknowledge your cooperation. The new Constitution which was ratified in 1949 assures complete freedem and equality for all races and faiths, but your collaboration in its implementation is required. I always have acted and not just talked, and I expect you to do the same and to carry out the promise you made today with positive deeds."

Earlier, a Jewish delegation visited Mms. Eva Peron to thank her for her part in the sending of a large shipment of clothing to Israel. Mms. Peron also announced the granting of a permit to ship 100 tons of food from Argentina to Israel.

NEW PHILADELPHIA JEWISH MEDICAL CENTER WILL BEAR NAME OF PROF. ALBERT EINSTEIN

PHILADELPHIA, July 8. (JTA) -- Philadelphia's new Jewish medical center being created by the consolidation of the Jewish, Mount Sinai and Northern Liberties Hos-pitals will be known as the "Albert Einstein Medical Center," it was announced today.

The center will provide medical care, research and education to the people of Philadelphia without distinction of race or creed. A campaigm is now being conducted jointly by the Medical Center Building Fund and the Allied Jewish Appeal to help complete a \$5,000,000 fund for new buildings and equipment to be added to the existing facilities of the three hospitals.

AMERICAN NEORO PRESENTS A \$10,000 CHECK OF DAMON HUNYON CANCER FUND TO ISRAEL

LONDON, July 8. (JTA) -- A Damon Runyon Cancer Fund check for \$10,000 for the Habrew University Medical School and Hadassah Hospital in Jerusalem, was presented here by Sugar Ray Robinson, American Negro world's middleweight boxing champion, to a representative of the British Friends of the Hebrew University. The presentation was made at a dimmer at Windsor given by Jack Solomons, British fight promotor. Other checks were presented to cancer research foundations in England, Ireland, scotland and Norway.
