SECURITY COUNCIL MEETS TODAY ON ISRAEL'S AND JORDAN'S COMPLAINTS

UNITED NATIONS, N.Y., Oct. 18. (JTA) — Secretary General Dag Hammarskjold virtually asked the Security Council today to censure Israel for a "dangerous negation" of the Israel-Jordan armistice agreement by refusing to allow United Nations observers to operate freely inside Israeli territory in connection with the Israel army's recent reprisal raid against a Jordanian police fortress at Qualqilya.

At the same time, Mr. Hammarskjold told the Council that its own previous decisions indicated "clear and firm lines" leading to "condemnation of all acts of violence."

The Council is meeting tomorrow morning to consider Jordanian and Israeli complaints and counter-complaints dealing with recent reprisal raids by Israel and with Israels contention that Jordan is guilty of "persistent violations" of the armistice agreement. Israel charges further that Jordan has broken the cease-fire pledge it gave Mr. Hammarskjold last April.

Mr. Hammarskjold's letter to the Council was a preface to a new report received here today from Maj. Gen. E. L. M. Burns, chief of staff of the UN Truce Supervision, Organization. That report brought the UN's final count of casualties-resulting from the Qualqulya action, showing that the Jordanians suffered 48 dead while the Israelis lost 18 lives.

Israel-Arab Attacks Placed in Perspective

However, the report could be construed also as placing all of the Israel-Arab attacks and counter-attacks of the last 21 months into perspective, thus applying Mr. Hammarsk-jold's requested condemnation of "all acts of violence" against the Arab states as well as against Israel.

Gen. Burns informed the Council that in the 21 months ending September 31, 1956, Israel-Arab fighting along the various borders resulted in a total of 617 dead and 915 wounded. Of that total, Israel suffered 121 dead and 632 wounded; while the Arab casualties totalled 751, including 496 dead. Of the Qualqilya kaïd, he said; "The casualties resulting from this incident are the highest since the Gaza indident in April, 1952.

While Gen. Burns' report dealt in detail with the Qualqilya attack and included overall Israel-Arab casualty figures for the year of 1955 and the first nine months of this year, it made only indirect meterence to Israel's latest policy of boycotting the Israel-Jordan Mixed Armistice Commission and refusing to allow United Nations military observers to investigate matters affecting the Qualqilya raid on Israel's side of the border. Gen. Burns mentioned only that the UN probe of the Qualqilya incident was "Carried out on the Jordanian side with the cooperation of the Jordanian delegation."

In his preface, Mr. Hammarskjold pointed out that in the document General Burns stated that "one of the parties"—meaning Israel--"makes its own investigations which are not and cannot be made subject to check or confirmation by the United Nations observers, publishes the results of such investigations, draws its own conclusions from them and undertakes actions by its military forces on that basis."

"I endorse the view of the chief of staff," Mr. Hammarskjold told the Council, "that this is a dangerous negation of vital elements of the armistice agreement."

It is expected that tomorrow's Security Council meeting will hear statements on the Jordan and Israel complaints by Abdul Monem Rifai, head of the Jordan delegation, and Mordecai R. Kidron, acting chairman of Israe's delegation. It was seen as likely that the Council might adjourn until next week when Israe's delegation chief, Abba Eban, will have returned from consultations in Jerusalem.

LONDON REPORT ON SALE OF ARMORED CARS TO ISRAEL PUZZLES WASHINGTON

LONDON, Oct. 18. (JTA) - The British press reports today that 18 surplus armored cars have been cleared by U.S. customs for shipment to Israel. (In Washington no one at the State Department or Department of Commerce knew anything about such shipments. It was pointed out that there are certain types of vehicles which do not acquire export licenses, and that the vehicles might be in that category.)

ISRAEL AMBASSADORS START CONSULTATIONS WITH FOREIGN MINISTER

JERUSALEM,, Oct. 18. (JTA) -- Mrs. Golda Meir, Israel's Foreign Ministex, began consultations today with Israel's Ambassadors to Washington, London, Paris and Moscow who had been called home for urgent discussions in which Premier David Ben Gurion will participate this week-end.

The Ambassadors will report on talks they held at the Foreign Ministries of the contries to which they are accredited just prior to embarking for Israel. Mrs. Meir will brief them on government policy, the latest developments and the situation leading to and arising from Israel's boycott of the meetings of the Israel-Jordan Mixed Armistice Commission.

Upon arrival here last night, Abba Eban, Ambassador to Washington, said that Israel appears to be gaining ground in her fight-for freedom of passage through the Suez Canal. Her legal right is unchallenged, he said, but noted that there was considerable distance between legal rights and reality.

Yaacov Tsur, the envoy to Paris, reported that France's interest in Israel is rising and said that important personalities -- whose identity he would not disclose -- would shortly visit Israel.

Joseph Avidar, Ambassador to Moscow said that the only positive statement from the USSR had been made by Deputy Premier Anastas Mikoyan who, in a conversation with newsmen at a reception at the Afghan legation earlier this week, had agreed that Israel had the right, to send shipping through the Suez Canal. The government, Mr. Avidar cautioned, has made no official retatement on the matter.

SOVIET FOREIGN MINISTER REPORTED FAVORING SUEZ PASSAGE FOR ISRAEL

PARIS, Oct. 18. (JTA) - Soviet Foreign Minister Dmitri Shepilov was reported to the expressed himself in favor of freedom of passage through the Suez Canal for Israell shipping and cargo.

According to reports here, French Foreign Minister Christian Pineau, a luncheon guest yesterday of Mr. Shepilov, asked whether the Soviet statesman thought the principle of freedom of navigation through the canal without discrimination meant that Egypt could not interfere with Israeli shipping. Mr. Shepilov is said to have replied: "Gertainly. This is a principle that must be applied in all its force."

SENATE TO STUDY U.S. FOREIGN AID PROGRAM IN THE NEAR EAST

WASHINGTON, Oct. 18. (JTA) -- The Senate Foreign Relations Committee announced-today that former Ambassador James C. Dunn, a well known career diplomat, will make a survey of the U.S. Foreign Aid program in the Near East to study its effectiveness and future.

Mr. Dunn was U.S. political adviser to the supreme military command of the Medit erranean area. He served as Ambassador to France, Italy, Spain, Brazil, and in other posts.

BRITISH JET FIGHTERS ARRIVE IN JORDAN; CAME FROM BASES IN CYPRUS

LONDON, Oct. 18. (JTA) - British Royal Air Force jet fighters arrived in Jordan to reinforce British air units already stationed there, it was reported from Amman today. The dispatches said that a British Embassy spokesman in the Jordan capital would not say how many planes were expected.

Officials here, manwhile, stress that RAF Hunter jets reported flying from airfields in Jordan are not now based in that country. The Hunters flew in from bases in Cyprus and, according to one source, such flights have occurred often in the past. This same source insisted that it was most unlikely that the Jordan Air Force would be supplied with these modern jets.

NEED OF DIRECT ARAB-ISRAEL PEACE TALKS STRESSED BY ISRAELI DIPLOMAT

LACONIA, N.H., Oct. 18. (JTA) - Peace talks between Israel and the Arab states. constitute the prime need in the Middle East, Dr. Eliezer Yapou, a member of the Israel delegation to the United Nations, and the delegation's counsellor in charge of information, told the annual "U.N. Town Meeting of the World" here this week.

"The basic problem in the Middle East," Dr. Yapou said, "is how to make the Arab states sit down to talk about all the problems started by them with premeditated acts of force a few minutes after the establishment of our State--the consequences of which we still feel today."

The United States policy in the Middle East is not only to achieve peace there, but to obtain "peace with justice," the "Town Meeting of the World" was told by another of the speakers, Christopher H. Phillips, United States Deputy Assistant Secretary of State. Other speakers on the program were Dr. Mohammad Ali Massoud-Ansari, of Iran; and Rokhi Jaipal, a member of the Indian delegation to the United Nations.

NAZI PHYSICIAN GIVEN INCREASED FINE FOR TORTURING VICTIMS

BERLIN, Oct. 18. (JTA) -- Berlin's and Germany's last Denazification Court of Appeals increased from \$8,200 to \$12,000 a fine imposed upon Dr. Karl Genzken, former chief of the SS Medical Corps, who han American military tribunal less than ten years ago sentenced to penal servitude for life for cruel pseudo-eclentific tests to which he subjected concentration camp immates.

A small town physician, Genzken joined the Nazi Party as early as 1926 and eventually rose to the rank of a lieutenant general in the SS. He was found guilty in 1947 obarbarous spotted fever experiments on helpless human guinea pigs, but in 1954 received a parole. At his Denazification Court trial last year, he was given an \$8,200 fine and barred from participating in elections, holding public office or drawing a government pension.

in Bonn, two SS concentration camp guards notorious for their brutality have been indicted, almost a year after they were returned to Germany by the Soviet Union. "Iron Gustav" Sorge and "Revolver Bill" Schubert, the former an SS leutenant and the latter an SS sergeant, were among the most sadistic torturers and killers in the Oranienburg, Esterwege, Sachsenhausen and Riga concentration camps. It is expected that witnesses can be found for hundreds of murder, manishaughter and aggravated assault charges.

SIX JEWISH CHILDREN FROM POLAND ARRESTED IN CZECHOSLOVAKIA

TEL AVIV., Oct. 18. (JTA) -- Six Jewish children--two girls and four boys-who escaped from an orphanage in Wroclaw, Poland, and crossed the Polish-Czech border, have been sentenced to two and six-weeks! terms of imprisonment by a Czech court, it was reported here today. The report added that Poland had demanded their extradition.

According to the information available here, the children testified to the court which tried them that they had tried to cross the border in order to reach a point from which they might emigrate to Israel.

DR. GOLDMANN TO RECEIVE HEBREW UNIVERSITY AWARD FOR 1956.

NEW YORK, Oct. 18. (ITA) -- Dr. Nahum Goldmann, president of the Jewish Agency, will receive the Hebrew University-Solomon Bublick Public Service Award for 1956, it was announced today by Daniel G. Ross, president of the American Friends of Hebrew University.

The award, conferred in alternate years on an outstanding scientist or on "the person, Jew or non-Jew, who has made the most significant contribution to the progress and development of the State of Israel," will be presented to Dr. Goldmann at the organization's annual dinner, next Wednesday at the Waldorf Astoria Hotel.

The Bublick award has previously been given to four leaders-Pfemier David Ben Gurion of Israel; former President Harry S. Truman; and Hebrew University scientists, the late Prof. Eleazer L. Sukenik; Israeli archaeologists who recognized the historic importance of the Dead Sea Scrolls; and atomic scientist Prof. Giulio Racah, who heads the Jerusalem University's Department of Theoretical Physics.

DR. TELLER NAMED POLITICAL SECRETARY OF WORLD ZIONIST ORGANIZATION

NEW YORK, Oct. 18. (JTA) -- The appointment of Dr. Judd L. Teller, author and American expert on Middle East affairs, to the post of political secretary of the World Zionist Organization, was announced today by Dr. Nahum Goldmann president of the World Zionist Organization.

In accepting the new post, Dr. Teller resigned as director of Information and Publications of the Jewish Agency. He has been associated with Dr. Goldmann since February, 1952, both at the Jewish Agency and as press consultant to the Conference on Jewish Material Claims Against Germany and the Committee for Jewish Claims on Austria.

Dr. Teller's past posts included that of editor-in-chief of the Independent Jewish Press Service. American editor of the Palcor News Agency, which specialized in news from the Middle East; information chief of the World Jewish Congress, and director of the Office of Jewish Information of the American Jewish Congress. He served for several years from the founding of the United Nations as UN correspondent for Israel news papers. He was also a foreign correspondent for American newspapers.

Since 1937 he has frequently visited israel and other Middle Eastern countries, variously as correspondent and on behalf of the Jewish Agency. Dr. Teller is a trillingual author of books of literary criticism and political history, and his articles on Middle East affars and Hebrew-culture have been published widely in American newspapers, magazines and specialized periodicals.

U. J. A. STUDY MISSION ARRIVES IN ISRAEL; HEADED BY ROSENWALD

TEL AVIV. Oct. 18 (JTA) ... The United Jewish Appeal's eighty-man overseas study mission arrived here today to begin the Israel section of its tour. The group, composed of American Jewish communal leaders, immediately started discussions with the Jewish Agency. The discussions will be devoted to the problems of immigration and settlement. The group is headed by William Rosenwald, general chairman of the UJA.

HOUSTON, Texas, Oct. 18. (JrA) - An appeal to the United States Government to include Israel "among the initions within the mutual security system so that she may be granted military aid and be linked in America's collective security arrangement, "was voiced here last night at the concluding session of the four-day 42nd annual convention of Hadassah, the Women's Zionist Organization of America. The plea was included in a resolution adopted by the 2,500 delegates urging the U.S. to "strengthen Israel as an outpost of democracy and a bulwark against Communism."

The convention adofted a \$9,000,000 budget for the 1956-57 fiscal year to maintain Hadassah; health and medical network in Israel, the Youth Aliyah and American activities. The major expenditures forecast in the budget are: \$3,150,000 for the Hadassah Medical Organization; \$2,100,000 for Youth Aliyah; \$1,000,000 for the Hadassah-Hebrew University Medical Center; \$700,000 for the Jewish National Fund, and \$600,000 for vocational training programs in Israel. Dr. Miriam Freund of Ossining, New York, was elected Hadassah's tenth president, succeeding Mrs. Herman Shulman.

The resolution, introduced by Mrs. Rose Halprin, Hadassah's Zionist affairs chairman and only woman member of the Jewish Agency executive, said such a step would give "practical expression to the Middle East plans adopted by both the Democratic and Republican national conventions, which indicate a bi-partisan awareness of Israel's danger, and would serve as an American commitment to prevent a renewal of hostilities against-Israel. "The resolution stated also that "Hadassah views with apprehension the threatened intrusion of Iraqi forces into Jordan, recalling that Iray as one of the Arab states which made war against Israel and is the only one which never concluded an armistice agreement with her."

Another resolution urged the United States to combat intensified Communist propaganda in the Middle East by formulating "a well planned policy designed to raise the standard of living of the peoples of the Near and Middle East so that they may be helped to understand the benefits and responsibilities of freedom, and be encouraged to seek freedom for themselves."

A third resolution asked the United States Government "to insist that as part of any settlement of the Suez Canal controversy, Israel shall have the same rights as all other nations. Any other course of action would legalize discrimination and cut at the very roots of international justice."

Michael Comay, Israel's Ambassador to Canada, told the final banquet session that his nation's army was "\$\frac{1}{2}\$ formidable fighting force." He emphasized that no "Arab army or any combination of Arab armies can put Israel out of business." At an earlier session, Cecil Hyman, Israel's consul-general in New York, praised Hadassah's vocational education program, asserting that this effort was providing Israel's newcomers with necessary skills 'to build a modern progressive state."

U.S. LABOR ZIONIST CONVENTION OPENS; WILL RE-DEFINE IDEOLOGY

LAKEWOOD, N. J., Oct. 18. (JTA) -- The 30th national convention of the labor Zionist Organization of America opened here today with leading personalities from Israel in attendance.

The convention will seek to redefine the Labor Zionist ideology in terms of presentday needs and interests arising out of the changed conditions of life in the United States, especially since the establishment of Israel. The restatement of principles of Labor-Zionism has been under discussion by the organization during the past two years.

The convention will be addressed by Dr. Dov Joseph, former member of the Israel Cabinet, Berl Locker, member of the Knesset and former co-chairman of the Jewish Agency executive, and Zev Argaman, Minister Counselor of the Israel Embassy in Washington, Itzhak Harcavi of Tel Aviv, Secretary General of Ichud Olami, the World Union of Labor Zionist Organizations; Eliahu Dobkin of, Jerusalem, and Louis Segal of New York, members of the executive of the Jewish Agency.

JEWISH AGENCIES IN PHILADELPHIA CONSOLIDATED IN SINGLE FEDERATION

PHILADELPHIA, Oct. 18. (JTA) - The creation of a single central organization for the health, welfare, communal and humanitarian work carried out by Philadelphia Jews has been accomplished here with the official birth of the new Federation of Jewish Agencies of Greater Philadelphia. The new central body is a product of the merger of the Federation of Jewish Chanties, founded in 1901, and the Allied Jewish Appeal, established.in. 1918. The body officially came into existence with the recording of an order approving the consolidation by Judge Curtis Bok here.

A The Articles of Consolidation signed by Judge Bok revealed that the new Federation started its existence with lassets of \$4,900,000, of which \$300,000 is in real estate and the remainder in Cash, securities and other personal property. Abrahami L. Freedman, president of the new organization, stressed that the funds will be used only for the purposes formerly served by the agency to which they were originally donated. Foremost among the tasks facing life new group, he added, were participation in the current United Community Campaign.here and preparation for the 1957 Allied Jewish Appeal drive.
