1, 291 CANDIDATES LISTED OFFICIALLY IN ELECTIONS TO ISRAEL PARLIAMENT

JERUSALEM, Oct. 20. (JTA) -- A total of 1, 291 candidates are bidding for the 120 seats in Knesset, Israel's Parliament, in the November 3 national elections, according to lists published today in the Official Gazette.

The Gazette reported also that 112 of the outgoing Knesset members are running for re-election with 92 of them assured of winning again. Eighty-four of the candidates are women.

A breakdown by professions showed that 300 of the candidates are clerks, 230 are farmers, 68 are exerchants, 120 are teachers, 64 are newspapermen, 79 are attorneys, 43 are professional politicians and 24 are housewives; 380 candidates are under 40 years of age and 40 candidates are 70 and over.

David Ben-Haroush, the self-styled leader of the North African settlers in Israel, serieased from prison yesterday for 24 hours to speak on behalf of his Knesset candidacy over Kol Israel, the Israel radio,

Ben-Haroush, who was sentenced to a two-year prison term for participation in the Haifa July rioting, heads a North African immigrants list in the forthcoming election and was therefore allotted time with other party leaders to explain his platform on the radio.

Supreme Court Justice Yoel Sussmann who heads the Central Elections Commission, may be unable to vote in the elections next month to the Knesset, Israel parliament. When he found himself listed in the woters register as "Sissman," he requested that the misspelling be corrected. He is now listed as "Suissmann," which may diaqualify him from casting his ballot,

BRITAIN SEEKS LIFTING OF ANTI-ISRAEL BLOCKADE OF SUEZ, MINISTER SAYS

UNITED NATIONS, N.Y., Oct. 20, (JTA) -- David Ormsby-Gore, Britain's Minister of State for Foreign Affairs and new chairman of London's delegation to the current General Assembly, today told the Jewish Telegraphic Agency that his government is in diplomatic negotiations aimed at lifting the United Arab Republic anti-Israel blockade of the Suez Canal,

Mr. Ormsby-Gore was questioned on the Suez issue at his first meeting with the press here since his arrival to head the British delegation. Considered Britain's topmost expert on disarmament, it is also the ranking representative of the Foreign Office in London who, most frequently, replies to questions in the House of Commons on issues dealing with Middle East tensions, including the Arab-Israel dispute.

The JTA asked him what his government was doing about Israel's Suez grievance currently since Selwyn Lloyd, Britain's Foreign Secretary, and 25 other delegation chairmen, including more than 15 Foreign Ministers, have reindorsed the principle of freedom of navigation as it applies to the Suez Canal.

"Our policy," he replied, "was stated in the Assembly by Mr. Lloyd. Now we are pursuing the subject and will continue to pursue the subject. However, we are relying on diplomatic negotiations, rather than on public debate. We feel that this is the best contribution we can make on this issue at this time."

Those "diplomatic negotiations" it was believed, were being conducted by Britainher, as well as through contacts with the UAR Embassy in London and with the Egyptian Foreign Ministry in Cairo. Mahmoud Fawzi, the UAR Foreign Minister, who came
to the UN three weeks ago, is still here and it was believed that he was being contacted
on the Suez issue both by Mr. Ormsby-Gore and by UN Secretary General Dag Hammarsijold.

On the topic that interests him most immediately—the issue of comprehensive world disarmament, which is being debated today—Mr. Ormsby—Gore took a stand at his press conference rejecting proposals that the Big Powers agree to use the Middle East region as a "disarmament pilot plant." Such a proposal we made here in the past by Abba Eban, former head of the Israel delegation at the UN while "area disarmament" was proposed here at the current Assembly by Ireland,

ARMISTICE BODY TO DISCUSS ALLEGED EXPULSION OF BEDUIN BY ISRAEL

JERUSALEM, Oct. 20. (JTA) -- The Jordan-Israel Mixed Armistice Commission with lold an emergency session Thursday to discuss a Jordanian complaint that Israel recently allegedly expelled more than 100 Beduin from the Negev into Jordan.

The Commission held a brief formal session last night but the results of a United Nations investigations were not yet available. Israel sources demand that any Israel Beduin have been expelled to Jordan,

The United Arab Republic two weeks ago lodged a similar complaint with the Israel-Egyrtian Mixed Armistice Commission after a clash between a group of Beduin and an Israel Army patrol investigating the murder of an Israel officer near the Egyptian border.

It was indicated here that the Beduin involved were the several thousand nomads, living most of the time in 'Agypt or Jordan, who often cross into the Negev with herds grazing in Arab territory.

Israel normally does not interfere but there was reported reason to believe that some of the Beduin have been trained by Egyptian intelligence and have conducted sabotage and murder in Israel. Israel authorities therefore decided to make these Beduin unwelcome.

FRANCE ASSURES ISRAEL THAT RENAULT CASE WILL NOT AFFECT FRIENDSHIP

JERUSALEM, Oct. 20. (JTA) -- The French Government has given Israel assurances that the decision of the Renault company to end car assembly operations in Israel will not affect Franco-Israel friendship, it was learned today.

The reassurance was given when Mordechai Shneerson, Israel Charge d'Affaires in Paris, handed to Maurice Cours de Murville, the French foreign minister, a note explaining Israel's views that the Renault action may influence other foreign companies to bow to the Arab League boycott against Israel.

Renault officials contended again today that high production costs and high Israel taxes made Renault participation in the Haifa assembly plant of the Israel Kaiser-Frazer company uneconomic and that this was the major factor for the decision.

Gen. Moshe Dayan, former Army Chief of Staff, declared last night that Israelis must not be influenced by the Renault cancellation. Speaking as a candidate for a seat in the Knesset, Israel's Parliament, Mr. Dayan said that France was a friend which helped Israel in its darkest hours and such friendships must be carefully cultivated.

Israel Cabinet Body Hears Plan on Replacing Renault Autos

JERUSALEM, Oct. 20. (JTA) -- An Israel Cabinet Interministerial committee met today to consider a proposal of officials of the Kajser-Frazer assembly plant in Haifa to manufacture a small car locally following the decision of the Renault company to cease assembling its Dauphine at the Haifa plant,

It was reported that Kaiser-Frazer officials said they could produce a complete car. Some of theparts would be locally produced and the rest would be bought from specialized manufacturers in accordance with automobile industry practices. The officials indicated this could be achieved within 18 months.

The officials reportedly told the Interministerial committee that manufacturing costwould probably be higher than the arrangements affected by the French auto firm's decision to halt Israel operations. They suggested that the Israel Government should reduce excise and purchase taxes on such locally-made cars to keep retail prices at a competitive level.

Kaiser-Frazer of Israel to Sue Renault for \$2,000,000 Damages

TEL AVIV, Oct. 20. (JTA) -- The Kaiser-Frazer company in Israel will sue the Renault auto firm of France for \$2,000,000 in damages for breach of contract, Ephraim Illin, general manager of the Israel company, announced today.

Mr. Illin cited documents relating to the current agreement between the two companies, dated February 27, 1959, which permits cancellation of contract without damages only if the Government of France banned the supply of car parts to Israel for assembly here.

He said that this was not the reason given by Renault for ending the agreement under which the French firm's Renault was assembled in the Haifa factory of Kaiser-Frazer. The company's attorneys have started collected material for the damage suit.

Renault car owners in Israel had some consolation. The Arab boycott regulations, to which it was presumed Renault bowed in cancelling the agreement, do not ban shipments of spare parts to Israel.

BONN HAS SUFFICIENT EVIDENCE TO START PROSECUTION OF EICHMANN

BONN, Oct. 20. (JTA) --- "We have sufficient evidence to start criminal prosecution against former SS leader Adolf Eichmann, if he should be extradited to West Germany," the Federal Government's chief prosecutor, Dr. H. Wolf, today told the Jewish Telegraphic Agency.

Eichmann, head of the "Jewish Section" of the Gestapo during the Hitler ragime, has been reported residing in the sheikdom of Kuwait. He has been held responsible for actually issuing the orders that resulted in the extermination of 6,000,000 European Jewa.

Dr. Wolf's assertion that there is enough material on which to base a firm legal case against Eichmann is supported by State Attorney Erwin Schuele, director of the Gentral War Crimes Investigation Commission. Furthermore, Dr. Wolf is known to have amassed documentary proof to support a legal case against Eichmann through his investigation of the charges of mass murder against Eichmann's principal assistant, Hermann Krumey. The latter is now being prosecuted by Dr. Wolf for organizing the deportation of 450,000 Hungarian Jews to death camps in the summer of 1944.

Meanwhile, it became known here today that Interpol, the International Police organization, is continuing its investigation into the whereabouts of Eichmann, Interpol is known to be cooperating in this probe with Israeli police authorities.

UNITED HIAS WORLD CONFERENCE ON JEWISH MIGRATION OPENS IN PARIS

PARE, Oct. 20. (JTA) -- The United Hias Service is currently giving vital migration and integration aid to close to 1,000 persons per month, James P. Rice, executive director, reported here today at the opening session of the organization's sixth annual migration conference at the UNESCO building here.

Jewish migrations during World Refugee Year is the theme of the current United Hiss conference which will hear reports of organization representatives from Europe, the United States, Canada, Latin America, North Africa, Australia and Israel. The organization celebrates its 75th anniversary this war.

A United Hias Service report issued at the meeting shows that, in the course of the past five years, the agency has helped resettle 37,000 persons in the United States and other lands. In the first half of 1959, more than 6,000 men, women and children were assisted by Hias,

Among the speakers at the opening session were Charles Jordan, overseas director of the Joint Distribution Committee and co-chairman of the International Committee for World Refugee Year; Harold Trobe, director of European and North African operations of United Hias, and Paul Pelletier, of the French Ministry of the Interior.

5,000 JEWS IMMIGRATED TO BRAZIL IN TWO YEARS; MAJORITY INTEGRATED

RIO DE JANEIRO, Oct. 20. (JTA) -- Approximately 5,000 Jewish immigrants have come to Brazil since 1957 under an agreement between United Hias Service and the Government of Brazil, it was reported here today. The immigrants included 2,804 Egyptian Jews who were brought to Brazil when the Egyptian Government declared Jews to be stateless persons after the 1956 Sinal campaign.

All of the immigrants were completely accepted. The Roman Catholic Church had a major role in helping to develop the program conducted by Hias. The Egyptian Jewish newcomers, whose transportation and resettlement was handled by Hias and Jewish groups here, have integrated themselves with substantial success, it was reported.

The majority of the Egyptian Jews had special skills or experience in managerial responsibilities. It was relatively easy for them to learn Portuguese. Their assimilation in Brazil was termed rapid and smooth.

A. J. C. PRESIDENT FINDS HUMAN RELATIONS PROBLEMS 'MOST EXPLOSIVE'

NEW YORK, Oct. 20 (JTA) -- Human relations problems, particularly those involving racial and religious prejudice, can be "the most explosive evil of our time," Herbert B. Ehrmann, president of the American Jewish Committee, warned here last night,

He stressed that "government on all levels--city, state and federal--have a primary duty to initiate, encourage and support research and function in the many diverse areas of human relations." He declared that voluntary agencies alone cannot handle this potentially dangerous problem. Mr. Ehrmann spoke at the annual meeting of the AJC's New York chapter.

Mr. Ehrmann declared that "the urgent requirements of national security" demand "a massive research and action program" into the causes of intergroup and interracial problems by the government and private agencies, "The young science of human relations must have a top priority in our government's budgets if we are to find new ways dealing with the compelling problems of group hostility and social upheavals," he said,

PHILADELPHIA POLICE COMMISSIONER APOLOGIZES FOR SLUR ON JEWS

PHILADELPHIA, Oct. 20. (JTA) -- The Daily Pennsylvanian, student newspaper at the University of Pennsylvania, reports that it has received an apology from Thomas J. Gibbons, Philadelphia Police Commissioner, for using the phrase "Jewish appearance" in a police flyer posted around the university after a stabbing in the area.

The apology was received after the student newspaper protested in an editorial that the use of such a term was not in the public interest and so nebulous that it might ever be applied to Abdel Nasser, President of the United Arab Republic.

The Police Commissioner said, in his reply: "Personally, and on behalf of the entire Police Department, will you please accept my humble apologies for the injudicious wording of our recent wanted circular." He added that the wording was not that of the department but a "word-for-word" description given to police investigators by a presumed witness to the stabbing.

FORMALITIES ON SWOPE'S \$7,000,000 BEQUEST TO TECHNION COMPLETED

NEW YORK, Oct. 20. (JTA) -- The estate of approximately \$7,000,000 bequeathed by industrialist Gerard Swope to the Israel Institute of Technology, will now be available in full to the Technolon following the filing yesterday of a transfer tax appraisal with New York State tax authorities.

The bequests of Mr. Swope, who died November 20, 1957, came from his personal estate and a trust left by his wife, who died October 28, 1955. The industrialist left \$691, 909 from his own estate to the Techninn Society for its loan fund and to provide advanced study for Technion graduates at the Massachusetts Institute of Technology.

NUMBER OF ASIAN AND AFRICAN STUDENTS IN ISRAEL WILL BE DOUBLED

JERUSALEM, Oct. 20. (JTA) -- The Israel Foreign Affairs Ministry reported today that the number of Asian and African students and experts training in Israel will be doubled next year to a total of about 350,

A spokesman said a second group of Burmese officers and war veterans will arrive in January for a year of agricultural training. The arrival will take place after the first group, made up of 40 families, finishes a one-year stay at Israel collective settlements. After returning to Burma, the families will establish border settlements engaged in both farming and defense along Israel patterns.

A special seminar for Afro-Asian experts on housing and village development will be opened soon in Israel. Plans are under way also to establish a permanent institute for Afro-Asian farm experts,

25,000-VOLUME LIBRARY OF HERMAN WOUK'S GRAND FATHER GIVEN TO ISRAEL

JERUSALEM, Oct. 20. (JTA) -- The 25,000-volume library of novelist Herman Wouk's grandfather, the late Rabbi Menahem Leib Levin, was presented yesterday to the Supreme Religious Center, the Heichal Shlomo, at a ceremony attended by rabbis and writers.

Mrs. Esther Wouk, the novelist's mother, made the presentation. She also donated 1,000 pounds to the Free Loan Fund named after Rabbi Levin.

THREE-VOLUME BRAILLE EDITION ON JEWS IN U.S. PRESENTED TO AUTHOR

NEW YORK, Oct. 20. (JTA) -- At a ceremony held today in the office of the Consul-General of Israel here, Moste Davis of the Jewish Theological Seminary, received a three-volume Braille edition of his book, "Jewish Religious tions in America," on the eve of his departure for Israel,

The book is based on a chapter in a larger work called, "The Jews: Their History, Culture, and Religion," edited by Dr. Louis Finkelstein, chancellor of the Jewish Theological Seminary. The Braille copy of Prof. Davis' book was presented to him by the managing director of the American Committee of the Cerral Library for the Blind in Israel, Mrs. Shoshana Shochett, blind herself.

Dr. Davis, who is Provost of the Jewish Theological Seminary and Associate Professor of American Jewish History there, will depart for Israel on October 28 on a two-year leave-of-absence to take up the post of founding head of the newly established institute of Contemporary Jewry at the Hebrew University in Jerusalem,

ANNE FRANK FUND ESTABLISHED IN COPENHAGEN; TO HELP CHILDREN IN ISRAEL

COPENHAGEN, Oct. 20. (JTA) -- An Anne Frank Foundation, to support the education and training of homeless children in Israel, was established here today. The Foundation's president, Margarethe Bohr, is the wife of the Nobel prize winning physicist, Professor Niels Bohr. In a radio appeal to the public to contribute to the Foundation, she said: "We could not help Anne Frank, but we can help her brothers and sisters to a better future,"
