SYRIANS REOPEN FIRE AGAINST ISRAELIS; ONE ISRAELI KILLED, TWO WOUNDED

JERUSALEM, Jan. 31. (FTA) -- One Israeli border patrolman was killed, and two injured, when Syrian gun posts and mortar batteries reopened fire at noon today, for the fourth successive day, against Israelis near the settlement of Tel Katzir, in the demilitarized zone southeast of Lake Tiberias.

Prime Minister David Ben-Gurion is in constant touch with the situation, while the Foreign Ministry has taken up the matter with the United Nations Truce Supervision Organization as well as with the United Nations Secretariat in New York. The Cabinet, at its session here today, discussed the Syrian border flare-up, going into the national security and foreign relations phases of the Syrian incursions.

As on previous days, Syrians disguised as "farmers," but wearing soldiers' boots, entered the area and started cultivating the land in the demilitarized zone. When the Syrians were challenged, the "farmers" opened fire, and were supported by heavy firing from emplacements on the Syrian side of the frontier. The patrolman killed had been pinned down by firing which kept would-be rescuers from reaching the fallen man.

At nightfall, the firing subsided, but the tension in the area prevailed. According to the Israelis, the issue concerns a Syrian effort to establish sovereignty over a small plot of land on the Israeli side of a drainage canal dug there with the consent of the UN Truce Supervision Organization.

The land in dispute comes fully under Israeli jurisdiction, and the Syrians have no role whatever in any arrangements that might be made concerning that land between Israel and the UN Truce Supervision Organization,.

Israel notified the Chief of Staff of UNTSO two weeks ago that it is willing that he mediate the dispute over this plot of land with Syria, but only in an atmosphere of calm and not under pressure of force.

#### U. N. Military Observers Endangered by Firing from Syria

Israel has now protested to UNTSO not only about the latest shootings but also about the overflights, over Israeli territory, Saturday, of two Syrian, Russian-type MIG-17 fighter planes.

Yesterday, Col. Raymond Pirlot, of Belgium, chairman of the Israel-Syrian Mixed Armistice Commission, arranged a cease-fire twice. During one of these lulls, the UN team was able to extricate some of its military observers who had been endangered by firing from the Syrian side.

Brigadier Meir Zorea, Israeli Army commander in the region, told military correspondents at his headquarters today that Israel is determined to maintain the status quo in the region and will not permit Syrians to establish "new facts."

Exhibiting heavy mortar shells fired by the Syrians in the current series of clashes, the general charged that the Syrians have concentrated large units in their section of the frontier. He said they are trying "to impose their sovereignty over land which is officially in Israeli demilitarized zone. "

#### 'FULL REPORT' ON U.S. NAVY'S ENDORSEMENT OF ARAB BLOCKADE REQUESTED

NEW YORK, Jan. 31. (JTA) -- Senator Kenneth B. Keating, New York Republican, said today that he has asked Secretary of the Navy William B. Franke, "for a full report on the Navy's policy precluding American shippers who deal with Israel from bidding for Navy contracts to carry goods of the American Government through Suez. "

He asked the reasons for the Navy's policy of endorsing the Arab blockade and inquired whether the Navy has taken any steps to protest or oppose the Arab boycott. He made announcement of his inquiry into Navy policy at a reception bonoring the 70th birthday of Rabbi Herbert S. Gbidetein by the World Academy in Jerusalem at the Hotel Plaza here.

Senator Keating stressed that the Navy's shipping methods were exposed on the "heels of the World Bank's endorsement of the Ashb boycott in loaning the United Arab Republic \$56, 000, 000. " He said "This will never do, Official American Government policy cannot and must not back the wholly indefensible tactics of Israel's hostile neighbors."

# HOUSE TO VOTE TODAY ON RESOLUTION CONDEMNING SYNAGOGUE DESECRATIONS

WASHINGTON, Jan. 31. (JTA) -- A resolution expressing Congressional indignation at desecration of places of worship will be voted today in the House. The resolution was initiated by Rep. Barratt O'Hara, Illinois Democrat. A Senate version of the same resolution was introduced this weekend in the Senate by Senator Jacob K. Javits, New York Republican.

Senator Javits said in a speech on the Senate floor that the bombing of a synagogue this weekend in Kansas City was evidence that "bigoted elements" would not hesitate to use violence "to tring fear to members of one religious faith, " He emphasized that this is only the latest manifestation of religious hatred in this country and abroad. The bombing indicated that those who thought the recent swastika episodes were "little pranks by young boys," were seriously mistaken, he added.

Bernard Abrams, national commander of the Jewish War Veterans, commenting on the bombing of the synagogue in Kanasa City, today sharply criticized Congress for failing in its responsibility to the American people in its inadequate attention to legislation that would make the bombings of places of worship and other public buildings a federal offense.

"With each new outrage, it becomes more and more apparent that Congressional paralysis has kept the United States from mustering all of its national police resources to ferret out the perpetrators of these crimes," be said. He urged the Congress to enact legislation immediately directing the FBI to enter into these cases.

#### F. B. L. Intensifies Investigation of Bombing of Kansas City Synagogue

KANSAS CITY, Mo., Jan. 31. (JTA) -- At least 40 high school students, and perhaps as many as 80, may be involved as members of Nazi youth groups here whose aim is "to get rid of all Jews and Negroes," it became known today while the FBI and the local police intensified their investigations of the bombing of the local synagogue.

The bombing, in which the FBI found dynamite had been used, took place last Thursday night at Kehilath Israel Temple, where 51 windows were shattered by the explosion. The only occupants of the house of worship at the time of the explosion, were the caretakers who were in their apartment in one wing of the synagogue. They were not hurt. A swastika had been painted on the front of the synagogue a day before the explosion, and another swastika was discovered at another synagogue nearby, three days earlier.

Federal Bureau investigators and local police said today they found that some of the self-styled student Nazis possessed Nazi-type uniforms, arm-bands bearing the swastika, daggers, and literature calling for ridding the community of Jews and Negroes. At least 12 boys, teen-age membera of a group called the Nordic Reich Group, are being questioned.

The youths arrested so far are students at East High School and Southeast High School here. In the school locker of one of the youths, the FBI found a statement of the group's purpose, declaring: "Our party is joining with the National Socialist German Workers Party. Our founder is Adolf Hitler. The war ended in 1945, but the ideas of the control of

#### American Jewish Organizations Call for More Police Vigilance

NEW YORK, Jan. 31. (JTA) -- Six major Jewish organizations issued a joint statement calling upon the police authorities to redouble their vigilance to prevent such acts as the bombing of the Kanasa City synagogue and the daubing of swastikas to apprhend those who commit them. The organizations included the American Jewish Congress, Jewish Labor Committee, Jewish War Veterans of the United States, Union of American Hebrew Congregations, Union of Orthodox Jewish Congregations and United Synagogue of America. The statement was issued through the National Community Relations Advisory Council.

Three youths, aged 17 to 21, were sentenced in New York this weekend to 90-day Jail sentences, after being convicted of disorderly conduct for strutting through Union Square, giving the Nazi salute and shouting "Heil Hiller." Magistrate Vincent Rao, who sentenced them, said the youths "certainly knew that their actions tended to provoke a breach of the peace." A Bronx rabbi attending a rally in the Square had lodged the original complaint against them.

# Jewish Youth Parley Blames Schools for Teen-Age Anti-Semitic Acts

WASHINGTON, Jan. 31. (JTA) -- American schools may be partially and indirectly responsible for the recent rash of teen-age anti-Semitic acts because of failure to teach more about "crimes of Hitler era," says a resolution adopted here today by the national executive boards of Aleph Zadik Aleph and B'nai B'rith Girls--teen-age boys and girls divisions of the B'nai B'rith youth organization. The B'nai B'rith-sponsored youth movement has some 38,000 members throughout the United States and Canada.

The resolution, adopted at the close of a three-day meeting, called on school authorities "to hold up a mirror to our educational system to determine what efforts are being made to teach youth about the evils of totalitarianism and intolerance," The resolution urges Catly that the "history of the Hitler era should be taught in schools,"

## GOLDMANN REPORTS ON GERMAN ACCELERATION OF INDEMNIFICATION CLAIMS

AMSTERDAM, Jan. 31. (JTA) 7- Dr. Nahum Goldmann, president of the Conference on Jewish Material Chims Against Germany, expressed gratification, at copening meeting of the Conference board of directors here last night, over the acceleration of German settlement of indemnification claims during the second half of 1959. But Dr. Goldmann expressed "lesvious deuth" as to whether the indemnification debt to Jewish victims of Nasism will be repaid in full by the March 31, 1963 deadline for such completion, set by the West German law on the subject.

At the same time, Dr. Goldmann commended the speed with which West Germany is meeting its reparations obligations to Iarael. Last year, for the seventh year in succession, Dr. Goldmann raid, Germany has met its schedule of reparations payments to Israel as agreed upon in 1952. During 1959, he reported, Israel received from Germany goods and services valued at \$60, 714, 085, bringing the amount since that program was launched, to a total valued at \$452, 380, 152.

By the middle of 1959, Dr. Goldmann stated, the Conference found the slow pace of indemnification processes for individuals "serious enough" to warrant an unprecedented meeting, which was held between the Conference, Chancellor Konrad Adenauer, German Finance Minister Franz Etsel, and the presidents of all the West German states. At that meeting, the Conference, according to Dr. Goldmann, pointed out the following shortcomings:

- Out of the \$619,000,000 in indemnification payments budgeted for the fiscal year, the state and federal governments had paid out only 60 percent.
- Two-thirds of the 2,814,000 claims for individual indemnification filed under the German Federal law wife. the individual states had not yet been settled, although processing of the claims had been going on for five years,

"We outlined to the Chancellor and to the Minister-Presidents," Dr. Goldmann reported, "a nine-point program, essential, in our view, for completion of the adjudications by the 1963 deadline." The program included a call for increased staffs at indemnification offices; coordinated administrative procedures; and exploration of the possibility of standardizing procedures and settlement of administrative difficulties by agreement among the German states.

#### Wants Germany to Indemnify Nasi Victims from Rumania and Hungary

"We are deeply disturbed," Dr. Goldmann said, "by the recent manifestations of an incorrigible minority. If these acts are not checked immediately, they may set up a chain reaction which will prove difficult to check, and will obliterate the influence of those who have brought Germany back into a respected position."

Compensation, said Dr. Goldmann, will be "of significance only if accompanied by moral regeneration," The compensition picture, he stated, showed "gratifying acceleration" since the mid-year meeting in two of the German states--Rhineland-Palatinate and North Rhine-Westphalia--which have jurisdiction over 50 percent of the individual Jawish claims. But "in some other states," said Dr. Goldmann, "recent results have proved disheartening."

Indemnification payments made during the past decade, the Conference president reported, have reached a total of \$1,660,411,428 as of September 1959. He expressed, on behalf of the Conference, "profound disappointment" over the failure of the German states to take steps toward the indemnification of victims of Nazism from Rumania and Hungary, At stake, the figures show, are the claims of some 40,000 claimants from Rumania and about 1,000 from Hungary.

"Even with the recent pick-up in the tempo of payments." Dr. Goldmann declared, "it appears unlikely that the target will be reached by the deadline of March 31, 1963. We are therefore intensifying our contacts with German indemnification authorities." Dr. Goldmann paid tribute to The Netherlands and the Dutch people for "having displayed their solidarity with the Jews during the Nazi era."

#### KLUTZNICK CONFERS WITH ADENAUER; RABBI PRINZ PREACHES IN COLOGNE

BONN, Jan. 31. (JTA) -- While Philip M. Klutznick, American Jewish leader, conferred here this weekend with Chancellor Konrad Adenauer, discussing the recent wave of anti-Semitism, steps were taken here by the Social Democratic Party to outlaw the Bavarian section of the German Reichs Party, some of whose members were involved in the Cologne awastika-daubings last Christmas Eve which sparked the resurgence of anti-Semitic outbreaks.

Rabbi Joachim Prins, president of the American Jewish Congress, who had been rabbi of the leading synagogue in Berlin until he secaped from the Nazi regims, preached the Sabbath sermon yesterday in the Cologne synagogue where Christmas Eve swastika daublings set off the recent wave of anti-Semitic malifestations, and called upon West Germany to pick up the lag in its "mooral education."

Asserting by was certain that Chancellor Adenauer and his Government 'want friendship with the Jews," Dr. Primm said "the success of this desire depends very much an the ability of the churches, schools and universities to educate the people."

### WORLD CONFERENCE OF JEWISH ORGANIZATIONS PLEADS FOR SOVIET JEWS

AMSTERDAM, Jan. 31. (JTA) -- The recent manifestations of anti-Semition, as well as the situation of the Jows in the Soviet Union, were reviewed here this weekend at a special session of the Conference of Jewish Organizations, with representatives of Jewish organizations from five continents in atendance.

Major resolutions adopted dealt with the anti-Semitic outbreaks, and with an appeal to the Soviet Union to halt its anti-Jewish campaign which, in the opinion of the Conference, "may have a bearing on the recont anti-Samitic outbreaks,"

The Conference expressed the hope that, in the atmosphere created by the scheduling of early East-West summit meetings, "Jewish problems may also find a solution." The group then expressed "concern at the situation of the Soviet Jews who are still denied facilities granted other minorities."

In the opinion of the Conference, recent anti-Jewish attacks in the Soviet press and over the Soviet radio may have had a bearing on the new wave of anti-Semitism in other countries outside the USSR. The resolution then appealed to the Soviet Government to halt such anti-Jewish campaigns and to "restore to Soviet Jewry the right to emigrate freely to Israel and to other lands, in order to requify families and to otstablish contact between Jewish religious and communal organizations in the Soviet Union. and Jewish communities abroad."

A reparate resolution expressed "sinck" at the recent outbreak of anti-Semitism which, "beginning in Germany, spread to many other lands." The Conference "welcomed" the position taken on this subject in the United Nations and by various governments, underlining "the need for further legal action to eliminate the spread of this racial and religious harted."

Still another resolution dealt with the Arab League's hoycott against Israel, and called for masures to fight against the boycott. Under the chairmanship of Dr. Nahum Goldmann, the Conference also debated a detailed report about Jewish education, and voted to summon a worldwide conference, representative of all trends in Jewish life, to deal with the problems of Jewish education.

#### Z.O.A. EXECUTIVE COUNCIL ANALYZES ISRAEL'S 'SETBACKS' IN WASHINGTON

NEW YORK, Jan, 31, (174) -- Declaring that Israel has recently suffered "set-backs" in Washington through the U.S. Navy's support of the Arab boycott and the vastly increased Arcerican aid to Nasser, the National Executive Council of the Zionist Organization of America, at the conclusion of a two-day meeting here today, issued a call for the strengthening of the Zionist movement in this country.

The ZOA Council also adopted a resolution urging the newly appointed United Nations Commission to study worldwide anti-Semitism to devote its attention to the activities of what was described as "a center of Nazism" in Cairo, Egypt, operating under the direction of a former head of anti-Semitism under Hitler.

A call was also issued for the sale of 300,000 Shekalim by members of the ZOA for forthcoming World Zionist Congress, which is scheduled to be held in Jerusalem in freember 1960.

Abraham Redelheim, ZOA president, told the assembled Zionists from all parts of the country that "the deterioration in the degree of American public support for lards is just claims coupled with the growing pro-Arab position of the State Department and U.S. policy of appeasement of Nasser seems to be in direct ratio with the extent the organized Zionist movement has been downgraded by Israeli leaders."

Dr. Emanuel Neumann, member of the Jewish Agency executive, predicted that as a result of the revised constitution of the World Zionist Organization, it may be expected that some new organizations will be represented at the next Zionist Congress by fully qualified or fraternal delegates, "thereby enhancing the representative character of the Congress as the greatest forum of world Jewry."

He reported that the revised constitution, which was adopted at the recent session of the Zionist Actions Committee in Jerusalem, clarifies the status of affiliated member-organizations and explicitly confirms the full autonomy of American Ziusist bodies linked with the world Zionist movement. The revised constitution also confirms the policy of opening the doors for the entry of new organizations not hitherto affiliated. Under special provisions they may now join the Zioniet movement either as full-fledged members or as associated organizations on a more limited basis, he said.

Dr. Max Nussbaum, chairman of the ZOA Executive Council, asserted that the recent resurgent wave of anti-Semitism points to "a new conspiracy of informational fascism, the wires of which are pulled by former members of the Nazi party, who have united their strength and are trying for a comeback,"

Rabbi Nussbaum, who himself fled Nazi Germany in 1939, charged "that there are at least four such groups, all of whom escaped from Germany at the last moment with huge sums of money at their disposal."

#### HADASSAH SCORES EISENHOWER FOR IMPLYING EXISTENCE OF 'JEWISH VOTE'

NEW YORK, Jan. 31. (JTA) -- Dr. Mirism K. Freund, national president of Hadassah, today said she was "pained" that President Eisenhower should imply that there is a "Jewish vote" in the United States and that it is being used to influence the Administration's attitude toward Israel.

In a report to the National Board of Hadassah at the opening session of its three-day Mids Winter Conference at the Belmont Plaza Hotel, Dr. Freund--who heads 318,000 American women of Hadassah--referred to President Eisenhower's press conference statement of last week in which he revealed parts of his conversation with Abba Eban, former Israel ambassador to the United States, which took place before the Suez episode of 1956.

In that conversation, the President mentioned "possible Jewish sympathy" in the United States toward the "mobilization of Israel at that time, "and said that "I hoped he (Mx. Eban) would not allow this to sway his Judgment as to what this Administration would do...to prevent any outbreak of hostilities..." Then, the President reported: "And I toldhim (Mx. Eban) that if he thought that this would have any part, iota of influence on me, he should disabuse his mind about it."

Dr. Freund said she hoped that the President of the United States did not intend to create the impression that American Jews are motivated primarily by the American Government's attitude toward Israel when they go to the polls. "American friendship for Israel has never been a partisan issue in an election in this country," the Hadassah leader declared. "The American people have been and are Israel's friends and this is not an issue to be raised in political campaigns in a partisan way.

"Everyone who knows the American scene knows that American Jews vote as indistributed as they please and will never permit r such issue to enter into their thinking," Dr. Freund continued. "The results of past ections show this to be a fact. The Jews of the United States go to the polls and exercise their franchise on the basis of what they believe is good for the United States—what is good for their respective states or municipalities. There is no 'Jewish vote' in the United States. There is no 'Irish vote' or 'Italian vote' in the United States, We vote as Americans for whom and for what we consider to be in the best interests of our country."

#### Dr. Freund Discusses Outbreaks of Anti-Semitism in U.S. and Abroad

More than 200 leaders of Hadassah from all parts of the United States are participating in the Mid-Winter conference, which will continue through Tuesday, Mrs. Herman Shulman, former national president of Hadassah, told the conference that Hadassah will carry out a special four-week pilgrimage to Israel in 1960. Mrs. Shulman headest the first Pilgrimage to Israel in 1958. At that time, more than 400 Hadassah memberi-participated.

Dr. Freund, in addressing the conference, also discussed the outbreaks of antimentium in Europe and in the United States. Reviewing anti-Semitism in West Germany, Dr. Freund said that the action of the Rhineland-Palatinate in banning the neo-Nazi Reichs party was "gratifying." However, she pointed out, "neo-Nazi groups should be eradicated throughout the Federal Republic of Germany."

She said that while she believed that the anti-Semitic outbreaks in West Germany arinspired" by neo-Nazi elements there, such vandalism in the United States is unorganized. Nevertheless, she asserted, "American hooligans and gutter fuehrers are being influenced by what is happening in West Germany." She added that "what is needed in the United States is an educational environment in which our 'children can be taught the meaning of a pluralistic society and our responsibilities to it. This kind of approach to the problem must embrace not only the school, but also the church, the parents, the recreation leaders," she emphasized.

At the dinner session, Hadassah leaders honored Consul-General Simcha Pratt and Mrs. Pratt, who are returning to Israel in the spring. The dinner commemorated the 100th anniversary of the birth of Theodor Herzl, founder of modern Zionism.

#### MRS. HALPRIN REPORTS ON ISRAEL; CALLS FOR INCREASED SUPPORT OF U. J. A.

NEW YORK, Jan, 31, (ITA) -- Returning from Jerusalem where she attended the recent session of the Zionist Actions Committee, Mrs. Rose L. Halprin, acting chairman of the Jewish Agency, reported today that she had found Israel in a "guiter mood than during any of my previous visits." She noted that "people seem to be settling down to the business of being normal citizens of a normal country. There are fewer tensions, and there is greater confidence in the political and economic stability of israel."

Mrs. Halprin stressed that while a large number of immigrants had been absorbed, many others were still awaiting full rehabilitation. She expressed the hope that 1960 would be a year of "extra efforts" on behalf of the United Jewish Appeal which would enable the Jewish Agency to make tangible progress in eliminating the backlog of unmet needs.

Turning to the Actions Committee sessions, Mra. Halprin declared that the meeting had achieved its aim. She noted that a revision of the constitution of the World Zionist

Organization had been long overdue and that the main purpose of the Actions Committee session had been to discuss and approve the necessary changes.

The Jewish Agency leader noted with satisfaction the improved climate for private investment and recalled that, in the past, the Agency had been active in that area. "The encouragement of private investment in Israel," she declared, "is in line with the American principle of helping to foster the development of under-developed countries through private initiative. I am happy to see that there are good prospects for continued progress in this direction."

#### B'NAI B'RITH INTERNATIONAL COUNCIL TO HAVE OFFICES IN SIX LANDS

AMSTERDAM, Jan. 31. (JTA) -- The B'nai B'rith International Council, at its first meeting here, announced plans yesterday for the establishment of six offices for research in contemporary Jewish affairs and for the promotion of greater cultural interchange between Jewish communities in various parts of the world.

Philip M. Klutznick, chairman of the International Council, said that except for a New York office which will have primary responsibility for B'nai B'rith activity as a Jewish organization affiliated with the United Nations, the other five offices will conduct negotiations with the leaders of the Jewish communities for the proposed program,

It was indicated that three of the offices would be in Europe, one in Isral and the fifth in Latin America. It was recommended that a disbursement of \$840,000 be made from the reparations funds the organisation received last year from West Germany.

The funds will be used primarily for Jewish educational and cultural programs. The largest single allocation of \$425,000 will be used in Israel. Programs in Latin America and Europe will each receive \$100,000. Programs in Great Britain and Ireland will get \$50,000 and \$20,000 will be expended in Australia.

With the exception of Israel, the funds will be matched on a dollar for dollar basis with money raised by local B'nai B'rith sources.

The Council, in a resclution, denounced the Arab boycott as a "policy of aggression against Israel and economic warfare against Jews throughout the world." The resolution followed a review of boycott activities by Label A. Katz, president of B'nai B'rith. He said that the Arab states had been encouraged in use of the boycott by the "non-chalant attitude of many persons and governments" toward it.

The resolution urged that "Governments and business enterprises resist the boy-cott and denounce its immoral international behavior." The boycott, the resolution stated, violated all principles of amity among members of the family of nations.

#### TRUMAN TO ADDRESS MIAMI CONFERENCE LAUNCHING ISRAEL BOND 1960 DRIVE

NEW YORK, Jan. 31. (JTA) -- Former President Harry S. Truman will address the conference in Miami which will mark the opening of the campaign to sell \$75,873, -550 in Israel bonds during 1960, it was announced today by Abraham Feinberg, president of the Ierael Bond Organization.

Mr. Truman will be a special guest at the 1960 inaugural Conference for Israel Bonds, which will open at the Fontainebleau Hotel in Miami on February 25. The foreversident will be the principal speaker at a dinner to be held on Sunday evening, February 28, in tribute to General Moshe Dayan, Minister of Agriculture of the State of the conference, The dinner will be the climax of the conference.

#### THREE-DAY ANNUAL CONFERENCE OF YVO OPENS: NEED FOR FUNDS STRESSED

NEW YORK, Jan. 31, (JTA) -- The 34th annual conference of the YIVO Institute for Jewish Research opened here last night marked by an appeal to Jewish individuals and organizations throughout the United States to increase their contributions to the institution.

The appeal emphasizes that YIVO is facing a deficit and, without increased financial aid, finds itself unable to carry out important projects dealing with Jewish research. Jewish Federations and Welfare Funds are especially urged to make larger allocations for YIVO in their budgets.

A large audience attended the opening session of the conference which took place at the Assembly Hall of Hunter College.
