ARGENTINA ASKS U. N. SECURITY COUNCIL FOR 'URGENT' MEETING ON EICHMANN

UNITED NATIONS, N.Y., June 15. (JTA) -- Argentina today requested an "urgent" meeting of the Security Council to consider its complaint that Israel, through "illicit and clandestine" means, violated Argentine sovereignty by taking Nazi murderer Adolf Eichmann from Argentine territory to Israel, and refusing to surrender him.

The request was made by Dr. Mario Amadeo, Argentina's permanent representative, in a note, backed by an explanatory memorandum, handed personally this morning to Dr. Tingfu F. Tsiang, of China. The latter is this month's president of the Council.

Immediately after handing the documents to Dr. Tsiang, Dr. Amadeo conferred with Secretary General Dag Hammarskjold. During the rest of the day, he conferred with other representatives to the Il-member Security Council. These, in addition to the five permanent mombers--the United States, Soviet Union, Britain, France and China--are: Ecuador, Italy, Poland, Tunisia and Ceylon. Argentina itself is, this year, also a member of the Council.

While the request for a Council meeting was called "urgent" by Argentina, it was indicated that the Council would meet next Wednesday to start discussion of the Argentine complaint, It was expected that Mrs. Golda Meir, Israel's Foreign Minister, who is in this country now, would attend the Security Council meeting.

The formal note from Dr. Amadeo was strictly legalistic in its wording, but the explanatory memorandum by the Government of Argentina secemed to go to extreme pains to justify today's action on the grounds that Israel violated Argentine sovereignty by the removal of Eichmann from Argentine soil. The memorandum claimed that such a violation sets up a precedent of a country "taking Justice in one's own hands" and, thus, constitutes "a grave danger to the preservation of peace."

Says It Does Not Expect Israel to Return Eichmann Now

Argentina also declared in its memorandum that it does not expect Israel now to return Eichmann to Argentina. It stressed that the government and the people of Argentina "fully understand" Israel's "reasons and considerations" for capturing Eichmann, and pointed out that it has tried normal diplomacy in an effort "not to Jeopardize the close friendships between Argentina and Israel."

A few hours after Argentina took its step calling for a Council meeting, Michael S. Comay, Israel's permanent representative here, conferred with Mr. Hammarsklold. It was said to have been "a preliminary" talk for the purposes of "clarification," Mr. Comay was scheduled also to meet with other members of the Council this week,

In its memorandum, Argentina started by explaining that it was "forced" to ask for UN intervention by the breakdown of "diplomatic actions," The memorandum was referring not only to the note sent by Argentina to Israel a week ago, demanding the return of Eichmann within a week, but also to the two-hour conference held yesterday between Dr. Amadeo and Mrs. Meir on the initiative of Urugusy'is delegation chairman, Dr. Enrique R. Fabregat, At that conference, Dr. Amadeo repeated his government's request for Eichmann's return, while Mrs. Meir, on behalf of Israel, stood fast in her government's refusal to send the Nazi killer back to Argentina.

Stresses that Israel Failed to Reply to the Argentine Ultimatum

After calling attention to the fact that Argentina had sent a note on the issue to Israel last week, the memorandum continued: "The time limit fixed by the note has expired and the Argentine Government still has not received a reply to its note. In view of the well-known statements of Israel Government representatives, Argentina has come to the conclusion that Eichmann is not going to be returned,"

Repeating the charge that Eichmann's "transfer" to Israel was "illicit and clandestine," Argentina then claimed this is "a flagrant violation of the sovereign right of the Argentine State and its Government, " This fact "alone, " continued the memorandum, "Justified Argentina's demand for redress, "

"No consideration of any kind," stated the memorandum, "including those invoked by the Government of Israel, could supersede the sovereign right of Argentina. The

Argentine Government and people fully understand the value of Israel's reasons and considerations. However, to allow them to prevail would be tantamount to permitting the taking of Justice in one's own hands, would disturb the equilibrium of international order, and would result in grave danger to the preservation of peace.

"Before approaching the Security Council, Argentina attempted to find satisfactory solution through normal diplomatic channels, It was guided in these steps by a desire not to Jeopardize the close friendship between Israel and Argentina. These efforts have had no result and, thus, there was no other alternative than approaching the Security Council," The memorandum stated,

Argentina said it is bringing the case to the Council under Article 34 and Article 35-Paragraph One of the UN Charter. Article 34 states: "The Security Council may investigate any dispute, on any situation which might lead to international friction or give rise to a dispute, in order to determine whether the continuation of the dispute or situation is likely to endanger the maintenance of international peace and security,"

The first paragraph of the next article states: "Any member of the United Nations may bring any dispute, or any situation of the nature referred to in Article 34, to the attention of the Security Council or of the General Assembly, "Thus, it was seen here, Argentina did not foreclose possible Assembly action if its requested "redress" is not obtained through Council action.

Israel Seeking U.S. Support in Eichmann Case, Washington Indicates

WASHINGTON, June 15. (JTA) -- Israel may be seeking American diplomatic support in the Adolf Eichmann extradition case now pending before the United Nations, Government sources indicated today after a meeting of Israel Ambassador Avraham Harman with Under Secretary of State C. Douglas Dillon.

The details of today's meeting were not divulged. Israeli sources characterized it as a normal, general exchange on mutually interesting topics.

BEN-GURION TO MEET AGAIN WITH DE GAULLE; ADDRESSES FRENCH JEWS

PARIS, June 15. (JTA) -- At the request of President Charles de Gaulle, another meeting between the French leader and Prime Minister David Ben-Gurion is being arranged before the Israeli leader's departure from France, it was disclosed today.

While no definite date has been fixed, it was understood that liaison officers were busylthis morning trying to arrange a second tete-a-tete between the two leaders. It was indicated that, because the French President has an unusually crowded week, the second meeting would probably take place Friday.

Mr. Ben-Gurion spent the morning in meetings with "old friends" and with leaders of the Paris Jewish community. He exchanged reminiscences and views on the future of the Socialist movement for more than an hour with former French Premier Guy Mollet and Maurice Bourges-Manoury.

Later, the Prime Minister addressed 18 leaders of the major Jewish organizations in France, calling on them to encourage Jewish settlement, particularly of their youth, in Israel. He also urged them to foster an increase in the teaching of Hebrew in France. With the establishment of the very close relations which had been achieved between Israel and France, he said, he hoped to find French Jewry even closer to Israel.

The Prime Minister and his party attended a dinner in his honor last night which was given by French Prime Minister Michel Debre, who praised Mr. Ben-Gurion and stressed the close ties linking Israel and France. It was reported that, during the meeting of the two Prime Ministers, they touched on the possibility of a link between Israel and the sixnation European Common Market.

SEN. FULBRIGHT URGES BEN-GURION AND NASSER TO SETTLE DIFFERENCES

WASHINGTON, June 15, (JTA) -- Chairman J. W. Fulbright of the Senate Foreign Relations Committee made a speech today on the floor urging Israeli and Arab leaders to overcome their "irrational emotion" and settle their differences. He suggested specifically that Premier Ben-Gurion of Israel and President Nasser of the United Arab Republic could help ease regional tensions,

He blamed both of these "two most powerful potential antagonists" for failure to solve the Arab refugee problem. The Arkansas Democrat termed solution of this problem the key to relaxation of basic tension. He said that neither Israel nor the Arabs were willing to take the first step.

Senator Fulbright reported that both the Israeli and Arab leaders were "considerably more rational in their private statements than they are in their public pronouncements." He speculated on the possibility for "quiet, off-the-record conversations to be held so that some agreement might be made which would move the problem off dead center,"

NEW ISRAELI VESSEL LAUNCHED IN GERMANY; BUILT AS PART OF REPARATIONS

BREMEN, June 15. (JTA) -- A new freighter, built by the Vulkan Werft West German shaperd for the Zim-Israel Navigation Company, was launched here today. The vessel was built under the West German-Israel reparations agreement. It was named the "Gederah" by Mrs. Vera Tsur, wife of Yaacov Tsur, member of the Jewish Agency executive and former Ambassador to France.

ZIONIST ORGANIZATION EMBARKING ON EXPANSION DRIVE, GOLDMANN ANNOUNCES

JERUSALEM, June 15. (JTA) -- Dr. Nahum Goldmann announced at a press conference here today that the World Zionist Organization, with the full support of the Government of Israel, will embark on a campaign to opt Jewish communities and non-Zionist groups into the world Zionist movement.

The first results of the campaign, he said, would be evident at the 25th World Zionist Congress which will be convened in Jerusalem December 27. He reported that organizations from all continents would have contingents at the Congress as full, associate or fraternal members. Some major organizations in the United States have indicated their readiness to send fraternal delegations, he stated, With a large periphery of organizations on behalf of millions of Jews who are not Zionists, Dr. Goldman said, the World Zionist Congress will assume the aspect of a general Jewish Congress.

The "Zionist offensive" would be spearheaded at a specially convened Congress of American Zionists in the United States on November 17. Dr. Goldmann reported. To demonstrate Israells support, a large and important delegation of Gabinet Ministers and other Israel leaders will attend the Congress, he revealed. He said that all Jewish communities in Latin America had already pledged support and will send delegations to the World Zionist Congress as associate members. They will have the right to participate in committee sessions and discussions but no voting rights.

The President of the World Zionist Organization stressed the importance of the unanimous decision reached at a meeting of Government leaders and Jewish Agency executive members which reaffirmed the exclusivity of the Zionist movement in Israel on Jewish efforts in the areas of immigration, absorption and settlement, In reply to a question, he said 20,000 to 25,000 immigrants were expected to awive in Israel this year.

ISRAEL GOVERNMENT BODY APPROVES COMPULSORY LOAN TO GOVERNMENT

JERUSALEM, June 15. (JTA) -- A proposal to levy a compulsory property loan of 15, 000, 000 to 20, 000, 000 pounds to cover a growing deficit in Israel's budget was approved today by a majority of the Government Coordination Committee.

The compulsory loan, as proposed by Finance Minister Levi' Eshkol, would be in the form of advance payment of property taxes due in the next fiscal year. The compulsory advance payment would be repaid in the form of deductions from taxes spread over several years.

While the Coordination Committee is an unofficial body, approval in that committee was considered as virtually assuring passage in the Knesset, since the committee's majority decisions bind all members of the coalition in the Knesset. A majority vote for the measure is thus assured when it comes up for Knesset action,

U.S. FIRM TO BUILD \$5,000,000 PLANT IN ISRAEL FOR PLASTIC MATERIAL

JERUSALEM, June 15. (JTA) -- An agreement for the construction by an American firm of a \$5,000,000 plant for the manufacture of polyethylene in Haifa was signed today. The signers were Pinhas Sapir, Israel Minister for Commerce and Industry, and Virgil Stark, president of the North American Services Construction Company.

Mr. Stark at the same time signed an agreement with the Haifa oil refineries to supply the new plant with ethylene. A \$4,000,000 plant to produce ethylene will be built by the Haifa refineries.

The Government will lend the company half of the cost of the polyethylene plant which is expected to become the nucleus of a \$50,000,000 petro-chemical industry. The two plant operation for the production of polyethylene, now made in only ten countries, is expected to begin in 1965. Polyethylene is widely used in food packaging and in container production.

ISRAELI FIRM TO BUILD \$3,000,000 PROJECT FOR U.S. ARMY IN TURKEY

JERUSALEM, June 15, (JTA) -- A spokesman for Solel Boneh, the construction arm of the Histadrut, disclosed today the signing of an agreement for a \$3,000,000 construction project for the U.S. Army in Turkey. The agreement was signed between the U.S. Army in Turkey and a partnership consisting of Solel Boneh and an American contracting firm.

EXPLOSION KILLS PRODUCER OF BOMBS FOR ANTI-JEWISH TERROR ACTS

MONTEVIDEO, Uruguay, June 15. (JTA) -- A 17-year-old member of an international anti-Semitic organization was killed yesterday in an explosion of a laboratory here used to make bombs for anti-Jewish terrorist activities, police reported here today. Two other youths were injured in the blast. The explosion occurred about the same time a bomb went off in a Montevideo synagogue. Bombs were discovered in two other local synagogues and were removed before they could explode.

The dead youth, Horacia L. Georgetti, was the son of an Argentinian exiled here during the regime of Argentine dictator Juan Peron. Police said he and two Uruguayans, who were injured in the explosion, had been making bombs. All three belonged to a bramch of an international anti-Semitic rine.

SEN. KENNEDY PRESENTS HIS VIEWS ON ARAB-ISRAEL ISSUE TO SENATE

WASHINGTON, June 15. (JTA) -- Senator John F. Kennedy, leading aspirant for Democratic nomination for the office of U.S. President, touched upon the Middle East situation in a programatic speech which he delivered in the Senate yesterday. He outlined his views on the Arab-Israel conflict and said that the United States must try "to hasten the inevitable Arab acceptance of the permanence of Israel."

"We must formulate, with both imagination and restraint, a new approach to the Middle East--not pressing our case so hard that the Arabs feel their neutrality and nationalism are threatened, but accepting those forces and seeking to help channel them along constructive lines, while at the same time trying to hasten the inevitable Arab acceptance of the permanence of Israel, "Senator Kennedy said. We must give our support to programs to help people instead of regimes--to work in terms of their problems, not ours--and seek a permanent settlement among. Arabs and Israelis based not on an armed truce but on mutual self-interest.

"Guns and anti-Communist pacts and propaganda and the traditional piecemeal approach are not enough-refugee resettlement and a regional resources development fund in full partnership with the Middle Eastern nations, all are parts of a long-range strategy which is both practical and in the best interests of all concerned," he declared,

ESTABLISHMENT OF ISRAEL PORT AUTHORITY IS ASSURED, U.S. EXPERT SAYS

NEW YORK, June 15, (JTA) -- Establishment of an Israel Port Authority modeled on the Port of New York Authority has been virtually assured, Austin J. Tabin, executive director of the New York Authority declared here today. Speaking at a luncheon of the American-Israel Chamber of Commerce, Mr. Tobin said that Israel "urgently needed" more port facilities. The New York port director returned last week from an inspection tour of Israel made at the request of the International Bank for Reconstruction and Development.

Dr. N. Wydra, managing director of the Zim-Israel Navigation Company, told the luncheon guests that very small nations, Israel among them, needed merchant fleets of their own to guarantee the flow of overseas trade in times of emergency and to provide employment and foreign currency for their growing economies. Dr. Wydra, who was guest of honor at the luncheon, decried "the present gross inequality in the distribution of world shipping."

CHICAGO STUDENTS TO UNDERGO MENTAL TEST FOR SYNAGOGUE DESECRATION

CHICAGO, June 15. (JTA) -- Two 18-year-old university students accused of malicious mischief for wrecking a bronze menorah at Lawn Manor Hebrew Congregation have agreed to undergo tests at the Chicago Municipal Court Psychiatric Clinic in advance of their trial in Boys Court on June 27.

Alphonse Radvila and James Erlenborn admitted the vandalism which took place on May 1. Rabbi Mordecai Schultz said the Menorah, cast in solid bronze and attached to one side of the synagogue, was damaged beyond repair.

VANDALS DESECRATE JEWISH CEMETERY IN LONG ISLAND; POLICE INVESTIGATE

NEW YORK, June 15. (JTA) -- Nassau County police are investigating today the descration by vandals of 15 gravestones in Beth David Cemetery, in Elmont, L.I., one of the largest Jewish cemeteries in the New York area. Cemetery authorities estimate the damage at over \$1,000.

HARRY RABINOWITZ ELECTED GRAND MASTER OF FREE SONS OF ISRAEL

SOUTH FALLSBURG, N.Y., June 15. (JTA) -- Harry Rabinowitz of Shenorock, N.Y., was elected grand master of the Free Sons of Israel at the closing session of the orderls four-day convention here today. The Free Sons of Israel, which has 10,000 members, is one of the oldest national Jewish fraternal orders in the United States.
