U. N. DELEGATIONS SEEK TO AVOID DEBATE ON EICHMANN AT SECURITY CCUNCIL

UNITED NATIONS, N.Y., June 19, (1TA) -- A number of delegations here, including leading representatives of the Western Powers, today continued to exert pressures against having the United Nations Security Council debate the Argentine complaint against Israel in connection with the capture of Adolf Eichmann, the Nazi leader who directed the killing of 6,000,000 Jews,

The Security Council meeting on this issue is scheduled to take place on Wednesday, However, hops were expressed here today that, prior to Wednesday, some compromise might be reached between Israel and Argentina, perhaps through a meeting between Israel's Prime Minister David Ben-Gurion and Argentine President Frondizi, both of whom are now in. Europe.

The Israel delegation here continued today to maintain close contact with members of the Security Council on the issue. Over the weekend, Israel's Foreign Minister Golda Meir interrupted a previously scheduled lecture tour of the United States to come here for a conference on the Argentine grievance with Secretary General Dag Hammarskjold. Israel's permanent representative, Michael S. Comay, also discussed the issue with the Secretary General as well as with Dr. Tingfu F. Tsiang, of China, president of the Security Council, and all other members of the Council, including Arkady A. Sobolev, of the Soviet Union.

(Moscow dispatches today indicated that the Soviet delegation at the UN may take a double stand on the Argentine grievance when it comes to the Security Council. On the one hand, Russia may support Argentina on its insistence that the anti-Israel grievance should be inscribed on the Council's agenda, thus making possible full debate on the issue. On the other hand, Russia might side at the Council with Israel on its method cf capturing Eichmann, pointing out that the arch-criminal was able to hide in the Western world for Is years.)

The consensus of many experienced observers here was that, if the Argentine issue does receive public airing before the Security Council, that body might adopt a resolution only "recommending" that Israel return Eichmann to Argentina, as the Buenos Aires Government insists. Such a recommendation, however, would not be legally binding upon Israel.

Ben-Gurion and Frondizi May Meet This Week. on Eichmann

PARIS, June 19. (JTA) -- Contacts between Argentina and Israel are continuing effectively on a diplomatic level for a meeting between Prime Minister David Ben-Gurion and President Arturo Frondizi, it was reported by Israel sources here today. The contacts are taking place in New York and in Buenos Aires, it was reported authoritatively.

It was indicated that, before such a meeting can be arranged while the two leaders are in Europe, some common ground would have to be found. The Argentine President, according to these sources, was aware that Israel will not yield Eichmann, as Argentina demanded, and a meeting now depends on Argentina's acceptance of this position.

According to these sources, there was belief that the meeting could be arranged on those terms, and that the two leaders probably will meet next week in either Holland or Holgium. (A Foreign Ministry spokesman in Israel said in Jerusalem today that a meeting in Europe between Prime Minister Ben-Gurion and President Frondizi, over the deadlock between the two countries on the Eichmann case, is "a technical possibility and even more than that,")

Knesset to Adopt Motion on Holding Eichmann Trial in Israel

JERUSALEM, June 19. (JTA) -- A "Meclaratory" resolution was filed here today in the Knesset (Parliament) by the right-wing, nationalist Herut Party, asserting that Adolf Eichmann, Nazi "specialist" in the extermination of 6,000,000 Jews, must be tried in Israel.

Although the Herut Party is in the opposition, and not a member of the Israeli coalition government, it is expected that the motion will be adopted by the Knesset this week. In presenting its motion, Herut called for unanimous approval by Parliament "as a demonstration of the nation's solidarity on this issue."

COURT EXTENDS INTERROGATION OF EICHMANN; RUSSIAN JEWS OFFER EVIDENCE

TEL AVIV, June 19. (JTA) -- Adolf Eichmann, Nazi SS colonel and Hitler's specialist in the extermination of 6,000,000 European Jews, today was remanded for a third time after a brief hearing before Magistrate Alfred Bach, of Haifa. The detention, for 15 days, is the third for the Nazi killer-the utmost permitted under Israeli law.

Today's application for further detention, to permit further interrogation, was made by Police Commander Ephraim Hofstatter, deputy head of the Police Department's Sixth Bureau. He was acting on behalf of Minister of Justice Pinhas Rosen who is also acting Attorney General. Under Israeli law, only the attorney general or his representative is entitled to an order for a third detention.

No preliminary hearing has as yet been held for Eichmann. Such a hearing can be conducted only after a charge sheet had been drawn up. The formal charge sheet will be presented after the current detention period is over.

Interrogation of Eichmann continued, meanwhile, by-efficers of the Sixth Bureau of the Israel police, Study also was continued in the documents and material which continue to pour in. One of the more unusual documents received recently was a letter from a Russian Jew, listing the names of several Jews in Russia who had survived Nazi death camps and could give evidence in the case,

Israeli authorities made public the latest letter, received here last week, from President Arturo Frondizi of Argentina to Prime Minister David Ben-Gurion, dealing with the Eichmann case. In his note, Mr. Frondizi agreed with Israel's stard about the need for bringing Eichmann to Justice, but insisted that the Nazi's apprehension in Argentina endangered "peaceful co-existence" because it was "not in accord with Juridical norms,"

BEN-GURION LEAVES FRANCE TODAY FOR BELGIUM; STRESSES WILL FOR PEACE

PARIS, June 19, (JTA) -- Israel's Prime Minister Daid Ben-Gurion today completed his state visit to France by voicing praise for the "will for peace" displayed by leaders of the free world--President Eisenhower, President Charles de Gaulle of France, Prime Minister Harold Macmillan of Great Britain, and Chancellor Konrad Adenauer of the West German, Republic. He is leaving tomorrow for Brussels, Belgium.

"I do not say that the leaders of ithe. Communist countries do not have an equal will for peace," he added, "I have not met them to judge their sentiments." He added that Israel remained ready to meet Arab leaders and to discuss with them all problems, including the Arab refugee problem, without any prior conditions,

At a luncheon given in his honor earlier this weekend by the French diplomatic press association, Mr. Ben-Gurion expressed hope that peace with the Arabs would come eventually. In reply to a question, he said he did not rule out a confederation with the Arab states, adding that "in such a climate, we might be able to cooperate with our neighbors in the political, economic, social and cultural fields for the good of the entire region." The principal needed, he said, was a desire for peace. Only then, he added, can a solution "to all problems be found."

The Prime Minister strongly defended Israel's stand that it is "morally and legally entitled" to try Adolf Eichmann for the crimes he committed against the Jewish people as Hitler's specialist in mass murder.

Replying to questions at the luncheon, he said that, while Israel did not exist as a state when Eichmann committed his crimes, "it existed inthe hearts of the Jewish people. Israel is the only country which can judge a man who deliberately killed 6,000,000 Jews."

Speaking in forceful tones, the Prime Minister said there was no opposition between justice and law in Israel's plans for Eichmann because "Justice is the superior form of legislation." He added that not only would Eichmann's trial in an Israel court not violate any law, but that it would serve the interests of historic justice.

"No man with a conscience can deny that it is the duty of the Jewish State to try a man accused of such crimes against the Jewish nation," he declared. He expressed confidence that the Nazi criminal, whose right to a lawyer of his own choosing has been acknowledged, would be tried "in a just way" according to the procedure of Israeli courts.

ARAB BLACKLIST BARS 635 SHIPS FOR TRADING WITH ISRAEL; U.S. ON LIST

JFRUSALEM, June 19. (JTA) -- A total of 307 companies and 635 ships are on the Arab boycott list for trading with Israel, according to figures published by the boycott office in Amman, it was reported here today. The figures were released on the eve of the opening tomorrow in Tripoli, Lybia of a conference of all Arab boycott liaison officers.

Four hundred and fifty-seven of the blacklisted ships are on the complete blacklist, which means that they cannot even obtain drinking water at Arab ports. Countries having the largest numbers of ships blacklisted were the United States, France, Britain and Turkey.

CHIEF ARGENTINE DELEGATE AT U. N. CHARGED WITH BEING IN NAZI SERVICE

BUENOS AIRES, June 19. (JTA) -- A member of the Argentine Parliament, representing the opposition Radical Peoples Party, tonight publicly accused a high Foreign Ministry official and this country's permanent representative to the United Nations of having been "enthusiastic followers of Hitler."

The charges were voiced on a nationwide network radio broadcast by Arturo Mathov. He debated Argentina's anti-Israel grievance at the United Nations with Dr. Ismael Bruno Quijano, Undersecretary of the Ministry of Justice. Mr. Mathov specifically named Pablo Pardo, legal adviser to the Foreign Ministry, and Dr, Mario Amadeo, Argentina's delegation chairman at the United Nations who is pressing the case against [srael's refusal to return Nazio butcher Adolf Eichmann to this country.

Dr. Quijano reiterated the government's official stand on the issue, as presented to the UN Security Council last week by Dr. Amadeo, maintaining that Israel had violated Argentina's sovereignty by abducting Eichmann and by refusing to return him here. Mr. Mathov, conceding that the question of Argentina's sovereignty was indeed at stake in the issue, said: "It is too, bad, however, that the officials who are handling this affair are Nazi-fascists Pablo Pardo and Dr. Amadeo."

"Dr. Amadeo," continued the member of Parliament, "cannot be our spokesman at the United Nations, having been himself an enthusiastic follower of Hitler. There is no justification for our going to extremes to defend a Nazi murderer. Juridical dialectics are elastic. If Eichmann were to be returned here by Israel, those elastic interpretations of legalisms might become so complicated that Eichmann could be allowed by some officials to escape justice.

"Argentina is a refuge for hundreds, perhaps thousands, of Nazi criminals who escaped when the Nazi regime collapsed. I feel that the entire Eichmann matter should be referred to the International Court of Justice at The Hague, and not to the Security Council. The Council is a political body, not a juridical organ."

UNITED NATIONS, N.Y., June 19. (JTA) -- Dr. Amadeo, questioned by the Jewish Telegraphic Agency about reports that, in 1946, the United States Department of State had identified him in an official publication as a wartime "trusted collaborator of the Sicherheitdienst," the Nazi intelligence service, replied: "No comment."

U. J.A. NATIONAL MID-YEAR CONFERENCE RAISES \$33,150,000 IN CASH

WASHINGTON, June 19. (JTA) -- The sum of \$33,150,000 in cash was reached here today for the United Jewish Appeal at the conclusion of a two-day national UJA mid-year leadership conference attended by 450 Jewish community leaders from all parts of the country who presented checks on behalf of their communities.

Rabbi Herbert A, Friedman, executive vice-chairman of the UJA, told the conference that "if the campaign continues at the present pace, there is every reason to believe that by the year's end the 1960 drive will approximate the \$68,000,000 raised by the UJA in its successful campaign of 1959. He commended "the maturity and deep sense of responsibility" displayed by American Jews in response to the 1960 campaign.

"There were no flaming headlines or day-to-day newspaper reports of Jewish disasters to spur the pace of this year's effort," he said. "Yet, American Jews have shown that they understand very well the great issues which still underlie the UJA, and that they are a generation which has an appointment with history to try to solve these issues."

Moses A. Leavitt, executive vice-chairman of the Joint Distribution Committee, underscored the long range aspects of the UJArs support. He told delegates that in 1960, the JDC-a UJA beneficiary--is aiding 250,000 Jews in Moslem countries, Europe and Israel. He noted that most of those helped by JDC no longer could be technically classed "refugees" but the needs of these people were termed "as great as in the days of homeless wandering, or greater."

Melvin Dubinsky, UJA national cash chairman and head of the UJA national campaign cabinet, called on community leaders to continue efforts to secure cash, ite praised and thanked a 50-man cash committee associated with him in the current drive.

President Abram Sachar of Brandeis University today told the delegates that Israelis long for the day of self sufficiency. American Jews 'have no right to become tired' of fund-raising appeals until Israel achieves economic independence, he stated,

PROTESTS MOUNT AGAINST PERMITTING RALLY OF NAZI PARTY IN NEW YORK

NEW YORK, June 19. (JTA) -- Mounting protests against issuance of a permit to George Lincoln Rockwell's American Nazi party for a July 4 rally were climaxed yesterday by a suit filed in State Supreme Court to prevent the city from giving the permit,

The suit was filed by The Public Awareness Committee, which obtained an order from Justice Vincent A. Lupiano directing Newbold Morris, the City Park Commissioner, to appear at 10 a.m. this Wednesday to explain why he should not be barred from issuing the permit.

The committee complained in its suit that the Nazi group aimed to overthrow the American system of Government and any rally would "lead to riot and bloodshed. The Mutual Radio network reported many listeners had called to protest an interview in which Rockwell said that the aim of his Nazi group was to "exterminate unfriendly Jews" and to "send Negroes back to Africa."

Mr. Morris had originally indicated he felt he should issue the permit on grounds of free speech. As protests grew, his position shifted and a Parks Department spokesman said yesterday that the permit was "in a state of suspended animation." Mayor Wagner stepped into the growing dispute and discussed the problem with Mr. Morris yesterday.

ISRAEL OBJECTS TO PLANNED BRITISH EXCAVATIONS NEAR WAILING WALL

JERUSALEM, June 19. (JTA) -- The Foreign Ministry was reported today readying an inquiry to the British Foreign Office about plans by British archaeologists to conduct excavations around the Wailing Wall, in Old Jerualem, part of this city under Jordanian furrisdiction.

The Wailing Wall, most sacred of Jewish shrines, is the last remnant of the ancient Temple in Jerusalem, having formed the western portion of the wall surrounding that sanctuary. Religious circles here are deeply concerned about the plans to disturb the Wailine Wall area.

The office of Chief Rabbi Yitzhak Nissim here announced that it is considering steps to prevent the excavations, possibly through requesting that the Government make representations on the subject to the United Nations.

(Archaeologists from Harvard University are planning to work this summer with other Archaeologists, as well as with specialists from Europe and Jordan, in an effort to ancover the site of Shochem, first capital of ancient Israel, it was annunced at Harvard this weekend. Cooperating with the Harvard archaeologists will be teams from Drew University and the McCormick Theological Seminary. Ancient Shechem is believed to have been destroyed in the year 128 before the Common Era.)

YAACOV HERZOG, NEW ISRAEL AMBASSADOR TO CANADA, PRESENTS CREDENTIALS

OTTAWA, June 19. (JTA) -- Yaacov Herzog, Israel's new Ambassador to Carada, presented his credentials yesterday to Governor General George P. Vanier. The Israel envoy and his party arrived at the Governor General's residence in a horse-drawn carriage escorted by an honor guard of Canadian mounted police.

During the colorful ceremonies here, Ambassador Herzeg declared: "Israel reborn is the fulfilment of the immortal prophecy. Thelland and the people, now reunited after a separation of close to 2,000 years, have enjoyed a continuity of tradition from the dawn of history." In his reply to the Ambasador, Governor General Vanier lauded Canadian-Israel friendship, Ambassador Herzog also met with Premier John G. Diefenbaker.

JEWISH REFUGEE MAY SUCCEED DR. SCHWEITZER AS HEAD OF MEDICAL MISSION

NEW YORK, June 19. (JTA) -- A Jewish refugee from Czechoslovakia is likely to succeed Dr. Albert Schweitzer as head of the medical mission at Lambarene in the Gabon Republic, according to a prediction yesterday by the head of the Religious Heritage of America.

The refugee, Dr. Richard Friedmann, is a 38-year-old physician on the staff of the Schweitzer hospital. He was mentioned as a possible successor to Dr. Schweitzer by Lisle M. Ramsey, director of the organization who recently made an eight-week tour of Africa.

COUNCIL OF JEWISH WOMEN AWARDS SCHOLARSHIP TO SOUTH AFRICAN LEADER

JOHANNESBURG, June 19. (JTA) -- Gustav Saron, General Secretary of the Jewish
Board of Deputies here, has been awarded a scholarship for advanced study in community
organization by the National Council of Jewish Women in the United States, it was announced here today.

Mr. Saron will leave for the United States in September to pursue postgraduate studies at the School of Applied Social Science at Western Reserve University in Cleveland, Ohio. The Board of Deputies has granted him sabbatical leave to enable him to take up the scholarship.
