BEN-GURION ARRIVES IN BRUSSELS ON STATE VISIT TO BELGIUM

BRUSSELS, June 20. (JTA) -- David Ben-Gurion, Israel Prime Minister, arrived here today for a State visit, after a five-day visit to France, where he conferred twice with President Charles de Gaulle.

Greeted ceremoniously at the airport by Prime Minister Gaston Eyskens, Minister for Foreign Commerce Jacques van Offelen, and Viscount Meeus d'Argentuil, who represented Queen Mother Elizabeth, Mr. Ben-Gurion reviewed a guard of honor, then read a statement emphasizing the friendship between Belgium and Isræl.

Speaking in French, Mr. Ben-Gurion said: "All free nations, large or small, are committed to solidarity in the defense of peace and fundamental liberties. After the talks I had recently in the United States and Britain, and these last few days in Paris, it is to me a particular pleasure to meet the Belgian leaders for an exchange of views on problems that confront all of us. It is a pleasure to be on the friendly soil of Belgium."

In his reply, Mr. Eyskens declared: "It is an honor and a pleasure for the Belgian Government to receive Mr. Ben-Gurion."

Mr. Ben-Gurion was accompanied here, as he was in France, by his wife, Mrs. Paula Ben-Gurion and his daughter, Mrs. Ranana Leshem. A sizable crowd cheered them as they deplaned at the airorst here.

CABINET APPROVES HUNDRED MILLION POUND INCREASE IN ISRAEL BUGGET

JERUSALEM, June 20. (JTA) -- A special meeting of the Israeli Cabinet today approved and sent to the Knesset an increase in this year's budget of 100,000,000 Israeli pounds (\$56,000,000),

The money would be raised through a special bond issue, short-term loans and compulsory loans by Israeli property owners. Levi Eshkol, Minister of Finance, in presenting the new financing plan to Parliament, said that security needs would absorb 34,000,000 pounds from the monies, while 20,000,000 bounds would go for new housing.

ADMINISTRATION POLICY ON ISRAEL IS ATTACKED ON SENATE FLOOR

WASHINGTON, June 20. (JTA) -- Three Democratic members took the Senate floor today to condemn the Eisenhower Administration policies on Israel and the Middle East and to charge that there was a wide gap between the Administration's policy declarations and its practice,

Senator Ernest Gruening of Alaska told the Senate that the Administration's pledges to Israel "are not worth the paper on which they are written." He charged that the Administration's appeasement of the United Arab Republic's blockade and boycott tactics revealed "id discrepancy between words and deeds," This "disparity," he said, was seen in a recent statement on Near Eastern issues by Vice President Nixon contained in a letter to Blaid British.

Senator Gruening said the "Eisenhower-Nixon Administration" was aware of transgressions by Nasser against Israel including Suez Canal restrictions but nevertheless loamed the UAR \$50,000,000 for canal improvements.

Senator Stuart Symington, Missouri Democrat, deplored the "ambiguous policy" of "the present administration toward freedom of the seas," He said that while the Administration avowedly supports navigation rights, it actually "refuses to take the practical steps necessary to assure free access for all nations to the sea lanes of the world,"

Senator Paul H. Douglas, Illinois Democrat, charged the Administration and the State Department with "pro-Arab bias." He said State Department officials had a "pronouncedly pro-Arab bias."

Although the Senate had gone on record against the anti-Jewish policies of the Arab states, Senator Douglas said, "it is now apparent that the Foreign Service and this Administration have no intention whatsoever of following the recommendations made by the Senate," He added that "we have the right to withhold aid from countries violating international law."

ISRAELIS SEE LITTLE CHANCE OF EARLY BEN-GURION -- FRONDIZI MEETING

JERUSALEM, June 20. (JTA) -- There is no "technical possibility" for a meeting before next weekend between Prime Minister David Ben-Gurion and Argentina's President Arturo Frondizi, a Foreign Ministry spokesman declared here today.

Eoth statesmen are in Europe this week. Hopes had been expressed in many quarters that they might get together before Wednesday, when the United Nations Security Council is scheduled to take up an Argentine grievance against Israel in connection with the transfer of Adolf Eichmann from Argentina to Israel.

The itineraries of both Mr. Ben-Gurion and Mr. Frondizi, said the spokesman, preclude the possibility of their meeting before the weekend. Mr. Ben-Gurion is in Belgium today, and is scheduled to spend the latter part of the week in The Netherlands. He was scheduled to leave Amsterdam for home on Friday.

DR. PRINZ ASSERTS ISRAEL'S RIGHT TO PUT EICHMANN ON TRIAL

NEW YORK, June 20. (1TA) -- Israel's claim to the right to try Adolf Eichmann "transcends" that of any other nation or any group of nations, Dr. Joachim Prinz, president of the American Jewish Congress, declared here today. He told a press conference that Israel "has not only legal grounds to try Eichmann, but also a great moral right and responsibility for bringing him to Jusuce."

"It is appropriate and fitting," Rabbi Prinz continued, "that he be brought to trial in Israel-a sovereign nation created by the Jewish people whom Eichmann sought to destroy; a country that rose on the ashes of millions of innocent men and women and children who m Eichmann put to death; a land recognized by the United Nations as the haven and refuge for hundreds of thousands of survivors of Eichmann's concentration camps, many of whom carry on their skins the blue tattoo marking them for extermination in Eichmann's death factories.

"Only in Israel will Eichmann's trial serve as a great moral lesson of retributive justice. For Israel is the living proof that Eichmann's plans for the 'final solution' of the Jewish problem through slaughter of the Jews ended in failure."

EICHMANN TRIED TO BLOCK 'DEALS' ON JEWS, FORMER NEGOTIATOR CHARGES

PARIS, June 20. (JTA) -- A forner Hungarian Jew who dealt with Adolf Eichmann, in 1944, in the effort to exchange 10,000 trucks and medical supplies for the lives of a million Jews, charged here today that Adolf Eichmann tried to block attempts to save the lives of mmy Jews from the Nazi death camps.

"Had it been up to Eichmann," the former negotiator said, "all Hungarian $J_{\hbox{\scriptsize ews}}$ would have been wiped out."

The man who revealed Eichmann's role in what he called "that grisly trucks-forlives affair" was Andre Biss, former industrialist in Hungary. He told his: story of here today at a news conference at the European headquarters of the American Jewish Committee.

Mr. Biss said he became the chief negotiator with Eichmann in 1944, when two Jews, who had been trying to make the "deal" for saving the lives of Jews by providing trucks to the Nazis, had to leave Budapest. The two who got out were Rudolf Kastner, assassinated in Israel' a year ago; and Joel Brand, now an Israeli citizen.

The "trucks for Jews" deal, said Mr. Biss, was the idea of Heinrich Himmler, head of the Nazi police system. But the actual negotiations had to be conducted iwith Eichmann, as the Nazi "specialist" for "the final solution" of the Jewish problem.

"In every way possible," Mr. Biss asserted, "Eichmann sought to sabotage Himmler's orders to deal with us. Had it been up to him, all Hungarian Jews would have been wiped out. He was obviously, coldly, happy in July, 1944, when he told Kastner and me that the negotiations had fallen through. 'I can do nothing for you,' Eichmann told us, 'you have not delivered.'"

According to Mr. Biss, "to us who dealt with the Germans, it was clear that we had to by-pass Eichmann at every opportunity, getting our offers to Himmler through other channels."

London Newspaper Advises Argentina to Accept Israel's Stand on Eichmann

LONDON, June 20, (JTA) -- The London Daily Telegraph, which has been critical of Israel's handling of the case of Nazi killer Adolf Eichmann, warned Argentina in an editorial that, if it persists in rejecting Israel's denial of the Israel Government's responsibility in the capture of Eichmann and his removal from Argentine soil to Israel territory, Argentina "is in danger of creating an unfortunate impression regarding its own attitude and intentions,

"To overplay objections that might prevent a trial for Eichmann," declared the editorial, "might look to some people like siding with Eichmann. It would be in Argentina's interest to avoid any danger of giving such an impression,"

JEWISH GROUPS HIT LIFTING OF BAN ON LOUDS PEAKERS FOR NAZI MEETINGS

WASHINGTON, June 20, (JTA) - Two Jewish organizations have protested to the Federal and District of Columbia authorities against a new concession made to George Lincoln Rockwell and his "American Nazi Party."

The Jewish War Veterans of America filed a protest with the Department of Interior today against the renewal of permission to Rockwell to use powerful loudspeakers. at his outdoor meetings. The Anti-Defamation League of B'nai B'rith made a similar complaint to the District police.

Rockwell had been temporarily barred from using amplification apparatus because his anti-Jewish tirades incited to riot and evoked resentment from hundreds of tourists at every rally. The restriction was lifted however for Sunday's rally.

When the police had, on previous weeks, temporarily withheld loudspeaker permission, the rallies were smaller and more orderly because he did not attract crowds from blocks around. A number of tourist attractions are within range of the loudspeaker hi-fi system which Rockwell transports to the rallies on a trailer truck.

Six men were arrested during the weekend in Nazi disturbances here. Included were two Jews who voiced disagreement with nazism at the rally. Arthur Meyenhoff, a Hyatts-ville, Md. engineer, was arrested for shouting at Rockwell. But Rockwell, who taunted, baited and defended Jews, was not arrested, police said, because they had orders to preserve his "free speech."

Larry Selinker, 22-year-old Providence, R.I. man who recently received a master's degree from American University here, was arrested after being abused by one of Rockwell's "stormtroopers." The Nazi, also arrested, forfeited \$10 collateral, Mr. Selinker asked for a trial and will appear in Municipal Court on July 10.

In another Nazi fray, police in nearby Arlington, Va., at the Nazi headquarters building, arrested two Nazis and a non-Jewish anti-Nazi. The anti-Nazi and one Nazi were charged with assault. A second Nazi involved in the brawl was held for using profanity.

Despite widespread protests to the Marine Corps, a marine was again active at Rockwell's side this weekend as a "stormtrooper." Rockwell also bragged that he had just recruited a U.S, Capitol police officer to his "stormtroop force."

Arlington County Judge Paul D. Brown today convicted two men described by police as Rockwell supporters. One was found guilty of assault and sentenced to 60 days in Jail, 50 of which were suspended. Another was convicted of breach of the peace because he used "language calculated to provoke a fight." He was fined \$100 of which \$75 was suspended. Judge Brown continued until tomorrow assault charges against the anti-Nazi involved in the disturbance.

Protests Mount Against Permit for Union Square Nazi Meeting

NEW YORK, June 20. (JTA) .- Protests mounted here today against a rally scheduled to be held in Union Square, July 4, by the American Nazi Party. Demands were made upon Mayor Robert F. Wagner and Commissioner of Parks Newbold Morris to forbid the projected rally.

Among those who protested, and coupled their objections with requests that the rally be forbidden, were Rep. Frank J. Becker, New York Republican, who telegraphed Mr., Wagner from Washington; Rabbi Joachim Prinz, president of the American Jewish Congress; L. Joseph Overton, president of the New York branch of the National Association for the Advancement of Colored People, and Louis Hollander, manager of the New York Joint Board of the Amalgamated Clothing Workers of America, who is also a vice-chairman of the Jewish Labor Committee,

Rabbi Prinz, who also appealed to District Attorney Frank Hogan and Police Commissioner Stephen Kennedy, zwerted in his protest that George Lincoln Rockwell, leader of the American Nazi Party, "has no right to disturb the peace or cause a public disturbance," Rockwell's "diatribes" against Jews, voiced at public rallies in Washington, "are more violent and more vicious than those of any American anti-Semite," Dr. Prinz declared,

Congressman is "Outraged" by Permit to Rockwell

Rep. Becker informed the Mayor that he was "outraged" at the thought that an outdoor rally permit might be granted to Rockwell. The Nazi rallies, said the Congressman, "do not involve a matter of free speech because they are designed to destroy the freedoms of American citizens," (In Washington, Rep. Becker also complained to the Department of Justice against the continuing Nazi rallies being held in the capital.)

Mr. Hollander told Mayer Wagner and Commissioner Morris that, if a meeting like the one scheduled by Rockwell is held here, "it would be an insult not only to our Founding Fathers, but to all freedom-loving people of this great city and to our democracy, which the Fourth of July symbolizes."

In his letter of protest, Mr. Overton said that the projected Nazi rally "would create tensions in areas where non now exist", and would be extremely harmful to the harmonious intergroup relations that have been built up in our great city."

73 FEDERATIONS REPORT INCREASED GIVING; TEN EXCEED 1959 TOTALS

NEW YORK, June 20. (JTA) -- A total of 73 Jewish federations and welfare funds reported an average national increase of 3.6 percent from the same contributors as of June 17, in the closing stages of their campaigns, Irving Kane of Cleveland, president of the Council of Jewish Federations and Welfare Funds, disclosed today. The central community campaigns raise the bulk of all American Jewish philanthropic funds for local, national and overseas Jewish needs, with the United Jewish Appeal the largest single beneficiary.

The report noted that these results were accomplished despite the fact that, "for the first time in several years, there were noemergency headlines for Israel's needs." It pointed out that "instead, there was a more mature approach to Israel's long-range needs and to the enormous backlog of unmet needs. This included shifting some 60,000 immigrants from ma'abarot to permanent housing and the consolidation of agricultural settlements,"

Ten of the 73 cities reporting, exceeded or equalled their final 1959 totals. These were: Boston, Cleveland, Detroit, Toronto, Dallas, Louisville, Phoenix, Tucson, Canton and San Jose. Two more communities, Phila Iclphia and Newark, estimated their final results will surpass their 1959 tallies.

Total funds raised by these 73 cities amounted to \$57,482,169 as compared with \$55,476,141 raised last year.

BID GOVERNOR END BIAS IN HIGHER EDUCATION IN PENNSYLVANIA

HARRISBURG, Pa., June 20. (JTA) -- Judge David L. Ullman, chairman of the Feluwship Commission Committee on Opportunities for Higher Education, has urged the Governor's Committee on Education to end bias in higher education in Pennsylvania,

Judge Ullman proposed that legislation be enacted with non-discrimination provisions for grants affecting post-high school educational institutions. He also recommended that all colleges and graduate schools, other than denominational institutions, be required to drep all questions on their admission forms on race, religion or national origin of students,

Another proposal offered by the Jewish leader was for creation of a state commission or council on higher education which would seek to expand facilities and opportunities for such education for all qualified persons, regardless of race, religion, national origin, sex or economic status.

UNIVERSITY OF WISCONSIN TO SET UP HEBREW STUDIES DEPARTMENT

MILWAUKEE, June 20. (JTA) -- A Department of Hebrew Studies will be established by the University of Wisconsin in Milwaukee in the fall of 1961.

Dr. J. Martin Klotsche, University provost, said establishment of the department has been existed by a pledge of the Wisconsin Society for Jewish Learning to provide \$50,000 for the project.

The department is expected to be similar to that in the University at Madison, which is at the graduate school level.

RAGNAR JOSEPHSON IS ELECTED MEMBER OF SWEDISH ACADEMY

STOCKHOLM, June 20. (JTA) -- Professor Ragnar Josephson has been elected to the Swedish Academy, an 18-member body which decides on the awarding of the annual Nobel Prize for literature. He is the first Jew to be elected to the Academy, which includes leading representatives of Swedish culture.

Dr. Josephson is a professor of art history and has written several plays and poems on Jewish themes. Together with the late Professor Marcus Ehrenpeis, he translated a number of Hebrew poems into Swedish.

FRIEDA HENNOCK, FORMER FEDERAL COMMUNICATIONS COMMISSIONER, IS DEAD

WASHINGTON, June 20, (JTA) -- Frieda Hennock, 55, only woman ever to serve on the Federal Communications Commission, died here today.

 ${\bf A}$ brilliant New York attorney of Jewish faith, she was appointed to the commission by President Truman.

She led the fight for educational television. A supporter of Israel and Jewish causes, she is survived by William H. Simons, her husband.

YEHUDA SHUVAL, HILLEL FOUNDATION DIRECTOR, DIES IN ISRAEL

JERUSALEM, June 20. (JTA) -- Yehuda Shuval, director of the B'nai B'rith Hillel Foundation in Jerusalem and a veteran American Zionist, died in his weekend cottage at Ashkelon at the age of 61.

Mr. Shaval emigrated to Israel from New York in 1947. He served as director of the English-speaking department of the Keren Haysod for ten years, Before coming to Israel, it was chairman of the Joint Hadassah-Zionist Organization of America committee for youth affairs. He was also active in the field of Hebrew education and devised modern methods for teaching Hebrew which were used by the Israel broadcasting services.
