## ISRAEL SEEKS SECURITY COUNCIL DELAY PENDING BEN-GURION, FRONDIZI TALKS

UNITED NATIONS, N. Y., June 21. (JTA) -- Israel formally notified the Security Council tonight that Prime Minister David Ben-Gurion is to meet with President Arturo Frondizi of Argentina. The notification was given in a letter from Israel's permanent representative, Michael S. Comay, to Council President, Dr. Tingfu F. Tsiang, of China.

In his letter, Mr. Comay indicated that Israel wanted postponement or cancellation of tomorrow's scheduled meeting of the Security Council to debate a complaint filed last week by Argentina. Argentina accused Israel of violating its sovereignty by "illicitly and clandestinely" transferring Nazi killer Adolf Eichmann from Argentine territory to Israeli soil.

Mr. Comay pointed out that negotiations between Israel and Argentina were still continuing in accordance with some of the very provisions of the UN Charter invoked in its complaint by the Argentine delegation. The Charter holds that negotiations be exhausted before action is taken by the Security Council. Thus, the Israel letter implied, public debate of the issue in the Security Council would not be appropriate at the present time.

As of tonight, however, the Council was still scheduled to meet. It was believed that the Council would be convened on scheduled time but would adjourn subject to the "call of the chair" after the body had taken note of Israel's letter.

### To Meet This Weekend in Europe

Authoritative sources in Europe stated that the Frondizi - Ben-Gurion meeting would take place between Friday of this week and next Sunday, either at Brussels, or at The Hague.

In Brussels today, where he was winding up a State visit, Mr. Ben-Gurion flatly refused to concede there was any question over Eichmann. He said, in a television interview: "There is no Eichmann problem. Eichmann will be tried in Israel."

Both Israel and Argentina were ready today to argue their respective cases before the Security Council. Mrs. Golda Meir, Israel Foreign Minister, will defend Israel's position when such a defense becomes necessary. She interrupted an American lecture tour to direct Israel's case here.

The Argentine case will be presented by that country's permanent UN representative, Dr. Mario Amadeo. The latter is known to have talked on the telephone with Mr. Frondizi, and to have insisted that his delegation continue its action here against Israel, without asking for a Council recess on the issue.

### Argentine Delegate Accused of Pro-Nazism

Two New York newspapers, the Yiddish-language Forward and the New York Post, today accused Dr. Amadeo of having been, during World War II, "a trusted collaborator of the sicherheitsdienst," the Nazi intelligence service. Both newspapers based their reports on a quotation from a booklet issued in 1946 by the United States Department of State which had characterized Dr. Amadeo as a Nazi intelligence "collaborator."

In Jerusalem, the Israel Parliament's Foreign Affairs Committee held two special sessions today, devoted to discussion of Argentina's complaint and general Argentine Israeli relations. The committee heard reports from Haim Yahlil, the Foreign Ministry's director general, and Abba S. Eban, former chairman of Israel's delegation to the United Nations, who visited Argentina last month.

## POLISH COMMISSION TO DELIVER DOCUMENTS ON EICHMANN TO ISRAEL

JERUSALEM, June 21. (JTA) -- Poland will send an official, five-man commission here at the end of this month, to deliver to the Israel Government documents pertaining to the mass extermination of Jews and non-Jews by the Nazis, and especially connected with the wartime activities of the Nazis' "specialist" on the murder of Jews, Adolf Eichmann.

The Polish commission will include Prof. Kaminsky, chairman of the Warsaw Government's Committee for the Punishment of Nazi War Criminals, and Prof. Mark, head of the Jewish Historical Institute at Warsaw.

It was reported here that Poland has indicated it would like to send a Judge to sit on the bench with the Israeli Jurists when Eichmann is tried. Poland argued that Eichmann had committed most of his crimes on Polish territory.

## BELGIAN PREMIER FORECASTS CLOSE COOPERATION BETWEEN ISRAEL, CONGO

BRUSSELS, June 21. (JTA) -- Prime Minister David Ben-Gurion of Israel told a delegation of all Zionist organizations here today that Israel expected three actions from non-Israeli Jewries.

He said these were provision of Jewish education to all Jewish children "so that the Jewish people will be united by a common culture"; establishing personal ties with Israel by sending children to Israel to visit and study there, and "the hardest," personal settlement in Israel so that the youth from other Jewish communities would participate "in the upbuilding of the Jewish State."

The Prime Minister attended a State dinner last night given in his honor by Premier Gaston Eyskens and attended by leaders of the Belgian Senate and Parliament and various Cabinet Ministers.

Premier Eyskens<sup>s</sup> said at the dinner that it was his pleasure to note "the friendly relations between our two countries and our two peoples who both want to work for peace in a fruitful way." He added that the relationships were developing "harmoniously, especially in the economic field where some recent initiatives give the hope that new progress will be achieved." The Premier added he was certain that "useful cooperation between Israel and the young State of the Congo will be established and that the Congo will find in Israel things to follow as examples, mainly in the field of rural economy and the organization of cooperatives."

## KNESSET VOTES BUDGET INCREASE, DEFERS ACTION ON COMPULSORY LOAN

JERUSALEM, June 21. (JTA) -- The Knesset today passed by a narrow margin a bill increasing Israel's current budget by 110,000,000 Israeli pounds (\$61,600,000). Only the coalition parties voted for the bill. There was no action on an additional proposal by the Finance Ministry and the Treasury for the levy of a compulsory loan from property owners in the form of advance tax payments.

One of the groups in the coalition government, the Progressive Party, opposes the compulsory loan feature of the new budget. The issue will be taken up again next week when Prime Minister Ben-Gurion has returned from Europe.

The Government's financial authorities anticipate that 40,000,000 pounds (\$22,000,000) of the new monies will be borrowed abroad. The entire, additional 110,000,000-pound budget is needed, the Knesset was told, for security purposes, immigrant housing, slum clearance, expansion of water resources and stepped-up industrial production.

## SEES FIRST STAGE OF JORDAN-NEGEV WATER PIPELINE COMPLETED BY 1963

TEL AVIV, June 21. (JTA) -- The first stage of the Jordan-Negev pipeline, Israel's largest irrigation project, should be completed by the end of 1963, if the current work pace keeps up. Aharon Wiener, chief engineer of the Israel Water Planning Authority, told members of the Knesset Finance Committee during a tour of the headwaters of the Jordan River. The Jordan-Negev pipeline is being constructed to bring the waters of the Jordan River to Israel's parched Negev.

Israel's plans to divert some of the Jordan waters have evoked threats of war from President Nasser of the United Arab Republic and announcements of plans by Lebanon and Syria to divert tributaries in their territories of the Jordan River.

Large volumes of Jordan water will begin irrigating parts of the Negev on completion of the first stage of the project at the end of 1963, Mr. Wiener told the deputies. An interim project, involving the laying of a 108-inch pipeline from the Pardes Hanna area to Tel Aviv, will be ready by the summer of 1962 to relieve the growing water shortage in the vicinity of Israel's largest city, Mr. Wiener said.

### Israeli News Briefs

JERUSALEM, June 21. (JTA) -- Colonel Yehuda Ben-David, Israel Consul General at Dakar, has been officially accredited as ambassador to the Mali Federation, which attained independence yesterday. He is the first accredited envoy to the new republic.

JERUSALEM, June 21. (JTA) -- A 64-year-old American Jew named Harry Stone, formerly Steinman, was shot and killed by Jordan border guards last night when he failed to heed their orders to halt as he approached the frontier in central Israel. Stone carried a mariner's papers and had been living in Shaar Haaliya.

JERUSALEM, June 21. (JTA) -- Israel and Cambodia have raised the status of their representation from legation to embassy. Mordechai Kidron, Israel Ambassador to Thailand, was named non-resident ambassador to Cambodia.

JERUSALEM, June 21. (JTA) -- Dr. Simon Btsh, head of the epidemiological department of the Israel Ministry of Health, has been appointed head of the organization department of medical care at Geneva headquarters of the World Health Organization. Dr. Btsh, 53, will serve the specialized agency for two years.

#### A. J. C. ASKS DEMOCRATS FOR PLANK BARRING ARAB BIAS AGAINST U. S. JEWS

NEW YORK, June 21. (JTA) -- The Democratic Party was urged today by the American Jewish Congress to include a plank in its 1960 platform to protect American citizens from religious discrimination by Arab countries.

The request was made by Shad Polier, AJC vice-president, in a statement delivered at the Democratic National Committee advance platform hearings here. He said that during the past two years, "the impact of the Arab boycott upon the rights of American citizens and the resulting impairment of basic policies of our Government have become intolerable."

He told the session that the United States for years "has passively accepted the denial by Arab countries of entry and transit visas to American Jewish citizens and the barring of U. S. military and civilian personnel of Jewish faith from our Air Force installations at Dhahran, Saudi Arabia."

#### TEXTBOOK STUDY SHOWS NEED FOR 'HISTORICAL FACTS' ON HITLER REGIME

PHILADELPHIA, June 21. (JTA) -- Public, private and parochial schools must teach the "historical facts of Hitlerism, including racism and genocide, and the law should require teacher-training in intergroup relations," the Jewish Exponent declared in its current issue, after completing an examination of high school and college textbooks here.

The study and recommendations stressed that "omission of racial and genocidal information of the Hitler period in typical history textbooks ranges from aching silence to stammered partial truth."

Mrs. Emily Sunstein, who made the study, quoted textbook publishers as contending that, because of the economic factors involved, they must keep "controversial matter" out of textbooks. On the basis of these interviews, the writer said: "We must assume that Hitler's racial and genocidal policies are a subject which Americans do not want to digest. They may be historical facts--but they are controversial."

The Exponent writer proposed that psychologists, human relations experts and educators create special programs to teaching the historical facts about racism and genocide to students.

"In spite of fears of publishers," she asserted, "like-minded school boards and organizations could join together to demand that realism and historical fact be written into textbooks. Publishers would undoubtedly comply. Until they do, special paperback or mimeographed material should be created to supplement texts."

#### GROSSE POINTE RESIDENTS CONDEMN ANTI-JEWISH 'POINT SYSTEM'

DETROIT, June 21. (JTA) -- A group of Grosse Pointe residents went on record today as strongly opposing the "point system" used to bar Jews and other "undesirables" from the exclusive area as "an affront to the standards of decency in human relations."

The group expressed its views in a letter to Corporations and Securities Commissioner Lawrence Gubow who is holding hearings on the Grosse Pointe housing bias practices. It commended the commission for "searching out the truth."

The signatories to the letter said they "hold firmly to the belief that racial, religious and national prejudices have no place in our democracy."

#### SWASTIKAS DAUBED ON JEWISH HOMES IN NEW JERSEY RESORT TOWN

ATLANTIC CITY, N. J., June 21. (JTA) -- The homes of three Jewish families in neighboring Absecon were defaced during the night with swastikas and anti-Jewish slogans warning the Jewish occupants to leave town. Two of the three homes had been similarly defaced last February.

Police said today that they believed adults were responsible for last night's incidents although they had ascribed previous events to juvenile pranksters.

#### AMERICAN LEGION IN LOS ANGELES DEVOTES JULY 4TH CELEBRATION TO ISRAEL

LOS ANGELES, June 21. (JTA) -- This year's Fourth of July celebration and fireworks display in the huge Los Angeles Coliseum will be dedicated by the County Council of the American Legion to a "Salute to Israel."

Tremendous fireworks displays will depict the contributions to civilization of Israel and the Jewish people. Michael Comay, Israel's permanent representative at the United Nations, and Yaacov Avnen, Israel Consul General in Los Angeles, will be guests of the American Legion.

The board of directors of the Jewish Federation-Council praised the American Legion for the plan and for its work in aiding relations between Israel and the United States.

Arrangements for the salute were worked out by American Legion officials with the Community Relations Committee of the Jewish Federation-Council.

## CRUSADING JEWISH EDITOR ESCAPES MIAMI BOMB ATTACK

MIAMI, June 21. (JTA) -- A bomb was hurled early this morning at the home of Samuel Mindlin, whose last name is the same as Leo Mindlin, executive editor of the Jewish Floridian. The two are not related.

Leo Mindlin has been crusading editorially against a local radio commentator, Alan Courtney, of Station WQAM, who has accused Israel, on the air, of "crimes worse than Hitler's." Courtney has insisted in his broadcasts that Nazi killer Adolf Eichmann, awaiting trial in Israel for the mass murder of Jews, "must be assumed innocent until proved guilty."

The bomb in front of the Samuel Mindlin home tore a hole three feet wide by three feet in depth on the lawn and sidewalk facing the Samuel Mindlin property. Police and FBI are investigating the attack, and have placed the homes of both Mindlins under 24-hour surveillance.

Leo Mindlin reported in his column last week that he had received seven threatening letters, two of which had warned that his home would be bombed. He stated that all of the letters included "crudely anti-Semitic" remarks.

Courtney has been haranguing on the air against Leo Mindlin and his newspaper, accusing them of having "crucified" Roy Cohn, former counsel for the late Senator Joseph McCarthy. He has been accused by Ralph Renick, vice-president in charge of news of the local CBS-TV affiliate, Station WTVJ, of "arousing the worst instincts" of men.

Officials of Station WQAM have denied any responsibility for the opinions expressed on the air by Courtney.

## A. D. L. OFFICIAL SAYS WASHINGTON POLICE ARE 'MISGUIDED' IN HANDLING NAZIS

WASHINGTON, June 21. (JTA) -- The United States park police force and the chief prosecutor of the District of Columbia were accused today of "gross injustice" by Ben Strouse, chairman of the regional board of the Anti-Defamation League of B'nai B'rith.

Mr. Strouse pointed out that the authorities tolerated Nazi provocations but prosecuted Jews. The ADL chairman charged officials with "misguided" interpretation of their responsibilities.

In a public statement, Mr. Strouse protested that "for six months now, the American Nazi Party has been permitted to engage in vile public threats and insults on the streets and parks of our nation's capital. It has been guilty of disorderly conduct. It has constituted a public nuisance."

Mr. Strouse said that "now we have witnessed the disgraceful spectacle of the park police arresting and the corporation counsel prosecuting the innocent victims of the Nazi provocations..."

He termed the Jews arrested "people who have naturally and righteously reacted to these public threats and insults in a normal American way."

The ADL chairman said "these officials, in our view, have shown a misguided sense of their responsibility and have committed a gross injustice."

The chief prosecutor of the District of Columbia at an arraignment hearing today ordered a Jew held for trial on July 12 for annoying Nazi leader Lincoln Rockwell by "talking loud" while Rockwell was delivering an anti-Semitic harangue at a public rally. The defendant, 22-year-old Larry Selinkin, of Providence, R. I., was criticized by the public prosecutor, Clark King, who made the decision to press charges.

## Supreme Court to Hear Plea Today for Injunction Against Nazi Rally

NEW YORK, June 21. (JTA) -- Justice Vincent Lupiano will hear argument tomorrow morning in New York County Supreme Court on two motions for an injunction restraining Newbold Morris, New York City Commissioner of Parks, from granting a permit to the "American Nazi Party" for a rally in Union Square on July 4.

One action was brought by State Senator Frank J. Pino and Assemblyman Irvin Brownstein who obtained a temporary injunction from Justice Louis L. Friedman in Brooklyn yesterday. The second action was initiated by the Public Awareness Committee.

In granting a temporary injunction pending the hearing by Justice Lupiano, Justice Friedman warned in a four-page decision that there would be "bloodshed, violence and riot under our very eyes" if the Nazi meeting were to be held. He said the police would be powerless to halt the violence.

Civic and Jewish organizations continued today to transmit protests to City Hall against Mr. Morris' reported intention to grant the permit. The Auschwitz-Buna Memorial Scholarship Fund, an organization of survivors of the dread Auschwitz camp, telegraphed a warning to Mayor Wagner and Commissioner Morris against permitting the Nazi meeting.

"Speaking for the pitiful number of those who escaped the gas chambers and crematoria of Auschwitz," the message said, "we warn America that your permitting the American Nazi Party rally could lead to the defeat of America by its own Constitution." Protests also came from the Transport Workers Union and the Fourteenth Street Association.
