GERMANS TO RAISE EXTRADITION OF NAZIS FROM ARGENTINA WITH FRONDIZI

BONN, June 28, (JTA) -- The extradition of Nazis who have fled to sanctuary in Argentina will be one of the topics to be discussed with President Arturo Frondizi of that country during his current visit to West Germany.

Dr. Fritz Schaffer, West German Minister of Justice, made the announcement in the Bundestag last night as questioning of the Government's policy by the opposition Social Democrats continued.

Dr. Schaffer asserted that the West German Government would immediately ask for the extradition of Nazi criminal Adolf Eichmann if Israel would return him to Argentina. He pointed out that Argentine authorities had explicitly rejected one West German request for extradition of a wanted Nazi criminal and that in other cases, the Nazis could not be found in Argentina, having left the country before the Argentine Government reached a decision on the West German requests.

NEW YORK WARRANT IS ISSUED FOR ROCKWELL, NAZI 'FUEHRER'

NEW YORK, June 28. (JTA) -- A warrant was issued here today for the arrest of George Rockwell, self-styled leader of the "American Nazi Party," on charges of disorderly conduct and inciting to riot. The warrant was issued by Kings County Supreme Court Justice Louis Friedman on a complaint signed by Lester Fahn, a member of the Jewish War Veterans of New York.

Mr. Fahn's complaint was based on the incident in the New York County Supreme Court building here last week when Rockwell was nearly mobbed by some 150 persons after making anti-Semitic remarks during a television interview outside the courtroom. Rockwell is subject to arrest on the warrant whenever he enters New York State. (Earlier story on page 4.)

BEN-GURION BACK AT WORK AS ESHKOL LEAVES TO VISIT AFRICAN STATES

TEL AVIV, June 28. (ITA) -- Prime Minister David Ben-Gurion resumed this morning his daily morning walk and later returned to his office to resume his regular duties as Premier and Defense Minister.

He spent several hours yesterday at the Herzlia seashore and was applicated by thousands of bathers.

Finance Minister Levi Eshkol, who had been acting Prime Minister during Mr. Ben-Gurion's visit to Europe, left soon after the Prime Minister's return for the Belgian Congo, That will be the first leg of a West African tour during which he will also visit Liberia. Ghana and Nigeria. He said, on his departure, that Israel anticipated cooperating with Africa's new nations and would place its technical and scientific skills at their disposal.

ISRAEL FOREIGN MINISTER MEETS WITH SENATE FOREIGN RELATIONS COMMITTEE

WASHINGTON, June 28. (JTA) -- Israel development programs were described to the Senate Foreign Relations Committee today by Israel Foreign Minister Golda Meir, Mrs. Meir was guest at a luncheon tendered by Chairman J. W. Fulbright, Arkansas Democrat.

Senator Fulbright said later that a "friendly, informal atmosphere prevailed," He said that Arab-Israel relations were covered in broad context. The Eichmann case was not discussed, he said. A short question-and-answer period followed the lunchon.

Mrs. Meir later met with the staff of the Israel Embassy here and a group of potential investors in Israel undertakings. Prior to his departure tonight for New York, she had nothing to say beyond the customary pleasantries about the luncheon today.

SEVEN ISRAELI JEWS EN ROUTE TO BONN TESTIFY AGAINST OBERLAENDER

BONN, June 28. (JTA) -- Testimony to be provided by seven Jewish witnesses, now envote from Israel, will largely determine whether the federal prosecutor here will ask Parliament to lift the immunity of Dr. Theodor Oberlaender, former Minister for Refugees, whose alleged Nazi past is now being investigated by the law enforcement agencies and by Parliament itself, the prosecutor's office said today.

OBJECTION RAISED TO ISRAELI CLAIMS TO SPEAK FOR JEWS OF WORLD

PARIS, June 28. (JTA) -- A number of leaders at the World Conference of Jewish Organizations expressed dissatisfaction today over the occasional practice of Israeli Government leaders in claiming to speak on behalf of all Jewry.

The conference authorized its chairman, Label A. Katz, president of B'nai B'rith, to bring the issue to the attention of Prime Minister David Ben-Gurion with whom Mr. Katz is going to meet next week in Jerusalem. Mr. Katz is going to Israel at the invitation of the Prime Minister.

The conference decided to hold another meeting in September to establish itself as a permanent world organization. From reports of the discussion, which was held behind closed doors, it was not clear how such a world Jewish body would function side by side with the World Jewish Congress since both would have, at least technically, the same areas of activity. However, the leadership of the World Jewish Congress, including Dr. Nahum Goldmann, its president, took an active part in the two-day conference.

ISRAEL TO TAKE CENSUS OF SKILLED MANPOWER POTENTIAL

JERUSALEM, June 28. (JTA) -- A nationwide census of Israel's manpower potential in engineering, the natural sciences, mathematics and agriculture will get underway immediately, it was announced here today.

The survey will provide an up-to-date picture of the current manpower situation in these fields and will help in forecasting the country's professional requirements in the coming decade.

The results of the census will also assist the Government in estimating the possibilities of expanding technical assitance to the underdeveloped countries of Asia and Africa.

U.S. COMPACT CAR ASSEMBLED IN HAIFA TO COST ISRAELI PURCHASERS OVER \$6,000

JERUSALEM, June 28. (JTA) -- The Studebaker custom Lark model, being assembled at the Kaiser-Frazer automobile assembly plant at Haifa, will cost an Israeli purchaser 10,900 pounds (\$6,104), according to a government ruling issued today.

The Lark is now being assembled by the Kaiser-Frazer plant at Haifa in place of the French Renault Dauphine, since the French firm withdrew its Israeli franchise in deference to the Azab League's anti-Israeli economic boycott.

Of the total retail price for the Lark to purchasers in this country, the seller will receive only 6,000 pounds (\$3,360), the remainder of \$2,774 going to the government in the form of excise taxes.

UNITY IS CRUCIAL JEWISH PROBLEM OF NEXT DECADE, NEUMANN DECLARES

ANTWERP, June 28. (JTA) -- The "crucial" problem facing world Jewry in the coming decade is "the unity of the Jewish people in Israel and the Jews outside of Israel," Dr. Emanual Neumann, president of the World Confederation of General Zionists, told 100 delegates representing eight countries at the opening session of the European Conference of General Zionists here last night. He appealed for an interchange of ideas between Jews in Israel and those living in other countries.

JERUSALEM, June 28. (JTA) -- The Jerusalem Municipal Council accepted a gift of \$70,000 from Mrs. Harry Sacher of London to establish a park in the new government offices area.

JERUSALEM, June 28. (JTA) -- Panama's Minister of Agriculture, Amilcar Tribaldos, on a visit here, has asked Israel to send an irrigation expert to Panama to advise his ministry.

JERUSALEM, June 28. (JTA) -- The Rockefeller Foundation has made an additional \$0.00 grant to Tel Hashomer Hospital for its research on blood solvents as a factor in hereditary illnesses.

CHICAGO, June 28. (JTA) -- More than 60 Israeli firms are represented here at the Israel exhibit of the International Trade Fair.

AMSTERDAM, June 28. (JTA) -- Trade between The Netherlands and Israel in 1959 reached a total of 96, 700, 000 guilders (about \$26,000,000) -- almost double the 1058 total. Israel's exports to The Netherlands amounted to \$7,000,000. Dutch exports to Israel totaled \$19,000,000.

PARIS CONFERENCE HITS DELAYS BY GERMANY IN SETTLING CLAIMS

PARIS, June 28. (JTA) -- The Conference on Jewish Material Claims Against Germany said today that less than one-fourth of chims for compensation by individual victims of the Nazi era had been processed by the first of this year.

Of 2,674,328 claims filed, only 596,403 had been processed to January 1. Delegates to the conference here also were told that the West German indemnification law expires on December 31, 1962 and that at the present pace, the full program could not be completed by that date.

The conference recorded its "deep comern" and urged the West German states to speed the rate of settlement by simplifying procedures and adding personnel to ensure that many thousands "are not cut off from the indemnification due them and which they desperately need."

Dr. Nahum Goldmann, who presided, said that in processing claims for compensation for permanent physical and mental injury suffered under Nazi persecution, states were demanding a volume of documentation "which it is practically impossible to provide and which is definitely contrary to the spirit of the federal law which requires only that reasonable proof be given."

JEWS CAN GIVE HOPE TO WORLD, JEWISH WOMEN'S CONVENTION IS TOLD

BASLE, June 28. (JTA) -- The Jewish people of the world can give "hope to mankind, facing the terrifying prospect of self-destruction," Mrs. Benjamin Robinson, of Montreal, president of the International Council of Jewish Women, told the annual convention of the ICJW that convened here today for five days of discussions.

More than 500,000 Jewish women, from 19 countries, are represented at the convention by 130 delegates. Yugoslavia is represented at the convention for the first time in the organization's history. Five Yugoslav Jewish women are here as observers.

"As Jews," Mrs. Robinson told the delegates, "we can tell the world to have faith because we have survived horrors and have kept alive." She paid particular tribute to Israel where, she said, "Jews demonstrate toall the world their faith in the future." Most affiliates of the ICJW support educational work in Israel.

ANFUSO BIDS ISRAEL INVITE OTHER COUNTRIES TO PARTICIPATE IN EICHMANN TRIAL

KIAMESHA LAKE, N.Y., June 28. (JTA) -- Rep. Victor L. Anfuso of New York proposed tonight that Israel invite countries with "an honest interest" in Adolf Eichtrann to send legal representatives to participate in the trial and thus give it "an international atmosphere appropriate for the trial of one guilty against all humanity."

The Congressman told the 73rd annual convention of the Order Brith Abraham that Israel "should not dirty its hand by sentence or taking any part in meting out punishment" to Eichmann but should, after he is committed, return him "to the country of his origin or birth for such action as this country may see fit to take,"

(Israel's right to try Eichmann rests on firm legal as well as moral grounds, according to a study by the American Jewish Congress published today. The analysis cites precedents in international law and in American Jurisprudence supporting Israel's claim to Jurisdiction. The study notes that international law has no provisions governing Jurisdiction by individual nations in criminal cases. In certain crimes, such as piracy, all nations are considered to be equally affronted and any state acquiring physical custody of the accused may try him, it is noted.

("The genocidal acts of which Eichmann is accused would seem to comprise no less universal a crime under international law than piracy," the report asserts.)

JUDGE SOBELOFF WARNS JEWS MUST REMEMBER SURVIVORS OF EICHMANN

CHICAGO, June 28. (JTA) -- The Adolf Eichmann case must not absorb Jewish interest to the exclusion of "far more important business--the responsibility of the Jewish people to those who were so fortunate as to escape Eichmann's slaughter of innocents," Judge Simon E. Sobeloff of the United States Court of Appeals warned here.

Judge Sobeloff was the principal speaker at a dinner on behalf of the Combined Jewish Appeal of Metropolitan Chicago. Howard Mesirow, general chairman of the Appeal, announced that, thus far this year, the CJA has Taised \$4,528,119, an amount "considerably ahead of the sum raised at this point in the campaign a year ago."

Those who survived the atrocities committed by Eichmann and his kind, Judge Sobeloff told the 250 Chicago leaders assembled at the dinner, have "necessarily become the care of their kinsmen. American Jews were the greatest single force in their rescue. We must not let the Eichmann case overshadow our responsibility to the living, the survivors, "

JUSTICE DEPARTMENT, MARINE CORPS CLASH OVER NAZI MARINE'S ACTIVITIES

WASHINGTON, June 28. (JTA) -- The activities of a member of the United States Marine Corps in the "American Nazi Party" found the Corps and the Department of Justice at odds today over the facts in the case.

The Marine Corps has taken the position that it could not take action against the marine because the Justice Department had advised that the Nazi group was not on the Attorney General's subversives list and there was no violation of the law.

Assistant Attorney General J. Walter Yeagley informed the JTA today that "neither I or anyone .in the Department of Justice, to my knowledge, has furnished the Marine Corps with an opinion concerning the affiliation of marines with the American Nazi Party."

The Marine Corps reasserted its contention today that the marine's affiliation with the Nazis was legal because the party was not on the Attorney General's list.

The Justice. Department was reportedly continuing its inquiry into activities of George Lincoln Rockwell and his American Nazi Party, but Mr. Yeagley noted that before the Department could take action, "there must be specific evidence to establish a violation of a specific Federal statute." He pointed out that "notwithstanding the highly offensive nature of the activities...they usually involve the interpretation and application of the free speech and assembly guarantees of the First Amendment and the Constitution,"

A delegation representing the Anti-Defamation League of B'nai B'rith, headed by Ben Strouse, chairman of the regional ADL board, conferred with Secretary of the Interior Seaton today on the continuing use of a District of Columbia park area under the Department's jurisdiction for rallies by the Rockwell group.

N.Y. SUPREME COURT ISSUES TEMPORARY BAN ON AMERICAN NAZI PARTY IN STATE

NEW YORK, June 28. (JTA) -- A temporary injunction banning the activities of George Lincoln Rockwell's co-called American Nazi Party in New York State was issued today by Kings County Supreme Court Justice Louis Friedman,

The order, which was requested by State Sen. Frank Pino and Assemblyman Irwin Brownstein of Brooklyn, directed Rockwell to appear in court on August 22 to: show cause why he should not be permanently enjoined from conducting activities in New York State under the name "American Nazi Party" and from using the swastika emblem,

Justice Friedman, in issuing the injunction, said that no question of free speech was involved in this case. He asserted that Rockwell was a "threat to our way of life, " if newspaper reports about his statements were true.

Rockwell did not appear at the hearing. He notified the court by telegram that the American Civil Liberties Union had advised him not to appear at the hearing.

SAYS ORTHODOX RABBIS FAILED TO MEET CHALLENGE OF PAST DECADE

STE. AGATHE DES MONTE, Que., June 28, (JTA) -- The executive vice-president of the Rabbinical Council of America, Rabbi Israel Klavan, told the 25th annual convention of the orthodox rabbinical group today that "the challenge of the past decade in terms of the religious revival has not been adequately met by the rabbinic and educational leaders" of American Orthodox Judaism.

Warning that "we must not look back upon these golden years with any degree of complacency, self-satisfaction and narrow pride," Rabbi Klavan declared that "we could have revitalized and rejuvenated the entire structure of the Jewish collectivity if we had been prepared to assume the burdens, disciplines and challenges of this action-packed era." He spoke at a testimonial convention banquet honoring him on the occasion of his 20th year in the rabbinate and tenth year as executive head of the Rabbinical. Council.

Despite what he termed Orthodoxy's inadequate response to the religious revival, Rabbi Klavan said that "the community served by the Rabbinical Council of America has made phenomenal and incredible strides in giving Orthodox Judaism a much greater stature, deference and regard on the American Jewish scene."

He warned that the years ahead "are going to demand the ability to face the issues and tackle the problems which increasing opportunities will present to us." He said Orthodox Judaism must "quadruple the number of institutions of Jewish learning, study and higher education. We must vastly increase the quantity of publications and Journals which can serve the intellectual needs and wants of Jewish youth and the general population."

NEW YORK CAMPAIGN FOR UNITED JEWISH APPEAL PASSES \$23,000,000 MARK

NEW YORK, June 28. (JTA) -- More than \$23,000,000 has been raised by the United Jewish Appeal of Greater New York to date in the 1960 campaign, it was disclosed today. More than \$1,500,000 was raised at 12 Person-to-Person sessions held under the chairmanship of former Senator Herbert H. Lehman,
