FRONDIZI REITERATES DEMAND FOR EICHMANN'S RETURN TO ARGENTINA

LONDON, July 4. (JTA) -- Arturo Frondizi, President of Argentina, today reiterated his demand for Israel's return of Nazi killer Adolf Eichmann to Argentina. He warned that his country's envoy to Israel, Ambassador Rodolfo Garcia Arias, will not return to his post in Israel until "ample reparation" is received from Israel for the violation of Argentine sovereignty by the transfer of Eichmann from Argentine to Israeli soft

Dr. Arias was recalled from Israel to Buenos Aires on June 12, following Argentina's sharp note to Israel four days earlier, demanding Eichmann's return.

(The Israeli Foreign Ministry in Jerusalem announced today it had been informed by the Argentine Foreign Ministry that Dr. Arias will not return, having been "given a new assignment,")

Mr. Frondizi made his announcement about his Government's continued insistence on the return of Eichmann in answer to questions from correspondents at a news conference here this morning. Affirming that his country still maintains its demand for Eichmann's return, he added: "Should Israel not comply with our request, we will demand ample reparations,"

Refusing to specify the kind of reparation he has in mind, the Argentine President declared that the current Argentine-Israeli talks on this issue are dealing with this matter.

After he said that Ambassador Arias will not return to Israel until "full satisfaction is received from Israel, the President was asked whether his Government contemplates breaking of diplomatic relations with Israel if the current negotiations with Israel should break down. He replied: "This depends on the outcome of the talks."

Argentina, said its Chief of State, is ready to extradite: war criminals upon the receipt of proper requests for their extradition. He revealed that the Argentine police have made a general census of war criminals residing in Argentina, but said that each demand for extradition will be dealt with on an individual basis.

NEW ISRAEL NOTE REJECTS ARGENTINE REQUEST, STRESSES FRIENDLY RELATIONS

JERUSALEM, July 4. (JTA) -- The Israel Government today sent its formal reply to Argentina's note of June 8, in which the Buenos Aires Government had asked for the return of Adolf Eichmann and the punishment of those who had captured the Nazi specialist in the mass murder of Jews.

While the contents of the long-delayed note were not disclosed, the letter is understood to make it clear that Israel has no intention of returning Eichmann to Argentina.

At the same time, however, the note reaffirms Israel's full respect for Argentine sovereignty. The letter declares that one of Israel's most important foreign policy goals is the preservation of friendly relations with Argentina.

The Israel reply was sent today after the Foreign Minister at Buenos Aires had reminded Israel's Ambassador there, Aryeh Levavi, that it had not as yet received a reply to its June 8 letter to Israel. Mr. Levavi was expected to present his new note to the Buenos Aires Foreign Ministry today.

Strenuous efforts are being continued here to attempt a rapprochement with Argentina and the re-establishment of the friendly relations that have existed with Argentina for 12 years. Israell circles here are considering a special gesture of amity toward Argentina, possibly the sending of a high-ranking personality whose task would be to soothe Argentinian sensibilities that have been hurt by the admitted violation of Argentine sovereignt.

Eichmann is officially still under detention for interrogation, and no date has yet been fixed for his formal graignment on the charges of "crimes against the Jewish people" and "crimes against humainty." Both those charges carry the death penalty under Israeli law. Yesterday, a magistrate went to his secret place of custody and extended the detention order against the Nazi for the fourth time. The new warrant prolongs the detention, pending a hearing. for another 15 days.

GOVERNMENT FORBIDS ROCKWELL TO HOLD RALLIES ON WASHINGTON MALL

WASHINGTON, July 4. (JTA) -- The United States Government today forbade George Lincoln Rockwell, leader of the Ammican Nazi Party, to hold any more rallies on the Mall--an area that attracted many thousands of tourists here today to celebrate Independence Day,

The order was issued by Elmo Bennett, administrative assistant to Secretary of the Interior Fred A. Seaton. It followed a bloody melee on the Mall yesterday, when Rockwell and 12 of his cohorts were arrested, some were beaten, while five anti-Nazi hecklers were also taken into police custody. All those arrested, including Rockwell, were released in moderate bail for hearings Wednesday on charges of disorderly conduct.

Mr. Bennett told the Jewish Telegraphic Agency that the order against using the Mall for speeches without a permit is directed against anyone attempting to hold a meeting there. Asked whether Rockwell would be granted such a permit, if he applied, Mr. Bennett stated flatly that permission would be denied to Rockwell because the type of preachments he utters!in public are always likely to incite to riot,

Promptly at his accustomed hour of 2 p.m., today, Rockwell and a dozon of his followers in uniform, featuring swastika armbands, showed up at his usual rallying point on the Mall, He started by announcing that he would exercise his "constitutional right of free speech." A police officer then-served him with the order from the Department of the Interior which has Jurisdiction over this area--a square flanked by the historic Archives Building, the Smithsonian Institution and the National Gallery of Art. Many of the tourists in the square at the time were lined up to view the original Declaration of Independence exhibited in the Archives Building.

Rockwell was told that he could use one of two other location in this city to exercise "free speck." He chose the nearest site, Judiciary Square, a relatively isolated area seven blocks away from the Mall.

Anti-Nazis Outshout Speaker; Police Prevent Fighting

By the time Rockwell reached Judiciary Square with his group now numbering 20 men, including some in civilian dress, about 25 anti-Nazis had gathered there. Police, outnumbering the combined number of Nazis and anti-Nazis, interposed themselves between the two sides. Rockwell, mounting a red-painted tin bucket, started to speak. His platform, banners and other public-rally paraphernalis had been destroyed in yesterday's fighting.

As Rockwell started shouting "Ladies and Gentlemen--and Jews," the anti-Nazis began hissing, booing, and yelling anti-Nazi slogans. He tried for an hour and a half to speak, but never uttered more than two or three words without being outshouted by the anti-Nazis. The police allowed the latter to reply to every one of Rockwell's attempted insults and jibes. Finally, Rockwell gave up. He and his group departed. Unlike yesterday, there had been no fighting.

Riot Reminiscent of Berlin Street Brawls in Early Nazi Days

A number of brownshirted Nazis were severely beaten at Rockwell's rally yesterday. Rockwell himself hid under the speakers platform at the first sign of violence, but his "Deputy Commander," Kenneth J. V. Morgan, was injured. Police were compelled to set up riot control conditions and to separate the estimated 50 persons who were exchanging blows.

Rockwell's Nazis evidently got the worst of the fight, and some required medical attention. The Chief of the Washington Park Police and the Chief Prosecutor for the District of Columbia were present. A number of Israeli tourists in Washington and local Jews became involved in the brawl. Witnesses described the brawl as reminiscent of the street fighting in Berlin, in the early 1930's, between anti-Nazis and the adherents of Hitler.

Before the fighting started, two Jews were arrested for heckling Rockwell. One "storm-trooper" was arrested by Armed Forces police for purposes of an identification check on his duty status. He was released, having established that he has been discharged from the service.

In the course of the fighting, the Nazi banner was trampled. An SS pennant, with skull and crossbones insignia of the SS troops of Hitler Germany, was ripped from its standard.

The Jew-baiting reached such a point that veteran police officers said it was "absurd to consider such hateful threats and abuse" of the public to be legitimate "free speech, "There was also resentment on the part of police to Nazi attempts to arrogate to themselve police power in a para-military formation guarding Rockwell and restricting the public in part of the park.

The police, however, sought to behave objectively against all infractions considered breaches of the peace.

JEWISH VETERANS HOLD RALLY IN UNION SQUARE, CLOSED TO ROCKWELL

NEW YORK, July 4. (JTA) -- More than 1,000 New Yorkers today attended an Independence Day celebration here in Union Square--the area denied for a proposed rally by George Rockwell, leader of the American Nazi Party. The celebration had been organized by the Jewish War Veterans of the United States.

New York State Assemblyman Irwin Brownstein, one of the men responsible for obtaining an order from Mayor Robert F. Wagner, forbidding the Rockwell meeting in Union Square, was among the speakers. All of the speakers condemned all forms of totalitarianism, and assailed Rockwell's Nazi sentiments.

Police were out in strength to prevent any attacks that might have been made by local adherents of Rockwell. However, the patriotic celebration was unmarred.

GERMANS ARREST WAR CRIMINAL ON INFORMATION SUPPLIED FROM ISRAEL

HAMBURG, July 4. (JTA) -- The first warrant for the arrest of a Nazi war criminal based on information supplied by Yad Vashem, the Israeli authority which chronicles the events of the Nazi holocaust, was issued here this weekend. The arrest was ordered of Ludwig Hahn, a former SS officer.

Another Nazi, former SS officer Schoenemann, whose identity was also supplied by Yad Vashem, was found to have disappeared when police swooped down on his home in Cologne. Both men are wanted for the murder of countless Jews in the Warsaw Ghetto and the Treblinka death camp.

Yad Vashem forwarded to the West German authorities last month a list of 325 war criminals believed to be alive,

ISRAEL COMPLAINS TO U.N. AGAINST BORDER AGGRESSIONS BY SYRIA

UNITED NATIONS, N.Y., July 4. (JTA) -- The situation along the Usraeli-Syrian border, where "a period of relative quiet "has existed for several months, has again "deteriorated" as a result of aggressions by the Armed Forces of the United Arab Republic, the Security Council here was warned this weekend by the Israel Government.

Five specific attacks by heavy Syrian gunfire, resulting in the death of one Israeli border patrol officer, the pinning-down of other Israelis, and gunfire attacks against UN observers trying to pacify the area are listed in Israel's latest complaint to the Security Council. The attacks occurred between June II and June 28.

According to Michael S. Comay, Israel's permanent representative, the Cairo radio has also stepped up its "bellicose and threatening" broadcasts. A June 27 broadcast cited by Mr. Comay declared that the First Syrian Army, along Israel's frontier, has been ordered to "first shoot, then wait for instructions."

Mr. Comay's letter, addressed to Jose A. Correa, of Ecuador, this month's president of the Council, noted that "these aggressive actions and declarations of the United Arab Republic constitute a violation of the United Nations Charter and a constant threat to peace in the area, " The letter did not ask for a meeting of the Council, but requested only that the contents be circulated to all Il members of the Security Council.

ISRAELI, JORDANIAN FIREMEN COOPERATE IN FIGHTING BLAZES

JERUSALEM, July 4. (JTA) -- For the second time this week, Israeli and Jordanian firemen cooperated yesterday in extinguishing blazes in the Jerusalem no-man's land.

Fire engines from both sides roared into the neutral area, and Israeli and Jordanian fire hoses poured on water to keep the fire from spreading.

In the first fire, last Monday, the Jordanians first attacked the fire and kept it from spreading into Israeli territory. Yesterday, it was the other way around.

NATIONAL INSURANCE BENEFITS IN ISRAEL TO EXCEED 75 MILLION POUNDS

FRUSALEM, July 4. (JTA) -- The National Insurance Fund will spend about 75,000,000 pounds (\$41,667,000) this year in benefits to insured persons, mostly inold age and surviors' benefits, it reported today.

The scheme gives old age, survivor, maternity, accident, and employment insurance coverage and family allowances to 640,000 persons.

The fund administers the family allowance plan under which the State pays special allowances to families having four or more children. One-eighth of the beneficiaries of the Fund receive these family allowances. Eighty percent of the family allowance recipients are immigrants from Africa and Asia, and ten percent, non-Jews although non-Jews constitute only seven percent of those employed. The fund is currently paying old age pensions to 46,000 men and women.

ISRAEL TO ISSUE FIRST GOLD COIN, \$20-PIECE, BEARING HERZL HEAD

JERUSALEM, July 4. (JTA) -- The Bank of Israel will issue the first gold coin to be legal tender in Israel, It will have a nominal value of 20 Israeli pounds, will contain the same amount of gold as the British sovereign, and will sell for \$20.

One side of the coin will show the head of the late Theodor Herzl, father of political Zionism. A menorah will appear on the reverse.

DR. ISADOR LUBIN, ECONOMIST, ACCEPTS POST AS JEWISH AGENCY CONSULTANT

NEW YORK, July 4. (JTA) -- Dr. Isador Lubin, noted economist and administratrator, accepted the invitation of the Jewish Agency for Israel, Inc. to organize the Agency's Jerusalem Representative office, it was announced here this weekend by Dewey D. Stone, chairman of the Agency's board of directors. He will serve as consultant to the Jewish Agency, which is a New York corporation.

According to Mr. Stone, the economist will spend the summer in Israel to work out bases organizational procedures, methods of accounting and reporting, Ilaison with the Jerusalem headquarters of the worldwide Agency, and other arrangements connected with the new system for allocation of American Jewish philanthropic funds for the Jewish Agency's rehabilitation and resettlement programs.

Detailed reports on every aspect of the projects for which allocations are made by the New York corporation will be made by Dr. Lubin. These reports, Mr. Stone declared, will provide the basis for decisions on budget allocations which will be determined at a meeting of the Agency's board, to be held in Jerusalem in the fall.

Dr. Lubin, a native of Worcester, Mass., has been a professor of economics at a manuber of leading American universities, is now on the faculty of "Rutgers University, New Brunswick, N.J., and is the author of many books and articles in the field economics. He has held many important posts in the fields of labor, employment, public works and economic plannine.

Among the official posts held by Dr. Lubin have been those of American Government representative to the International Labor Organization, the Allied Reparations Commission, the United Nations General Assembly, and the United Nations Economic and Social Council. He has also been chairman of the New York State Commission on Refugees, and Industrial Commissioner of the New York State Department of Labor.

ROSE HALPRIN DECRIES LACK OF UNITY AMONG AMERICAN. ZIONISTS

LONDON, July 4. (JTA) -- The American Zionist movement is "in a dreadful position," because it lacks unity, Mrs. Rose Halprin, co-chairman of the World Confederation of General Zionists, told the worldwide convention of the confederation here yesterday.

Seventy delegates from 28 countries are attending the convention, which is mapping plans for the Confederation's platform to be presented at the next World Zionist Congress, to be held next December in Jerusalem. Dr. Israel Goldstein, of New York, is the other co-chairman of the Confederation.

Mrs. Halprin staunchly defended the tasks which, she said, the Zionist Organization still has to fulfill, and emphatically disagreed with some of the views expressed by Israel's Prime Minister David Ben-Gurion.

"We say," she told the delegates, "that Ben-Gurion's views about the Jewish people are mistaken because the Jews lack the necessary ingredients to stand by Israel in times of stress. Only the Zionist Organization has these ingredients."

Mrs. Halprin outlined what she called "the Trinity of Zionism"--Jewish education, the wants of the Jewish people, and the centrality of Israel. She declared herself in favor of increased immigration to Israel from the United States, but warned that this will not occur unless Israel is ready to do its share to facilitate the absorption and housing of these immigrants.

Dr. Goldstein warned that a possible consequence of worsening international relations may be "the prospect of a harder lot for the 3,000,000 Jews in the Soviet Union," He reminded the delegates that it has been an invariable rule in the past that, when the cold war resumed, life for people inside Russia generally became more oppressive, and the Jews were the first to suffer. Even in those Communist countries in which Jews were not overtly oppressed, conditions were such, Dr. Goldstein said, that the likelihood of Jewish survival in the long run was slim.

Dr. Goldstein expressed the hope, however, that a day may come in a period of relaxation of world tensions, and of greater -stability in the Middle East, when Jews in the Soviet Union may be permitted to emigrate to Israel.

CONGRESS PASSES COMPROMISE IMMIGRATION BILL OF LIMITED SCOPE

WASHINGTON, July 4. (JTA) -- Congress has passed and sent to the White House a compromise immigration bill, authorizing immigration in the next two years of 25 percent as many European refugees as are resettled by the 38 other nations participating in the world refugee program. The United Nations has estimated there are about 28,000 still remaining in European refugee camps.

The bill would permit 500 of those admitted to be persons with physical handicaps, provided the Attorney General is satisfied they would not require public support. Other provisions would extend to June 30, 1962, the expiring law permitting admission on a non-quota basis of alien orphans adopted by American citizens.

Although several Senators voiced sharp dissatisfaction with the limited scope of the immigration bill, they were told it was the most the House would accept.
