#### IRAQI MINISTER ATTACKS ISRAEL AT'U.N.; GOLDA MEIR TO SPEAK MONDAY

UNITED NATIONS, N.Y., Oct. 6. (JTA) -- The elimination of Israel offers the "only" solution to tensions in the Middle East, Hashim Jawad, Iraqi Foreign Minister, told the United Nations General Assembly here today. He will be answered by Mrs, Golda Meir, Israel's Foreign Minister, who is scheduled to address the UN Assembly on Monday

"The question of Palestine," the Iraqi Minister declared, "is not settled, as nothing is really settled until it is settled right, And the only way to do do is that Palestine in its entirety blong once more to the Arab population, Israel," he insisted, "being an alien body in the Arab homeland, has no right whatsoever to continue to exist in the territories of the Arab East,"

The Iraqi foreign policy chief accused "certain powers, "--naming specifically the United States and France--of giving economic and financial aid to Israel in order to make Israel "a stronghold against the Arab states, " Jewish immigration into Israel, he held, "amply demonstrates the expansionist intentions of Israel toward the neighboring Arab countries," while Israel's training of army forces and expenditure of money for arms "are part of Israel's preparation for aggression against its neighbors,"

#### Israel Foreign Minister Is Host to African Delegations to U. N.

Twenty representatives of African nations, all of them relatively new members of the United Nations, were guests tonight at a dinner given by Mrs. Meir, at the Waldorf-Astoria Hotel in New York,

In addition to the African guests, all of them from countries "below the Sahara," and none of them Arab, Mrs. Meir invited also the president of this year's General Assembly, Frederick H. Boland, of Ireland; and Dr. Ralph J. Bunche, UN Underscretary for special political affairs. Tuesday evening she was a guest of Soviet Premier Khrushchev at a recention given by him for heads of delegations to the UN Assembly.

Against the opposition of Arab delegates, Shabtai Rosenne, legal advisor to the Israeli's Foreign Ministry. and a member of the Israel delegation to the General Assembly, was elected yesterday as vice-chairman of the Assembly's legal committee,

Arab delegates protested violently, but behind the scenes, against Mr. Rosenne's candidacy, and threatened to run a candidate of their own. When Israel stood firm, however, refusing to withdraw Mr. Rosenne's name and insisting that there would be a floor fight for the post if the Arabs insisted on opposing Mr. Rosenne, the Arab opposition collapsed, As a result, Mr. Rosenne was elected by acclamation.

### RUMANIAN JEWS CLAIM \$70,000,000 RESTITUTION FROM GERMAN GOVERNMENT

BONN, Oct. 6. (JTA) -- A delegation of the Association of Rumanian Jews in Israel placed before a special commission of the West German Parliament a claim that about 45,000 former Rumanian Jews were entitled to some \$70,000,000 in restitution for Nazi persecution.

Yithak Korn, a member of the Knesset, Israel's Parliament, and leader of the delegation, told the West German commission that West Germany had recognized compensation obligations to only some of the Jews of Rumania. He said this recognition covered the Jews of Bessarabia and Bukowina but not the Jews of old Rumania who had constituted 35 to 40 percent of the Jewish population and who also had suffered under the Nazis.

The commission, which included representation from all West German parties, promised to do everything possible to right the injustice. Mr. Korn discussed the issue with Erich Ollenhauer, leader of the Social Democratic party, and with other West German political leaders who promised support for the Rumania Jewish claims,

#### NAZI DOCUMENTS CONCERNING JEWS UNCOVERED IN BERLIN DEBRIS

PARIS, Oct. 6. (ITA) -- Nazi documents bearing the signatures of some of Hitler's most trusted collaborators in the extermination of Jews, and dealing mainly with the Jewish problem, have been uncovered in an old, rusty safe found by workers digging the foundation for a new building in West Berlin, according to a report received here today. Many bear the signatures of Rudolf Hess, Martin Bormann and Alffer Rosenberg.

## LAVON TAKES ISSUE WITH BEN-GURION ON INVESTIGATION OF ARMY OFFICERS

JERUSALEM, Oct. 6. (JTA) -- Pinhas Lavon denied today a statement issued earlier this week by Prime Minister David Ben-Gurion, in which the Premier asserted that there was no connection between his ordering an investigation into the integrity of two Army officers and Mr. Lavon's resignation as Minister of Defense in 1955.

In his denial, Mr. Lavon, who is now Secretary General of the Histadrut, Israel's labor federation, said that the cause of his resignation six years ago from the Cabinet of former Premier Moshe Sharett, was the refusal by the Government to dismiss two members of Israel's security network. He demanded their dismissal, he said, following a "Certain affair" that took place and which was investigated by a two-member committee in 1954. He said the nature of the "affair" has not been disclosed for security reasons.

The Histadrut official also challenged Mr. Ben-Gurion's assertion that he was unaware of Mr. Lavon's proposals for changes in the country's defense structure and why they were not accepted by Mr. Sharett. Mr. Lavon quoted, in his statement, a letter he addressed to the Prime Minister, reminding him that immediately after Mr. Een-Gurion resumed his post as Minister of Defense in February 1955, he invited Mr. Lavon to his office and asked him about the proposals and his conclusions.

At that time, Mr. Lavon said, he told Mr. Ben-Gurion what he had said to former Premier Sharett--that two persons should be dismissed from the security network, At that meeting, he had also told Mr. Ben-Gurion of various suggestions regarding the defense network structure, Mr. Lavon declared, and added that these suggestions were later forwarded to Mr. Ben-Gurion in a written memorandum.

#### Deputy Defense Minister Peres Involved in "Lavon Affair"

The Histadrut leader said that his ultimate condition for remaining in the Cabinet syars ago was the dismissal of the two persons involved with whom no self-respecting man could have continued to work after what happened in the "lectain affair,"

The Prime Minister later today sent a letter to Mr. Lavon, in which he admitted he was mistaken in saying that he was not aware of Mr. Lavon's proposals as Defense Minister for changes in Israel's security setup. In the letter, the Prime Minister declared that he now recalled that one of the two men whose dismissal Mr. Lavon had demanded was actually relieved from his post when Mr. Ben-Gurion took over the Defense Ministry after Mr. Lavon's, resignation.

It was disclosed today that one of the two men was Shimon Peres, now Deputy Defense Minister and then director general of the Defense Ministry, and that hee other was "a high ranking officer," The Mapai secretariat was expected to take up the issue again inasmuch as the dispute involves two or more prominent members of that party.

#### DEFENSE MINISTRY WILL CHALLENGE ISRAEL'S RIGHT TO TRY EICHMANN

JERUSALEM, Oct. 6. (JTA) -- Isræll's right to try Adolf Eichmann, the Nazi war criminal who directed the mass killing of 6,000,000 Jews in Europe, will be challenged during the trial next spring by the defense attorney Robert Servatius, it was disclosed here today. The Cologne lawyer, who arrived here this week to begin preliminary work on Eichmann's defense, said that this would be one of the major points raised at the trial.

The West German lawyer, who met with Attorney General Gideon Hausner yester-day, raised "problems in connection with procedure and technical arrangements of the trial, including translation," according to the official communique issued arter the meeting. Dr. Servatius, who requested the help of an Israeli attorney in the case, was referred to the Israel Lawyers Association for the name of a local attorney.

"Arrangements were made for the Cologne lawyer to maintain contact with the Public Prosecutor's Office to discuss any problems which might arise after his meeting with Eichmann." the communique stated. This was interpreted as an indication that Attorney General Hausenc gave Dr. Servatius formal permission to meet with Eichmann. Such permission is required in view of the fact that the West German lawyer has not yet been officially appointed as Eichmann's attorney. He will be appointed only after the charge sheet is submitted some time in December.

Eichmann's wife, meanwhile, has requested permission from the Israel Government to visit her husband, it was disclosed today.

# PROSECUTOR DROPS CHARGES AGAINST SIX ARRESTED FOR HECKLING ROCKWELL

WASHINGTON, Oct. 6. (JTA) -- The District of Columbia prosecutor dropped today disorderly conduct charges against five anti-Nazi hecklers who were arrested at a July 3 rested July 4.

Prosecutor Clark King pointed out that during Rockwell's trial resulting from the July 3 rally--where a mob fight erupted--and from a July 24 rally, municipal court judge Mildred E. Reeves had said the Nazis caused the violence and trouble. Rockwell was convicted August 30 and has appealed.

#### C. J. F. W. F. ASSEMBLY TO DEAL WITH PROBLEMS FACING COMMUNITY IN 1961

NEW YORK, Oct. 6. (JTA) -- Major problems confronting organized Jewish community life in 1961 will be dealt with at the four-day General Assembly of the Council of Jewish Federations and Welfare Funds which opens in Detroit on November 10, it was announced here today by Irving Kane. CJFWF president.

More than 700 Jewish community leaders from all parts of the United States and Canada are expected to attend the conference. They will review Jewish needs and programs, and formulate policies to guide the communities in meeting those needs locally, nationally and overseas.

The General Assembly is the major annual meeting of the leaders of 216 Jewish the derations, welfare funds and community councils which comprise the CJFWF. These member agencies, which represent more than 800 communities throughout the United States and Canada, annually raise the bulk of all American Jewish philanthropic funds,

The Assembly will open with an address on the changes that have taken place on the American scene and the way federations might adapt to meet those changes. A second general session, the same evening, will include an analysis of the recent structural changes in the Jewish Agency, and some of the problems raised by the reorganization of American Jewish philanthropic aid in Israel. A major address will also be delivered on the goals, values, and realities of American Jewish life and community organization,

Campaigning in 1961 will be the theme of a special session. Top fund-raising leaders will assess the 1960 results and cite the challenge of campaigning in 1961. This will be followed by a series of workshop sessions which will focus on four major aspects of campaigning: personalizing campaigns, developing campaign leadership, campaign goals and themes, and missions as an inspirational force.

#### RESTRICTIVE PACTS BAR JEWS FROM PURCHASING PROPERTY IN MIAMI AREA

MIAMI BEACH, Oct. 6. (JTA) -- The Bal Harbour residential section, a swank barring Jewish purchasers, The covenants are embodied in warranty deeds issued for property in the area. One clause in the deeds spells out the duration of the covenants and another binds the buyer or seller to maintain the restrictions.

One of the clauses provides that no land in the area "shall be sold, conveyed or leased to anyone not a member of the Caucasian race, ror to anyone having more than one-fourth Hebrew...blood, nor to any concern or corporation in which any member or stockholder has more than one-fourth Hebrew...blood or is not of the Caucasian race..."

Two other clauses of the warranty deed link Jews with Syrians, who also are excluded from the exclusive residential area. The duration is indicated in a clause which provides that the restrictions "shall be and remain in full force for 25 years from the first day of January A. D. 1947 at which time that shall automatically be extended for successive periods of ten years each" unless a majority of the Bal Harbour residents at that time vote to change them.

#### MERGER OF BOSTON JEWISH PHILANTHROPIES AND JEWISH APPEAL APPROVED

BOSTON, Sept. 6. (JTA) -- Trustees of the Associated Jewish Philanthropies and the Combined Jewish Appeal of Greater Boston have announced approval of a plan to merge the agencies into a single organization.

Before the merger goes into effect, it must be approved by the enactment of enabling legislation, then by the Massachusetts Supreme Judicial court, and finally by the memberships of the two agencies. Completion of formalities will provide Boston Jewry with a single agency to carry out community planning, fund-raising and fund-allocation.

# NEW ORLEANS JEWISH FEDERATION AND LOCAL WELFARE FUND TO MERGE

NEW ORLEANS, Oct. 6. (JTA) -- The Jewish Federation of New Orleans and the New Orleans Jewish Welfare Fund will be consolidated into a Jewish Welfare Federation of New Orleans.

The plan, which has been under consideration since 1954, has been approved by the board of directors of each agency and will be submitted to the members of the agencies at a joint meeting early next month for ratification.

#### HARTFORD U. GRANTS RECOGNITION TO FRATERNITIES BARRING BIAS

HARTFORD, Conn., Oct. 6, (JTA) -- The University of Hartford extended official recognition today to five fraternities and sororities which accepted criteria barring any form of discrimination in membership.

The criteria include the rule that "no social fraternity or sorority shall discriminate against any candidate because of race, color, religion or national origin,"

# AMPAL PLANS TO INCREASE ITS INVESTMENTS IN ISRAEL ENTERPRISES

TEL AVIV, Oct. 6. (JTA) -- AMPAL, the Israel-American investment firm, and its affiliates posted new records in capital growth and credit during the past six months, Abraham Dickenstein, AMPAL president, reported at a press conference here today.

Capital was increased by \$1,000,000 and credit resources were boosted by \$8,000, -000, he said, He also disclosed AMPAL plans to invest \$15,000,000 in Israel during the next three to five years, He said that the funds will be invested in various Koor enterprises, in Tel Aviv municipal programs and in a construction company which will build rental apartments.

Mr. Dickenstein said that the Israel American Industrial Development Bank, an AMPAL subsidiary, planned to float a 10,000,000 Israel pound debenture issue in Israel.

#### DENVER JEWISH PHILANTHROPIST LAUDED BY EISENHOWER ON 80TH BIRTHDAY

DENVER, Oct. 6. (ITA) -- President Eisenhower, Prime Minister David Ben-Gurion of Israel and other leaders joined today in lauding Adolph Kiesler, Denver's famous Jewish philanthropist, on his 80th birthday. Mr. Kiesler, who has contributed about \$1,200,000 in 17 years to a variety of Jewish, Zionist and general causes, was honored at a community-wide dinner Tuesday night.

President Eisenhower said, in his message, that Mr. Kiesler had "in the highest American tradition of philanthropy," helped "many worthy enterprises regardless of race, color or creed." Mr. Ben-Gurion welcomed Mr. Kiesler's forthcoming visit to Israel with a United Jewish Appeal Study Mission and sent his "greetings and best wishes."

Other messages were received from Philip Klutznick, former president of B'nai B'rith, and Irving Kane, president of the Council of Jewish Federations and Welfare Funds.

#### DAVID HOROWITZ, GOVERNOR OF BANK OF ISRAEL, HONORED IN NEW YORK

NEW YORK, Oct. 6. (JTA) -- David Horowitz, Governor of the Bank of Israel, today linked the future of Israel to the growth of the Hebrew University in Jerusalem. Speaking at a luncheon in his honor given by the American Friends of the Hebrew University, Mr. Horowitz described the university's role in providing the experts needed to develop Israel's economy and to chart the country's future physical and cultural development.

The luncheon was also addressed by Senator Jacob K. Javits of New York, who lauded the Hebrew University for its contributions to the development of the newly independent countries of .Asia and Africa by training students from these countries,

#### GROUND BROKEN FOR ANNENBERG RESEARCH LABORATORY IN THE NEGEV

BEERSHEBA, Oct. 6. (1TA) -- Ground-breaking ceremonies for the Sadie C, Annenherg Negev Research Laboratory for Soil and Irrigation, which will survey possibilities of irrigation with saline water, were held yesterday at Gilat settlement near here. Construction of the research facility, to be completed within a year, is being made possible through a \$250,000 donation by the Annenberg family of Philadelphia.

Mirs. Annenherg, for whom the laboratory will be named, and her son Walter Annenherg, a prominent Philadelphia publisher, came to Israel to attend the ceremonies. The laboratory will engage in various types of arid zone research and attempt to promote agricultural knowledge of the Negev. The research unit will also include a library and lecture hall.

Dr. Raanan Weitz, director of the National and University Agricultural Institute, said that the new facility, to be supplied with the latest equipment, will result in considerable progress in agriculture in Israel's southern desert. B. Kaplan, director of the Negev Region for the Jewish Agency, told the gathering that the Gilat experimental station will become the center of agricultural science to serve the entire Negev region.

# DETROIT JEWS PLAN BUILDING AT TECHNION IN MEMORY OF LEON KAY

DETROIT, Oct. 6. (JTA) -- The Detroit chapter of the American Technion Society announced today plans to establish a food technology building at the Haifa Institute of Technology in memory of Leon Kay, a veteran Zionist leater, who died here at the age of 85.

Mr. Kay was a national vice-president of the Zionist Organization and of the American Technion Society. He was a former president of the Jewish National Fund Council of Detroit and was active in the Israel bond drive. He visited Israel twice each year since its establishment. Born in Russia, he came to the United States as a young man and earned a degree in chemical engineering at Ohio State University. He was a founder of the Keystone Oil Refining Company of Detroit.
