### SOVIET WEAPONS TO U.A.R INCREASING; RED CHINA TO USE EGYPT AS ARMS 'DUMP'

JERUSALEM, Oct. 30. (JTA) -- The flow of arms from the Soviet Union to the United Arab Republic was reported today to be increasing in quantity and quality. Foreign Minister Golda Meir told visiting Americans that the supply of late-model Soviet Jet fighter planes to the UAR was a "special reason for concern" to Israel.

Gershon Avner, head of the United States desk in the Foreign Ministry, said that "the newer Soviet weapons, in larger number, are being steadily directed to Nasser."

(Cairo dispatches received in London today, disclosed that the United Arab Republic had asked the Soviet Union to supply it with the latest model "Super-MIG" Jet fighters to offset the late-model French jet fighters used by the Israeli Air Force.

(Cairo reports to London said a Communist Chinese military mission had reached an agreement with the UAR for the use of Egyptian military depots as dumps for Chinese war materiel being supplied to the Algerian rebels. UAR diplomats indicated this weekend, it was reported, that the Chinese war materiel might also be used against Israel. They asserted that both Algeria and Israel were Arab struggles in which the Arabs had to help themselves from whatever sources were available.)

#### LODGE OPPOSES UNITED STATES VOTE FOR U. A. R. SEAT ON SECURITY COUNCIL

CLEVELAND, Oct. 30. (JTA) -- Henry Cabot Lodge, the Republican vice-presidential candidate, sàid this weekend that the United States should not support the election of the United Arab Republic to a seat on the United Nations Security Council.

The former head of the American delegation to the United Nations said in a Cleveland press conference, in response to a question: "I have always taken the position that nations should not be elected to the Security Council that are not confined within United Nations resolutions. I think if a member is going to be elected to the Security Council, it ought to be in compliance with United Nations resolutions."

Mr. Lodge pointed out that "The UAR is not complying with United Nations resolutions on the subject of free navigation of the Suez Canal" and declared that "therefore, I would not think we should support the election of the UAR to the Security Council," He said he had no alternate candidate to the UAR.

#### French Delegation At United Nations Instructed To Vote For U.A.R.

PARIS, Oct, 30, (1TA) -- The French delegation to the United Nations will vote in favor of the United Arab Republic's candidacy for the UN Security Council, official sources stated here today. The Government was said to be basing itself on an unwritten "gentleman's agreement" at the UN, according to Security Council representation on a geographical basis.

While Government officials "do not relish" having the UAR as a colleague on the Council, the sources said that no other candidate for this forthcoming Security Council vacancy has come forth from any other member in the Middle East area. Officials drew attention to the Security Council rule providing that a member of the Council is not entitled to a vote on an issue in which this member is directly involved.

#### KENNEDY PLEDGES TO USE WHITE HOUSE INFLUENCE FOR MIDDLE EAST PEACE

DETROIT, Oct. 30, (JTA) -- Senstor John F. Kennedy, the Democratic presidential candidate, pledged today that, if elected on November 8, he would "use all the authority of the White House to seek peace and implement our moral commitments in the Middle East," His pledge was contained in a message to the 32nd national convention of the Labor Zionist Organization of America. The convention unanimously approved carlier action by the organization's central committee, endorsing the Kennedy-Johnson ticket.

The convention adopted a resolution calling on the United States Government not to support, under any circumstances, the candidacy of the United Arab Republic for membership in the United Nations Security Council. The resolution declared that the United States should bring all its influence to bear to prevent any UN member from obtaining a seat on its highest peace tribunal who persists in avowing that it is in a state d war with another member, and continues to ignore resolutions of the Security Council.

(Foreign Minister Golda Meir of Israel told members of the United Jewish Appeal study mission in Jerusalem Saturday night that Israel hoped that whoever was elected President of the United States on November 8 would continue a policy of friendship towards Israel and would work to bring about direct A<sub>7</sub>ab-Israeli talks.

(Mrs. Meir stressed that Israel wanted help only in getting direct talks with the Arabs and would not agree to any arbitration or mediation.)

The Labor Zionists also urged the United States Government to provide Israel and all other peace-loving nations with firm guarantees against aggression; to refuse to acquiesce in any illegitimate acts of boycott, blockade or denial of just rights committed against Israel; and to reject the "intolerable" discriminations which the Arab States practice against American firms doing business with Israel,

#### BEN-GURION FACES CABINET CRISIS ON PROBE OF LAVON AFFAIR

JERUSALEM, Oct. 30. (ITA) -- Prime Minister David Ben-Gurion faced a new Government crisis today when the two Mapam party members of his coalition cabinet walked out of a Cabinet meeting in protest against his refusal to name a Mapam representative to a five-man ministerial committee designated to investigate all aspects of the Lavon affair.

The commission named today is composed of two me., bers of Mr. Ben-Gurion's Mapai party, one Progressive, one representing the National Religious Bloc, and one from Achdut Avodah. Mr. Ben-Gurion refused to agree to the designation of a Mapam member because a spokesman of that party had characterized the Lavon case as another Drevfus affair.

When the two Mapam ministers angrily stalked out of the Cabinet session, Yitzhak Ben-Aharon, the Minister of Transport and Achdut member, announced that he would not serve on the committee unless the Mapam were given representation.

It was expected tonight that Mr. Ben-Gurion would summon an extraordinary session of the Cabinet for tomorrow morning, to seek agreement on composition of the commission prior to the meeting of the Knesset in the afternoon.

The Knesset will have before it a Herut Party motion tantamount to a non-confidence vote on the Lavon affair. Observers said that, unless the Mapam and Achdut Avodah claims were settled, both parties might abstain from voting with the Government on this motion, or might even vote against the Government, thus shattering the coalition a recement.

#### Ministerial Committee Is Compromise; Search For 'Guilty' Pressed

Designation of a ministerial committee had been a compromise between a Parliamentary orobe, for which there had been wide demand, and a judicial probe which Prime Minister. Ben-Gurion had insisted upon. Mr. Ben-Gurion had taken the position that only a judicial commission with full powers of subpoena and cross-examination would be competent to deal with the affair and establish the identity of the person or persons who ordered the 1954 military operation, the nature of which has never been disclosed, which led to the resignation of Minister of Defense Pinlas Lavon in 1955,

Mr. Lavon, whose demand that he be absolved of responsibility for the "security mishap" had precipitated the crisis, said last week that a statement by former Prime Minister Moshe Sharett, and publication of the Attorney General's report on forgery and subornation of perjury in testimony involving him with the affair, had satisfied his demand for exoneration.

The incident, however, did not close with Mr. Lavon's statement, but took a new turn with demands for the identification of those responsible for the military operation. The question that emerged was whether the defense establishment had acted independently of the elected civilian authority of the country, in mounting the mysterious operation,

Mr. Ben-Gurion staunchly defended the Army this weekend against these charges. Speaking at the graduation ceremony of an officers' training school somewhere in Israel, he said emphatically that "Israel's army was and always will be subordinated in a civilian regime. The Army never dared, and would never dare, to do anything without the permission of civilian authorities."

Raising his voice, the Prime Minister told the graduates that Israeli officers "can walk with their heads erect, since their morals are of the highest," He said that, as in any army, Israel officers were not angels, and that those who were found guilty of conduct unbecoming an officer were dismissed or tried. He reiterated his opinion that the Knesset, Israel's Parliament, was obliged to clear up any doubts about the relations between the armed forces and civilian authorities.

# RESISTANCE FIGHTERS CALL FOR IMMEDIATE GERMAN-ISRAELI RELATIONS

BONN, Oct. 30. (JTA) -- The International Union of Resistance Fighters, at its annual convention here, adopted a unanimous resolution tonight calling upon the Federal Republic of Germany to establish diplomatic relations with Israel "immediately." Such relationship between West Germany and Israel, the resolution declared, "would not only help live down Germany's past, but would also help purify and strengthen the free nations of the world."

## ORT CONGRESS RE-ELECTS HABER; WOMEN'S GROUP NOTES GROWTH

LONDON, Oct. 30. (JTA) -- Dr. William Haber, professor of economics at the University of Michigan, has been re-elected president of the Central Board of the World ORT Union.

Other world ORT officers elected included Daniel Mayer, chairman of the executive committee, and the following vice-presidents: Armand Brunscvig for Switzerland; Julius Hochman for the United States; Mrs. L. Kaphan for Italy; Abel Shaban for South Africa; J. J. Shapiro for Israel. Max A. Braude was again named director-general of the World ORT Union.

The four-day Congress ended with a session of the Women's ORT organization, attended by 74 delegates from ORT women's groups in 13 countries.

The conference noted the growth of women's ORT groups in the United States, Ganada, Britain, Israel and France, and adopted a series of new projects as special responsibilities of the women's units. These included a new ORT school in Marseilles, and an expansion of the ORT program in Teheran,

#### U. J.A. MISSION LEAVING FOR HOME TODAY; ARABS WARNED ON JORDAN RIVER

TEL AVIV, Oct. 30. (JTA) -- The 120-man mission of the United Jewish Appeal, which has spent 12 days here conferring with Government officials and inspecting various development and immigrant-absorption installations through Israel, is leaving for home tomorrow.

Today, the members of the mission conferred with Mrs. Golda Meir, Israeli Foreigi Minister, and Haim Yahil, director-general of the Foreign Ministry, who told the Americans that "any attempt by any Arab state to divert the waters of the Jordan River would be regarded by Israel as an act of open hostility,"

#### 22 NEW HEBREW DAY SCHOOLS OPENED THIS YEAR, TOTAL NOW IS 268

NEW YORK, Oct. 30. (ITA) -- Twenty-two new Hebrew Day Schools, including 14 primary schools, were opened in the United States for the current academic year, bringing the total of 'such Orthodox-oriented schools throughout the country to 268, according to a report issued here today by Samuel C. Feuerstein, president of Torah Umesorah, the National Society for Hebrew Day Schools.

The new schools included five Junior high schools and three high schools, Mr. Feuerstein said. Most of the 22 new schools represented the first such schools in their communities. He noted that schools are occasionally opened under Orthodox auspices not associated with any reporting agency or central service agency for such schools, but that the 268 total 'may be considered a fairly complete one' on the current status of the Orthodox-sponsored day school movement.

#### EXPERT SEES SKILLED WELFARE PROFESSIONALS ATTRACTING VOLUNTEERS

NEW YORK, Oct. 30. (JA) -- Continued attraction of volunteer leaders of high caliber by private social welfare agencies depends on their conviction concerning the need for skilled and well-trained professional staff, the annual meeting of the Jewish Community Center Division of the National Jewish Welfare Board was told here.

Dr. Benjamin B. Rosenberg, executive director of the Associated Jewish Philanthropies of Greater Boston, said that, if leadership development programs are to be successful in social welfare agencies, "we must provide the necessary staff which can help to attract and work with men and women who in their personal and professional lives have lived and worked with associates of highest commercial and professional attainment."

Dr. Rosenberg spoke at the opening session of the two-day annual meeting of the Jewish Community Center Division, through which the JWB serves as the national association of Jewish Community Centers and YM-YWHAs. Today's leadership in social welfare agencies, he declared, "demands that staff be equal in skills, in trainin, and in personality to the tasks created by current developments and conditions." Agen cies in the social welfare field, he said, "need a conscious and constant inventory" of leadership needs and with it "a conviction of the need to provide opportunities for the exercise of creative leadership in all levels of agency program and operation,"

#### STUDY SHOWS JEWS PRACTICE PLANNED PARENTHOOD MORE THAN NON-JEWS

PRINCETON, N.J., Oct. 30, (JTA) -- Jewish families engage in planned parenth more than their Protestant or Catholic neighbors do, according to a preliminary represeleased here today by the Office of Population Research of Princeton University.

According to Dr. Charles Westoff, who helped conduct a six-year study that preceded today's report. "It is only among the Jewish groups that couples consistently refrain from desiring additional children because they want to be able to send those tihave to college."

# REPORT DISCLOSES AMERICAN JEWS STILL SUFFER DISCRIMINATION IN HOUSING

NEW YORK, Oct. 30. (JTA) -- American Jews still face discrimination in housing in the United States, a study published here today by the Fund for the Republic, declared. The study, entitled "Residence and Race," is "the final and comprehensive report" of the Fund's Commission on Race and Housing. It was written by the Commission's director of research, David McEntire, professor of social welfare at the University of California.

"Although most residence areas are open to Jews," Dr. McEntire declares in his report, "and Jewish segregation as remains is voluntary or economic, nevertheless this group has not yet achieved full equality with the white Christian population in choice of residence. Throughout the country, there are communities and housing developments closed to Jews,"

Incomplete surveys, Dr. McEntire maintains, have identified "Judenrein preservers": in NeweKork: New England, Chicago, the District of Columbia, Miami, Houston, Fenver, Seattle and elsewhere in the United States. The terms "exclusive" and "restricted," as used in real estate advertising, are interpreted by the scholar as meaning, usually, "closed to minortites, including Jews,"

The scholar declares that unlike Negroes, who often fight discrimination as violations of Constitutional provisions, Jews, on the whole, "have made little use of litigation because discrimination against them is practiced mainly by private groups, and is not subject to the restraints of the Fifth or Fourteenth Amendments" to the United States Constitution.

Dr. McEntire reports that, among "forces for equality" that fight discrimination are a number of Jewish organizations, including the American Jewish Committee, American Jewish Congress, the Anti-Defamation League of B'nai B'rith, the Jewish Labor Committee, and various trade unions with large Jewish membership or leadership by Jews like the Amalgamated Clothing Workers of America and the International Ladies Garment Workers Union.

Among experts who served in individual capacities on the commission that compiled the studies leading to today's report was Philip M. Klutznick, chairman of the International Council of B'nai B'rith.

# INTERNATIONAL NAZI NETWORK REVEALED; SLAWSON WARNS AGAINST BIAS INVEST

DALLAS, Oct. 30. (JTA) -- A "growing international network of nazism" is operating "aggressively" from headquarters in Europe, South America and the Middle East, the executive board of the American Jewish Committee, meeting here, was told this weekend by the Committee's president, Herbert B. Ehrman.

The report, based on material submitted by the organization's representatives in Buenos Aires, Rio de Janeiro and Paris, expressed "serious concern over the activities of neo-Nazis" which, Mr. Ehrman stated, "are rooted in anti-Semitic, anti-democratic and totalitarian philosophies,"

In the Middle East, Mr. Ehrmann said, the United Arab Republic "has provided refuge to a considerable number of former Nazis who escaped from Germany and who are serving as advisers to that country in its propaganda campaign against Israel."

The report also charged that "Hungarian fascist groups are now operating in the United States," but pointed out that such groups "must be clearly distinguished from the decent and loyal Hungarian majority in this country." A New York weekly, "Free Hungary," was identified in the report as a "periodical which publishes unbridled, anti-democratic and anti-Semitic propaganda,"

During the executive loard meeting, Dr. John Slawson, executive vice-president of the American Jewish Committee, announced plans by Harvard and by the University of Michigan to probe, in cooperation with the A.J.C., "discriminatory practices on the full utilization of management manpower resources,"

"Extensive discriminatory practices" by large American corporations, said Dr. Slawson, have resulted "in serious losses in management manpower," Studies, he declared, showed that Jews constitute less than half of one percent of the total executive personnel in American industrial companies, while eight percent of the college-trained population in the United States, from whose ranks management personnel are chosen, are Jews.

# SIX HUNGARIAN REFUGEES HALL RETURN OF HITLER; CANADIAN CONGRESS ACTS

MONTREAL, Oct. 30. (JTA) -- Six youths, all Hungarian refugees, are under arrest here today, following a street brawl in which they shouted "Hitler is coming," The Canadian Jewish Congress has requested the Dominion Department of Citizenship and Immigration to investigate the brawl because of its anti-Semitic and pro-Nazi implications.

Emmanuel Coke, an attorney and a member of the CJC Council, told the court where the youths were arraigned: "These assaults and the circumstances surrounding them have caused a great deal of dissatisfaction in certain parts of the community in Montreal, We must make these people understand that they cannot come over here, and attack citizens, threatening them with death and the coming of the Nazis and Hitler."
