#### KHRUSHCHEV WOOS NASSER'S MILITARY MISSION; ISRAEL STRENGTHENS SECURITY

JERUSALEM, Dec. 1. (JTA) -- The Knesset, Israel's Parliament, today approved a special bill permitting Finance Minister Levi Eshkol to take a \$13,000,000 loan from Israel banks for security purposes. Even the right-wing Herut party, which is critical of Israel Government financial procedures, approved the loan.

The Knesset action coincided with reports received here that Soviet Premier Khrushchev sent a special plane to bring the United Arab Republic Vice President and chief military commander, Field Marshal Abdel Hakim Amer, and his entourage from Cairo to Moscow.

Although the subject of Marshal Amer's second mission to Moscow has not been disclosed, either by the UAR or the Soviet Union, it has been reported that the UAR seeks replacements for its aging acquisitions of 1956 weapons, including the new Soviet MIG-19 jet fighter plane.

It was reported also that the UAR will sell its surplus and outdated Soviet weapons to other African countries. The first was reported to be Sudan, which has already received six MIG.17s from the UAR. The UAR was expected to receive three more Soviet submarines, which would bring its total of such undersea craft to twelve.

#### Opposition in Knesset Fails to Force Debate on Security Censorship

JERUSALEM, Dec. 1. (JTA) -- Prime Minister David Ben-Gurion adroitly warded off in the Knesset last night three separate denunciations of security censorship in Israel. He succeeded in preventing a full dress debate on the issue.

Appearing in his capacity as Defense Minister, the Prime Minister replied to three separate motions for debate on censorship "interference with freedom of expression," and managed to have the issue referred to the Knesset Foreign Affairs and Security Committee,

Arich Ben Eliezer, a Herut deputy, with whom Mr. Ben-Gurion clashed on issues of alleged libel in the 1954 "security mishap" case, cited examples of political censorship to disprove the Prime Minister's repeated declarations that only security censorship existed in Israel.

S. Abramov of the General Zionists charged that the Israel censor exceeded his bounds and was guilty of overzealousness. He said it was "absurd" that the Israel press could not reprint items from overseas newspapers, and added that "suppression of news" led to exaggerated rumors, created confusion and undermired morale.

Moshe Sneh, the Communist deputy, asserted that a public statement by former outgoing Chief of Staff Chaim Haim Laskov, which he called entirely political, had been banned by the censor but permitted to appear in the Histadrut newspaper, Davar, Other inconsistencies were cited by speakers who pleaded for a more realistic approach and less "hyper-sensitivity" by the censor.

Asserting that the issue had been blown up "beyond" its actual processions, the Prime Minister cited a long-standing agreement between news editors and the Army's general staff to submit to a three-man committee any disputes about censorship. He said that, during the past six years, censorship officials had listed 21 complaints, and that the committee had unanimously sustained the complaints, fining 20 papers and closine one for one day.

In 18 complaints by editors, the committee had lifted four censorship orders, and upheld nine, listing the others as inconclusive. The Prime Minister said this information disproved the charges of those seeking a debate. The majority of the Knesset supported him and, by mutual agreement, the matter was referred to committee.

The clash between the Prime Minister and the Herut deputy Ben Eliezer developed when the former challenged Ben Eliezer to waive Parliamentary immunity and stand prosecution for libel. The deputy had read a press extract charging Shimon Peres, now Deputy Defense Minister, with forging documents in the 1954 security mishap case when he was director-general of the Defense Ministry. Before the session was ended, Mr. Ben Eliezer took the floor for a private statement in which he denied libeling Peres and attacked the Prime Minister's practice of challenging deputies to waive immunity as "demagogic."

## BEN-GURION AND GOLDMANN MEET ON PREMIER'S STAND AT ZIONIST CONGRESS

JERUSALEM, Dec. 1. (JTA) -- Dr. Nahum Goldmann met with Prime Minister David Ber-Gurion today to discuss the role of the Prime Minister and the Israel Government in the 25th World Zionist Corgress next month.

Mr. Ben-Gurion's stand on the World Zionist Congress will be discussed at a Cabinet metring on Sunday. It was reported that the Prime Minister, who last week attacked the forthcoming Zionist Congress in Knesset, Israel's Parliament, had been advised later that it is expected that his opening address at the Congress should reflect the official views of the Israel Government.

The Prime Minister, it was reported, was told by members of the Cabinet that if he wanted to voice his personal criticisms of the Zionist movement at the Congress, he would be welcome to do so but only in his personal capacity as one of the debaters during the Congress sessions after the major policy speeches are delivered.

Dr. Goldmann was reported today to favor the idea of the inclusion of the right wing Herut in the next Jewish Agency executive but the idea, it was disclosed, is opposed by the labor parties. General Zioinists, Progressives and the Religious Party are reported to be in favor.

## CONGO PRESIDENT ORDERS ALL NASSER'S DIPLOMATS TO LEAVE THE COUNTRY

LONDON, Dec. 1. (JTA) -- President Joseph Kasavubu, of the Republic of Congo, today broke off diplomatic relations with the United Arab Republic, and ordered the "immediate" departure of the UAR Ambassador and his entire staff from the Congo, according to official reports received here today.

President Kasavubu accused the Cairo ambassador of "plotting to overthrow the established authority" of the Republic, and of encouraging "rebel elements" in the country.

(A first group of 25 high-ranking Congolese officials will take part in a four-month public administration course organized in Israel for African officials under United Nations auspices, it was announced today in Jerusalem. The course was developed by the Israel Productivity Institute and the Foreign Ministry.)

## ISRAEL AND FRANCE OPEN TALKS FOR RENEWAL OF ECONOMIC AGREEMENTS

PARIS, 'Dec. 1. (JTA) -- Israel and France opened negotiations today for a renewal of Franco-Israel economic and financial agreements for 1961 with Israel hoping to broaden its sales and reduce its highly unfavorable balance of trade with France.

Israel negotiators planned to seek particularly an easing of quotas which currently limit the quantities of textiles, clothing and industrial products Israel can export to France.

In recent months, Israel has increased economic contacts with the French economy and has contributed to that economy by placement of orders for construction of a number of ships in French shippards hit by a lag in orders and threatened unemployment.

## IDENTITY OF NAZI WHO RECORDED EICHMANN'S CONFESSIONS IS ESTABLISHED

BUENOS AIRES, Dec. 1. (JTA) -- Wilhelm Sassen, alias Willem S. Sassen, the Dutch Nazi whom Adolf Eichmann entrusted with the tape-recording of his confessions on the mass-murder of Jews in Nazi-held countries--which were published in Life magazine--was identified here today also as a writer for the Argentine German-language publication Der Weg, which was suppressed in 1957 by the Argentine Government for its Nazi policy. He published his articles in that newspaper under the name Willem Sluyse.

In one of his articles--an "open letter" to Sir Anthony Eden, former British Prime Minister--he identified himself as "W. Sluyse, Section Leader of the Foreign Service of the 55 Division in The Netherlands," His true identity was established here today by Mark Turkow, executive director of the Argentine branch of the World Jewish Congress, following the disclosure yesterday by the Jewish Telegraphic Agency in New York that Sassen was not a German, but a native of The Netherlands who was an officer of Hitler's Elite Guard, the SS, and who escaped from Holland to Argentina after being charged with war crimes,

Sassen was identified here today as Sluyse, one of the most active collaborators of Der Weg from 1953 until the time when it was closed down by the Argentine authorities. His articles were strongly pro-Nazi and were dated either from Buenos Aires or from Santa Rosa, in Pampa province. In 1955, when the Argentine Nazi leader Enrique Oses died, he wrote in Der Weg a culogy signing at that time the name W, Sassen,

## EXHIBIT SHOWING NAZI PERSECUTIONS OF JEWS OPENED IN FRANKFURT

FRANKFURT, Dec. 1. (JTA) -- An exhibit of photographs and documents depicting Nazi persecutions of Jews was officially opened here in the presence of Lord Mayor Werner Bockelmann, members of the City Council, and other prominent Germans.

## EX-NAZI NOT PERMITTED TO ENTER BRITAIN: WAS TO ADDRESS LONDON MEETING

LONDON, Dec. 1. (JTA) -- A leading German neo-Nazi, who had been scheduled to address a meeting of neo-Fascists in London, will not be permitted to enter Britain, British Home Secretary R.A. Butler announced in Commons today.

Hans Rudel, a lieutenant colonel during the Nazi regime, was one of several European Fascists scheduled to address a meeting of the neo-Fascist "Friends of Europe" to be presided over by Sir Oswald Mosley, long-time British Fascist figure,

Marylebone Town, fearing the possibility of disturbances, canceled a permit to the group for the meeting on December 6 and the Kensington Town Hall was booked for the meeting for the same day, However, Mosley, leader of the British Union Movement, said there was a question whether the meeting could be held at the Kensington Town Hall because the hall might not be large enough.

The issue was raised in Commons today by Barnett Janner, MP and British Jewish leader, who asked Mr. Butler if the latter was aware that Rudel had been a prominent Nazi during the Hitler regime and that Rudel would address a meeting in London. Mr. Janner asked whether the Home Secretary would act to prevent Rudel from coming to England. Replying, the Home Secretary said Rudel would not be allowed to enter the United Kinpdom.

#### KLUTZNICK REPORTS TO B'NAI B'RITH COUNCIL ON ANTI-SEMITISM IN RUSSIA.

NEW YORK, Dec. 1. (JTA) -- Prejudiced attitudes toward Jews are commonplace among people living in the European area of the Soviet Union, the B¹nai B¹rith International Council reported at its annual meeting here today. Analysis of a series of "depth interviews" of Soviet refugees and emigres "strongly indicates that after 25 years of Communist rule, popular anti-Semitism remains deeply embedded in the Soviet culture, "declared Philip M, Klutznick, Council chairman,

The published study, prepared by Dr. William Korey, the Council's research director, showed that 35 percent of the respondents held anti-Semitic attitudes. Of this group, 10 percent were "violently hostile," Another 25 percent held negative stereotypes about Jews. The sampling was conducted in 1950-51 by Harvard University's Russian Research Center. Former Soviet citizens who had involuntarily left their homeland, were probed for their views and attitudes on a wide variety of subjects.

Mr. Klutznick said there is "no available evidence" that Soviet authorities have taken any action "to reduce negative stereotypic thinking about Jews." The study showed that about eight percent of the respondents recalled the Soviet statute which forbids anti-Semitism but most of them considered the law "a device demonstrating that Jews were favored by the regi me," The study also showed that "violent hostility was not limited to the unsophisticated" and that "prejudice toward Jews was particularly strong among Ukrainians,"

About ten percent of those interviewed, including many who registered no hostile attitudes towards Jews, spoke freely about widespread anti-Semitism in the USSR, the study said. The small number of Jews in the sampling also reported that anti-Semitism was "strong" in the Soviet Union.

The Council concluded its sessions by reelecting Mr. Klutzrick chairman. A surprise presentation of the B'nai B'rith President's Medal, the organization's highest award, was made to him at a banquet that opened the two-day meeting. In presenting the award, B'nai B'rith president, Label Katz, cited Mr. Klutznick as "a leader among leaders in his vision, dynamism and eloquence, as spokesman the world over for creative progress in contemporary Jewish life,"

### AMERICAN NAZI PARTY SUES U.S. OFFICIALS AND ANTI-DEFAMATION LEAGUE

WASHINGTON, Dec. 1, (JTA) -- Five members of George Lincoln Rockwell's American Nazi party filed suit yesterday in district court here charging that the group's constitutional rights had been violated,

Named as defendants were the District of Columbia Commissioners officials of the U.S. Interior Department, the office of the Corporation Counsel, the District of Columbia General Hospital and the Anti-Defamation League of B<sup>1</sup>na i B<sup>1</sup>rith.

The suit asked \$550,000 damages, contending that the District of Columbia's disorderly conduct statute was being enforced in a manner which deprived the American Nazi party of its constitutional rights to hold public meetines.

#### NEW SHECHITAH SYSTEM IN CANADA ENTERS INTO USE IN MAJOR CITIES

MONTREAL, Dec. 1. (JTA) -- New devices for handling animals, prior to their stanghter, in accordance with Jewish ritual law, went into use today in abbatoirs in this city. Winninge and Ottaws.

The devices were worked out to accord to humane slaughter requirements in recently enacted Government regulations, and were approved as conforming to Jewish laws on shechitah. The approval was given by Rabbi Eliezer Silver, of Cincinnati, and Rabbi Joseph Soloveitchik, of Boston,

The change-over to the new method of handling the animals prior to slaughter was accomplished here under arrangements by the Council of Orthodox Rabbis and the Jewish Community Council here.

#### MONTREAL COURT STARTS HEARING ON ANTI-SEMITIC ATTACKS BY HUNGARIANS

MONTREAL, Dec. 1. (JTA) -- An all-day hearing in the municipal court here was devoted to the details of a brawl which resulted in charges being laid against five Hungarians accused of anti-Semitic attacks on Jewish passers-by. Charges against two others were dismissed.

Complainants told of hearing cries of "Hitler is back," "Death to the Jews," But the judge ruled that an elaboration of this theme is not pertinent to the case. Complainants testified that their wives were insulted by the accused and that they were themselves struck by the Hungarian youths. Three of the accused took the stand to deny the charges and to say that they acted in self-defense.

#### CANADIAN JEWS COMPLAIN AGAINST MISSIONARY'S TALK IN HIGH SCHOOL

HALIFAX, Canada, Dec. 1. (1TA) -- Three local leaders of the Canadian Jewish Congress complained today to the Halifax Board of School Commissioners here against the appearance of a Christian evangelist in a local high school where, allegedly, he made "certain offensive comments which made several of the Jewish students quite uncomfortable."

The evangelist, Dr. Hyman Appleman, does missionary work which "happens to direct itself in mission to Jews," the Education Board was told by the Jewish delegation, consisting of Magistrate Nathan Green, Peter Herschorn and Ralph M, Medjuck,

The clergyman's appearance at a student assembly of the Queen Elizabeth High School here, according to the complainants, "was not previously announced to the students, nor did they have an opportunity not to attend if they so desired." The delegation asked the board to see to it that, in the future, no opportunity be afforded in public schools "to speakers such as Dr. Appleman,"

"Generally speaking," the delegation told the board, "it is the position of the Canadian Jewish Congress that it is in the best interests of Canada and our democratic way of life if religion is attended to by the churches and synagogues. We do object most strongly to missionary activity in our public schools, whether it be directed to members of the Protestant, Catholic or Jewish faiths,"

#### \$3,350,000 RAISED BY MONTREAL JEWISH APPEAL IN 1960 CAMPAIGN

MONTREAL, Dec. 1. (JTA) -- The 1960 Montreal Joint Campaign for the Combined Jewish Appeal and United Israel Appeal raised a grand total of \$3,350,045, according to a report by Arthur Pascal, general chairman.

He told 500 campaign workers and supporters that the sum was the largest ever raised in an annual campaign since the Joint Campaign was started in Montreal in 1951 and the largest amount ever raised in one campaign by any Canadian Jewish community. The total was an increase of nearly \$171,000 over the results in 1959.

#### DIRECTOR OF WORLD ORT ARRIVES IN U.S. TO DISCUSS 1961 FINANCING

NEW YORK, Dec. 1. (1TA) -- Max A. Braude, director-general of the World ORT Union, arrived from Geneva today for discussion concerning the financing of the more than 650 trade schools and other vocational programs which the organization conducts in 19 countries. ORT receives funds in the U.S. from the Joint Distribution Committee, out of the income of the United Jewish Appeal, and from its membership activities.

"The vocational activities of ORT which are expected to provide instruction in occupational skills to some 40,000 persons during 1961, will cost a minimum of \$6,500,000," Mr. Braude stated. He noted that ORT was receiving several times as many applicants for admissions as could be accommodated in its training facilities. "This trend, which is already severely straining our budget, will continue to grow," he asserted,

#### STREET IN BRAZILIAN CITY NAMED FOR STATE OF ISRAEL; CEREMONY HELD

RIO DE JANEIRO, Dec. l. (JTA) -- A street in Salvador in Bahia province, a former capital of Brazil, was today named for the State of Israel in ceremonies in which Israel Ambassador Yosef Tekoah participated. Some 250 Jewish families live in the city.
