MOSCOW ATTACKS ISRAEL; SAYS BEN-GURION IS FANNING 'MILITARY HYSTERIA'

LONDON, Dec, 5. (JTA) -- A severe attack on Israel, containing charges that Prime Minister Ben-Gurion keeps on saying that "Israel will remain secure as long as the Israeli Army carries out the task of frightening its neighbors with its strength," is published in the Red Star, official organ of the Red Army in the Soviet Union, which reached here today.

"It is necessary to point out," the paper writes, "that calls for war have become a routine and daily pursuit of Israeli Zionists. The question of the revival of militarism in the country and the fauning of military hysteria dominate all Israeli ruling quarters,

"Military expenditure in Israel has reached a record figure, comprising one-third of the state budget," the article continues. "Nevertheless, this sum, in their opinion appears to be insufficient. For this reason the Israeli Government imposed additional new taxes on the populace last August. Israeli papers pointed out in this connection that the government is seeking by this means additional sums estimated at 10 million dollars for the purchase of arms.

"In addition, the Israeli Government is doing its utmost to develop the war industry which enjoys various concessions. The production of war material in the country has reached a very high level--so much so that arrangements have been made for arms exports to other countries. Arms exported by Israel go chiefly to NATO countries which in turn meet the needs of the Israeli war industry. It is known, for instance, that besides exporting Israeli arms to NATO countries, Israel has been granted the right to submit bids for the supply of goods to the armies of this organization,

"In the light of these facts, the object of the statements made by Israeli statesmen becomes very clear. They believe that the guarantee of peace is not through disarmament or the realization of peaceful coexistence, but through nuclear armament and the continuation of the cold war. This is a natural consequence of the policy of Israeli ruling quarters, which are trying to develop the country along the road of militarism and preparations for aggression against the Arab countries, "the article concludes.

PROBLEMS OF MUTUAL INTEREST TO U.S. AND ISRAEL DISCUSSED IN JERUSALEM

JERUSALEM, Dec. 5. (JTA) -- United States Ambassador Ogden Reid was received by Foreign Minister Golda Meir today--the second tirre within the past few days--for what was understood to have been a review of various problems of mutual interest to both countries. It is believed that the UN debate on the Arab refugees was the center of the discussion.

An earlier meeting between Mrs. Meir and Ambassador Reid was devoted to technical problems and the supply of American agricultural surpluses to Israel.

BEN-GURION LAUDS TOURISTS; TELLS ISRAELIS NOT TO 'SKIN' THEM

JERUSALCU, Dec. 5. (JTA) -- Prime Minister David Ben-Gurien called on the Israel tourist industry today to treat tourists fairly and not to "skin them" during their stay in the country. Addressing the opening session of the congress on tourism here attended by tourist officials, travel agents and hotel operators, the Premier declared that "more important than the great economic value of tourism is the fact that it brings people to see the land of Israel."

Jews visiting Israel, Mr. Ben-Gurion said, "return hore more proud and with the Jewish content of their lives enriched. But," he added, "they must return with their skins whole-don't skin them during their trip." He emphasized that tourism also encouraged aliya. "Non-Jewish tourists who depart from Israel, praise the country, not from politeness but from the heart. This is one of the best ways to break the walls of Arab hatred surrounding Israel," the Prime Minister declared.

Teddy Kollek, director-general of the Prime Minister's Office, told the Congress that Israel's tourist industry needed 250 to 300 million Israeli pounds in investment during the next three years, to expand air and sea transport, hotel and other facilities. He pointed out that the country could earn at least the equivalent sum annually from tourism.

CANADIAN WHO JOINED AMERICAN NAZI PARTY IS ORDERED TO LEAVE U.S.

WASHINGTON, Dec. 5. (JTA) -- An order of deportation was issued today against a naturalized Canadian citizen who came to the United States as a visitor and joined the American Nazi party.

The special inquiry officer of the U.S. Immigration and Naturalization Service, ruled that "to foment hatred against individuals, or against race and religion, cannot be regarded as conduct reasonably necessary to the pursuit of a visit or conduct reasonably allied therewith,"

The subject of the inquiry was John Pall, a native Hungarian who became a Canadan citizen and came to the United States last September in order to paint and sell his paintings, according to his own definition of the purpose of his visit which was intended to last for about two years. He Joined George Rockwell's American Nazi party, participated in its activities and lived at its headquarters,

When charged with non-compliance with non-immigrant requirements, Pall enjoyed the protection of the "commander" who acted as his attorney before A. Gold, the special inquiry officer. During the proceedings, the respondent did not answer some questions, pleading the Fifth Amendment. It was established that Pall engaged in picketing Sen. John F. Kennedy's campaign headquarters and "carried an insect spray gun on occasion which apparently relates in some way to race extermination,"

The special inquiry officer ordered the deportation on two counts. That a visitor should be allowed to engage in activities necessary to carry out the purpose of his visit or activities which can reasonably be expected from a guest in the United States. The participation in Nazi activities, seeking to foment hatred, cannot be regarded as such conduct, and therefore constitutes a failure of compliance with a condition of non-immigrant.

It was held that he also failed to comply with another condition of the same status by acceptance of employment without prior approval by the Immigration and Naturalization Service. Mr. Gold ruled that Pall had been employed by the American Nazi party by prforming assignments given to him by that organization in return for which he received sleeping quarters.

The respondent was given time until December 12 to appeal from the deportation order to the Immigration and Naturalization Board. George Rockwell lists Pall as the international secretary of the World Union of Free Enterprise National Socialists.

FASCIST MEETING CANCELED IN LONDON AFTER BAN ON NEO-NAZI SPEAKER

LONDON, Dec. 5. (JTA) -- The scheduled meeting of the fascist "Friends of Europe," to have been held in London tomorrow, has been called off, due to the ban on the admission into England of Hans Rudel, a leading German neo-Nazi, it was announced today by Sir Oswald Mosley's fascist Union Movement.

Rudel was banned from entering England last week by Home Secretary R.A. Butler, after an inquiry on the subject in the House of Gommons by Barnett Janner, Laborite Member of Parliament, Meanwhile, Marleybone Town, which has Jurisdiction over the auditorium booked by the fascists for the meeting, canceled the permit for the session. Other European fascist leaders had originally been scheduled to appear at the rally, in addition to Rudel.

EX-NAZI DIPLOMAT FREED; WAS CHARGED WITH DEPORTING II, 000 JEWS

FRANKFURT, Dec. 5. (JIA) -- Heinz Beckerle, former Nazi Ambassador to Sofia, was free from detention today after the Frankfurt examining magistrate ruled there was lack of evidence to support charges he had organized the deportation of 11,000 Macedonian Jews in March, 1943,

The ruling also held that although Beckerle belonged to the Nazi elite, he could not have known of the fate intended for the deportees. Beckerle was first arrested in October, 1959, but was released a few days later. He was arrested again last May after the apprehension of Nazi master killer Adolf Eichmann.

NAZI WHO DEPORTED 2,000 JEWS FROM DUTCH HOSPITAL IS ARRESTED IN GERMANY

THE HAGUE, Dec. 5. (JTA) -- Officials of the Dutch Ministry of Justice here were informed by German authorities today that they have arrested a Nazi Storm Troop leader who ordered the deportation of almost 2,000 Jews from Appledoorn, h 1943.

The man is Dr. Willy Zopf. In 1943, he ordered all 1,900 inmates of the Jewish Mental Hospital at Appledoorn sent to death camps. With the inmates, he sent to the extermination factories also the entire medical, nursing and maintenance staff of the institution, then one of the largest of its kind in Europe.

Zopf, according to the information received here, has been working as a masseur in the small Bavarian town of Murnau for the last seven years. He was apprehended recently, and lodged in the prison at Munich.

FRENCH LITERARY JURY CANCELS AWARD VOTED FOR ANTI-SEMITIC AUTHOR

PARIS, Dec. 5. (JTA) -- The Goncourt Prize Jury, which annually announces a literary award, small in cash value but great in resulting sales of the book thus honored, announced today that it will make no award this year.

Thus ended the chance for Vintila Horia, Rumanian exile, to obtain the award, which had been previously voted him by the Goncourt Jury. He has, since, been charged with being a fascist writer and Nazi collaborationist during the war, who wrote anti-Semitic articles.

Horia had already announced that he would reject the Goncourt Prize because he did not mut "to be a cause of dissension. The charges against him were made here last week by the Communist daily newspaper, L'Humanite, and later backed up by the Rumaniab Embassy here. Horia was seen to have failed to deny the charges when he told the press here that, during the war "even saints had erred,"

GERMAN PHYSICIAN LOSES MEDICAL LICENSE FOR TORTURING NAZI VICTIMS

BONN, Dec. 5. (ITA) -- A German woman physician, Dr. Herta Oberhauser, today lost her medical license for practice "contrary to German law and the ethical rules of the medical profession" by participating in "medical experiments" on prisoners in the Ravensbrucck concentration camp during the Nazi regime. Additionally, she faces prosecution for three "mercy killings.

At the same time, the West German Medical Association issued a declaration, for the first time since German physicians were tried for malpractice by the Nuremberg War Crimes tribunal in 1947, officially stating that it is "unequivally determined to express opposition to the medical experimentations undertaken during the Nazi regime."

Dr. Oberhauser was convicted by the Nuremberg tribunal in 1947 of performing "medical experiments" on prisoners at Ravensbrueck, and sentenced to 20; years! imprisonment. She was released in 1952 and reopened her medical practice at Stocksee, a small town in Schleswig-Holstein. Two years ago, the Ministry of the Interior ordered her license revoked for the same crimes of which she had been convicted at Nuremberg, and ordered also that she stand trial again on those charges.

On appeal, the Administrative Court rejected the Ministry's plans to try the doctor again, ruling that such a trial would place her in double jeopardy. However, the court upheld the order to revoke her medical license. The Schleswig-Holstein Justice Ministry announced today it plans to prosecute Dr. Oberhauser nonetheless, on other charges. The new charges involve a confession she made that, during the war, at Ravensbrucck, she performed 'mercy' killings on three women prisoners.

Trial of Medical Aide Who Murdered Nazi Victims Starts in Germany

FRANKFURT, Dec. 5. (JTA) -- The trial of former SS medical aide Gottlieb Muzikant, charged with the brutal murder of 210 persons in Austrian concentration camps, started today in the city of Fulda.

A total of 37 witnesses have been called to testify in the trial which is expected to continue until the end of the month. Among the witnesses will be Michai Haqk, Chief of the French Secret Police, Mr. Ariche, the president of the Paris Lawyers Association and Dr. Rakopoulos, the physician to the Queen of Greece. The murders occurred in the Mauthausen and Steyr camps.

GERMAN MINISTRY INSISTS ON REVOKING PENSION OF HIGH NAZI OFFICIAL

BONN, Dec. 5. (JTA) -- An appeal was filed today against an Administrative Court's decision to continue pension payments to Franz Schlegelberger, former Nazi Deputy Minister of Justice. The appeal was filed by the Schleswig-Holstein Ministry of Finance.

The Ministry had revoked the 2,900-mark monthly pension on grounds that Schlegelberger had miscarried Justice by enacting laws against Poles and Jews during World War II and for having ordered the execution of a 76-year-old Jewish prisoner in Kattowice.

JEWS IN CANADA FIND FAULT WITH CENSUS CLASSIFICATION RESULTS

OTTAW... Bec. 5. (JTA) -- Organized Jewry in Canada was informed by the Government today that Canadian Jews, like all others in the Dominion, will again be able to enroll themselves as "Canadian," without indicating their ethnic origin, when the next census is conducted in this country in 1961.

In the 1951 census, Jews were permitted to register as "Canadians" as to ethnic origin, while putting themselves down, if they chose to do so, as "Jew" by religion. The same rules will prevail in the 1961 census, Dr. O. Lemieux, chief of the Government's Census Branch here, today told a delegation representing the National Joint Public Relations Committee of the Canadian Jewish Congress and Bruai Birth.

Jewish leaders point out that such double classification results in incorrect statistics, the note that, inthe 1951 census, only 181, 670 persons declared themselves of Jewish think origin, while 204, 836 said their religion was Jewish. The result, say the Jewish leaders, was thet "the erroneous impression was given that 23, 166 persons, or 13, 5 percent of all Jews by religion in Canada in 1951, were not Jews by ethnic origin which was evidently incorrect."

FIRST JEW TO SEEK MAYORALTY IN OTTAWA SUPPORTED BY LOCAL PRESS

OTTAWA, Dec. 5. (JTA) -- The first Jewish candidate to enter the mayoralty race in this city's history, has received the enthusiastic support of both of Ottawa's newspapers against all three of his opponents. Samuel Berger, Q.C., a member of the city's Board of Control, is making his first bid to head the City Council.

The Ottawa Citizen, the city's most influential daily, has announced its support of Mr. Berger in spite of the fact that his leading opponent is Dr. Charlotte Whitton, a columnist on the paper. The surprise move by the paper had drawn a storm of protest from supporters of Dr. Whitton, who has now resigned from the staff of the Citizen. The Ottawa Journal, also announcing its support of Mr. Berger, declared today that "Mr. Berger has shown more leadership in any crisis than any other member of the Council."

LEADER OF ARAB LEAGUE CONFERS WITH PRIME MINISTER OF CANADA

OTTAWA, Dec. 5. (JTA) -- Mohammed Abdel Hassouna, secretary-general of the Arab League, met for a half-hour this weekend with Prime Minister John G. Diefenbaker here. The visit was described as a "courtesy" call, and it was emphasized by a government spokesman that no political subjects were discussed.

Later, Mr. Hassouna held a press conference, in which he repeated the customary Abd League charges about Israel's alleged "refusal" to abide by United Nations resolutions, declaring the "Arab world objects to the establishment of Israel. " He called for "repatriation" of all Arab refugees to Israel. The Canadian press paid scant attention to Mr. Hassouna's visit or anti-Israeli declarations.

Colonel Hillel Al-Daag, chief d the Israeli Army's engineering corps, continued today to visit Canada's major military installations, as a guest of the Dominion Department of Defense. Colonel Al-Daag arrived here last week at the invitation of the Canadian Army. He is accompanied on his tour by Nol A. Tsur, assistant military attache to the Israel embassies here and in Washington.

40,000 NEW YORKERS TO ATTEND TWO CHANUKAH FESTIVALS FOR ISRAEL

NEW YORK, Dec. 5. (1TA) -- More than 40,000 New Yorkers will celebrate Chanukah. by attending two Chanukah Festivals for Israel, which will be presented by Israel Bonds on December 19 and January 2 at Madison Square Garden, it was announced today. Governor Nelson A. Rockefeller will be the principal speaker on December 10. Admission to the festival will be free to purchasers of Israel bonds,

A total of more than 350 campaign events will be held this month to bring the 1960 Israel bond drive to a successful conclusion, it was announced by Dr. Joseph J. Schwartz, vice-president of the Israel Bond Organization. The end of the current year's drive will be marked with Chanukah festivals in a number of major cities, and with many dinners and other social events, the most important of which will be a nationwide tribute to former President Harry S. Truman in Chicago on December 10. More than 4,000 persons are expected to participate in the dinner in Mr. Truman's honor.

PHILIP SLOMOVITZ MARKS 50TH ANNIVERSARY OF BECOMING A U.S. CITIZEN

DETROIT, Dec. 5. (JTA) -- Philip Slomovitz, editor and publisher of the Jewish News here, marked 50 years of his becoming an American citizen with a tribute to the American way of life which attracted the attention of the Detroitt Free Press, one of the leading newspapers in the country, which reprinted part of Mr. Slomovitz! column expressing thanks "for the privilege of being an American,"

"Fifty years as an American," Mr. Slomovitz wrote, "meant 50 years of freedom-freedom to speak the mind and to express views without hindrance, 50 years of service to causes that fit into the American way of life and therefore to help in the uplifting of the less fortunate, 50 years that were not without their battles and debates but they were disputes and arguments of such a nature as to exho what the striver for Justice acquired as part of his immersion into Americanism."

Outlines La experiences of half a century as an American, a Jew, a Zionist and a Journalist, Mr. Slomovitz, lauded the "genuine principle of fair play" prevailing in this country. "In this country we were free to speak our minds against intolerance, to battle the anti-Semites," he stressed, adding:

"When you fight the anti-Semite you seek to climinate the negative aspects of American life. It is when one searches for the positive, when you aim to do the creative things in life, that you are faced with the true test of American greatness. Your commentator has found the genius of America in the freedom to act in behalf of his fellow Jews through the Zionist ideal."
