BEN-GURION TO SPEND FOUR DAYS IN N.Y.; WILL MEET PRESIDENT KENNEDY

NEW YORK, May 22. (JTA) -- Israel Prime Minister David Ben-Gurion will spend four days in New York, following his visit to Canada and prior to his return to Jerusalem; it was learned here today. During his stay in New York, he expects to confer with President John F. Kennedy, and also to meet with United Nations Secretary General Dag Hammarskfold and with Adlai Stevenson, head of the United States delegation to the Unit.

Mr. Ben-Gurion also accepted invitations to address an Israel bond dinner in Philadelphia, on May 29, celebrating the 10th anniversary of the Israel Bond Organization. He will also address, on May 31, a closed dinner-meeting of the United Jewish Appeal leaders which will be held at the Waldorf Astoria Hotel here.

(In Israel, the press indicated today that Mr. Ben-Gurion may ask President Kennedy for a renewal of the 1950 Anglo-American - French declaration on the Middle East, which guarantees the present Israel-Arab borders, or he may discuss the possibility of such a four-power declaration in which the Soviet Union should be the fourth power.

Mr. Ben-Gurion's meeting with President Kennedy will probably take place on May 30. President Kennedy is leaving the next day for Paris. The Israel Prime Minister, it is believed, will present to Mr. Kennedy a general view of the Israel Government on Middle East problems, presumably with special consideration toward the meetings which President Kennedy is to hold with President de Gaulle of France and later with Soviet Premier Nikita Khrushchev.

EICHMANN TO TESTIFY AT HIS TRIAL; COURT TOLD OF HIS CRIMES IN GREECE

JERUSALEM, May 22. (JTA) -- Adolf Eichmann is expected to take the witness stand on his own behalf on June 5, Dr. Robert Servatius, his chief defense counsel, stated here this afternoon, as the trial of the ex-Gestapo colonel was resumed.

A spokesman for the special security guard over the prisoner announced that, during himprisonment, Eichmann has had two attacks of "extra systolia," manifested by an irregular pulse. This malady, also known medically as "functional arythmia," was caused by nervous tension, the spokesman said. The announcement about Eichmann's attacks came after Dr. Servatius himself had told some correspondents here that Eichmann had suffered two heart attacks.

The trial today brought forth testimony, and documentary evidence, showing the nature and magnitude of Nazi atrocities against Jews in Greece and Bulgaria, eliciting from one witness the fact that, of 56,000 Jews deported from Greece, only 1,900 survived.

At the same time, an announcement was made by Attorney General Gideon Hausner that former Nazi SS General Hubert Kappler, now serving a prison sentence in Italy for war crimes, will be questioned in Italy fors that former Nazis in Germany are being questioned there now by German courts. Dr. Servatius had requested questioning of General Kappler. Both the prosecution and the defense will draw up questionnaires to serve as the basis for the Italian court's interrogation of the Nazis.

Documents showing that Eichmann's office had urged the Hitler Foreign Ministry to put pressure upon Bulgaria to hand over Bulgarian Jews to his Jurisdiction were introduced this afternoon by Mr. Hausner. Since Bulgaria was an ally of Nazi Germany, and not an occupied country, Eichmann had to approach the Sofia Government through the Foreign Ministry. The papers showed he wanted Bulgaria to close its borders against Jewish emigration before they could escape.

Then Mr. Hausner opened the chapter on Greece, showing that Eichmann was pressuring the Italian army, occupying Greece, to implement "systematic" anti-Jewish measures in Thracia and Macedonia. Eichmann was shown to have ordered his aide in Greece to report on "the progress" of the various steps he ordered, including establishment of ghettoes and the launching of a deportation program.

Yithak Nehama, a Jew who had been a small store owner in Salonika, Grecce, testified to the terror and brutalities suffered by the Jews in his city at the hands of Germans. He told of being part of a transport of 2, 700 Jews sent to Auschwitz, saying only ten of these Jews survived. When Eichmann's own assistant in Salonika tried to postpone further deportation of Greek Jews, Eichmann ordered that the transports be resumed.

U.S. MILITARY AID TO ISRAEL IS SMALL COMPARED TO SUMS GIVEN TO ARABS

WASHINGTON, May 22. (JTA) -- During the 15-year period from July 1, 1945 to
June 30, 1960, Israel received from the United States only \$1,000,000 incash funds for military assistance, figures disclosed here today by the International Cooperation Administration established. No military personnel whatever was sent to Israel by the United
States, the ICA report showed.

Israel's closest neighbors among the Arab countries received much greater military aid in cash, the report showed. Iraq got \$46,100,000; Jordan received \$17,600,000; and Lebanon was given \$8,700,000. Like Israel, none of these countries received any American military personnel. Egypt and Syria are not listed as recipients of any military aid.

ISRAEL STARTS SECOND CENSUS; 4,500 CENSUS TAKERS TO COLLECT INFORMATION

JERUSALEM, May 22. (JTA) -- Israel started today the taking of its second census of the population with a visit by the director of the Census Bureau to the residence of President Izhak Ben-Zvi where he "counted" the President's household. Israel's first census was taken in November 1948.

About 4,500 census takers will fan out to homes through the country to collect abbreviated questionnaires and statistical punch-cards which were mailed out to every family during the last two weeks. In addition, every fifth family will be required to fill out a more detailed questionnaire inquiring about dwelling conditions, education, employment and other economic and social situations.

BRITAIN BANS ENTRANCE OF 20 DELEGATES TO WORLD ANTI-SEMITIC PARLEY

LONDON, May 22. (JTA) -- The Home Office today refused permission to land in England to 20 delegates who tried to come here from Denmark, Belgium, Sweden and Holland to attend the first international rally of the anti-Semitic, neo-fascist British National Party,

A delegation from the United States was also banned, the Home Office declared. The Americans were notified before they left the United States that they would be barred, and decided to stay home. The rally will be held all this week at Narford, in Norfolk. A. Fountaine, president and co-founder of the British National Party, said today that about 50 delegates are attending the rally at his estate, including 15 from abroad. They are all "racial nationalists," he said, and are engaged "in activities of a cultural nature."

One of the British-National Party's organizers is Colin Jordan, a school teacher who was among eight neo-fascists arrested here and fined for picketing a Warsaw Ghetto memorial meeting several weeks ago. The party's mctuces are "Britain for the firstish," and "Keep Britain White " According to Fountaine, the party is not connected with the group led by Oswald Mosley.

2,500 DELEGATES ATTEND WORLD PENTECOSTAL CONFERENCE IN JERUSALEM

JERUSALEM, May 22. (FTA) -- More than 2,500 delegates from many countries are participating in the three-day world conference here of the Pentecostal movement, formally organized as the Church of God in Christ. The movement claims 8,500,000 members throughout the world, and considers the rebirth of the State of Israel as one of the signs that the Messiah is coming.

Prime Minister David Ben-Gurion in a message to the delegates emphasized "the historic meaning of the Biblical promises for the return of Israel to its land and the revival of the language of the prophets." Abba Eban, Israel-8 minister of Education, —addressing the conference, pointed out that "this generations greatest issue is drawn, not between Christianity and Judaism, and not between Israel and the Christian nations, but between those who assert and those who deny the supremacy of faith and freedom."

In a statement directed toward the Israeli people, the Rev. Howard Courtney of Los Angeles, chairman of the conference, declared: "We believe God's hand is on you. We believe that the Jews are in Israel, not by accident but in definite fulfillment of prophecy. This is a greater manifestation of God's power than when He brought you out of Egyptian bondage. For us, this is a modern-day miracle."

Another speaker was Rabbi Arthur Gilbert, director of the department of inter-religious affairs, of the Anti-Defamation League of B'nai B'rith. "Deepening of inter-religious understanding," he stated, "and a growing sense of fellowship are the fruits of the sincere Pentecostal belief in Israel's establishment."

So enthusiastic were the delegates about the welcome they have received in Israel tlat, at star night's session, they decided spontaneously to plant a forest of 10,000 trees in this country "las an expression of thanks for the warm welcome we received here." Each of the 2,500 conference delegates contributed \$10 for the purchase of four trees,

Many of the delegates attended sessions of the Eichmann trial while here, and expressed approval of Israel's efforts to bring Eichmann to Justice. Among these were (Dr. D. Law-rence Williams, presiding bishop of Memphis; and the Rev, James A. Cross, overseer of the Church in Philadelphia. "It think," said Dr Cross, "all Christians everywhere will rejoice to see justice triumph."

U.S. ZIONIST LEADERS IN COUNTER-ATTACK ON BEN-GURION'S ASSAULT ON THEM

NEW YORK, May 22. (JTA) -- Leaders of the Zionist movement in this country today continued to criticize Israel Premier David Ben-Gurion for his latest attack on American Zionists, voiced in the Israel Parliament last week. Leading in today's counter-attack against Mr. Ben-Gurion was the American Zionist Council, the central coordinating body of all Zionist groups in the United States. Rabbi Irving Miller, chairman of the Council, said in a statement:

"It is not news to read in the press that Mr. Ben-Gurion has indulged upon his favorite obsession of attacking Zionism and particularly the American Zionist. What is however shocking in his latest statement is his attempt to define an American and a Jew and the relationship of one to the other. It is difficult to imagine a more inaccurate or distorted statement on this subject. I prefer to accept as an authority on this subject the Justice Brandeis, who understood infinitely better America and American Jews than does Ben-Gurion

"Brandeis wrote: 'There is no inconsistency between loyalty to America and loyalty to Jewry. The Jewish spirit, the product of our religion and experience, is essentially modern and essentially American. Indeed, loyalty to America degmands rather that each American Jew becomes a Zionist. For only through the ennobling effect of its strivings can we develop the best that is in us and give to this country the full benefit of our inheritance.'

"The common loyalty which American Jews share with Israelis is a loyalty to the values, ideals and aspirations of the Jewish people, in other words, loyalty to Judaism in the broadest sense of the term. What is abundantly clear to anyone informed on the Israel scene is that Ben-Gurion is completely isolated in his opinions on Zionism and American Jews, not only in the Knesset and in the Government but in his own party as well. He speaks for himself and for himself only."

Ben-Gurion Called *Self-Styled* Supreme Authority on Judaism

Max Bressler, president of the Zionist Organization of America, k..med Mr.Ben-Gurion's attack on the American Zionist movement as an "outburst against American Jewry!" and called upon all ZOA members "to intensify their vigilance and consolidate their efforts for the security and economic stability of Israel" undeterred by Mr. Ben-Gurion's latest blast. He characterized Mr. Ben-Gurion's speech against the American Zionists in the Knesset as "part of the cold war which he has been waging against American Zionists for their refusal to accept his pose as a self-styled supreme authority on Judaism and Zionism, "

"It is a matter of sincere regret and distress that Mr. Ben-Gurion for some inexplicable reason, perhaps under the pressure of heavy burdens of office, chose to give vent to his hostility to the degree of obsession by defining who is an American, an area in which he has exhibited the same distorted and biased Judgment as in relation to Zionism," the ZOA president declared. "The political allegiance of American Jews is and will always be entirely and unequivocally to the United States of America and Mr. Ben-Gurion has committed a grave and dangerous injustice in casting aspersions upon the very texture of American democracy.

"I am confident that these aspersions will not endanger our position any more than the canards of the enemies of the Jewish people and of Israel and the infinitesimal group of escapist Jews among us," Mr. Bressler said: "He also voiced confidence that "the American Jewish community and the American Zionists within it will not allow the rash outburst of Mr. David Ben-Gurion, which he made in his private and individual capacity to influence them in relaxing their vigilance and energy, and their unquestionable loyalties to our country, the U S.A., and our responsibilities on behalf of the State of Israel."

The United Zionist-Revisionists of America issued a statement declaring: "Mr. Ben-Guricn's statement gives aid and comfort to the American Council for Judaism and all the other enemies of Zion and the State of Israel, in the United States, and strikes a gratuitous blow at the Zionist movement."

The B'hai Zion said in a statement: "The remarks of Mr. Ben-Gurion are a reckless—and baseless attack not only upon the American Zionist movement, but on the entire American Jewish community. B'hai Zion, which was founded 53 years ago on the cardinal principles of Americanism and Zionism, and which has devoted itself to the contemporaneous development of those principles ever since, utterly rejects and labels false in theory that which implies that the devotion of American Jews to the creation of a Jewish homeland makes them any less good Americans, or that their devotion to America makes them any less good Zionists. Mr. Ben-Gurion is hardly an expert on America and now certainly shows himself to be no expert on either logic or Zionism."

KING OF MOROCCO DECORATES TWO JEWISH PHYSICIANS FOR SERVING IN CONGO

CASABLANCA, May 22. (JTA) -- Two Jewish doctors who served with the Royal Moroccan Army in the Congo were reported today to have been personally decorated by King Hassan II in a ceremony at Meknes. The two physicians are Dr. Emile Chekoury of Casablanca and Dr. E.G. Joseph of Marrakech. They received directly from the King medals citing them for "Courage and endurance."

ROCKWELL TAKES HAND IN ALABAMA FIGHT; SEEKS 'PROTECTION' FROM JEWS

WASHINGTON, May 22. (JTA) -- George Lincoln Rockwell, self-styled "commander" of the American Nazi Party, injected himself today into the explosive "Freedom Rider" situation that has resulted in martial law in Montgomery, Alabama, by attempting to use the situation for propaganda against Jews and against integrationists.

Rockwell sent 12. of his stormtroopers this morning from his headquarters at Arlington, Virginia, announcing that they will go on to New Orleans, and demanding that Attorney General Robert Kennedy provide his cohorts with "protection from Jew and Negro hoodlums." In a telegram to Mr. Kennedy, Rockwell said "we are sending a hate bus full of Nazis to urge respect for law and legal organizational efforts to preserve the white, Christian republic established by our forefathers."

Justice Department officials said today that, while they deplore Rockwell's "intrusion" into the explosive situation, there was nothing the Federal Government could do to halt Rockwell's Nazi tour. However, Alabama's Attorney General MacDonald Gallionwarned Rockwell to "steer clear" of Alabama, stating he was "unwelcome" there.

Meanwhile, Arlington County authorities announced adoption of a strict ordinance requiring solicitors to be photographed and fingerprinted and to establish "good character and business respectability" with Commonwealth Attorney William J. Hassan, pointing out that, without such legal machinery, the American Nazi Party would be allowed "free rein to go from door to door in Arlington, soliciting memberships." Mr. Hassan said the Nazi group would not be granted a permit for solicitation under the "good character and business respectability" clause of the new ordinance.

CLEVELAND JEWISH WELFARE FUND DRIVE YIELDS \$5,431,680; BEST IN 31 YEARS

CLEVELAND, May 22. (JTA) -- The 1961 Jewish Welfare Fund appeal ended this week with pledges of \$5,431,680, setting an all-time record for the 58 years of the Jowish Community Federation, sponsor of the drive. The total topped the previous record, set last year, of \$5,422,000.

The figures were disclosed at a dinner meeting at which Edward Ginsberg, general chairman, presided. A highlight of the meeting was a tribute to the living past chairmen of the Cleveland campaign, first conducted in 1931. The list of those honored was headed by Rabbi Abba Hillel Silver, who led the drive in 1935 and in six subsequent years. L. W. Neumark is president of the Federation. Henry L. Zucker is executive director.

ENGLISH-JEWISH PUBLISHERS DISCUSS VARIOUS PROBLEMS AT ANNUAL CONFERENCE

NEW YORK, May 22. (JTA) -- Problems concerning American Jewish life and the publication of news of Jewish interest from all over the world were discussed at the three-day annual conference of the American English-Jewish Press Association which concluded here yesterday. Eleazer Lipsky, president of the Jewish Telegraphic Agency, was the principal guest speaker at the annual luncheon of the conference.

The conference re-elected Joseph G. Weissberg, co-publisher and executive editor of the Jewish Advocate of Boston, president of the organizations. Other officers re-named by the association were Jules Miller of the Jewish Exponent of Philadelphia, Albert W. Golomb of the American Jewish Outlook of Pittsburgh and Leo H. Frisch of the American Jewish World of Minneapolis-St. Paul, vice-presidents, James Wissch of the Texas Jewish Post of Dallas-Fort Worth, secretary, and Milton Pinsky of the Ohio Jewish Chronicle of Columbus, treasurer.

Joseph Cummins of the B¹nai B¹rith Messenger of Los Angeles was re-named chairman of the executive committee. Other members of the committee are Eli Jacobs of the Buffalo Jewish Review, Morris Janoff of the Jewish Standard of Jersey City and Adolf Rosenberg of the Southern Israelite of Atlanta.

KALAMAZOO MAYOR, CHRISTIAN, IS CO-CHAIRMAN OF LOCAL ISRAEL BOND DRIVE

DETROIT, May 22. (JTA) -- The Mayor of Kalamazoo, Michigan, a leading Christian layman, today accepted the post of co-chairman of the local Israel bond campaign and immediately set to work to line up the entire community behind the drive. Mayor James S, Gilmore, Jr., as the first step in assuming this responsibility, purchased \$13,000 in Israel bonds. Mr. Gilmore and other members of his family have bought a total of \$20,000 in Israel bonds this year.

ISRAEL SHUMACHER, FAMOUS JEWISH ACTOR, DIES IN ISRAEL; WAS 53

TEL AVIV, May 22. (ITA) -- Many of Israel's leading artists and stage personalities today attended fundral services here for the late Israel Shumacher, famous Jewish actor, who died yesterday after a long illness. He was 53.

Mr. Shumacher was the second half of the famous Dzigan-Shumacher duo whose skits had brought grim humor for many years to suffering Jews in Poland and Russia during the pre-war years and, for a time, after the outbreak of World War II. They came here after the State of Israel was founded in 1948 and, of late, had separate theatres. Mr. Shumacher's remains were brought to the Habimah Theatre here for the funeral services, and were interred at the Kiryat Shaul cemetery near this city.
