BEN-GURION SALUTED IN CANADA; WELCOMED BY CANADIAN PREMIER AT AIRPORT

OTTAWA, May 24. (JTA) -- Prime Minister David Ben-Gurion of Israel arrived here today on a mission he described as strengthening the spiritual and material ties between North America and Israel. He was welcomed by Prime Minister John G. Diefenbaker as a "gallant and great leader."

"You come here as a welcome guest to a country in which the Jewish people--now 200,000 strong--have made a contribution in politics, science and the arts," the Canadian Prime Minister stressed.

Mr. Ben-Gurion was given a general salute and reviewed a 100-man Royal Canadian Air Force guard of honor. About 100 members of the Jewish community of Ottawa attended the arrival and about 50 others carrying welcome placards in support of the visit paraded outside the hangar.

Replying to Premier Diefenbaker's greeting Mr. Ben-Gurion stressed the friendly relations existing between Canada and Israel, expressed appreciation of the interest taken by Canada in Israel's development, and emphasized that he hoped that his visit would contribute "to a further strengthening of the friendly ties between our two countries."

The Israeli Prime Minister was driven with an honor escort to the Canadian National Warmorial in the heart of the Capital where he laid a wreath to commemorate the dead of both world wars. The wreath-laying was followed by a kosher lunch for the Prime Minister at the Government House with Governor Genetal and Mrs. Vanier.

A sprinkling of about 100 Arab sympathizers appeared at the airport carrying signs reading "Ben Go Home" and "Zionists Are Murderers." They then proceeded to the War Memorial and picketed the scene as the Israeli Prime Minister was engaged in wreathlaying ceremonies. There were no disturbances.

Both Premiers Discuss Present Situation in the Middle East

The two Prime Ministers met later in the afternoon and it is believed that their talks covered the situation in the Middle East. Earlier at the airport, Prime Minister Ben-Gurion in thanking Prime Minister Diefenbaker for the latter's "words of welcome" and for his "kind references" to Israel, said:

"If first visited Canada 44 years ago when I was in transit from the United States of America to the Middle East as a soldier in the British Army. Since then I have always borne with me fond memories and impressions of this land with its vast physical scope blessed with manifold resources and material capacity and in this land peoples of varying origins had united to build a new nation dedicated to freedom and democracy, inspiring it with a deep reverence for the Biblical heritage, with pioneering and dynamic progress and serving as a link between the continent of Europe and the American hemisphere. In those days, renewed nationhood and independence were only a long-cherished aspiration for my people.

"Mr. Prime Minister, in the Canadian House of Commons two weeks ago, you spoke of the close and friendly relations which have existed between Canada and Israel since the founding of Israel. Indeed, even on the long and difficult path to statehood, we always felt friendship from all segments of the Canadian people. My Government and people deeply appreciate the interest and good will manifested by the Canadian Government and her people in Israel's development.

"On our part we follow with sympathy Ganada's growing stature and activity on the world scene and the dedication to and consistent effort for world peace on the part of the Prime Minister and the people of Ganada in the spirit of Ganada's noblest traditions. On a personal note I would say that I welcome this opportunity of renewing my acquaintance with you which began with our meeting in Jerusalem some years ago.

"It is my hope that my visit may contribute to a further strengthening of the friendly ties between our two countries. I wish to convey to you, Mr. Prime Minister, and through you to the Government and people of Canada, Israel's best wishes for Canada's welfare and future, "Mr. Ben-Gurion concluded,

Tomorrow Mr. Ben-Gurion will visit the Jewish Community Center here and City Hall, and will hold a press conference. He leaves for Quebec City Friday morning.

WITNESS AT EICHMANN TRIAL TESTIFIES ON ANNIHILATION OF SLOVAKIAN JEWRY

JERUSALEM, May 24. (JTA) -- More documentary evidence and personal testimony was piled up here today by the prosecution in the Adolf Eichmann trial spelling out Eichmann's personal implication in the anti-Jewish atrocities in Hungary and Slovakia.

Among details of the European holocaust revealed today, it was shown that of Slovakia's 98,000 Jews, nearly 80 percent, or 72,000 perished. Grim records brought to the court by one of the witnesses, Dr. Bedrich Steiner, showed that, in 1942 alone, 57,837 Slovakian Jewish men, women and children were sent in 57 transports to the Auschwitz factories.

One of the documents introduced today was a telegram from Eichmann himself, referring to the fate of Gizi Fleischmann, a Hungarian Jewish woman who has been called one of the greatest heroines of the entire Nazi period. Mrs. Fleischmann had refused toleave Hungary even after her children had escaped to Palestine. She stayed on, organizing rescues for Jews and writine reports about the Nazi atrocities.

Finally captured, and tortured, she still defied her Nazi captors. At last she was taken to Auschwitz. Eichmann telegraphed: "Jewess Gizi Fleischmann captured by Slowakian police when she compiled atrocity report for dispatch to Switzerland." At Auschwitz, whence she had tried to escape but was caught again, she was finally put to death.

One document introduces today showed how Eichmann nad arranged a special "inspection" of Auschwitz for a Slovakian editor, who was shown "model conditions." The purpose of that fraud was to dupe Slovakian bishops who had complained about Nazi atrocities in their region. The editor wrote a report to "prove" to the bishops that all was well at Auschwitz. Eichmann had handled the matter thus after the Foreign Ministry in Berlin had delegated the Slovakian clergymen's complaints against treatment of Jews in Auschwitz for his handling.

Budapest Jewish Leader Testifies on Nazi Action in Hungary

Dieter Wisliceny and Hermann Krumey, Eichmann's principal assistants, were tied to Eichmann's direction of the Jewish annihilation program by Pinhas Freudinger, scion of a family that founded the Budapest Jewish community and president of the community until 1944.

Mr. Freudinger told the court how the situation in his country worsened for the Jews as soon as the Nazis took command. Hungary's community, he said, had been swelled from 500,000 to 800,000 by the immigration of Jews who fled the Nazis from neighboring courtries. The day after the Nazis took command, he said, leaders of Hungary's Jewish communities were summoned to a meeting with the new German officials empowered to deal with the Jews. Among those officials, he said, were Krumey and Wisliceny.

He told the court that 17,000 Jews of Hungarian nationality were ordered to Galicia and were never heard from again. They are presumed to have perished. He said he recognized Wisliceny as the Gestapo officer who had already conducted the deportation of the Slovakian Jews. Wisliceny was executed in Czechoslovakia in 1948 for his war crimes.

Mr. Freudinger led up in his testimony to a point where he started to tell of negotiations conducted with Wisliceny to rescue Hungarian Jews, when the court adjourned. He will take the stard again tomorrow morning.

Another of today's witnesses, Adolf Rosenberg, told more of the Nazi activities in Slovakia. He testified that at the Sered camp, one night, the guards ordered that one of the rabbis in the camp come to their quarters with a Hebrew prayer book. The youngest of the rabbis; named Ungar, volunteered. The next day, his body was turned over to the Jews for burial. The Jews learned that Rabbi Ungar had been ordered by the merry-making guards to read from his prayer book and to translate the passages he read. Then they accused him of mistranslating, tortured him, almost cut off an ear, and finally shot him.

Mr. Rosenberg brought in Gizi Fleischmann's name again. He said his parents were on the same train with this martyr when that transport arrived at Auschwitz. When the train pulled in, Mrs. Fleischmann's name was called out--showing that she was treated as a special captive.

ISRAEL COURT SENTENCES EILAT RESIDENT TO SEVEN YEARS IN JAIL FOR TREASON

JERUSALEM, May 24. (JTA) -- A 33-year-old resident of Eilat, who owns a yacht--the Calypso--was sentenced today by the Jerusalem District Court to seven years' imprisonment on charges of high treason.

The yacht-owner, Yehuda Bachar, was found guilty of transmitting information of a military rature to an embassy of one of the Arab countries in Ethiopia while on a voyage to that country with cargo from Israel. The court prohibited the publication of the name of the Arab courtry to which the information was forwarded.

DR. GOLDMANN HONORED AT NEW YORK DINNER; WARMLY LAUDED BY BEN-GURION

NEW YORK, May 24. (JTA) -- Dr. Nahum Goldmann, president of the World Zionist Organization, tonight summoned the American Ziohist movement to "become one of the decisive and determining forces in American Jewish life and play a similar role now in American Jewry after the creation of the State of Israel as it has played in the great years of the struggle for the emergence of the State."

The world Zionist leader issued this call at a dinner at the Hotel Statler-Hilton, commemorating the 13th anniversary of the State of Israel at which he was presented the first Louis D4. Brandeis Award of the American Zionist Council in recognition of his outstanding services to Israel, Zionism, and the welfare of Jewry.

The presentation of the Award was made by Rabbi Irving Miller, chairman of the Council, the coordinating body of nine Zionist organizations in this country. The Award read:
"To Nahum Goldmann, who with rare gifts and boundless energies has labored for the re-birth of Israel, for world Jewish unity, for Justice to his people, and for human freedom everywhere."

In a tape-recorded address of tribute, Israel Prime Minister David Ben-Gurion said:
"The guest of honor, Dr. Nahum Goldmann, is no stranger either to you or to me. On the
occasion of his being presented the Justice Brandeis Award, I send him my warmest greetings and congratulations. Nahum has given himself wholeheartedly to the service of his
people and we all unite in wishing him well. Nahum and I have had and may still have differences of opinion on matters of principle and this is as it should be for free and healthy
discussion is a concomitant with democracy. While these differences exist they have
never beclouded the warm personal relations between us. May you, Nahum, and all of
our friends see the realization of our ideals speedily and completely and may you carry
on in health and good fortune with your most useful labors, "

Addresses of tribute lauding Dr. Goldmann's lifelong services to the furtherance of Zioinsm, to the cause of Jewish statehood, and the welfare of the Jewish people everywhere, were delivered by Israel Ambassador to the United States, Avraham Harman, Label Katz, president of B'nai B'rith and chairman of the Conference of Presidents; Philip M. Klutz-nick, member of the United States Delegation to the United Nations; Dr. Miriam Freund, former president of Hadassah and chairman of the executive committee of the American Zionist Council; Louis Lipsky, Lady Reading and Rabbi Miller.

Close to one thousand representatives from all nine constituent organizations of the Council, together with leaders in all walks of American life attended the dinner which marked the first formal national public function of the American Zionist Council in its expanded form since it took over from the Jewish Agency an enlarged program of major activities in this country. Rabbi Miller formally announced the establishment of a National Sponsor Society under the chairmanship of Dr. David Lowenthal of Pittsburgh. This Society, Rabbi Miller said, is to consist of eminent men and women throughout the country who are prepared to give moral and material support to the expanded program of the American Zionist Council.

Answers Ben-Gurion's Attacks on American Zionists

In his address responding to the tributes, Dr. Goldmann, in acknowledging the receipt of the first Brandeis Award termed the late Justice Brandeis, "one of the greatest figures in Zionist history both intellectually and morally." Obviously alluding to the recent controversial statement by Mr. Ben-Gurion on the status of a Zionist, Dr. Goldmann emphasized: "In his (Brandeis) work and his personality he personified in a classic way the compatability of being a good Zionist and a full and loyal citizen of the country in which he lived."

"The misunderstandings which have recantly arisen because of the statements of the Prime Minister of Israel questioning such a synthesis are partly due to the use of the same term meaning different things," Dr. Goldmann said. "In Eastern Europe, to which the Prime Minister alluded in his statement in the Knesset the concept of the State was one which was the property of the majority nationality, granting the national minorities special protection through national autonomy or-specific national rights. Therefore, it was only natural for a Jew in Eastern Europe to think of himself primarily as a member of the Jewish nationality while being at the same time a citizen of his country.

"This concept," Dr. Goldmann continued, "does not exist in Western Europe and certainly not in the U.S.A. There is no concept here of a majority and a minority. This country is a melting pot of dozens of peoples of various national, racial and religious origins trying to form one state and one community. 'National' here means a citizen of the state, a member of the community, and therefore the whole parallel with Eastern European notions, the antithesis between a Jew or a Zionist, and being an American or a Canadian is misleading and without any basis."

Dr. Goldmann further clarified this point in stating that "at the same time, Jews and Jewish communities, even when fully integrated into the life and citizenship of the countries, have the full right to be linked intimately with the Jewish people in the world, with

its new Jewish center in Israel, naturally not on the basis of any political loyalty but emotionally, religiously and spiritually."

"To deny American Jews this right which the anti-Zionists do is Just as wrong as construing a conflict between being a Jew and being an American. The discussion how to define the Jewish community is unproductive and sterile. None of the usual terms: people nation, race, religion, cover the specific character of the Jewish people adequately. We Jews are a little of all of these definitions and as a whole a unique historical entity which cannot be fully defined, by any non-Hebrew terms,"

Continuing on the same subject, Dr. Goldmann further maintained that "to regard the subsish community exclusively as a religious group is just as incomplete and wrong as to define it exclusively as a nationality." He further asserted that "whoever denies the right of Jewish communities and individual Jews to regard themselves as members of the Jewish community with a sense of solidarity with all the Jews of the world and being deply attached to the Jewish center in Israel destroys the basic foundations and characteristics of our history and future."

Urges American Zionists to Penetrate Jewish Community Life

The world Zionist leader reiterated the unfulfilled tasks of the Zionist movement. He stressed that "as long as only a minority of the Jewish people is concentrated in Israel, as long as the State of Israel is not secured neither politically nor economically, and as long as Jewish life outside of Israel is not tied up with it and not secure in its future, Zionism is:still unfulfilled." Dr. Goldmann further said that "the main tasks the movement will have to face lie within the American Jewish community which, under present circumstances, is determining the direction of Jewish history."

At this point, Dr. Goldmann issued his call to the American Zionist movement to try and become one of the decisive and determining forces in American Jewishlife and to play a similar role now as it has done in the great years of the struggle for the emergence of the State.

To attain this end, Dr. Goldmann said that American Zionism "has to penetrate more and more Jewish community life, cooperate closely with other Jewish organizations not only in the field of aid to Israel, but in the spheres of Jewish education and youth work, "He added that "it must have the ambition to become the main powerhouse of American Jewish life both by organizing American Jewish life both by organizing American Jewish life both by organizing American Jewish life hoth by or

"One of the great unfulfilled tasks of the American Jewish community is to have it organized and create a representative body which can coordinate its efforts and be able to speak for this largest community in the world, "he said. He made it clear that "this does not imply the standardization of American Jewish life whose definite tendencies and nuances should be developed but it should do away with the chaotic situation as no other community would tolerate it where nobody can rightfully speak on behalf of this powerful community. Jewish unity solidarity is one of the basic conditions of Jewish survival and one of the main aims of Zionism."

SEN. CAPEHART, IN SENATE DEBATE, ATTACKS U.S. GROUPS SUPPORTING ISRAEL

WASHINGTON, May 24. (JTA) -- Senator Homer E. Capehart, Indiana Republican, today injected an attack on Israel and "pressure groups pushing U.S. foreign policies in special interest directions" into a Senate debate on foreign policy.

While the issue before the Senate was relations with Cuba and the "Tractors For Freedom Committee," Senator Capehart denounced "private individuals" who "take it upon themselves to speak for our Government, "Senator Capehart said that Chairman J.W., Fulbright of the Senate Foreign Relations Committee "aptly surmed this up last year in discussing the role of some of the Israelis in the Suez Canal dispute,"

Senator Capehart quoted from an attack by Senator Fulbright on Americans who backed Israel in the Arab boycott and blockade controversy, especially the picketting of the Egyptian ship "Cleopatra" in New York harbor. (The ship was picketed by an American seamen!s union because the Arabs discriminated against American vessels that visited Israeli ports.)

Senator Capehart quoted Senator Fulbright on application of the Logan Act to Jail or imprison Americans who carry on "any correspondence or intercourse with any foreign government" in relation to international controversies. 'He inserted into the Congressional Record, in connection with anti-Nasser activities in America, remarks by Senator Fulbright on "the questionable operation of individuals and groups in this area of foreign relations."

Referring to supporters of Israel, Senator Capehart quoted the Fulbright allegation that "despite the official actions of the United States, we find private groups proceeding by coercive devices of their own to interfere with the official activities of our Government in the field of foreign policy." Under the Logan Act cited, convicted persons may be fined "not more than \$5,000 or imprisoned not more than three years, or both."

KNESSET APPROVES LAW AIMING TO CHECK DEVELOPMENT OF SPLINTER PARTIES

JERUSALEM, May 24. (JTA) -- Israel's Parliament approved last night changes in the election law which will make it more difficult for splinter parties to develop and which bars electioneering of any kind by public servants who have administrative authority.

The law, which was adopted in clause-by-clause voting, requires a deposit of 5,000 pounds (\$2,800) for a new list of candidates in an election which will be forfeited if the new list fails to obtain one percent of the valid votes cast in that election.

Prime Minister David Ben-Gurion's Mapai party favored less stringent restrictions on new parties and the clause was approved by votes of the other parties. The new Liberal party also voted against the clause on grounds that it was undemocratic, because it allegedly favored vested interests against newcomers to the political arena. The clause provides that the amount to be forfeited will be only 1,000 of the 5,000 pound deposit in the event the list is invalidated by the Israel Central Election committee.

The measure barring electioneering by public servants, including employees of a municipality, the Jewish Agency and the Jewish National Fund, applies to any employee of a public body who has the power to make administrative decisions. Such persons will be barred from electioneering, publicly or privately, within his own work area or elsewhere.

If he proposal which was adopted again involved Mapai versus other parties, Mapai favoring an arrangement under which the ban on election activity would apply only to the individual's work area. The stronger proposal, offered by the Mizrachi, Mapam and Achdut Avodah, passed by a slim majority.

ISRAEL PLANS TO ABOLISH EXIT VISAS FOR CITIZENS TRAVELING ABROAD

JERUSALEM, May 24. (JTA) -- A bill to abolish exit visas for Israeli's traveling abroad was submitted to the Knesset today by Minister of the Interior Moshe Shapira.

Under the present law, all but Israeli diplomatic personnel and other Israelis traveling abroad in the Government service must apply for visas and wait at least two weeks, during which their records are checked in regard to payment of income taxes or possible, pending court proceedings.

KNESSET DISCUSSES ABDUCTION OF MINOR BY ULTRA-ORTHODOX GRANDFATHER

JERUSALEM, May 24. (JTA) -- The Knesset, Israel's Parliament, last night asked its Interior Committee to consider means of locating an Il-year-old boy who was abducted from his parents by his ultra-Orthodox grandfather and who has remained hidden since.

The grandfather took the boy out of fear that his parents would not give him a traditional Jewish upbringing. After the Israel Supreme Court ordered the boy's return, police Jailed the grandfather but released him on ill health pleas without the grandfather revealing where the child was staying. Officials indicated he might be abroad. The parents are still in Israel.

AMERICAN-BORN ISRAELI NAMED MILITARY COMMANDER OF JERUSALEM AREA

TEL AVIV, May 24. (JTA) -- American-born Colonel Yosef Nevo was appointed today military commander of the Jerusalem District, succeeding Colonel Yitzhak Peri who was named to another post.

Colonel Nevo, 42, who was born in Chatanooga, Tenn., came to Israel during his childhood. He was a member of the Haganah, the Jewish pre-state voluntary army and took part in the night squads which were organized by the late Colonel Orde Wingate and which fought the Arabs during the 1936 disturbances.

He Joined the British Army during World War II as an artillery man and later was one of the founders of the Israel artillery corps which fought in the War of Liberation. He was named charge d'Affaires of the Israel Legation in Canada in 1952 and rejoined the army in 1954. He is married and the father of two children.

U.S. SECRETARY OF INTERIOR CONFERS WITH ISRAEL'S MINISTER OF DEVELOPMENT

WASHINGTON, May 24. (JTA) -- Stewart Udall, United States Secretary of the Interior, today accepted an invitation from Israel Minister of Development Mordechai Bentov to go to Israel in the spring of 1962 to attend the scheduled opening of a desalination plant now being built at Eilat.

Mr. Udall told Mr. Bentov he was highly impressed with reports he had received about the new Alexander Zarchin desalination process now being-developed by the Israel Government in cooperation with an American firm, the Fairbanks-Whitney Corporation.

MUNICIPALITIES IN WEST GERMANY UNDERTAKE TO BUY ISRAEL BONDS

MUNICH, May 24. (JTA) -- Bavarian municipalities have undertaken to purchase \$255,000 worth of Israel bonds, it was announced here today. The cities, and the amounts they have pledged to buy, are: Munich, \$35,000; Augsburg, \$100,000. Nuremberg and Wurzburg, \$50,000 each; and Bayreuth, \$20,000.

ISRAELI AND ARAB DELEGATES ATTEND MEDITERRANEAN COLLOQUIUM IN ITALY

FLORENCE, Italy, May 24. (JTA) -- Abdul Aziz Zaobi, a Moslem who is deputy mayor of Nazareth, Israel, advocated here today the creation of regional organizations in Africa and the Middle East to prevent local wars and solve local problems by peaceful means. Mr. Zaobi was the principal speaker at today's session of the third Mediterranean Colloquium, which opened here yesterday, with Israelis and Arabs Joining Africans and Europeans in discussion of this year's main theme, revolving about African affairs.

Professor Jehoshua Prewar, of the Hebrew University in Jerusalem, was chairman of the meeting addressed by Mr. Zaobi. Prof. Prewar is one of the two other Israeli Jews attending the conference, the other being Prof. Pesah Shinar, also from the Hebrew University. Mr. Zaobi is one of the two Israeli Arabs here, the other being Nazareth's Mawür Malachi.

The African and Middle East regional organizations, Mr. Zaobi warned, must not be motivated by enmity among neighboring states, by any desire on the part of stronger nations to force their will on the weaker countries, and must not be based only on cultural or racial ties. "Wars never solved problems," Mr. Zaobi declared, "as demonstrated by the Palestine refugee issue which only bilateral negotiations within the framework of peace talks can solve."

Florence Mayor Girgio Lapira told the conference, which had applauded Mr. Zaobi loudly, that the speaker, "being a Moslem Arab citizen of Israel, is the symbol of peace." Yesterday, Mayor Lapira, greeting the conference, referred to Arab-Israeli disputes, asserting: "Another peace colloquium will certainly take place when time has matured, and it will have incalculably important repercussions--historical, political and religious--throughout the world."

The colloquium this year has attracted delegations from Tunisia, Algeria, Morocco, Leanon, Senegal, Mali, Kenya, the Union of South Africa, several European countries, and two delegates from the United Arab Republic. There is a general atmosphere of friendship here, and Israelis are exchanging views, on and off the floor, with many of the participants, including several from Morocco and Tunisia and others from Frenchspeaking Africa.

ROCKWELL'S 'HATE BUS' FORCED IN NEW ORLEANS TO COVER UP HATE SLOGANS

NEW ORLEANS, May 24. (JTA) -- The "hate bus" carrying about a dozen members of the American Nazi Party met with stern warnings here and in Montgomery by the local police against staging any anti-Jewish and anti-Negro demonstrations. They were also ordered here last night upon their reaching New Orleans to cover up the anti-Jewish and anti-Negro hate signs painted on their bus.

Police Captain T.H. Troxclair halted the bus at the city outskirts and told the driver "you are not to move a wheel until you cover every one of those signs." The management of a motel here turned the Rockwellites away and refused to permit them to stay overnight in his place.

Seven carloads of Federal officers nurrounded the "hate bus" when it entered Montgomery yesterday. Montgomery police commissioner L. B. Sullivan ordered a ban on plans of the troopers to stage an anti-Semitic demonstration. He also instructed Montgomery police to cooperate with Federal officers in forcing the bus to leave Montgomery. Commissioner Sullivan said the Rockwell group was handled "the same as any agitating group. They are not welcome. We don't want them."

CONNECTICUT JEWISH CENTER WINS RIGHT TO FUNCTION IN SWANK AREA

HARTFORD, Conn., May 24. (JTA) -- The Norwalk Jewish Center was sustained today the Supreme Court of Errors in its right to operate as a community center in a swank residential area. The higher court ruled unanimously in support of a decision by Superior Judge J. Howard Roberts who ruled that the use of the former Matthew Brush estate in the area was not in conflict with Norwalk zoning laws.

The ruling by Judge Roberts was appealed by Eugene L. Garbaty, whose home is on one of the borders of the ll acres of the Jewish Center. He and other residents brought the Original suit against the center, asking for an injunction to bar its activities. Judge Roberts issued a regulatory ruling specifying some of the uses of the land but he held that the use of the former estate for a community center was in conformity with the Norwalk zoning law. Mr. Garbaty appealed this phase of the ruling.

Rabbi Feinberg, who will remain with the congregation as Rabbi Emeritus, will devote most of his time to writing.
