STATE DEPT. SEES 'MUTUAL ADVANTAGE' IN MEETING BETWEEN KENNEDY, NASSER

WASHINGTON, June 26. (JTA) -- A spokesman for the State Department said today the United States Government recognized the "mutual advantages" that might be gained by a visit of President Nasser of the United Arab Republic to Washington, but added that "a visit by President Nasser is not at present under active consideration." The statement was made in response to reports that plans were under way for a meeting here between President Nasser and President Kennedy.

Pierre Salinger, news secretary for President Kennedy, said he knew of no present plans to invite President Nasser to the United States for a formal State visit, At the same time, Mr. Salinger today comfirmed that President Kennedy wrote Arab leaders on Arab-American relations, but pointed out that the text of the letter as published was incomplete. He termed it was not quite complete.

Mr. Salinger said that President Kennedy sent different letters to five Arab Heads of State, and that the White House is now deciding whether to make their contents public.

While a published text to King Hussein of Jordan was termed "generally accurate," perhaps with some omission, Mr. Salinger said he wanted to correct the impression that President Kennedy had sent identical letters to President Nasser of the United Arab Republic, President Chehab of Lebanon, King Saud of Saudi Arabia and Premier Kassem of Iraq.

The letters to each of the Arab rulers differed, Mr. Salinger said, and it was up to each recipient to decide whether to publish his letter. However, the White House is now discussing with the State Department the publication of all the letters.

The Kennedy letter to King Hussein seemed to f. /or repatriation and compensation for Arab refugees. It was understood that all the letters expressed concern over the plight of the Arab refugees, and favored repatriation and compensation by Israel.

Meanwhile, State Department sources stressed today that American relations with the UAR were constantly improving, since the Cairo-Môscow rift. They said that the UAR, though neutralist, was a friendly nation, and that the possibility of an invitation to Nasser at some future date could not be entirely ruled out. They indicated that, if Nasser attends the session of the UN General Assembly next September, it was virtually certain that arrangements would be made for a meeting with President Kennedy.

IRAQI RULER ADAMANT ON KENNEDY LETTER; ANTI-ISRAEL BOYCOTT TIGHTENED

LONDON, June 26. (JTA) -- Premier Kassem of Iraq today told a press conference at Baghdad he would not answer President Kennedy's message on the Palestine problem. He made clear that Iraq does not endorse the idea of a collective answer by all Arab leaders who received the message.

Premier Kassem said Iraq refused to negotiate about Palestine because it was up to the Arab states to solve the Palestine issue without permitting any foreign country to interfere. He said Iraq would support the Palestinian Arab refugees "with money, men and arms, and political efforts."

At the same time, in Damascus, Syria, the Arab League announced sweeping new plans to tighten and intensify the Arab blockade, boycott, and embargo against Israel. An announcement by the central boycott office said the tightening resulted from recent developments, including a boycott conference in the Arab sector of Jerusalem.

The new tactics will be aimed at severing Israeli commercial ties in Africa through a JointArab program. It will feature economic aid to emergent African countries, if such countries reject Israeli help.

HAMMARSKJOLD TO VISIT CAIRO; CORDIER, MIDDLE EAST EXPERT, TO QUIT

UNITED NATIONS, N.Y., June 26, (JTA) -- Secretary General Dag Hammarskjold announced here today that he will visit Cairo, capital of the United Arab Republic, "for a couple of days" next month. He volunteered the announcement at the opening of a news conference this morning when he also revealed that Andrew W. Cordier, who as executive assistant to the Secretary General holds the highest post next to Mr. Hammarskjold himself, is quitting that post.

 $\dot{I}_{\rm h}$ his nearly 16 years in that post, and especially under Mr. Hammarskjold's tenure since April 1953, Mr. Cordier has frequently visited the Heads of State and of Governments

in the Middle East, and has carried out many missions in that area on behalf of the United Nations. He has met frequently with both Prime Minister David Ben-Gurion of Israel and President Gamal Abdel Nasser of the United Arab Rpublic.

In announcing his forthcoming trip to Cairo, Mr. Hammarskfold said "we have so many in the fire in that part of the world that it is rather exceptional that I have not been in touch with that area in some time." Asked whether he plans on going to Israel, he replied: "I have no plan to visit any wher country in the area. The UAR, as you know, has a special position. We have many operations there."

His trip to Cairo, he said, will take place during the period he will spend in Europe next month. He is scheduled to attend a meeting of the United Nations Economic and Social Council at Geneva on July 10.

In announcing the resignation of Mr. Cordier as executive assistant, Mr. Hammarsk-Jold said that Mr. Cordier decided to quit that post "because of geographic reasons." He was sluding to the fact that many member states, led chiefly by the Soviet Union, have been insisting of late that high UN posts be given to more representatives from new or uncommitted nations.

- Mr. Hammarskjold said, however, he has persuaded Mr. Cordier to stay on in the organization, for the time being, declaring Mr. Cordier will become an Undersecretary in charge of General Assembly affairs, beginning August 1.
- Mr. Hammarskjold also said, in answer to a question, that the Palestine Conciliation Commission is "considering the present situation now" but will have to make its own announcements regarding anything it may be doing. The question, asked by an Arab correspondent, referred to the letters recently written to heads of Arab states by President Kennedy, touching upon the PCC's functions in regard to repatriation and compensation of Arab refugees by Israel. Mr. Hammarskjold, in his reply, carefully avoided mentioning Mr. Kennedy's letter or the specific functions of the PCC.

SYRIAN GUNFIRE CONTINUED DURING NIGHT, ISRAEL REPORTS NO CASUALTIES

TEL AVIV, June 26. (JTA) -- Syrian gunfire continued sporadically last night, until later midnight, the fire being directed at Israeli settlements in the area of Northern Israel adjacent to the Syrian border. No Israeli casualties, however, were reported.

Israelis went back to work in that area this morning. The project upon which they are working is connected with the development of a large area for cultivation in the northern Huleh region. As a first step in that development, Israelis are now paving a road as an approach to the drained areas.

(Dispatches received in London today from Damascus claimed that Israeli border patrols had fired at the Syrians in the area of conflict, saying there were no Syrian casualties.);

EICHMANN ON STAND FOR SECOND WEEK; DECLARES SELF FREE OF ALL GUILT

JERUSALEM, June 26. (JTA) -- Adolf Eichmann today went into his second week of direct testimony at his trial here, continuing along the same lines he had apparently worked out with the chief of his defense, Dr. Robert Servatius of Cologne. As he has done until now, he spent the entire day telling the three-judge tribunal he had only acted as a subordinate carrying out orders from superiors. He insisted several times today that his conscience is clear in regard to the charges that he had directed the annihilation of 6,000,000 European Jews during the Nazi regime.

Dr. Servatius notified the court today that direct examination of the prisoner will last at least through the end of this week, possibly until the middle of next week. It was believed that Eichmann's testimony on his own behalf may last a full three weeks. After the direct testimony, Attorney General Gideon Hausner, as chief of the prosecution, is expected to take at least three, possibly four days, for cross-examination. Three or four days will then be spent in summation by both the defense and the prosecution. Thus, it is expected, it will be at least the middle of July before the case goes to the three Judges for consideration of a verdict.

All day today, Eichmann continued his posture as the careful, thorough efficient bureaucrat, who expedited orders and took pride in their swift accomplishment. When he was asked about an order given by one of his assistants for the murder of 100 children captured by the Nazis in the Czechoslovakian village of Lidice, he pointed out to the court that it had taken 24 days to carry out the order. That fact proved, he said, that the order was carried out by a zealous subordinate. "If I had handled the matter, he said, "it would not have taken 24 days."

Landau Asks if He was 'More Efficient,' Warns Against Ironic Laughter

Previously, he had been questioned by Dr. Servatius about a document showing that a Nazi officer had contacted him about supplying skelêtons of dead Jews for "anthropological examinations" at the Nazi Institute for Research in Ancestry. He replied that, if he had been contacted by the officer given the assignment of getting the skeletons, "I must have referred him to my chief, Gen. Heinrich Mueller." And he added: "If I had handled this matter, certainly it would not have taken six months."

When he brought up the time-lag a second time, to prove that he did not do the deeds contained, Presiding Justice Moshe Landau asked him: "You mean to indicate you were more efficient?"

Several times today, spectators burst out in loud, ironic laughter while Eichmann was testifying. At one time, such laughter greeted Eichmann's explanation when he was asked why he had assigned 1,000 Jews to trains earmarked for a capacity of only 700 persons. He said that the 700-capacity referred to military personnel, whereas the Jews placed on those trains had no need for luggage space. Justice Landau rapped sternly for order and warned the spectators he would have "to take steps" against them if they continued showing such reactions.

Today, as all of last week, Eichmann's testimony was related to documents previously introduced by the prosecution. In each instance, he had his own explanations.

Cites Heydrich, Gen. Mueller as Culprits; He Was 'Only A Postman'

He was asked about the Wannsee conference held at a Bérlin suburb in January 1942, for firming up the Nazi line on "the final solution" of the Jewish question. That was Reinhard Heydrich's fault, he answered, and Eichmann said he knew after that parley he had to carry out orders, since Heydrich was chief of the SS.

On the Nazi decision to requisition gas and other paraphernalia for the annihilation of Jews, Eichmann said that was the decision of General Mueller.

Sterilization of Jews, said Eichmann, was not his Job, since he was responsible only for "technical functions."

Deportation of elderly Jews--that was done by "local officials" who did not want elderly people on their hands, while younger Jews were being deported.

His signature on orders for the hanging of Jews was appended on orders of superiors, he said. In these cases, claimed Eichmann, he was "only a postman" relaying superior orders.

Court Hears Prisoner's Credo -- 'The Feeling of Pontius Pilate'

All in all, he testified, everything that was done in regard to the Jews, coming after the Wannsee conference which had arrived at "unexpected unanimity with boundless enthusiasm," was the work of others. As for him, Eichmann gave the court his credo, admitted that, in dictating his memoirs to a Dutch Nazi Journalist in Argentina, he had expressed "Joy" in the happenings. But, he said:

"My Joy is to be traced to an entirely different source. While Heydrich's satisfaction was in regard to the factual results, my Joy was quite different. I examined and weighed my character and my personality in the light of the Wannsee Conference as background.

"As far as my own ego is concerned, I summed up the meaning of my satisfaction. I felt solace and comfort in the fact that I had done my best, my utmost, despite my low rank of lieutenant colonel, in seeking a final solution which was not repellent nor hideous, but was at the same time both feasible and possible.

"I had to draft certain proposals, and the truth of this statement can be verified. I did my level best to bring order and organization into all the havoc and turmoil. I left no stone unturned. What was done, was not my doing. That guilt did not rest with me. I felt I was not to blame because what was decided at Wamnsee was decided by the Elite. I have the feeling of Pontius Pilate. The popes of the regime decided. I had to toe the line."

GLOBKE EXPLAINS ROLE IN NAZI RACIST LAWS; SAYS HE 'FOUGHT' SUPERIORS

LONDON, June 26. (JTA) -- Dr. Hans Globke, West German State Secretary and principal aide to Chancellor Konrad Adenauer, today gave his version of the part he played in writing the commentary on the Nuremberg Race Laws. Dr. Globke ascribed the "initiative" for the Nuremberg Laws to Rudolf Hess, former Deputy Fuehrer under Adolf Hitler, who is now serving a life sentence for war crimes at Spandau Prison in West Berlin.

In an interview with the Daily Mirror columnist "Cassandra," Dr. Globke said that Hess "wanted to go much further in legislation against the Jews" but asserted that he and other civil servants fought against incorporation of the worst Hess proposals into law.

"We were successful at least in this, but some of the objectionable material remained," he declared. Asserting that he was not "all powerful," Dr. Globke told the British correspondent that "perhaps I made a mistake but at the time and under those circumstames, I thought it would be better to persevere in my work rather than hand it over to some-body else."

Referring to his part in the decision that German Jews should carry specially marked passports, Dr. Globke said that he was involved in the matter "by some sort of procedural mistake." He explained that the initiative came from the Swiss authorities, who were embarrassed by the number of Jews fleeing to Switzerland. He stated:

Consulted Rabbi on Names for Jews; Saw Eichmann Obeying Superiors

"I realized the danger behind the Swiss proposals and suggested unofficially that it might be possible to mark the passports of all Germans in some special way. This might prevent

Jewish citizens from going to Switzerland but would not hinder them from going to other countries as Germans," He added that his proposal was never accepted.

A suggestion of his that was adopted, the State Secretary said, was the substitution for the letter "J" in the passports of the name "Israel" for all Jewish males and the name "Sarah" for Jewish females. Dr. Globke said the "spoke to a rabbi to find out which Jewish names could be used in:a decent way without giving offense" and declared "I can tell you in all honesty that I had a hard fight with my superiors to limit the matter to the first names 'Sarah' and 'Israel, ' "

Referring to Adolf Eichmann's testimony at the trial in Jerusalem, in which he menof Dr. Globke's efforts "toward the withdrawal of citizenship and the confiscation of Jewish property," the State Secretary said that Eichmann had "a strong interest in shifting and reducing responsibility he exercised and intransferring the onus of responsibility to other people."

Dr. Globke said that he first met Eichmann one morning in a hallway in the Berlin Interior Ministry. "Eichmann wasc certainly in charge of a Reich department of the Security Office," Dr. Globke declared, adding: "He had a certain reputation-certainly not a savory one. I thought he was a person who carried cut his duties after instructions had been passed to him by his superiors."

The State Secretary told the Mirror correspondent that "I never had any doubt that the anti-Semitic evils of Hitler should be rejected" and added: "Right up to the end of the war, I did not know there was an order for the extermination of all Jews."

ISRAEL OFFICIALS 'SHOCKED BY BONN'S SELECTION OF FORMER NAZI AIDE AS ENVOY

JERUSALEM, June 26. (JTA) -- Israeli officials today said they were shocked to learn of the appointment by the Bonn Government as West German ambassador to Sweden, of Karl Werkmeister, former Nazi di plomat in Budapest during the period of Adolf Eichmann's activities in connection with the annihilation of hundreds of thousands of Hungarian Iews.

The Israeli officials, who earlier believed that the new envoy was not the same former Nazi diplomat, said today that they were now convinced that Karl Werkmeister was the wartime aide to Vessenmayer, the Nazi representative in Budapest at the time Eichmann served there.

15 LISTS OF CANDIDATES FILED FOR ISRAEL'S ELECTIONS DUE IN AUGUST

TEL AVIV, June 26. (JTA) -- Fifteen lists of candidates were presented to the Central Elections Committee by the deadline this evening for the Knesset elections, August 15.

The parties are: Mapai, Andut Ha'Avoda, the Liberal Party, Herut, the Communists, the National Religious Party, Agodat Israel, Poalei Agodat Israel, two Mapai-sponsored Arab parties, a Druse faction and a Yemenite party. There is also an independent Arab list from Nazareth, and an independent religious list headed by Moshe Islan, formerly of the National Religious Party who was not given a high enough position on that party's list to assure him of election. All parties posted with the Elections Committee the required depost of 5, 000 Israel pounds (82, 800).

The Mapai list contained 10 new names, including four to replace four previous candidates who died, four who were sent to diplomatic posts outside Israel since the last election, and two replacing former candidates who were dropped. The latter are Pinhas Lavon, who was forced off the list by Premier David Ben-Gurion; and Professor A. Rotenstreich.

The Sephardi groups decided not to present a separate list this time as they did in the last election. It was agreed, however, to form a separate Sephardi party after the elections.

ISRAELI SOCCER TEAM TIES DUBLIN SHAMROCK ROVERS, 2-2, AT POLO GROUNDS

NEW YORK, June 26. (JTA) -- The Petah Tikva soccer team of Israel yesterday played to a 2-2 tie with the Dublin Shamrock Rovers, in the opening match of the second half schedule of the International Soccer League.

In a vigorous game in which both sides fought hard, the Irish team maintained its lead until 14 minutes of the second half, when Nahum Stelmach of Israel, scored the tying goal for the Israelis.

EZRA ICHILOV, MEMBER OF KNESSET, CANDIDATE, DIES AT AGE OF 54

TEL AVIV, June 26. (JTA) -- Ezra Ichilov, member of the Knesset, Israel's Parliament, representing what was formerly the General Zionist Party, and a candidate for the next Knesset elections on behalf of the Liberal Party, died here today of a heart attack. He was 54.

Born in Petah Tikva, Mr. Ichilov was elected a member of that town's Municipal Council in 1931. He was elected to the Knesset in 1951, and served as a member of the House Committee, and the Law Committee.

ISRAELI SHIP BEACHED IN WALES AS FIRE DAMAGES VESSEL EN ROUTE TO LIVER PCOL

CARDIFF, Wales, June 26. (ITA) -- An Israeli cargo vessel, the S.S. Etrog, this morning was beached near Milford Haven, about 100 miles west of here, after a 17-hour fire was extinguished in the ship's hold. No casualties were reported among the 46 crewmen and passengers, but the Zim-Israel Navigation Company, owners of the vessel, confirmed today that the ship was extensively damaged. Efforts are now in progress to refloat the vessel.

The ship was beached at Dale, a holiday resort near Milford Haven, after the women and children and 28 crew members were landed at the latter town. Plans to beach the ship at Milford Haven had to be abandoned when it was learned that an Egyptian vessel was loading explosives at the Royal Navy depot in the harbor. Ten crew members and the ship's master, Capt. Rafael Spirath, stayed aboard the Etrog to fight the blaze. The crew's quarters were completely destroyed in the fire.

The 1,845-ton vessel, which was carrying cotton and plywood, was en route from Haifa to Liverpool, when the fire broke out.

42 PERCENT OF ISRAEL'S SLUM DWELLERS ARE EUROPEAN, 16 PERCENT NATIVE-BORN

JERUSALEM, June 26. (JTA) -- The Ministry of Labor published a study today demonstrating that a widespread belief that most of ixrael's slum dwellers are immigrants from Oriental countries was inaccurate.

The study showed that 42 percent of slum dwellers had emigrated from Europe, and a similar percentage from Asia and Africa. The remainder were Israeli-born. The survey also showed that more than half of the slum dwellers seemed resigned to their conditions and many were satisfied with those conditions.

The survey did not give data on the number of Israelis living in substandard housing. But a Government study, made more than a year ago, listed about 25,000 Jewish families living in insanitary and overcrowded housing.

RESTRICTIVE QUOTAS AGAINST JEWS, 'SUBTLE' BIAS PROTESTED IN BRITAIN

LONDON, June 26. (JTA) -- The practice by many independent London day schools of maintaining restrictive quotas against Jewish pupils was attacked here today by Mrs. Joseph Grimond, wife of the leader of the Liberal Party. Referring to a Liberal Party Council resolution against such quotas, Mrs. Grimond criticized press charges that the Council was "more Jewish than the Jews."

Deploring the fact that Jewish attendance at such schools was generally limited to 10 percent, Mrs. Grimond said the practice caused "considerable hardship and distress to their parents, and must inevitably lead to educational segregation for an important and talented minority of our population."

The Daily Herald today editorially deplored a subtle form of anti-Semitism existing in British golf clubs. Discussing discrimination in Britiain, the newspaper cited religious bias in golf clubs, declaring: "Here again there is no open bar. People would not tolerate that. But somehow, Jews Just don't get admitted as members."

BRITISH BANKING FIRMS UNDERWRITES SHARES FOR DEAD SEA WORKS

LONDON, June 26. (JTA) -- The British banking firms M. N. Rothschild and Sons and S.G. Warburg and Company have agreed to underwrite a block of ordinary shares of the Israel Dead Sea Works for distribution in Britain and other European countries, it was reported here today in the Financial Times.

The shares are part of a new issue by the company of 27,000,000 ordinary shares, conditional on the granting of long-term credits to the firm totaling \$35,000,000 by the World Bank and a private American banking institution.

ISRAEL'S SABRA CAR PLACED ON CANADIAN MARKET, 30 AUTOS UNLOADED

MONTREAL, June 26. (JTA) -- Israeli Sabra automobiles are now being sold in Canada. Thirty of the cars were unloaded here today. Mr. Y. Narkiss, Israel's counsel for Commercial Affairs in Canada, said that the cars represented "further evidence of the growing sophistication and diversification of Israel's economy." Cummings Continental Car Corporation will handle the distribution and sale of the Sabra in Quebec Province.

MEXICO'S FIRST CONSERVATIVE TEMPLE DEDICATED AT SPECIAL SERVICE

MEXICO CITY, June 26. (JTA) -- Mexico's first Conservative house of worship, Temple Beth El, was dedicated with special ceremony here this weekend. The first Sabbath Eve service was conducted by Rabbi Carol Klein, who came here especially from the United States for this purpose.

Participating in the dedicatory services were Mordechai Schneersohn, Israel Ambassador to Mexico and naron Assa, a member of the Israeli mission here. Luis Schidlow, of this city, is president of the new temple.

NEW YORK, June 26. (JTA) -- The Zionist Organization of America today embarked on an intensive campaign to raise funds for increasing the organization's educational activities, as well as those projects aimed at promoting immigration to Israel from the United States.

At the closing session of the ZOA's national executive council meeting, the organization also adopted a resolution urging the United States Government to ratify the United Nations Genocide Convention "at the earliest moment," The group decided to proclaim September 1961 as "Genocide Convention Month."

The ZOA delegation to the Isræl Bond Conference next month in Jerusalem will announce 1,000 purchases of Israel bonds by Bar Mitzvah Guardians totaling \$1,300,000, the Council was bild.

Max Bressler, president of the ZOA, announced that the 64th annual convention of the organization will be held in New York from August 30 through September 2. Some 1,000 delegates from all parts of the country are expected to attend the four-day sessions.

The Council also considered plans to counteract what was termed "the growing anti-Zionist propaganda campaign" which, it said, was being "spearheaded by He American Council for Judaism," Dr. Max Nussbaum, chairman of the Council, urged a dynamic, positive approach to the problem through "a revitalization and strengthening of the Zionist novement on the home front, and the intensification of Jewish education to assure the survival not only of Jews in America but of American Judaism."

BILLS OFFERING AID TO PRIVATE SCHOOLS OPPOSED BY PHILA, JEWISH COUNCIL

PHILADELPHIA, June 26. (JTA) -- The Jewish Community Relations Council of Greater Philadelphia today expressed "vigorous objections" to two legislative measures passed by the Pennsylvania State Legislature, and now awaiting signature of Governor David L. Lawrence. One of the measures criticized by the Council would permit educational institutions to accept and administer any grants or gifts "upon such terms and conditions as may be prescribed by the donor." The other bill would provide transportation, paid for out of public funds, for students of non-profit private schools, including religious-controlled educational institutions.

Murray Shusterman, president of the Philadelphia JCRC, pointed out that the measure permitting grants under any conditions prescribed by the donor would enable schools and colleges to accept and administer gifts and grants for scholarships that could exclude any individual because of race, religion or national origin.

In letters to Governor Lawrence, Sydney C. Orlofsky chairman of the JCRC Religious Freedom Committee, and Jules Cohen, JCRC executive director, declared that "free transportation to schools under the supervision or control of any religious denomination or sect, whether Jewish, Catholic or Protestant, constitutes governmental aid to religion in violation of the freedom of religion clause of the First Amendment to the Federal Constitution."

GOLDSTEIN SEES ISRAEL ABSORBING MORE NEWCOMERS IN PRESENT BOUNDARIES

NEW YORK, June 26. (JTA) -- Dr. Israel Goldstein, former American Jewish leader who settled in Israel, declared here that "absorptive capacity is man-made and the people of Israel are resolved to make room within the present boundaries for all who need and want to come."

Addressing 500 members of New York Jewish organizations at the 22nd annual Freedom Luncheon of the United Jewish Appeal's Council of Organizations here, Dr. Goldstein saidthat one of the most dramatic events in Israel now "is the planning of new towns and settlements in different parts of the country." Dr. Goldstein is on a visit here as world chairman of Keren Hayesod, the financial arm of the Jewish Agency.

LABOR ZIONISTS FETE SEVEN ISRAELI MAYORS, ALL MEMBERS OF HISTADRUT

NEW YORK, June 26. (JTA) -- Mayors of seven Israeli cities were guests at a public reception here tonight tendered by the National Committee for Labor Israel. The group of municipal leaders attended the international conference of mayors in Washington last week, and will return to Israel in a few days. Joseph Schlossberg, president of the National Committee for Labor Israel, presided.
