KEATING ASKS ADMINISTRATION TO DENY AID TO STATES PRACTICING BLOCKADE

WASHINGTON, June 27. (JTA) -- Citing the barring by Saudi Arabia of Rep. Seymour Halpern, New York Republican, as "the most flagrant recent instance of discrimination against an American citizen by a country which is the recipient of American aid," Senator Kenneth Keating, of New York, questioned today whether the Executive Department was doing enough to protect the rights of American Jews abroad. Senator Keating made his views known in a statement to the Senate Foreign Relations Committee.

Commenting on the Administration's new request for foreign aid funds, he called on the Executive Department to implement the previously expressed sense of Congress asking severance of aid to nations that discriminate through boycotts and blockades.

Senator Keating said the Administration's new bill contained in its preamble "a watereddown, weakened version of the Douglas-Keating Amendment," He raised a question of why the Executive Department did not use existing authority to sever Arab aid and whether the new provision would be enforced.

Referring to Rep. Halpern, Senator Keating said "a Congressman who the Administration is asking to provide money for foreign aid and other assistance projects in Saudi Arabia, is being barred from that country. Before additional aid is granted to the Arabs," he said, "guarantees should be received that American citizens will be permitted to use the ir terminals and other facilities built with American funds. That is the very least which the United States can do in its role as the defender of individual liberties and human dignity throughout the world."

Arab Boycott is 'Clear Effort to Blackmail'

Senator Keating said "the State Department seems more concerned to ewade responsibility for supporting Americans and American concerns...than it is to exercise it...the Arab boycott is a clear effort to blackmail all nations of the world...the next step, if Nasser wants to follow the example of his counterpart, Castro, is to demand a tractor for every shipload of goods for Israel that is allowed through the Suez Canal or for every refugee that is settled on Arab soil."

Senator Keating charged that "American aid is being wasted and the motives behind it thoroughly perverted when it is offered to nations such as the Arab ones which pursue a policy of economic warfare against other nations which we are also aiding." He said "It is self-defeating, wasteful of the taxpayers' money, and in the long run derogatory to our own interests in the Middle East."

The New York Senator said also that "there is continuous, documented proof" that American ships are being affected by the Arab boycott although the State Department shirks this problem. He cited the case of the U.S. freighter "Valiant Faith." He said "the Egyptians held up this freighter in Port Said...denied its crew shore leave, leaving them, in effect, imprisoned on the ship for 28 days."

He urged Congress to take a "firm and unwavering" stand against Arab discrimination affecting Americans and also against Arab boycott and blockade tactics.

MINISTER'S FORTHCOMING TRIP TO SPAIN AROUSES ISRAELI CRITICISM

JERUSALEM, June 27. (ITA) -- Minister of Social Welfare Yosef Burg is leaving soon for Spain, to represent Israel at an international welfare conference to be held in that country, it was revealed here today. The Cabinet approved the trip, reportedly without debate.

There was severe criticism among various Israeli parties today against Dr. Burg's trip, which will mark the first time a member of the Cabinet will visit Franco Spain. Representatives of the Mapam and Ahdut Avodah parties were unhappy because the Government would thus permit one of its ministers to visit a country run by a fascist dictator who backed Hitler during World War II. Since Dr. Burg is a member of the National Religious Party, religious elements are unhappy about his trip, pointing out that Orthdox Jews have avoided visiting Spain since the mass expulsion of Jews from that country in 1492.

RISE IN INDUSTRIAL OUTPUT OPENS JOBS FOR IMMIGRANTS, SAPIR REPORTS

JERUSALEM, June 27. (JTA) -- Israel's industrial production rose, during the first quarter of 1961, by 13 percent over last year, while the country's employment in industry went up by eight percent, Pinhas Sapir, Minister of Commerce and Industry, announced here today.

Because of this higher industrial productivity, Mr. Sapir said, there will be no difficulty in finding employment for the increasing number of immigrants now arriving in Israel. According to the plans, he stated, 15,000 to 20,000 more workers can be absorbed in Israeli industry alone by the end of next year.

19 MILLION SHARES IN DEAD SEA WORKS SOLD BEFORE PUBLIC ISSUE IS MADE

TEL AVIV, June 27. (JTA) -- The Dead Sea Works, Ltd., announced last night the flotation of an issue of 27,000,000 ordinary shares as part of a massive financing of a major expansion of production of minerals from the Dead Sea.

Most of the new issue has already been underwritten by Israeli banks, special funds of the medical functions such as the Hebrew University, the Israel Institute of Technology and the Weizmann Institute, some industrial and economic agencies, the Palestine Economic Corporation and AMPAL. Four million of the shares have been underwritten by two British banking firms, N.M. Rothschild and S.G. Warburg and Company.

Only 7,500,000 shares will be offered to the Israel public, with priority for purchase to workers and members of the Dead Sea Works staff. The shares have a par value of one pound and are being sold at seven percent above par.

The overall expansion planned will require an investment of 128,000,000 Israeli pounds (\$61,000,000). This will come from various sources: the stock flotation, loans from the World Bank and American banks, from capital funds of the company and other sources.

The expansion plans envisage an increase in the production of potash from 135, 000 tons in 1960 to around 200, 000 tons by 1963 and to 400, 000 tons by 1966 when additional dams are completed.

Output of bromine and bromides, now approaching 3,000 tons a year, would be increased to 10,000 tons a year by January 1962. A new plant in Beersheba will produce 2,000 tons of various bromide by-products at that time. By 1963, it is expected to reach 75,000 tons of magnesite a year and a new table salt plant will produce 20,000 tons of such salt each year.

Mordecai Makleff, general director of the Dead Sea Works, said that there were no problems in marketing the products. He reported that potash output for 1961 and 1962 had already been sold. He added that the company also had standing contracts for almost half of its potash output until 1969. He said this was also true for output of magnesite and bromine and bromine by-products. After deductions for income taxes, the company hopes to reach a net return of from 13 to 15 percent of the total value of the capital of the share issue, He predicted this percentage would rise from 22 to 33 percent during 1968 and 1969.

YEMENITES, SEPHARDIM, ARABS ENTER NEW LISTS IN KNESSET ELECTIONS

TEL AVIV, June 27. (JTA) -- Four new lists have been presented for elections to the fifth Knesset Israel's Parliament, the Central Elections committee reported today.

They are a Yemenite list, a Sephardi list and two Arab lists. One Arab list is headed by Sheikh Hnifas, who was a member of the third Knesset. The other Arab list has only one near-Daoud Khuri of Nazareth, who declared he was unemployed. His list is named "Seekers of Democracy."

Khiri brought the required 5,000 Israel pound deposit all in small bills, giving election committee officials a headache before they finished counting the currency. The candidate declined to disclose the source of the 5,000 pounds.

The Sephardic list is headed by Moshe Ishai, a former member of the National Religious Party.

The Mapam Party list submitted previously to the Central Elections Committee is headed by Meir Yaari and Yaacov Chazan, Knesset deputies, and includes the two Mapam cabinet ministers, Mordechai Bentov, Minister of Development; and Israeli Barzilai, Minister of Health. The list also includes two Arabs, Yousouf Hamis, a member of the Knesset and Abdul Azziz Zobbi, deputy mayor of Nazareth.

EXPERTS STUDY EDUCATIONAL TELEVISION POSSIBILITIES IN ISRAEL

TEL AVIV, June 23. (JTA) -- Television experts from the United Nations and Australia agreed today that Israel has the necessary cultural and artistic resources to produce interesting and significant television programs.

That view was expressed by Dr. Henry Cassirer, chief of the UNESCO television department, and Albert Duckmanton, assistant general manager of the Australian Broadcasting Commission. They came to Israel at the invitation of Alba Eban, Minister of Education, to study the possibilities of irtroducing educational television in Israel.

EICHMANN, ON STAND, CONTINUES EFFORTS TO PROVE HE LACKED REAL AUTHORITY

JERUSALEM, June 27. (ITA) -- Adolf Eichmann went into a marathon description of the Nazi genocide organization chart today in an effort to prove that he was consistently by-passed in the chain of command ending in the mass murders of European Jews.

Five charts were submitted by Eichmann's attorney, Dr. Robert Servatius, at the String in Servatius of the trial. These depicted those departments concerned with killing Jews, with legislative activities against Jews and with deportation matters. Dr. Servatius contended that despite Eichmann's post as chief of Jewish affairs in Bureau IV of the Gestapo, he never operated in any field except transportation.

Haggling over documentary evidence also marked Eichmann's sixth day of testimony in his own defense. As on each previous day, his statements were keyed to the twin themes of his inability to do anything but follow the orders of his superiors in his anti-Jewish activities and his alleged isolicitude for the deportees in general and the Jewish expellees in particular.

The haggling today was about an affidavit purporting to prove that 30 Czech children believed to have been murdered by the Nazis were alive near the end of World War II. The prosecution contends that Eichmann was responsible for the murder of some 80 children left orphans when the Nazis razed the village of Lidice in retaliation for the Czech assassination of Reinhardt Heydrich, the SS chief who had been made boss of Czechoslovakia.

Polish Poet Committed Suicide After Eichmann Refused Aid

Eichmann was questioned about a meeting with a Polish poet, Jochem Klepper, who can to him to appeal against a forced divorce from his Jewish wife, which was to be followed by his wife's deportation. Eichmann testified he did not remember exactly what he told the poet but that he must have told him that he was simply following orders in such situations. The poet committed suicide immediately after the meeting with Eichmann,

In an effort to demonstrate that he was not the typically fanatical anti-Semite of the Nazi regime, Eichmann said he did not remember reading a particular book on Jewish ritual murders but he had read other books on the subject. He added that "Jewish functionaries with whom I had contact knew I considered stories of ritual murder as belonging to the class of fair vales."

Judge Tells Eichmann Not to Deliver Lectures

The defendant was again admonished today by Judge Landau to stop giving lectures and to answer specifically the questions put to him. The justice said sternly, "we do not want general explanations for each document--there could be endless explaining. The aim is to get replies to questions which you are asked and as far as I recall you have not been asked to give a lecture on this document. Please bear this in mind in all your future replies." The defendant bowed and assented with a muttered "Jawohl."

Dr. Servatius questioned Eichmann about documents on the correspondence between the ex-Mufti of Jerusalem and Nazi Foreign Minister Joachim von Ribbentrop. Eichmann insisted that he met the ex-Mufti, who repeatedly praised the Nazi persecution of Jews, only once. He said that oncasion was an introduction at a Nazi reception for the Arab leader. He said that other than acknowledging the introduction, he never spoke to the ex-Mufti. He did disclose that, after an agreement was made between the ex-Mufti and von Ribbentrop, three Iraqi majors came to the Reich Security office on a study mission and that they spent three days in his department in Gestapo Bureau IV.

Asked whether he had been offered a post as advisor on Jewish affairs to the ex-Mufti, he said there had not been any contacts between him and the Arab except at the introductory meeting.

GREAT MAJORITY OF AMERICANS BELIEVE EICHMANN IS RECEIVING FAIR TRIAL

WASHINGTON, June 27. (JTA) -- The Eichmann case has served mainly to confirm the impression most Americans received I5 years ago after the Nuremberg trials rather than to shock them into a new awareness of the horrors of the Nazi regime, according to a survey of American public opinion on the Eichmann case made by the American Institute of Public Opinion-the Gallup Poll.

John Fenton, managing editor of the institute, reported to the National Community Relations Advisory Council that the major effect of the trial on American opinion was a reminder of the evidence it heard 15 years ago. He-disclosed that awareness of the trial among the American public had been exceptionally high--87 percent--and noted that 71 percent of those polled thought that the holding of the trial had served a useful purpose.

The poll showed marked differences of opinion as to whether Israel was Justified in putting Eichmann to trial for the murder of six million Jews before an Israeli court. Thirtyfive percent said that trial by an international tribunal, was preferable. An overwhelming majority--72 percent expressed the belief that Eichmann was receiving a fair trial.

Mr. Fenton said that on balance, if the Eichmann trial had had any reaction in American public opinion, the positive aspects would outweigh negative effects.

MAJORITY OF JEWISH MARRIAGES IN WEST GERMANY ARE 'MIXED MARRIAGES'

MAINZ, Germany, June 27. (JTA) -- A demographic study dealing with West German Juney, issued here today at Mainz University, showed that 59.1 percent of all Jewish marriages in this country since 1945 have been 'mixed marriages.' The study also showed that, of 1,166 newly born children in the Jewish communities in this country between 1951 and 1958, only 71 were of 'all-1/ewish' extraction.

The study, a doctoral dissertation by Dr. Harry Maor, of Tel Aviv, showed that only one-fifth of the newly born Jewish children were listed as members of the Jewish communities here and were enrolled in Jewish, religious and education programs.

Dr. Mapr's figures showed there are 23,000 Jews registered officially in the West German Jewish communities. Most of them are concentrated in the large centers like West Berlin, Hamburg, Cologne, Munich and Frankfurt. There are 72 official Jewish communities in West Germany, but Jews also reside in smaller numbers in more than 500 other localities in this country.

The statistics also showed that only four percent of the Jews here lived in Germany before the Nazis wiped out the Jewish communities. Since 1945, about 12, 000 Jews have immigrated to Germany: 4,500 of them from Israel, the others, from 32 other countries.

The study showed further that about 6,000 of the Jews here now are "pensioners," living on one form or another of pensions or restitution funds. About 8,000 Jews are active in the West German economy, 4,800 of these being independent businessmen, while 3,200 are employees.

GERMAN PROSECUTOR REJECTS JEWISH COMPLAINT AGAINST STATE PRESIDENT

BONN, June 27. (JTA) -- The State Prosecutor of Brunswick rejected today a complaint filed by 30 Jewish citizens of Amsterdam, Holland, against Dr. Friedrich Knost, Administrative President of Brunswick, whom they accused of having collaborated in writing a commentary on the Nuremberg anti-Jewish laws while he was an official in the Nazi Ministry of Interior.

The prosecutor's office rejected the complaint on the technical grounds that the statute of limitations barred action now. The prosecutor rejected a similar complaint earlier this year on the grounds that there was "no causal connection between the commentary and the extermination of the Jews."

GERMAN POLICE PROBE REVIVAL OF BANNED NEO-NAZI STUDENT ORGANIZATION

BONN, June 27. (JTA) -- The Federal Police for the Protection of the Constitution has neceived information that the banned neo-Nazi Union of Nationalist Students is trying to organize new extremist student groups, the Jewish Telegraphic Agency was stold today.

The Union of German Students Association said that the police organization was planning to survey the activities of the banned student organization and possible successor youth organizations in West Germany.

The group was banned during the past year at seven institutions of higher learning on charges of having a subversive program and of engaging in anti-Semitic and anti-democratic activities. Its periodical, "Student Im Volk," was recently succeeded by a new publication, "Deutsch Studenten Anzeiger" which is published in Munich. Peter Dehoust, former editor of "Student Im Volk," has guaranteed a circulation of 10,000 for the new publication. The banned students group had a membership of 600 plus an additional 400 supporters in various university organizations.

MISSION ADVISES ANGLO-JEWISH LEADERS ON ORGANIZATION AND FUND QUESTIONS

LONDON, June 27. (JTA) -- Leaders of British Jewry, in meetings with the overseas delegation of the Council of Jewish Federations and Welfare Funds during its visit here, expressed great interest in American methods of raising and distributing funds through united campaigns and central community organizations.

The American mission, headed by Irving Kane, of Cleveland, president of the CJFWF, met with leaders of the major Anglo-Jewish organizations for a general discussion of mutual problems. The American group also visited the hadquarters of the Jewish Board of Guardians and the Otto Schiff home for elderly refugees from nazism to inspect health and welfare services here. As a result of these meetings, machinery for continued coperation and exchange of ideas and information was established. The Anglo-Jewish organization heads were also invited to attend the CJFWF General Assembly in Dallas, next November.

ROBERT BRISCOE IS ELECTED AGAIN AS LORD MAYOR OF DUBLIN

DUBLIN, June 27. (JTA) -- Robert Briscoe, who became Dublin's first Jewish Lord Mayor in 1956, was again elected to that office last night by a 22-21 vote of the City Council. A former president of the Irish Board of Shechita and a former member of the New Zionist Executive under Yladimir Jahofinsky, Mr. Briscoe was named Lord Mayor in 1956 when his name was drawn from a hat after a tie vote in the Council. He lost the election the following year in the same manner.

BRITH ABRAHAM CONVENTION CALLS FOR AMERICAN ACTION AGAINST ARAB BOYCOTT

KIAMESHA LAKE, N.Y., June 27. (JTA) -- Delegates to the 74th annual convention of Brith Abraham called on the United States Government today to "take vigorous action against the Arab boycott of 50 American business firms doing business with Israel." The resolution was adopted unanimously by the 750 delegates, representing 275 lodges of Brith Abraham throughout the country.

Other resolutions adopted by the convention called upon Congress to liberalize the immigration laws; endorsed "sit-ins" by Freedom Riders in the South; supported President Kennedy's aid-to-education bill, pending in Congress, and asked the United States Government to ratify the United Nations Genocide Convention.

Another resolution urged the U.S. Government to "use pressure" on the Government of the Soviet Union to permit Jews from areas behind the Iron Curtain to emigrate "to wherever they please." This resolution emphasized that Jewish religion and culture were being "systematically destroyed" in the USSR, and charged also that a "violent anti-Semitic campaign" was being conducted in the controlled press in the Soviet Union.

Earlier, the convention voted to plant a woodland in Israel as part of the Freedom Forest being developed now at Betar, near Jerusalem, on soil owned by the Jewish National Fund. The plan was proposed by the fraternal organization's grand master, Maurice Goldstein, after the convention was addressed by Albert Schiff, president of the Jewish National Fund of America. Mr. Schiff had stressed the importance of lard reclamation and afforestation to Israel's security and development.

In another address, the delegates heard from New York State Attorney General Louis J. Lefkowitz about the State's work on a cooperative program of public education in the field of human relations. The convention bestowed on Mr. Lefkowitz the Brith Abraham's annual community service award.

NEW YORK CONSERVATIVE CONGREGATION ACCORDS WOMEN 'ALIYAH' PRIVILEGE

NEW YORK, June 27. (JTA) -- A new clash over Jewish religious law loomed today over the action of a leading Conservative congregation in deciding to grant to women congregants the privilege of being "called up" to witness the reading of the Torah scroll on Sabbath mornings and to recite the traditional blessings.

The decision of the Park Avenue Synagogue to establish the grant of aliyah to women congregants was believed to be the first by a Conservative congregation. There have been some isolated instances of women being given the honor but not on a formal and consistent basis.

In Orthodox Judaism, aliyot have never been accorded to women. Reform Jews rarely practice this custom for either men or women.

Joseph H. Katz, chairman of the synagogue board of trustees, said the step was "another expression of our congregation to make Judaism traditional, yet growing with modernity." He added that "the mere fact that some ritual in Jewish religious life has thus far been reserved for men or for women does not imply that it is equal and fair to deny aliyot to women in our synagogue where men and women worship together and where women serve on our board of trustees."

Rabbi Judah Nadich, spiritual leader of the congregation, said the action demonstræd "the adaptability and viability of Jewish religious practice." He asserted that the practice was not a contravention of Jewish religious law, declaring there was evidence that calling women to the Torah was practiced several hundred years ago.

EDUCATOR ASKS JEWISH EDUCATION OVERHAUL TO CENTER IT ON YOUTH NEEDS

HALLIBURTON, Ont., June 27 (JTA) -- A leading Jewish educator charged here last night that Jewish education in the United States was "tragically inadequate" and was "no further advanced than was secular education in America at the turn of the century."

Dr. Max Baer, national director of the B'nai B'rith Youth Organization, told the annual convention of B'nai B'rith Young Adults here that there must be "a drastic over-hauling-of the curiculum in Jewish schools so that it will be child-centered instead of subject-centered, reflecting the needs of today's youth, not of their grandparents, "

Dr. Baer suggested a "coordinated approach to Jewish schooling in local communities." He ceclared that: "Education standards can be raised successfully only if there is agreement on the part of local synagogue congregations for uniformly high quality religious instruction."

The gradual decline in religious discrimination throughout the United States will, in the next decade, "challenge Jewish youth to remain loyal to their faith," he said. This was especially true, he said, in cases where Jewish youngsters had identified with their own people largely because of discrimination.

"With this barrier crumbling, there is danger of an alienation of Jewish youth from the Jewish community, unless there is an affirmative and revitalized program of Jewish education," Dr. Baer asserted. "Such a program," he maintained, "will obviate any serious concern over the possibilities of assimilation."

WEIZMANN INSTITUTE DIRECTORS APPROVE NEW TEN-YEAR EXPANSION PROGRAM

NEW YORK, June 27. (JTA) -- A ten-year building and expansion program for the Weizmann Institute of Science in Rehovot, Israel, which will erable the institution to fank abbue all other research centers between Italy and India, was approved by the Institute's board of directors here yesterday. Dewey Stone, chairman of the board of governors of the Institute, said that the first unit of the expansion program would be the Ullman Institute of Life Sciences to be started immediately. and to be devoted to molecular biology.

Later this year, ground will be broken for the International Research Student and Training-Center, an extension of the Institute's Graduate School in Natural Sciences. The new facility will be open to doctoral and post-doctoral students from all over the world who wish to continue their studies in the exact sciences. Fellowships will be provided for students from the Afro-Asian countries as well as from Europe and North and South America.

NEW REITMAN DORMITORY DEDICATED AT BRANDEIS UNIVERSITY

WALTHAM, Mass., June 27. (JTA) -- A new Brandeis University dormitory building with a capacity for 120 students, was dedicated here in honor of Mr. and Mrs. Frank H. Reitman of Newark, N. J., supporters of the university. The new structure, part of a five-building quadrangle on the university's north campus, contains fully equipped student rooms, a spacious lounge and a large recreation room.

DR. IRVING GREENBERG TO TEACH IN TEL AVIV ON FULBRIGHT GRANT

NEW YORK, June 27. (ITA) -- Dr. Irving Greenberg, assistant professor of history at Yeshiva College, has been awarded a Fulbright grant by the U.S. State Department to lecture in American history at Tel Aviv University, during the coming academic year. The grant is one of more than 500 for teaching and research abroad which are part of the U.S. Education Exchange Program.

FOREST IN ISRAEL TO HONOR DR. GRUBER, CLERIC WHO TESTIFIED AGAINST EICHMANN

FRANKFURT, June 27. (JTA) -- A group of non-Jewish victims of Nazi persecution announced today establishment of a fund for the planting of a forest in Israel in honor of Dr. Heinrigh Gruber, the Protestant bishop who recently testified for the prosecution in the Jerusalem trial of Adolf Eichmann. The forest, to be planted near Jerusalem, will mark Rev. Gruber's 70th birthday which he cele brated this weekend.

Rev. Gruber is credited with saving the lives of thousands of Nazi victims until his arrest by the Gestapo during the Second World War.

FREDERICK F. GREENMAN, PRESIDENT OF AMERICAN JEWISH COMMITTEE, DEAD

NEW YORK, June 27. [JTA] -- Funeral services will be held here tomorrow at Temple Emanu-El for Frederick F. Greenman, 68, president of the American Jewish Committee, who died here last night. Rabbi Julius Mark and Rabbi Nathan A. Perilman will officiate at services here. Mr. Greenman who served in the United States Army in both World Wars, will be interred in Arlington National Cemetery on Thursday.

Mr. Greenman, a prominent attorney, was elected to the presidency of the Committee last April and was to have served for one year. A native of New York City, he received his education at Harvard and was active in both local and national Jewish affairs as well as in numerous civic activities. A former vice-president of Temple Emanu-El, Mr. Greenman was also a former honorary president of the New York Federation of Reform Synagogues and served as vice-president of the Union of American Hebrew Congregations from 1939 to 1950. He was a former national chairman of the allotment committee of the United Jewish Appeal,

In 1957, Mr. Greenman led an American Jewish Committee fact-finding mission on a consultative tour of Europe, North Africa and Israel. He also headed a group of A.J.C. officials who took part in a ceremony in the White House in 1960, naming President Eisenhower the first honorary president of the Committee's Institute of Human Relations.

Tribute to Mr. Greenman was paid in a statement issued here today by his associates in the American Jewish Committee. "With Mr. Greenman's passing." it said in part, "our nation has lost a sincere patriot, American Judaism, a deeply religious son, the American Jewish Committee, one of its most dedicated leaders. His sense of responsibility to the community was exemplary and his dedication to the welfare of his fellow men, was boundless."

SALOMON SACK, MILLIONAIRE PHILANTHROPIST, DIES IN CHILE

SANTIAGO DE CHILE, June 27. (JTA) -- Salomon Sack, who arrived in Chile from Vilba in 1914, a penniless laborer and became a legendary figure here in his lifetime as a millionaire philanthropist, died here today. He was 69 years old.

A prominent figure in Jewish communal life here, he was president of the Jewish bank and a director of the Jewish community. His outstanding benefaction was his gift of \$1,000,000 to the University of Chile ten years ago to found the School of Architecture. Dr. Juan Gomez, Rector of the university, and thousands of students were expected to participate in the funeral services. The Chilean Federation of Students asked all its members to Join in honoring the Jewish philanthropist.
