ISRAEL SET FOR FINAL ELECTION MEETINGS; 1,000 RALLIES SCHEDULED

TEL AVIV, Aug. 10 (1TA) -- No less than 1,000 campaign meetings will be held this weekend throughout Israel by the various political parties in their final bid for votes in the national election Tuesday of members to the fifth Knesset, Israel's Farliament, it was estimated here today. It was also estimated that the various parties spent about 100,000,000 pounds -- \$55,000,000 -- on campaigning?

Prime Minister David Ben-Gurion's Mapai party has scheduled 600 of the meetings for the weekend. One mass rally has been set with Mrs. Golda Meir, Israel's Foreign Minister, and Moshe Dayan, Minister of Agriculture, as the principal attractions. A larger rally has been set for Saturday night at which Mr. Ben-Gurion and Jewish. Agency executive chairman Moshe Sharett will speak.

The Herut party has scheduled 300 meetings, with three main rallies at which the party's leader, Menachem Beigin, will be the main speaker. The rallies will be held mostly in the suburbs. Dr. Nahum Goldmann and other Liberal party leaders continued their meetings in all parts of Israel. The smaller parties scheduled meetings on a lesser scale.

The Agudat Israel scored an unexpected success with a mass meeting in Tel Aviv, addressed by Chassidic rabbis and other rabbinical leaders, which drew 12,000 listeners. The ultra-Orthodox party called another meeting but the party faced a possible reaction from popular disapproval of the kidnaping of nine-year-old Yosele Schumacher and his being kept in an Agudah settlement before he disappeared altogether.

The Central Electi on Committee reported that 19,000 of Israel's estimated 500,000 qualified voters would be abroad on election day and that no more than 15,000 would have to travel any substantial distance to get to a polling booth. The Committee also amnounced that a Yemenite list of Knesset candidates was officially withdrawn yesterday. The withdrawal cut from 15 to 14 the number of lists to be presented at the polls Tuesday.

A key figure in the dispute last winter which brought about the dissolution of the Government and the need for the election Tuesday -- Pihnas Lavon -- returned today from a lengthy stay in Europe. He made it plain that the Mapai had nothing to fear from him, "My silence is not meant particularly to help Mapai's election campaign but to avoid confusing an immediate issue, such as the elections, "he said," it was the "Lavon Affair" that precipitated Premier Ben-Gurion's resignation resulting in the automatic fall of the cabinet and leading to the present elections.

PROSECUTOR ASKS COURT FOR 'JUST AND TRUTHFUL VERDICT' ON EICHMANN

JERUSALEM, Aug. 10 (JTA) -- Attorney General Gideon Hausner today completed his three-day summation of the case against Adolf Eichmann and demanded conviction of the former Gestapo colonel on all 15 points of the indictment against him.

"Y ask you, judges of Israel to render a just and truthful verdict," he told the three-judge court; He emphasized that all 15 points of the indictment "have been proved" during the four-month trial; He did not demand the death penalty as provided by Israel's law against Nazis, because the court in Israel does not permit such a demand until the defendant is convicted;

At the close of the prosecution summation, the trial was adjourned until Monday when Dr. Robert Servatius, Eichmann's West German defense counsel, will present his summation; This will be completed on the same day and the trial, which began last April 11, will be ended. The three justices will then retire to begin consideration

of the mountain of documentary and eye-witness testimony. Their verdict, which isexpected to be one of guilty, is not expected before October. Dr. Servatius has indicated he will appeal the verdict.

The prosecutor, winding up his summation, cited affi davits presented by proxy by former associates of the defendant, as well as statements made before various postwar tribunals by condemned Nazis; "We have to remember that these people had nothing to gain by implicating others," the prosecutor told the court; "They admitted their guilt and knew they would hang." They should be believed;"

The prosecutor scoffed at Eichmann's defense claim that he was a "small sausage" in the vast Nazi murder machinery. He said Eichmann had answered incriminating evidence against him from former Nazi associates with "subterfuges, ruses and lies," Under every accusation, the prosecutor declared, Eichmann immediately found his bearings and gave the best answer. These answers, the prosecutor said, "were often absurd, but that was the fault of the facts, not of Eichmann's purported medicority."

"He who can react under cross-examination the way the accused has done is not a small man," Mr. Hausner told the court. "This is a man of serious and considerable intelligence who tried to come out of the web of evidence which could convict him. His evil personality appeared again and again in his clever and cunning answers."

Says Eichmann Acted Lustfully and Zestfully in Annihilating Jews

Terming Eichmann's claim that he was never an anti-Semite "absurd," the prosecutor said that the defendant "acted willingly, lustfully and zestfully to the very end" of his career as head of the Gestapo department for Jewish Affairs. He pointed out that Eichmann was not willing even to consent to one proposal Hitler was ready to consider — that Jews with service records would not be forced to witness the executions of members of their families, a favorite bit of Nazi sadism.

In the final portion of his summation, the prosecutor paid tribute to the Europeans who sought, at the risk of merciless torture and death, to save Jews from the Nazi murder. "We shall never forget the nobility and greatness of the entire Danish nation, its King and its underground who helped Jews to escape to Sweden," the prosecutor said; "We will remember the Norwegians who smuggled Jews out of their country at the risk of their lives, the brave Beleians and the magnanimous Swedes?

"We remember Raoul Wallenberg who singlehandedly stood up to Eichmann and saved thousands of our people. We remember the Dutch nation which went on strike for the Jews, the Dutch church, and the Ralians who protected the Jews, especially in the convents and monasteries. We will remember the Poles who risked their lives, the French Maquis, the Lithuanians, the Yugoslavs, the Greeks and the undergrounds and partisans in all of occupied Europe."

"Their names and their deeds will always be engraved in our memories," the prosecutor said;" There is no consolation for the third of the nation that has fallen, "he added "but there is solace in the fact that the Jews knew how to face the enemy with dignity and pride; These victims cannot be brought back to life but there must be justice for what was perpetrated against them; I am proud of the fact that the days have come when a citizen of Israel can speak the language of justice to an evildoer;"

3,000 ISRAELI STUDENTS ATTEND COLLEGES ABROAD; 2,000 STUDY IN U. S.

JERUSALEM, Aug. 10 (JTA) -- Three thousand Israeli students are attending colleges in other countries, two-thirds of them in the United States, a survey by the Prime Minister's Office disclosed today.

The data showed that 250 are in British colleges, 200 in Austria, 150 each in France and West Germany, 120 in Swiss schools and smaller numbers in Turkey, Japan, Yugoslavia and Poland.

ESRAEL TO TEST OVERLAND TRANSPORTATION IN COMPETITION TO SUEZ CANAL

JERUSALEM, Aug. 10 (JTA) -- Plans for an overland Suez Canal detour will be given a first test by an Israeli company next month, it was disclosed today. The company will bring a shipment of Japanese goods to Eilat and transport it overland to Haifa fortranshipment to its destination in Italy.

SO, RHODESIAN JEW ELECTED MAYOR OF SALISBURY; IS FOURTH JEWISH MAYOR

SALEBURY, Swithern Rhodesia, Aug. 10 (JTA) -- Ivor Pitch, 54, was today elected Mayor of this city. He is the fourth Jew ever to have been elected to that post. The other three were Harry Pitchanik, Mayor Pitch's brother, who served in 1955-56; Jay van Pragh, 1900-01; and H. L. Lezard, 1914-15.

JERUSALEM, Aug. 10 (JTA) -- Israel has a record population of 2,170,082 persons, according to provisional results of the May 22 census reported today. The total is nearly two and a half times as much as that indicated by a previous census taken Nov; 11, 1948, six months after Israel statehood was declared.

The findings were presented to President Ben-Zvi by Prof. R. Bachi, the government statistician, and senior members of the census staff at a reception. Three cities were listed as having populations of more than 100,000. They are Tel Aviv, with 386,612 residents; Haifa, with 182,007, and Jerusalem, with 166,301 persons; Jerusalem has almost doubled in population since the 1948 census.

The next two largest urtan areas are Ramat Gan, near Tel Aviv, with more than 90,000 residents, and Petah Tikvah, with 53,000. Forty-nine other towns with populations of from 5,000 to 50,000 include three all-Arab towns, as well as a dozen points in the Negev which were unpopulated in 1948. The new Negev settled points range in population from 6,000 in Eilat to 24,000 in Ashkelon.

The census data showed that while Tel Aviv did not match the rate of increase of other urban areas, the population growth of its suburban areas rose at a faster pace than that of the rest of Israel. Creater Tel Aviv now numbers nearly 700,000 persons. Beersheba and Ashkelon subdistricts showed a record increase of 170 percent, with Safad close behind in growth.

ISRAEL POLICE RE-ARREST ORTHODOX GRANDFATHER IN KIDNAPING AFFAIR

JERUSALEM, Aug. 10 (JTA) -- Police continued their search today in Komemiut, an Agudat Israel settlement in the Negev, for nine-year-old Yossele Schumacher, who was hidden by his grandfather, Nachman Starkes, out of fear that the boy's parents would not give him a sufficiently Orthodox upbringing. Among the homes searched in the settlement was that of the local rabbi, where the boy was believed to have been kent for some time.

The latest move by Israeli police in the case followed the rearrest yesterday of the aged Mr. Starkes, who was taken from his Jerusalem home back to the Ramleh Jail after failing to find the boy during a three-month suspension of sentence given him to enable him to produce his grandson. The court had found that the grandfather had not made a genuine effort to locate Yossele. Mr. Starkes has already spent nearly a year in Iail for his retusal to yield the boy.

In London, meanwhile, Scotland yard is keeping under surveillance Shalom Starkes, Yossele's uncle, who is suspected of having taken the boy to England; London police said, however, that a check of the flight on which Shalom Starkes arrived in England revealed that no children were aboard;

JEWISH FAMILY KILLED BY ALGERIAN REBELS IN TERRORIST ATTACK ON HOTEL

PARIS, Aug. 10 (JTA) -- An entire Jewish family was wiped out by Algerian rebel terrorists last night in a submachine gun attack on a resort hotel where the family was vacationing, it was reported here today. The attack took place on the verandah of the hotel in Ziamma Mansouriah. Among the six victims of the outrage were Gabriel Levi, his wife, and his two children, one 12 and one seven.

In recent weeks, the FLN, the organization of the rebels, has been driven out of its traditional mountain strongholds and members have resumed indiscriminate terrorist attacks. Many Jewish families which in past years would have gone to Europe for their vacations have not done so this year because of threats by the OAS, the French underground in Algeria, to blow up properties of "fleeing" Europeans.

CENTRAL JEWISH BODY IN FRANCE PROTESTS TO GERMAN GOVERNMENT ON GLOBKE

PARIS, Aug 10, (JTA) -- The Representative Council of Jews in France, CRIF, submitted today to the West German Ambassador in Paris, a resolution protesting against the continued retention in office of State Secretary Hans Globke.

The resolution, addressed to Chancellor Konrad Adenauer, recalled Dr. Globke's active association with the Nazi party and his participation in the drafting of the Nuremberg racial laws on anti-Jewish discrimination. The resolution asked Chancellor Adenauer to dismiss Dr. Globke at the earliest possible date.

JEWS AND EX-NAZIS ARE UNWANTED IN GERMAN POLITICAL LIFE, SURVEY SHOWS

FRANKFURT, Aug. 10 (JTA) -- Former Nazis and Jews alike are unwanted in West German political life, according to a survey conducted by the Divo Institute in Frankfurt. A total of 41 percent of West Germans polled said they had "misgivings" about Jews taking part in politics.

DANGER OF JEWISH ASSIMILATION DISMISSED AT BINAL BIRITH YOUTH PARLEY

STARLIGHT, Pa., Aug 10 (JTA) -- Those who forecast inevitable assimilation of the American-Jewish community are "armchair prophets of doom who just have not gotten out and around to see what is happening every summer in the young American Jewish community," a leading Conservative rabbi said here today addressing some 125 top teen-age regional leaders of the B'nai B'rith Youth Organization participating in the organization's 4th annual leadership training conference.

Rabbi Myron M. Fenster, who is spiritual leader of the Jewish Center of Jackson Heights, New York and consultant on adult Jewish education for the United Synagogue of America, said warnings of assimilation of Judaism in the United States come from those who "simply aren't taking into account all the facts -- including Judaism's history. No one who spends any time at such a program of Jewish learning and living with our young people can help but be enormously impressed and uplifted."

"It is a refreshing experience to leave the hurried attempts at Jewish education at home and come to the open spaces where study can be both intensive and leisurely", he stated, "One returns with heightened hopes for our leadership of tomorrow." He admitted there may be some merit to charges that the American Jewish community was besieged "by much promotion and little instruction" and that "we busy ourselves with communal affairs, and forget the life of the individual," But, he said, this is hardly a full picture of American Jewish life in the 1960's.

Jewish history is not solely the chronicle of the great communities. It is also the story of devoted individuals," Rabbi Fensher continued, "Our eager young people who participate in summer study programs are our affirmative and strident response to those who would write us off and bemoan our possibilities. It may yet be that the summer will be the saving grace of a large segment of Jewry in this country;" He confidently predicted for the future, "generations more knowledgeable than the present one;"

VANDALS DESECRATE SAN FRANCISCO SYNAGOGUE; SMEAR ANTI-JEWISH SLOGANS

SAN FRANCISCO, Aug. 10 (JTA) -- Police today were investigating the desecration by anti-Semitic vandals of Congregation Ner Tamid, in which walls of the synagogue building were smeared with swastikas and anti-Jewish slogans. The incident, which took place while two groups were meeting in the building, was the second to have occurred to the synagogue.

The vandals, who carried out the desecration in the early evening while the building was well lighted, smeared the walls with such phrases as "We like Hitler and Eichmann," and "Heil, Nazism will rise again;" That the daubings were not the work of small children was evident by the fact that they were found six feet above the ground;

FIRE CAUSES \$200,000 DAMAGE TO CHICAGOS YNAGOGUE; VANDALS SUSPECTED

CHICAGO, Aug. 10 (JTA) -- Police began an investigation today to determine if vandals were responsible for starting a blaze last night which damaged the Agudath Achim South Shore Congregation. The fire, which destroyed the main auditorium of the synagogue, resulted in damage estimated by Rabbi Harold P. Smith at \$200,000. The synagogue was the third Jewish house of worship to have burned in the area during the past three weeks.

BOSTON JEWISH LEADER NAMED ADVISER TO GOVERNMENT OF RHODESIA-NYASALANI

Mr. Winer, who is chairman of the Chemical Division of the Combined Jewish Fhilanthropies, will leave for his new post next month,
