ARAB RIOTS IN ISRAEL PROVOKE REQUESTS FOR PARLIAMENTARY INVESTIGATION

JERUSALEM, Sept. 25; (JTA) -- Demands for a parliamentary investigation into the circumstances of the death last week of five young Arabs attempting to cross the frontier into the Egyptian-held Gaza Strip were made today in the aftermath of two days of rioting in Nazareth and incidents in Haifa, Acre and other centers.

Both the Mapam and Communist parties called on the Knesset presidium to put demands for a parliamentary probe of the whole affair on the Knesset agenda. The Herut Party asked that a special session be convened of the Knesset Foreign Affairs and Security Committee. An Arab deputy, Yussef Khamis, a member of Mapam, filed a parliamentary question to be answered by the Government when the Knesset reconvenes on October 4.

The Cabinet, at its weekly meeting yesterday, heard a detailed report by Minister of Police Behor Shitreet and was to hear from the Chief of Staff on action taken by the Army in the situation.

The northern areas, where the rioting occurred last week, were quiet over the weekend, although tension remained high. Strong police patrols in the outskirts of Haifa and in the nearby Arab communities, which headed off potential demonstrators, prevented a recurrence of the rioting which started in Nazareth and continued for two days. The mayors of Haifa and Acre made strong efforts to pacify the population and to enlist Arab notables in this task as Communist agitators and other disaffected elements sought to incite the Arabs to further demonstrations.

Charges that the five young Arabs, killed in two different border incidents when they attempted to cross the frontier illegally from Israel to the Egyptian-held Gaza Strip, had been mutilated, were used by the agitators to whip up Arab ire. Police gave distribution to the report of the official post mortem on the five bodies which established that the five had been shot from long-range and that there were no signs of mutilation on their bodies.

ESHKOL DISCUSSES STRICTER PARLIAMENTARY SUPERVISION OF ISRAEL'S ARMY

TEL AVIV, Sept. 25; (JTA) -- Finance Minister Levi Eshkol, who has been entrusted by President Izhak Ben-Zvi with the formation of the new Cabinet, began discussions yesterday on one of the major demands of the opposition--the introduction of stricter parliamentary supervision of the armed forces.

The left-wing Mapam and Ahdut Avodah parties insist on the formation of a Ministerial Committee as a supreme body responsible for the country's security. Premier David Ben-Gurion, who is also the Defense Minister, has been insisting that all security matters be left in the hands of the Defense Minister only.

In an attempt to settle this issue, Mr. Eshkol conferred yesterday with Israel Galili, leader of the Ahdut Avodah, who is particularly firm on the demand of introducing parliamentary control over the armed forces. Mr. Galili is reported to have prepared a detailed plan for the implementation of such control.

Meanwhile, representatives of Mapai and other parties are also discussing another issue to affect the next coalition. This one deals with establishing a "collective responsibility" rule, which would make it mandatory for all parties that are partners of the coalition to support all Government bills in Parliament, or at least not to vote against such bills.

The principal issue, however, on whether Mapai is to have a majority of the members of the next Cabinet, is still in dispute. Further intra-party discussions of that issue will be held at meetings scheduled for Wednesday.

At a meeting of the inter-party committee of Mapai's former coalition partners--the Liberals, the National Religious Party, Mapam, and Ahdut Avodah--held yesterday, in preparation for further talks with Mr. Eshkol, it was decided to maintain "a firm and united" stand on the three central issues: 1. Numerical and qualitative parity between Mapai and the other parties in the Cabinet; 2. An equitable distribution of important portfolios, particularly the ministries of defense, foreign affairs and finance; and 3. Parliamentary supervision of the armed forces.

Mr. Eshkol today expressed optimism about his prospects of forming a government soon after the holidays. It is understood that he believes that Mapam and Ahdut Avodah understand now better than a week ago the necessity of keeping a strong labor coalition. This sentiment has also been expressed during the last few days in articles written by Ahdut Avodah writers in the Israeli press.

JEWISH POLICE CHIEF ASSASSINATED IN ALGIERS; ANXIETY AMONG JEWS GROWS

PARIS, Sept. 25; (JTA) -- The press here reported today that there is considerable anxiety existing among the Jewish communities in Algeria, following the assassination there of Alexis Goldenberg, chief superintendent of police and highest ranking Jew in the French police in Algiers.

Mr. Goldenberg, 49, held two university degrees, in science and in law, and was a linguist speaking seven languages. His widow flew to Algeria after his murder, and he was buried yesterday in a Jewish cemetery.

According to the press here, the Algerian Jews feel they are caught between the two principal contending forces in Algeria--the Moslem, terrorist, FLN, and the French secret underground, the OAS.

MOROCCAN JEWISH LEADERS DISCUSS PROBLEMS WITH MINISTRY OF JUSTICE

CASABLANCA, Sept. 25; (JTA) -- David Amar, secretary-general of the Council of Moroccan Jewish Communities, met here yesterday with the director for civil affairs of the Ministry of Justice, to discuss a number of problems of concern to Moroccan Jewry.

Mr. Amar, who was accompanied by Rahamim Tobaly, president of the Jewish community of Sefrou, urged the Government official to restore the post of rabbi of Sefrou, which has been abolished by the Government. The Jewish representatives also urged the Justice Ministry to consider the problem of forced conversion of many young Jews, and to prohibit the conversion of minors. The Government official promised "careful consideration" of the issues discussed.

PALESTINE REFUGEES ARE USED AS PAWNS BY ARAB RULERS, U.S. WRITER REPORTS

NEW YORK, Sept. 25. (JTA) -- Nearly one million Arab refugees from Palestine are used as pawns by the Arab countries in continuing a state of war with Israel, according to an article in the October issue of the Atlantic Monthly Magazine. The article emphasizes that the leaders of the Arab nations have used the plight of these refugees as the central theme in a hate campaign against Israel.

Martha Gellhorn, novelist, journalist, former war correspondent, and the author of The Atlantic's article, "The Arabs of Palestine," says that of the thirty-nine million war refugees since World War II few have been exploited. "The unique misfortune of the Palestine refugees is that they are a weapon in what seems to be a permanent war," she says. She refers to the fact that "Mein Kampf" was ignored in its day, and says that "we ought to have learned never to ignore dictators or their books. 'Egypt's Liberation,' by Gamel Abdul Nasser, deserves careful notice."

Miss Gellhorn visited eight of the 58 refugee camps which the United Nations relief organization has operated for the past 11 years at a cost of nearly \$360 million. After talking with the Arab families in these camps, she says: "The Palestinian refugees are unfortunate victims of a brief moment in history. If we can keep the peace, however troubled, the children of Palestinian refugees will make themselves at home among their own kind, in their ancestral lands."

JACQUES LIPSHITZ, AMERICAN JEWISH NOTED SCULPTOR, HONORED IN ISRAEL

JERUSALEM, Sept. 25; (JTA) -- Jacques Lipshitz, world-noted Jewish sculptor, who has donated 300 plaster casts of his works to the Jerusalem Museum, arrived here from New York for a month's visit as the guest of Prime Minister David Ben-Gurion. President Izhak Ben-Zvi gave a special reception in his honor.

Accompanied by his wife and daughter, Mr. Lipschitz held a press conference at which he asserted: "We must recall that 'from Zion shall go forth the Law.' If we want to be good Jews, we must remember we must be universal human beings, 'mentschen.'" The sculptor announced that he is now at work on a "very big" sculpture, about 12 feet in height, depicting "the descent of wisdom to man."

LONDON COURT REFUSES BAIL FOR ISRAELI IN CHILD ABDUCTION CASE

LONDON, Sept. 25. (JTA) -- Magistrate Bertram Reece today again refused an application to set bail for Shalom Shtarks, the 22-year-old Israeli teacher, who is being held in jail here on the application of the Israel Government for his extradition. The religious school teacher is accused by Israel of hiding, "somewhere in England," 11-year-old Yossele Schuma-cher. That boy had been abducted from his parents in Israel, who feared he would not receive an Orthodox Hebrew education.

The court remanded Shtarks for another hearing, scheduled for Thursday. His counsel insists that he does not know where the child is. Leonard Caplin, an attorney for the Israel Government in the extradition request, told the court that the Shtarks defense is "drawing a procession of red herrings" across the missing boy's trail.

MAX J. RUBIN NAMED PRESIDENT OF NEW YORK'S BOARD OF EDUCATION

NEW YORK, Sept. 25; (JTA) -- Max J. Rubin, a New York attorney born on the lower East Side, and one of three Jews on New York City's new Board of Education, was appointed by Mayor Robert F. Wagner as president of the Board. He is the only member of the Board named by the Mayor to a full, seven-year term.

ARAMCO HANDBOOK IGNORES EXISTENCE OF ISRAEL; ELIMINATES IT FROM MAPS

NEW YORK, Sept. 25; (JTA) -- The West's attitude towards the Palestine Arab refugee question and "a real sense of insecurity with respect to possible further expansion of Israel" are the major reasons why the Arab States have turned to the Soviet Union for arms and economic assistance, according to the "Aramco Handbook," published by the Arabian American Oil Company for the guidance of its employees.

The lavish volume, profusely illustrated and printed in The Netherlands, has been distributed by the oil company to public libraries throughout the country. The 343-page volume contains only two references to Israel--a brief reference to the fact that "the Arab States dispute Israel's claims to rights in the Gulf of Akaba," and a longer reference to the Arab-Israeli dispute as a source of tension in the Middle East.

Nor does the name of Israel appear anywhere on the score or more of maps appearing in the book, or on any of the numerous charts on the Middle East which are included in the book. An illustration, in color, "Middle East Flags," depicts the national colors of 10 Middle East countries, but not the blue-white flag of Israel.

A historical section, describing the mandate system established after World War I, makes reference to the British Mandate over Palestine and the subsequent severance of Jordan for establishment as an independent state, but fails to report that the Palestine Mandate ended with establishment of the State of Israel in part of the territory of Palestine or to explain in any way how the Palestine Arab refugee situation was created.

Justifies Nasser's Turning to Moscow for Arms and Economic Aid

In dealing with present tensions in the Middle East, the "Aramco Handbook" notes that "another cause has been the tragic impasse in the Arab-Israeli conflict. Current problems in the Middle East cannot be understood without a comprehension of how strongly the Arabs feel on this issue. The West's apparent indifference to Arab viewpoint and to the plight of the million or so Arab refugees displaced from their homes in Palestine has been both disillusioning and frustrating to the Arabs."

The editors added that "these feelings, coupled with a real sense of insecurity with respect to possible further expansion of Israel, largely explain why Egypt and later Syria turned to the Soviet Union for arms and economic assistance after failing to get what they wanted from the West."

An introduction to the handbook noted that it had been prepared by Aramco employees who are not professional writers and that the central purpose was "to help Aramco employees see the Aramco venture in proper perspective--to see what is happening today against the background of the past and in the light of current world affairs." Opinions expressed, it said, "do not necessarily represent official views of Company management." No reference is made to Aramco discriminating employment practices with respect to Jews.

PUBLIC HEARING TO BE HELD ON ARAMCO'S DISCRIMINATION AGAINST JEWS

NEW YORK, Sept. 25. (JTA) -- A public hearing will be held by the New York State Commission Against Discrimination on charges that Aramco, the Arabian American Oil Company, discriminates against Jews by refusing to hire Jews, it was confirmed here today by Elmer A. Carter, chairman of the State Commission. Mr. Carter said that he will soon appoint three members of his commission to conduct the hearing. No date for the hearing has been fixed as yet.

The issue has been pending since the American Jewish Congress filed a complaint against Aramco before the commission in 1956. Two years later, Mr. Carter ruled that an exception granted Aramco by the New York State body in 1950 should stand. The AJC fought the issue through the New York State Courts, and the State's highest court ruled finally that the commission must conduct a public hearing.

Efforts to conciliate the issue, made recently, have now collapsed. The oil company conceded that it bars Jews from most jobs, but has argued that such steps are required by its agreement with the Government of Saudi Arabia.

WESTPORT RESIDENT ARRESTED FOR MAILING ANTI-SEMITIC PROPAGANDA

WESTPORT, Conn., Sept. 25; (JTA) -- Alan F. P. Moyler, a 35-year-old freelance commercial artist living near Westport, is under \$11,000 bail today, after being arrested and arraigned on 16 separate charges of violating Federal and State laws by spreading and mailing anti-Semitic propaganda.

According to police, Moyler has been, for three years, mailing anti-Semitic materials, scribbling slogans in telephone booths and other public places, and sending dead rats in the mails to Jews in this area. Government handwriting experts traced the offensive materials to Moyler, police authorities said.

He has posted a \$5,000 bond for trial in the U.S. District Court at New Haven, and is under another bond, of \$6,000, awaiting a hearing in Circuit Court here on October 3. Moyler told police he is a British subject born in China.

NEW YORK JEWISH FEDERATION LAUNCHES \$22,500,000 APPEAL; HIGHEST ON RECORD

NEW YORK, Sept. 25. (JTA) -- A record goal of \$22,500,000 was set today by the Federation of Jewish Philanthropies of New York, which opened its 44th-annual maintenance appeal. Fifteen thousand volunteer fund-raisers are participating in the campaign on behalf of Federation's 116 affiliated agencies, now serving almost 800,000 New Yorkers of all races and faiths, it was announced by Joseph L. Mailman, chairman of the drive.

The year's maintenance appeal, topping last year's Federation campaign by \$3,500,000, is being conducted simultaneously with a three-year capital funds drive for \$104,365,000. The maintenance appeal is for funds needed to pay day-to-day operating costs of Federation's network of hospitals, social service and recreation agencies, constituting the largest group of private community service agencies in the United States.

ASHES OF ZYGELBOIM, LEADER OF JEWISH RESISTANCE IN POLAND, BURIED IN N. Y.

NEW YORK, Sept. 25. (JTA) -- An urn containing the ashes of the cremated remains of Shmuel Mordecai (Artur) Zygelboim, a leader of the Polish Jewish resistance fighters during World War II--who committed suicide in 1943 as a step to alert the world to the martyrdom of the heroes of the Warsaw Ghetto revolt--rest today in the cemetery of the Workmen's Circle, in suburban Queens. Three thousand Jews attended a memorial service for Mr. Zygelboim at Carnegie Hall here yesterday, and many followed the funeral procession to the cemetery.

Mr. Zygelboim was the Jewish Labor Bund's representative in the Parliament of Poland's Government-in-Exile in London, when he received word that the Nazi Army had wiped out the last pockets of Jewish resistance in the Warsaw Ghetto. He killed himself, leaving letters to leaders of the Polish Government-in-Exile, declaring his death was a protest against "the inactivity with which the world is looking on and permitting the extermination of the Jewish people." His remains were cremated in London 18 years ago.

The urn containing the Zygelboim ashes stood at the center of the stage at Carnegie Hall yesterday, as representatives of Jewish labor eulogized his martyrdom. Survivors of the Warsaw Ghetto revolt flanked the urn on stage. Speakers included Adolph Held, chairman of the Jewish Labor Committee; Dr. Emanuel Scherer, of the Jewish Labor Bund; Charles S. Zimmerman, vice-president of the International Ladies Garment Workers Union; Israel Breslaw, president of the Workmen's Circle; and A. Glantz-Leyless, president of the Yiddish PEN Club.

RABBI POUPKO DEAD; WAS HONORARY PRESIDENT OF UNION OF ORTHODOX RABBIS

PHILADELPHIA, Sept. 25. (JTA) -- Rabbi Eliezer Poupko, a leading Orthodox rabbi and formerly an honorary president of the Union of Orthodox Rabbis of the United States and Canada, died here yesterday of a heart attack at the age of 75. He was spiritual leader of the Aitz Chaim Congregation here at the time of his death.

Born in Russia, Rabbi Poupko was ordained in Volozin in 1908 and served as spiritual leader of various communities in Russia until he was sentenced to a Siberian prison for defying the religious policy of the Soviet Union. He came to the United States in 1931, when U. S. rabbis secured his release, and assumed his post as spiritual leader of Aitz Chaim congregation in 1943.

JOSEPH SMOUHA, NOTED JEWISH INDUSTRIALIST AND PHILANTHROPIST, DEAD

PARIS, Sept. 25. (JTA) -- Joseph Smouha, prominent British-Jewish philanthropist, died here at the age of 83. Two months ago he was awarded some 3,000,000 pounds sterling (\$8,400,000) compensation for property in Alexandria, Egypt, confiscated by the Nasser regime. The property was reportedly worth more than 12,000,000 pounds sterling (\$34,000,000).

Mr. Smouha, who was a textile industrialist in England, settled in Alexandria in 1923 where he turned 700 acres of water and marshland into "Smouha City." Much of the property was donated by Mr. Smouha to schools, hospitals and other public institutions before the Nasser regime confiscated the entire tract.

ALICE PROSKAUER DAY CAMP FOR 2,500 UNDERPRIVILEGED CHILDREN DEDICATED

NEW YORK, Sept. 25. (JTA) -- Dedication ceremonies were conducted at suburban Wyandanch, Long Island, yesterday, for the opening of a new, 240-acre, children's camp site, named after the late Mrs. Alice N. Proskauer, wife of former Supreme Court Justice Joseph M. Proskauer.

The new day camp will afford facilities for 2,500 underprivileged children. It is part of the Henry Kaufman Camp Grounds, created and supported by the Federation of Jewish Philanthropies of New York. Principal speakers at the dedicatory exercises were Justice Proskauer and James Felt, a member of the New York City Planning Commission.
