TERRORISTS SLAY TWO JEWISH CHILDREN IN ALGIERS; MOSLEM NURSE MISSING

ALGIERS, May 15. (JTA) -- One of the most brutal murders in the recent outbreak of terrorism against Europeans in Algeria yesterday was the slaying of two Jewish children, one two years of age and the other six years old,

The mother had left the children in the care of a Moslem serving woman while she went shopping. On her return she found their bodies with their throats cut. The Moslem was gone and has not been seen since,

SRAEL SUPREME COURT TO RENDER FINAL EICHMANN JUDGMENT ON MAY 29

JERUSALEM, May 15. (JTA) -- The reading of the judgment by the Israel Supreme Court, on the appeal by Nazi Adolf Eichmann from his death sentence, will take place on May 29, it was officially announced here today.

Dr. Robert Servatius, the West German attorney who is the former Gestape colonel's hief defense counsel, is scheduled to come to Israel on May 27 in preparation for the eading. If the appeals tribunal upholds the Jerusalem District Court judgment and verict of death by hanging, Dr. Servatius is expected to make one final move for his client-n appeal for clemency to President Ixhak Ben-Zvi.

Eichmann, whose capture and presence in an Israeli jail cell was disclosed on May 23, 160, was placed on trial in April last year on charges of having had a key role in the azi wartime slaughter of 6,000,000 European Jewish men, women and children. The tal lasted until August.

The three-man court which heard the long trial found Eichmann guilty on December 15, at imposed sentence the same day. Dr. Servatius filed abtice of appeal, and a special ibunal of five Supreme Court justices began hearing the appeal last March 22.

NESSET REJECTS FOUR-PARTY ATTACK ON GOVERNMENT BY VOTE OF 55 TO 47

JERUSALEM, May 15. (JTA) -- The Knesset, Israel's Parliament, defeated tonight ur non-confidence motions criticizing the Government's new economic policy. The policy is initiated by the devaluation of the Israel pound last February, The vote against the motions is 55-47.

The motions, proposed by Herut, the Liberals, Mapam and the Communists, demanded resignation of the Government over the "failure" of the latter's economic program. The udat Israel faction supported the non-confidence motions.

Prime Minister David Ben-Gurion, who replied to the motions on behalf of the Governint, ridiculed the opposition for failing to propose an alternative to the Government they aght to depose. None of the parties which submitted motions could take on the task of ming a new Government, the Premier challenged, adding that it was questionable whether y would even agree to est in the same Cabinet together.

Mr. Ben-Gurion also asserted that the motions were premature, since Finance Minis-Levi Eshkol was scheduled to present the new economic policy to the Knesset tomorrow.

ROCCAN GOVT. PARTY CALLS ON ALL ARABS TO PROCLAIM WAR AGAINST ISRAEL

PARIS, May 15, (JTA) -- The Moroccan Government Istiqlal (Freedom) party demanded ay that all Arab countries proclaim war against Israel, and to "liberate Palestine," acding to a dispatch from Casablanca. The party said it regarded war against Israel as aational religious duty." Morocco, a Moslem country and a member of the Arab League, already cut off postal ties with Israel.

. NAMES FIRST TRADE MISSION TO ISRAEL; TO SURVEY COUNTRY FOR MONTH

WASHINGTON, May 15. (JTA) -- The United States Department of Commerce today ned a five-man delegation which will go to Israel next month as the first U.S, trade sign there. The members of the 'mission are experts in the fields of heavy equipit and earth moving machinery; food processing; chemicals, synthetics and fibres; in-manufactured machine tools and metals; and electronics for medicine and science, group will stay in Israel nearly the entire month of June.

GOLDMANN ANALYZES SITUATION OF JEWS IN RUSSIA, WARNS. ON ALGERIA

NEW YORK, May 15. (JTA) -- Dr. Nahum Goldmann asserted here today that the Jew-shepole will continue to demand that the Soviet Union provide to its Jewish community the same facilities granted in the USSR to all other religious and national groups. He added, however, that an effort will be made "to separate this demand from the general anti-Soviet propagands of the Cold War."

Prior to his scheduled departure, tomorrow night, for Europe; and Israel, Dr Goldmann. also discussed the present position and the near future of the Jews in Algieria and talked about the forthcoming Ecumenical Council, to be convened by the Catholic Church in Rome, next October.

As president of the World Zionist Organization and the World Jewish Congress, Dr.Goldmann asserted, regarding Russia, that "it is very difficult be see the rationale of Soviet policy toward its Jewish minority." Citing the facts about Russian Jews enjoying certain rights on an equal basis with other national groups, he pointed to:

- l, "The large number of death sentences against Jews for economic crimes and the special publicity given to them.
- 2. "The refusal, for the first time in the history of Soviet Russia, to provide the Jewish community with matzos," indicating "a policy of discrimination which, naturally, causes considerable concern among Jews all over the world."
- 3. "The main complaint with regard to Soviet Jewish policies is against the undeniable difficulty for Jews to express themselves as Jews, religiously, culturally and nationally, despite their status as a national minority under the Soviet Constitution."

Appeals to Soviet 'Self Interest,' Hopes Authorities Will Change Policy

Asserting that "it is almost impossible to understand the motives of such a policy of enforced assimilation as is applied to the Jewish minority in Russia, "but specifically disassociating himself from joining the Jewish issue to Cold War propaganda, he stated:

Despite the lack of real progress until now, we do hope that, from the point of view of their own interests, the leadership of the Soviet Union will realize the unfairness and ack of justification for their policies, which endanger the survival of the second largest Jewish community in the world, and that they will begin to change this policy."

(in a letter to The New York Times today, Democratic Congressman William Fitts Ryan, of New York, stated that he had received "evidence of widespread discriminations" against Soviet Jews. He proposed that the U.S.A. and the USSR include religious leaders in their cultural-exchange programs, and asked: "If the well-documented reports of religious persecution can be refuted, then why does not the Soviet Union allow, indeed encourage, a free interchange of personnel and information with her Jewish religious community?"!

Hopes for Action Vs. Anti-Semitism at Rome; Sees Dangers in Algeria

Dr. Goldmann announced that 'a large number of Jewish organizations around the world represented in the Combrence of Jewish Organizations, have presented to Pope John XXIII a memorandum asking the Ecumenical Council to adopt "a clear statement of the Chruch against racial and anti-Semitic tendencies and the elimination from the Catbolic liturgy and Catechism of passages which inseminate anti-Jewish prejudices among millions of Catholic children."

He expressed the "confident hope" that the Council "will take positive action to combat aggrous anti-Semitic prejudices, stating that "such action would be acknowledged with deep satisfaction by the Jewish community everywhere." He expressed "satisfaction" over the advance planning for the Council by the Vatican under the direction of Cardinal Agustin Bea.

The Jewish leader expressed "deep concern over the future of the Jewish community in Algeria, despite the rights and guarantees given them under the Evian agreement. He stated: "The confused situation, full of violence and crimes perpetrated by the OAS terrorists, which unfortunately still prevails in Algeria, threatens the Jews possibly more than other parts of the European community. The Jews in Algeria, not less than all others, have a great stake in the quick restoration of law and order."

Dr. Goldmann expressed the hope that within its limited possibilities, the Jewish community in Algeria will contribute to the efforts of the French Government to implement the Evian Agreements and bring about a new era of peace and presperity "to that unhappy country," "Whatever may happen in Algeria," he said, "it is clear that many Jews will leave and are leaving.

"Most of them go to France and their influx creates very serious problems for the rench Jewish community. It is the duty of world Jewry to help French Jewry to take care of the Algerian newcomers, both materially and culturally. At the same time, it is to be hoped that more and more will go to Israel, where the government and the Jewish Agency stand ready to absorb and settle them."

HAUSNER, EICHMANN PROSECUTOR, URGES ISRAEL SUPPORT AS HOLOCAUST REPLY

WASHINGTON, May 15, (JTA) -- An appeal to American Jewry for "a supreme effort to secure the existence" of Israel, as an implementation of "the desire" of the 6,000,000 Jows murdered during the Nazi era, was sounded here tonight by Israel Attorney General Gideon Hausner. He delivered the principal address to more than 1,200 delegates and guests at B 'hai B 'rith's triennial convention banquet.

Avoiding any direct reference to the Addf Eichmann trial, in which he served as Israel's chief prosecutor, Mr. Hausner, a surprise speaker whose appearance was not previously announced, said that the moral to be learned from the Nazi holocaust is that "every surviving Jew has now to do for his people not only what he would have done anyway, but more. Included in the audience that heard him paint a dramatic and moving picture of Nazi brutality were Government officials, members of Congress and representatives of the diplomatic corps.

The Israeli official asserted that Hitlerian terror has left world Jewry "crippled," and said that, to assure continuance of Jewry's existence, "we must make up for the cataclysmic losses in manpower and spiritual values." Pointing out that Israel offered the basis for such hope, he asked for "a supreme effort to secure its existence, to insure its development so that it will be able to implement the hopes which hinge upon it. We will surely thereby implement the desire of those 6,000,000 who have constantly prayed and yearned for the State, but never lived to see it, "be said.

He called also for greater concern in Jewish problems on the part of all world Jewry. "We must look for proper solutions, we must strengthen our Jewish education, in other words," He added, "We must be even better Jews than we are," He warned that the world must be on constant alert against a resurgence of the anti-Semitic terror which stalked Europe under Hitler. "Hatred must be faced and combated, he said, ""Wherever we recognize the well-known signs of anti-Semitism, of prejudice, of the denial of a common obligation between one human being and others, they must be denounced and fought."

B'nai B'rith Leaders Confer with Kennedy, Present Symbols of Judaism

Earlier in the day, leaders of B'nai B'rith, led by Mrs. Moe Kudler, of Los Angeles, president of B'nai B'rith Women, and Label A. Katz, of New Orleans, national president of B'nai B'rith, conferred privately for over a half-hour with President Kennedy. Mr. Katz said the discussions ranged over matters pertaining to civil rights, Soviet Jewry, and the Middle East. The delegation, he said, found the President's reactions on these issues "re-assuring."

The B'nai B'rith leaders presented to the President a silver relief design including a seven-branch menorah flanked by the "lamp of learning" and the Ten Commandments. The work had been executed by William Myers, of Newark, N. J. Included in the delegation at the White House were Maurice Bisgyer, executive vice-president of B'nai B'rith; and Frank Goldman, of Lowell, Mass., honorary president of B'nai B'rith.

Javits, Humphrey Address Convention; Dr. Salk Honored

The guest of honor at the banquet tonight was Dr. Jonas A. Salk, developer of antipolio vaccine. He was presented with a citation for his achievements. Another principal
speaker, in addition to Mr. Hausner, was Senator Jacob K. Javits, New York Republican,
who told the audience that American failure, thus far, to accede to the United Nations Convention Against Genocide is inconsistent "with our position of championing the rule of law in
the conduct of nations."

Senator Javits told of opposition to the Genocide Pact, voiced in 1953 by the late Secretary of State John Foster Dulles, on the grounds that the Soviet Union and some of its satellite states had ratified it. He quoted Mr. Dulles as testifying before the Senate Judiciary Committee at that time that "the solution of the problem as envisaged by that *reaty could better be reconsidered at a later date."

Citing the problem in more current terms, Senator Javits asked: "Who has not felt a tremor of fear at the recent reports of the nature of Soviet persecution of Jews for alleged economic offenses. As long as the spectre of genocide continues to haunt: mankind," he said, "the United States has a basic international obligation to assume the responsibilities of this Convention,"

In an address last night, Democratic Senator Hubert Humphrey, of Minnesota, majority whip, told the convention be would 'never be content until our foreign policy has been able to bring 'about a fulfillment of the 'unfilled commitment in the Middle East,' Without specific reference to any current events, Senator Humphrey cited as one of those commitments the United Nations pledge in 1956, guaranteeing Israel free access to international waterways.

Asserting that "Israel's example of freedom in the Middle East is a powerful force," the Minnescta lawmaker said that, although there are Congressional critics of U.S. aid to Israel, "they will never win out."

AMPAL TO INVEST \$10 MILLION IN ISRAEL AS PART OF \$50 MILLION PROGRAM

NEW YORK, May 15. (JTA) -- AMPAL--American Israel Corporation will invest \$10,000,000 in Israel this year in the first phase of a \$50,000,000 investment program to be carried out over the next five to ten years, Abraham Dickenstein, president of AMPAL, announced today.

Mr. Dickenstein told a meeting of the AMPAL Board that this year's investments would be in expansion of the productive capacity of major industrial exporters, in construction of upper and middle-income apartment houses, and in purchase of heavy equipment for Israel's largest construction company.

VETERAN U.S. ZIONISTS HONOR LOUIS LIPSKY, ELECT OTHER OFFICERS

NEW YORK, May 15. (JTA) -- Louis Lipsky was elected honorary president of the Brith Rishonim of the United States, an organization of veteran Zionists whose affiliations date prior to 1930, at the organization's annual meeting here.

Dr. Samuel Margoshes was elected president; Dr. S. Federbush and Robert Szold, vice-presidents; Meyer Brown, treasurer; and Morris Margulies, honorary secretary, Paul L. Goldman, Rose L. Halprin, Rabbi Mordecai Kirshblum, Dr. Joseph Schechtmen and Louis Segal were elected to the board.

AMERICAN JEWISH COMMITTEE ESTABLISHES JEWISH PROFESSORSHIP AT ST. LOUIS

ST. LOUIS, Mo., May 15. (JTA) -- A professorship in Jewish History and Hebrew Language will be established at Washington University here, it was announced today by the University and the American Jewish Committee which has undertaken to raise \$75,000 to underwrite the professorship for a five-year-period.

Addressing the annual dinner meeting of the St. Louis chapter of the AJC, Thomas H. Eliot, chancellor-elect of the University, thanked the Committee for the initiative in making the professorship possible. Similar chairs in Jewish learning now exist at leading American universities.

Dr. John Slawson, executive vice-president of the AJC, commended Washington University and declared: "The creation of the professorship in Jewish history, culture and the Hebrew language will result in a significant contribution, anot only to the cultural life of St. Louis, but to American life itself."

BAR-ILAN UNIVERSITY PRESENTS VALUABLE BIBLE TO GOVERNOR ROCKEFELLER

NEW YORK, May 15. (JTA) -- A hand-wrought, silver-encrusted Bible was presented today to Governor Nelson A. Rockefeller, at his office here, by Bar-Ilan University of Ramat-Gan, in appreciation for a rare lithograph of Abraham Lincoln given to the university by the Governor last February.

Rabbi Joseph A. Lookstein, acting president of Bar-Ilan, expressed appreciation of the Administration and student body to Mr. Rockefeller for the gift, and told him that the portrait and the flag of the State of New York would be ompermanent exhibition on the campus. A science building on the Bar-Ilan campus bears the name of Abraham Lincoln.

'JUDGMENT AT NUREMBERG, ' EICHMANN TRIAL TV BROADCASTS, GIVEN AWARDS

NEW YORK, May 15. (JTA) -- The National Council on Jewish Audio-Visual Materials, sponsored by the American Association for Jewish Education, has awarded a citation to the film, "Judgment at Nuremberg," for its "eloquent and dramatic presentation of the relationship of law to man's moral obligations," it was announced today.

The Council, at a session attended by representatives of 41 national Jewish communal and education agencies, also presented a citation to WABC-TV of New York, for its divenights-a-week, 30-minute coverage of the Eichmann trial, in Jerusalem. The sponsor, Louis J. Glickman, was also cited.

Other awards went to the Keren Hayesod for a 16mm film, "Years of Destiny"; to the Commission on Jewish Education of the Union of American Hebrew Congregations for "Rav and Samuel: Teachers of Talmud"; and to the Bureau of Jewish Education of the Jewish Federation-Council of Los Angeles for outstanding audio-visual services,
