SELE SHUMACHER, ABDUCTED ISRAELI BOY, DISCOVERED IN UNITED STATES

WASHINGTON, July I. (JTA) -- Yossele Shumacher, the Israeli boy abducted in el three years ago, has been found in the United States and is now in the protective ody of the U.S. Immigration Service, it was made known here today. His mother, stael, has been notified, and is on her way here to make formal identification, She, presumably, be permitted by the American authorities to take him back with her stael.

Cossele was abducted in Israel in 1959. He is about 10 years old now. Israeli orities have searched for him on three continents. His grandfather, in Israel, was d for refusing to reveal the boy's whereabouts. His uncle, Nachman Shtarkes, is ill in England, awaiting a court ruling on Israel's petition that he be extradited for aping the boy. Is raeli authorities have contended since he had been missed by his nts in 1959 that ultra-Orthodox persons abducted him for fear that his parents at not give him a sufficiently Orthodox education.

Recently, Israeli authorities found that a youth in Israel was receiving mail from man in the United States who seemed to have Yossele in her custody. Israeli offitiraced her address and notified American authorities who, thus, located Yossele is country.

It is understood that the woman who had charge of Yossele had trasted with him in ours countries, using various false names for the boy. She had brought him to country under the name of "Yaacov Gertner." It could not be determined today her U.S. authorities are planning prosecution of any person or persons responsible he child's illegal eatry into the United States,

ENTINE POLICE FIRE ON JEWS GUARDING SYNAGOGUE; SITUATION TENSE

BUENOS AIRES, July l. (JTA) -- Tension continued to prevail today among Jews rgentina, following a clash between police and Jewish youths guarding a suburban gogue from possible attacks by anti-Semitic hooligans. A police in spector and Jewish youth were wounded in the exchange of fire.

The police were watching the Jewish youths from a German-made Volkswagen car hi snot usually used by police authorities. The car provoked suspicion on the part is Jewish guard and was therefore stopped by the Jewish youths. The youths asked occupants -- who later turned out to be policemen in civilian clothes -- to identify selves. As the Jewish youths demanded that the occupants show their identificadocuments, the latter opened fire, wounding one of the Jews. The Jewish youths med the fire, seriously wounding a police inspector.

Manwhile, two Argentine young men were arrested, both admitting membership in right-wing organizations, both armed. One, found carrying a revolver, was caught edical students during a demonstration against anti-Semitism. This man, 21-year-orge Steffens Soler, admitted he was a member of the anti-Semitic Tecuara move. The other, 17-year-old Juan Daniel Zverko, was captured after several youths roken a window and tossed a Molotov cocktail into a Jewish store. Zverko was carrying a package containing another Molotov cocktail. He admitted membership extremist Guardia Restauradora Nacionalista.

Jewish anxiety has grown since a 19-year-old Jewish girl, Craciela Sirota, was sted by hooligans and subjected to disfigurement by a swastika cut into her body. It central Argentine Jewish organization, DAIA, conducted a full business stop-protesting that attack, a second atrocity came to light. Interior Minister Assures Action Against Anti-Semitic Terrorists

Dr. Carlos Adroguq, Minister of the Interior, declared at a press conference yesy that the Government will respond to the series of anti-Semitic attacks "in the serious and most effective manner possible," He made that statement following c with Argentine President Guido. The latter had received a report on the ocnees from the police chief, Captain HGCacio Enriques Green, who had been accused by the Jewish community and by many leading Argentine educators, newspapers and broadcast stations of laxity in probing the anti-Semitic attacks.

"I have asked the rectors of Buenos Aires University, Dr. Adrogue said, "I have asked the rectors of Buenos Aires University, and the faculties, to contact the police chief for guarantees of security and order, requesting the police to repress any attack with maximum energy."

"The Government," continued Dr. Adrogue, "is ready to take concrete, effective and efficient measures. In:my opinion, the events are the product of the passionate attitude of small sectors of our population which are not systematically organized. But repetition of events, and impunity, have given a character of gravity to the events. The man in the street thinks that there is too much passivity in repressing such actions. I give you the most absolute assurance that the Government has an irrevocable decision to act in the most serious, most effective manner possible with all means at its disposal.

"Naturally, technical difficulties may have at times made difficult that application of concrete measures. But the Federal police and other Government organs have received strict orders and I hope that, if there has been some laxness, this will be modified in the most effective way."

Police Chief Charged with Laxity; Jews Protest His Statement

Police Chief Green was reported reliably to have offered his resignation as a result of the charges that he has been lax in following up on DAIA's protests against anti-Semitism The latest of these protests were filed with him at least a week prior to the attack on Miss Sirota, and Capt. Green reportedly failed even to reply to the Jewish organization's notification that trouble was mounting.

Green's resignation was rejected by the Government. But it was made clear here today that the Minister of the Interior, to whom Captain Green is directly responsible, has taken over personal jurisdiction of the entire series of anti-Semitic developments, Dr. Adrogue's assurances were, thus, seen as confirmation of the report that Capt. Green's jurisdiction over the anti-Semitic attacks has been taken over by Dr. Adrogue personalty.

The DAIA is particularly incensed over Capt. Green's statement in which the police chief accused the Jewish organization of "taking the law into its cwn hands" through last week's protest business stoppage. The stoppage was widely supported by many non-Jewish businesses which also closed their doors,

In an open letter to Capt, Green, published in all major Buenos Aires newspapers, DAIA stated its officers "had read with profound surprise your expressions attributing to DAIA and to other Jewish institutions an allegation that they are a 'menace' and 'taking the law into their own bands.' Respectful as always of legal norms, DAIA rejects categorically such imputations, stressing again that "the DAIA orly saks for punishment of the culprits who have lately disturbed Argentine public opinion, particularly that of the Jewish community. In regard to the gravity of the latest event, and in order to stress this orientation, the DAIA asked on June 21 for an urgent interview with the Folice chief-which still has not been granted,"

DR. SOBLEN DEPORTED FROM ISRAEL; TRIES TO COMMIT SUICIDE ON PLANE

TEL AVIV, July l. (JTA) -- Dr. Robert A. Soblen, the psychiatrist convicted in the United States of espionage, who flew here last week to escape a life sentence, was deported from Israel early this morning. He was placed aboard an El Al Britania airplane making its first stop in Athens. The Greek and American Governments have an extradition treaty permitting the man's immediate transfer into the hands of American authorities at Athens.

(Dr. Soblen tried to commit suicide on the plane on which he was being taken from Athens back to New York, and was placed in a hospital in London this afternoon after the plane landed at the London airport en route to New York. He was nabbed by five American agents of the Federal Bureau of Investigation as soon as the El Al plane bringing him from Israel landed at the Athens airport. Aboard the plane, he tried to slash his wrists with a razor blade and to stab himself with a steak knife.)

Moshe Haim Shapiro, Israel's Minister of the Interior, signed the deportation order Friday, after conferring with Prime Minister David Ben-Gurion, but implementation of the order was deferred until after the Sabbath, Dr. Soblen was informed last night that he would be deported early in the morning. Israeli authorities explained they were determined to send Dr. Soblen out of the country "to dissuade other Jews, convicts or criminals, from considering Israel as a place of shelter from justice."

ANTI-JEWISH DEMONSTRATION IN LONDON BOOMERANGS; 12 PERSONS ARRESTED

LONDON, July I. (JTA) -- A demonstration of the National Socialist Movement held at Trafalgar Square here today under the slogan, "Free Britain from Jewish Control" turned out to be a complete fiaseo. The crowd of five thousand, made up almost completely of organized groups that normally oppose fascism in Britain, kept up a continuous barrage of ironical cheers, chanting and singing so that it was impossible to hear the anti-Jewish triades of the speakers.

The Police were forced to suspend the meeting three times for fear of violence, and arrested 12 persons.

Z.O.A. CONVENTION CLOSES WITH APPEAL TO U.S. ON DIRECT ARAB-ISRAEL TALKS

WASHINGTON, July I. (JTA) -- The 65th annual convention of the Zionist Organization of America concluded here today with resolutions calling upon the United States Government "to press for the settlement of the Arab-Israel dispute peacefully through direct negotiations," The resolution voiced "regret that United States representatives found it necessary to oppose the resolution sponsored by 16 small nations during the 16th United Nations General Assembly, advocating direct negotiations between Israel and the Arab nations."

Another resolution noted "with appreciation" President Kennedy's greeting to this year's convention, in which the President voiced a desire for "peace and prosperity in the Middle East," The ZOA urged the Government to take "resolute and consistent measures to promote these ends and thus counter the mounting dangers to the peace of the world inherent in the threat of a new conflagration in the Middle East."

Resolutions were adopted urging continued American economic aid to Israel and also that Arab political exploitation of the Arab refugee issue be "squarely faced by our Government." Another resolution noted "with growing concern the continued threats of the Arab countries to renew full-scale hostilities, threats escalated through the stepped-up flow of modren arms to the Arab countries, and in particular to Egypt, supplied by the Soviet Union."

This was followed by a resolution stressing that economic development of the Middle East is retarded by increased arms expenditures. Continued aid to the region was urged, but the Government was asked to take into account "that such aid should not contribute to the military build-up of those states threatening the stability of the entire Middle East."

Deplore Rift in General Zionism; Elect Dr. Nussbaum as President

A resolution deplored the "rift in General Zionism" and regretted that efforts to unify the two existing World Confederations of General Zionists have failed. In the absence of an early agreement, ZOA said, the World Confederation of General Zionists with which it is affiliated should convene a world conference of all General Zionists organizations that "are prepared to associate themselves with this effort for unity."

It was resolved that "any world union of General Zionists must provide for adequate representation and participation of the General Zionists in Israel, formerly divided and now happily united."

Dr. Max Nussbaum, of Los Angeles, veteran Zionist leader and rabbi of Hollywood's Temple Israel, was elected president of the Zionist Organization of America at the closing session of the convention. He succeeds Max Bressler, of Chicago.

In his acceptance address, Dr. Nussbaum disclosed that, during the convention, he conferred privately with President Kennedy at the White House on Israel-American problems. Dr. Nussbaum said he was satisfied that American policy has not changed from the views enunciated by President Kennedy at a ZOA convention in August 1960, He expressed a conviction that the President remained devoted to Israel's security and the objective of Near Eastern peace. Dr. Nussbaum stressed American economic assistance to Israel.

Dr. Neumann Assures Friendship to Kennedy Administration

Dr. Emanuel Neumann, honorary president of the ZOA and member of the Jewish Agency executive, told the convention that "though our confidence in the present Administration has been strained at certain moments, it has not been impaired."

Dr. Neumann said that "we have nothing but friendship toward the Administration headed by President Kennedy. Despite some painful disappointments we have experienced, we do not question his friendship toward Israel and the sincer ity of his desire to carry out the pledges he made to our own organization in 1960."

He speculated that some "disappointments" arose from shortcomings in communication. To remedy that, he said, "in the past few days, important contacts have taken place on a high level, and there is a prospect that lines of communication, which have been established, will be kept open so that we may gain a better insight into the mind of our Administration and policy-makers--and vice-versa."

Dr. Neumann nevertheless stressed that Zionists could not ignore "the fantastic milirary build-up of Egyptian power." He said that, while there was a "bedrock of Israel-American friendship, basic principles needed translation into deeds consistent with declared objectives.

Senator Jacob K. Javits, New York Republican, strongly attacked the Administration's Near Eastern policy before the convention. He cited indirect American financing of Egypt's Soviet arms purchases, and named President Kennedy and American UN Ambassador Adlai Stevenson in connection with what he said were failures to protect Israel and Jews.

Rep. Seymour Halpern, New York Republican, announced that he will offer an amendment to the Mutual Security Act in the coming week to bar assistance to Egypt because of the disclosure of Egyptian purchase of the new Soviet MIG-21 missille-firing jet fighters.

UNITED HIAS SERVICE HAILS NEW LAW ON ADMISSION OF REFUGEES TO U.S.

NEW YORK, July I. (JTA) -- The new bill on admission of refugees to the United States, signed by President Kennedy last Thursday, was hailed here today by Murray I. Gurfein, president of the United Hias Service. The bill provides the basis for continued U.S. participation in international refugee assistance programs.

The new act, Mr. Gurfein said, "for the first time in our history establishes refugee legislation with no terminal date." Pointing out that the U.S., now had a permanent method of admitting certain categories of refugees, Mr. Gurfein said this means that "there no longer is any cut-off date for the migration assistance United Hias Service is giving to refugees from Europe and Egypt who desire to emigrate to this country,"

"The new refugee aid law is a landmark in refugee lagislation and renews our confidence in the ultimate passage of a revised non-discriminatory immigration and nationality-act," Mr. Gurfein continued. He stressed that the United Hias Service has already assisted approximately 2, 000 refugees to come to this country under the previous law on admission of refugees, "The permanent extention of provisions for refugee aid enables us to assist those now calling upon us for belp in even greater numbers than during the past two years," he stated,

FOUR JEWS IN NEW CANADIAN PARLIAMENT; LARGEST NUMBER IN HISTORY

OTTAWA, July l. (JTA) -- When the new Canadian House of Commons convenes, it will have the largest number of Jewish members in the history of Canada, four Jewish candidates having won in the recent national election.

They are Leon D. Crestohl, who was re-elected as a Liberal member for Montreal-Cartier, which he has represented for the past 12 years; David Lewis, national vice-president of the New Democratic Party, elected for Toronto York South; Herbert Grey, a Liberal, who was elected in Essex West, Windsor; and David Orlikow of the New Democratic Party, who was elected in Winnipeg North.

MIAMI ANTI-SEMITE GETS SIX MONTHS FOR ATTEMPTING TO BOMB SYNAGOGUE

MIAMI, July l. (JTA) -- A former Miami city employe was convicted here this weekend on two counts in the attempted bombing of a synagogue and sentenced to serve three years in prison on each count.

Donald Branch, 26, was convicted in a Dade County court of possessing and transporting explosives. The jury deliberated less than three hours after hearing evidence which included tape recordings of conversations Branch had had with Stefan Plumacher, an undercover police agent, which were filled with lewd and vicious anti-Semitic remarks. The tapes were offered in support of Dade County State Attorney Richard Gerstein's contention that Branch plotted with the undercover Miami policeman the attempted bombing of Anshe Emes Synagogue last April 28.

Branch faces another and more serious charge on July 23 when he faces trial on charges of bombing the home of DonShoemaker, editor of the Miami Herald, last February. Conviction would mean a possible 20 years to life sontence. A number of leading South Florida Jews were allegedly targets of an assassination plot by Branch.

AUTOMOBILE WORKERS UNION IN DETROIT BUYS \$100,000 IN ISRAEL BONDS

NEW YORK, July 1. (JTA) -- The United Automobile Workers of America, AFL-CIO, purchased \$100,000 in State of Israel Bonds at a dinner given by the Detroit Jewish community in honor of Mrs. Franklin D. Roosevelt. Last year, the UAW purchased an equal amount at a tribute to its president, Walter Reuther, which was sponsored by the Israel Bond Organization of Detroit.

Mr. Reuther joined more than 800 men and women at the dinner in paying tribute to Mrs. Roosevelt, and in stressing the importance of Israel as a democratic nation. Sales at the dinner brought to more than \$500,000 the amount in Israel bonds sold in Detroit in the first six months of the year.

86 STUDENTS LEAVE U.S. FOR ISRAEL TO ATTEND SUMMER PROGRAM

NEW YORK, July 1, (JTA) -- Eighty-six high school and college students from 13 states departed for Israel today in the sixth annual Yeshiva University "Youth Summer in Israel" program. Included in the tour are participants from New York, Pennsylvania, Illinois, Connecticut, Maryland, Massachusetts, Kansas, Colorado, New Jersey, Michigan, Oklahoma, Olio and Elorida, as well as Canada.

MONUMENT TO 4,000 JEWS KILLED BY NAZIS IN ZAGREB UNVEILED IN CITY

ZAGREB, Yugoslavia, July 1. (JTA) -- A monument to the memory of the four thousand Jews of this town who were murdered by the Nazis, was unveiled here. The inscription on the memorial states that the Jews had been "tortured by the Fascist Amalekites."
