U.S. APPROVES \$35,000,000 LOAN TO ISRAEL; REPAYABLE IN TWENTY YEARS

WASHINGTON, July 4, (JTA) -- The United States Government has approved a loan of \$35,000,000 for Israel from the Development Loan Fund, it was learned today.

The loan is to be used in the framework of the Israel development plan for the process of goods and services in the United States. Among the items to be financed under the loan are computers, steel, non-ferrous metals, trucks, construction equipment, chemicals, pharmaceuticals, plastics and other materials. The loan is for a period of 20 years at three-quarters of one percent interest with no repayment of principal for the first five years.

Meanwhile, it was made known that Israel Ambassador Avraham Harman has met with high Commerce Department officials to open negotiations on the cotton products quota question.

ARGENTINE MINISTER TALKS TO NATION AGAINST ANTI-SEMITIC OUTBREAKS

BUENOS AIRES, July 4. (JTA) -- A statement condemning the current outbreak of anti-Semitism in this country in sharpest terms, warning that the Government would take every legal step to suppress racist activities and the forces responsible for such anti-Jewish practices, was made here last night by Dr. Carlos Adrogue, Minister of the Interior.

Addressing the nation over the combined radio and television networks, Dr. Adrogue made the Government's position on the current racist situation absolutely clear. He was immediately praised by Dr. Isaac Goldenberg, president of DAIA, the central organization of Argentine Jewry. Dr. Goldenberg told the Jewish Telegraphic Agency: "Never has a governing Minister in Argentina been so outspoken in condemning a process which dates back several years. He will have the support of public, democratic opinion in all Western lands."

In his statement, Dr. Adrogue told the nation: "The citizens may be absolutely e-rtain that this Government will be firm and decisive in taking sanctions against those who start and sustain a climate of insecurity and insubordination resulting in riolence. The Government has a duty not to permit such excesses. In the fulfillment of its duty, the Government will be inflexible. This should be every clear, solated and presumably separated, they (the racist agitators) show a synchronization which is characteristic of subversion."

Says Attacks on Jews Are 'Unacceptable' to Argentine Civilization

Dr. Adrogue noted that "apparently, racist attacks, which public opinion does not ee with clarity," have brought about some "illegal mobilization by those who are preared to repress" these attacks themselves. He was referring to some Jewish self-efense units which, last week, engaged in an exchange of pistol fire in which a Jew-sh youth and a police inspector were wounded, while the young Jews were trying to uard a suburban synagogue against Nazi attacks. He deplored such actions, declaring nees too as illegal.

"Without pondering on one or two cases, which the judiciary will have to clear up, must be stated that the attacks against our Jewish compatriots, against temples dedited to their religion, against institutions for public welfare which have their headarters in such establishments, against their homes, all these are not characteristic 'Argentinas' way of life, and are unacceptable in our civilization,

"Such acts are even more absurd in our country, with a great preponderance of atholics among our population. Such acts signify rejection of the words and feelings Pope John XXIII and of the Catholic Church hierarchy in our country.

Praises 'Fruitful and Laborious' Efforts of Argentine. Jewry

"It is not necessary to point to the fruitful and laborious efforts by the hundreds thousands of our Jewish compatriots to stress conscientiously that these attacks incre our Fatherland and present us before the world in a seriously-distorted image.

"In my capacity as a Minister, I make known to all residents of our country that antional Government assumes the pledge to repress these shameful activities, and

I assure all that the Federal police and other Federal forces have acted and will act by conviction and by duty to make the Government's purposes effective.

"The Government will prosecute energetically and with every means at its disposal those groups which have created a climate making possible events of such a character which can be exholited by Communists."

Dr. Adrogue said the Government will employ, when necessary, these steps: "Closing premises; prohibiting any means of expressing attacks against the Jewish community or its members or any other religious or racial group; exhaustive investigation of individuals accused of such acts and so-called 'ideologies' that encourage them; and cancelation of the licenses of political organizations which proclaim anti-Semism."

"These," he said, "are some of the means we shall employ to combat those (racist) purposes. I ask for serenity and for confidence in my words--which will be supported by facts,"

Catholic Hierarchy Issues Statement; Asks Government to Act

Today, a statement on the situation in the country was issued by the Argentine Catholic hierarchy, consisting of the Cardinal, the Archbishops and the Bishops. The statement read: "We consider it our duty to denounce as dangerous a series of armed attacks against persons, institutions and groups carried out by as-yet unidentified, and therefore more dangerous, assailants.

"While the authers of these acts are as yet unidentified, we resist the belief that such infamous contradictions can be real among the baptized. It is necessary to state, however, that the State must put an end to such activities which, in this moment, could lead to the introduction of actions of greater excess against the sacred right of nersons and institutions."

Preceding Dr. Adrogue on the radio-TV network was an interview with Capt. Raul Angelini, a naval officer who, this week, resigned from his post as head of the Federal police department's division of anti-democratic activities (the equivalent of the FBI in the United States).

Captain Angelini accused the DAIA of being "a communist instrument," He stated that not only is the DAIA such an "instrument," but that the entire Sirota case is "a communist fabrication," He was referring to the case of Miss Graciela Sirota, the 19-year-old Jewish medical student at the Buenos Aires University, who last week was captured by unidentified thuge who engraved a swastika on her body.

"The entire agitation," said Capt. Angelini, "is a Communist fabrication, an attempt to divert attention from various financial scandals in which the Jews are involved."

YOSSELE EXPECTED IN ISRAEL; COURT ORDERS RELEASE OF HIS GRANDFATHER

JERUSALEM, July 4. (JTA) -- The Israel Supreme Court approved today a request for the release from prison of Nachman Shtarkes, grandfather of Yossele Schumzcher. The ruling was handed down while the ID-year-old boy, found in Brooklyn Saturday night, was en route here by plane with his mother, Mrs. Ida Schumacher, and his 14-year-old sister, Zina.

The boy and his mother and sister were due at Lydda Airport this afternoon. They departed from New York's International Airport early today aboard an El Al Israel Airlines plane, after the mother had spent 36 hours in New York, where she form, identified him as her son and obtained his release from authorities of the U.S. Immigration Service,

The elderly Mr. Shtarkes had been in prison more than two years, after refusing to heed a court order to help Israel authorities to trace the child, kidnaped in 1959, when the grandparent refused to surrender him to the parents, Alter and Ida Schumacher. The grandfather had feared that the Schumachers would not give the boy an education of sufficient Orthodoxy. Originally arrested on the complaint of the Schumachers, the grandfather was ordered released on a petition filed by the Schumacher's counsel.

It appeared unlikely however that Israeli authorities would abandon their efforts to obtain the extradition from Britain of the boy's uncle, Shalom Shtarkes, who is under custody awaiting the outcome of extradition proceedings. Israel asked his extradition on charges of perjury and complicity in the abduction. Officials indicated also that they intended to press charges against others involved in the abduction and hiding of the boy since 1959.

JEWISH AGENCY READY TO ACCEPT CHILDREN FROM ALGERIA WITHOUT LIMIT

JERUSALEM, July 4. (JTA) -- The Jewish Agency executive planned today to continuous its discussions on the extent of aid needed for Algerian Jewish refugees after hearing a report that the Youth Aliyah department had already responded to requests from French Jewish communal agencies. The department reported it had sent additional instructors to France and announced its readiness to accept without limitations all Algerian Jewish children.

CONFERENCE OF GOVERNORS BACKS PRAYERS IN SCHOOLS: PETITION CONGRESS

NEW YORK, July 4. (JTA) -- With only Governor Nelson A. Rockefeller of New York abstaining, the governors of the other 49 states voted yesterday at their annual conference in Hershey Pa, to petition Congress to adopt a constitutional amendment that would invalidate the Supreme Courts ruling against official prayers in public schools.

The resolution adopted by the governors urged "the Congress of the United States to propose an amendment to the Constitution of the United States that will make clear and beyond challenge the acknowledgment of our nation and people of their faith in God, and permit them the free and voluntary participation in prayer in our public schools."

The chairman of the Governors Conference announced after the measure had been passed that adoption was "unanimous." However, Gov. Rockefeller immediately arose to announce he had abstained. Later, the New York State chief executive said:

"The freedom of every person to worship or not to worship, as his conscience dictates, is fundamental to American society. Until the whole question can be considered in terms of the fundamental precept of freedom of religion, which was the basis of the constitutional provision upon which the Supreme Court based its opinion, I shall abstain from the endorsement of any hasty action by the Governors relating to amendment of the Constitution of the United States. Any such proposal should certainly have the fullest possible study and discussion before the Governors offer an ordnion."

In New Jersey, that state's Governor, Richard J. Hughes, stated that he would fight efforts to invalidate New Jersey laws dealing with school prayers. In 1950, the New Jersey State Supreme Court had upheld laws making it mandatory to teach in the public schools five verses from the Old Testament. Another law permits recital of the Lord's Prayer in public schools.

In Tuckahoe, N.Y., Mayor Milton A. Gibbons reported he had received 3,500 signatures to a petition that would ask President Kennedy and Congress to impeach the six U.S. Supreme Court justices who voted against prayers in public schools, The petition would also ask Congress to pass a Constitutional amendment whichwould specifically permit prayers in the schools, Mayor Gibbons, a Democrat and a Kongress Catholic, said he would seek circulation of the petition in other states and localities around the country.

In Washington, Label A. Katz, national president of B'nai B'rith, addressing the 6th regional convention of B'nai B'rith, deplored "the abusive nature" of criticism directed against the Supreme Court, calling such attacks "a disturbing demonstration of irreligious behavior in the name of religion." He condemned all "provocative slanders" directed against the Court by public officials.

In Philadelphia, Rabbi Morris Pickholz, president of the Board of Rabbis, issued a statement on behalf of the Board, "welcoming" the Supreme Courts decision. "The Court," he said, speaking for the entire Board, "has done the country and religious liberty a great service in summoning us back to first principles--namely, that in the American system, religious education is not the province of Government,"

A number of leading Protestant clergymen in this city, preaching their first set sermons since the Supreme Court handed down its prayer ruling, took a favorable view of the High Tribunals decision. Such a stand was taken, among others, by the Reverend John M. Krumm, Columbia University chaplain; and by the Rev. Dr. Lawrence L. Durgin, of the Broadway Congregational Church, who declared the court's ruling "deserves general applause." However, other Protestants, as well as Cathdic clergymen, criticized the High Court's stand,

BRITISH GOVERNMENT TO CURB ANTI-SEMITIC RALLIES IN LONDON

LONDON, July 4. (JTA) -- The British Government gave assurances last night that stronger measures would be used in the future against the kind of pro-Hitler and anti-Jewish agitation which sparked a riot in Trafalgar Square Sunday during a meeting of the British National Socialist movement,

The assurance was given in the House of Commons by R.A. Butlen Home Secretary, as demands rose for the dismissal of the party's leader, Colin Jordan, from his teaching job in Coventry. The Home Secretary said police had not expected the violence that erupted in response to the anti-Semitic speeches at the meeting.

He said in the future police would act more strictly in such situations and that there was a possibility that the Nazi speakers would be charged with violation of the Public Order Act. Twenty persons, including a number of Jews, were arrested and fined for breaking through police lines at the riotous meeting.

As press condemnation grew against the inflammatory speeches voiced at the meeting, other Government officials indicated that the British Nazi group probably would not be given permission again to hold public rallies, Government spokesmen had consistently argued, in response to complaints in Parliament prior to the meeting, that barring it would be a violation of free speech.

U.S. INVESTORS TO GET HALF OF SHARES IN ISRAEL CHEMICALS COMPANY

JERUSALEM, July 4. (JTA) -- The Negev Phosphates Company and Fertilizers and Chemicals, Ltd., are to be merged under a decision taken by the Israeli Cabinet, it was announced here today.

Half of the shares in the new company will be taken over by the American Investors Corporation, headed by Sam Rothberg, which originally had an option to acquire 80 percent of the Fertilizers and Chemicals firm. An agreement on the merger was reached two weeks ago between the two companies and the Ministry of Development,

JERUSALEM MUNICIPALITY NAMES STREET AFTER LATE RABBI STEPHEN S. WISE

JERUSALEM, July 4. (JTA) -- A street was dedicated here by the city today in the name of the late Rabbi Stephen S. Wise. The new Stephen S. Wise Street is in the area where the Israel Government's complex of buildings is being constructed.

Mayor Mordechai Ish-Shalom, who presided at the ceremonies, read a message from Prime Minister David Ben-Gurion, who declared: "Stephen Wies's name is linked unalterably to the land of Israel. Along with the late Justice Louis D. Brandeis, Rabbi Wise was the greatest leader of American Jewry in the first half of the Twentieth Centure."

Among the participants in the ceremonies were Moshe Sharett, chairman of the Jewish Agency executive; and Dr. Nelson Glueck, of Cincinnati, president of Hebrew Union College-Jewish Institute of Rel gion; and Dr. Avraham Granott; president of the Jewish National Fund. Attending were also a group of 40 Israel bond leaders from Chicago. The ribbon to the new street was cut by a member of that group, J. Krensky, of Chicago.

TWO ROCKWELLITES ARRESTED IN MIAMI; CARRIED ANTI-JEWISH PLACARDS

MIAMI, July 4. (JTA) -- Two members of George Rockwell's American Nazi party were arrested yesterday while they were picketing in downtown Miami when a crowd of several hundred onlookers threatened them with bodily harm.

The two, Roger C. Foss and Gene Slaydon, wore khaki uniforms and carried crudely made placards which read: "Eighty-five percent of convicted Communists are racial Jews," The pair was spirited away by metropolitan police when one member of the crowd jumped one of the Nazis and tore his placard away.

The two men, who admitted to membership in the Rockwell group, apparently arrived from Arlington, Va., Rockwell's headquarters, to picket the Congress of Racial Equality convention in Miami last weekend. But they had evidently been mixed up on the dates. The CORE convention was over before they arrived. The picketing also was aimed at the Anti-Defamation League Florida office.

A spokesman for the Dade County State Attorney's office said he understood the two Nazis had been taken into custody for their own protection. But Miami police officials said that the two were arrested on charges of disturbing the peace, assaulting a police officer, inciting to riot, and possible vagrancy.

THREE PICKET N. A.A.C.P. CONVENTION IN ATLANTA WITH ANTI-JEWISH SIGNS

ATLANTA, Ga., July 4. (JTA) -- Three pickets in military-style uniforms, two of them wearing swastika armbands, and carrying anti-Semitic signs, picketed a Negro convention in Municipal Auditorium today. A police patrol wagon stood by, but police made no arrests,

Robert Bolling, one of the defendants indicted but never tried in the 1959 bombing of a synagogue in Atlanta, was one of the pickets. The others were idntified as Harry Blair, of Arlington, Va., and Lawrence Smith of Washington, D.C., both members of the American Nazi party.

The signs read: "Race Mix Jew Plot," "Communist Jews Stay Out of Atlanta" and "Why Must Negroes Be Led by Jews?" The target of the picketing was the 53rd annual convention of the National Association for the Advancement of Colored People,"

ARGENTINE JEWS LAUNCH 1962 UNITED JEWISH DRIVE; PLEDGE AID TO ISRAEL

BUE NOS AIRES, July 4. (JTA) -- The 1962 United Jewish Campaign opened here last night with Dr. Israel Goldstein, president of the Keren Hayesod in Israel, as principal speaker. The several hundred delegates, representing all Jewish groups in the country, adopted a resolution pledging Argentine Jewry to raise funds this year for the settling of at least 500 refugee families in Israel.
