#### ARGENTINE ANTI-SEMITES BOMB JEWISH BUILDINGS; TERRORISTS ESCAPE

BUENOS AIRES, July 15. (JTA) -- New anti-Jewish violence flared in Buenos Aires today, when bombs were thrown by unknown assailants against two Jewish-owned buildings. There were no injuries, and damages were slight. Police did not seize any suspects in the new attacks.

The first bomb was thrown against a Jewish cooperative, and the second at a building that formerly housed the Jewish daily newspaper, Die Presse. The bombers apparently were ignorant of the fact that the newspaper moved to a building a block away, eight months ago. A car parked in front of the building was slightly damaged,

(In London, R. N. Carvalho, president of the Anglo-Jewish Association, led a delegation which presented to the Argentine Ambassador there this weekend a memorandum sharply protesting the wave of anti-semitic manifestations in Argentina. The memorandum pointed out that anti-Semitic propaganda and incidents in Argentina had increased in the last two years. The delegation expressed the hope and "trust that the Argentinian Government will take immediate steps" to halt anti-Semitism,)

#### ISRAEL DISBANDS MEDICAL TEAMS DESTINED FOR ALGERIA; ACTS ON REBUFF

JERUSALEM, July 15. (JTA) -- Medical teams, comprised of Israeli experts in medicine and hospital administration, were ready to leave for Algeria, but the teams were disbanded today, following the anti-Israel statement made last Friday by the Algerian Provisional Government, joining the anti-Israel front of other Arab countries.

It was revealed here today that the request to Israel for medical aid was initiated by Algerians some time ago. The lining up with the other Arab nations against Israel was, therefore, considered here as a step taken under pressure from Cairo.

Official quarters here have declined to comment on the Algerian, anti-Israeli statement. But the attitude in Algiers was seen here as leaving no prospects for normal relations between Israel and Algeria. Unofficially, it was pointed out here that Israel did not ask for an exchange of diplomatic relations between the two countries. Israel's official recognition of independent Algeria a week ago, it was noted, was announced only to prove to African states, friendly to Israel, that Israel was not "pro-French" on the Algerian question.

#### Algeria's Anti-Israel Statement Provokes Pessimism in Paris

PARIS, July 15. (JTA) -- Political circles here predicted that the position of the remaining Jews in Algeria will definitely become as difficult as that of the Jews in Tunisia and Morocco, since the Provisional Government of Algeria has placed itself in the camp of Israel's enemies.

The prediction was based on the statement made last Friday at a press conference in Algiers by M'Hammed Yazid, Information Minister of the Provisional Government, in which he said that Algeria's attitude toward Israel was "exactly like that of the other Arab states," and that "Palestine is an Arab country occupied by Israel, therefore Israel is a state we cannot recognize."

He stressed that this position had nothing to do with the position of the Jews in Algeria. He said that, in Algeria, the Jews had exactly the same status as Moslems, and that Jews might be expected to hold key positions in the new Government. However, this part of his statement is taken here with a good deal of suspicion.

#### U.N. Officials in Geneva Astonished at Algerian Attitude

GENEVA, July 15. (JTA) -- International circles here -- including the Red Cross, the World Health Organization and some officials at the European headquarters of the United Nations -- reacted with amazement today, when it was disclosed that the Algeria's Provisional Government has rejected acceptance of voluntary, Jewish medical teams ready to provide aid during the grave health situation in Algeria. They expressed astonishment over the "racist" attitude apparently taken in Algeria.

### SOVIET GOVERNMENT CHARGED IN LONDON WITH USING JEWS AS SCAPEGOATS

LONDON, July 15. (JTA) -- Condemning the Government of the Soviet Union for pursuing a policy which uses the Jews as a scapegoat, Sir Barnett Janner, president of the Board of Deputies of British Jews, appealed to the USSR today to mitigate the severe sentences recently meted out against Russian Jews accused of "economic crimes, and to conduct a campaign of "enlightenment against anti-Semitism" in the USSR,

Sir Barnett made his statement in addressing a meeting of the Board of Deputies, He pointed out that, in the last year, 28 of the 46 death sentences passed in the USSR against persons convicted of "economic and currency" offenses had been decreed against Jews. Declaring that "in no other country would such savage penalties be imposed for such crimes in peacetime," he stated:

"This figure represents an inexplicably high proportion of the total, even after making full allowance for the fact that Jews are largely city dwellers," Additionally, he noted, "the accounts of the court hearings, often conducted as show trials, reveal a distinct, anti-Jewish bias."

"Taken in conjunction with other anti-Jewish manifestations," Sir Barnett declared, as the outrages on synagogues in remote districts and, above all, the continued refusal of the Soviet authorities to grant the Jewish community reasonable facilities to pursue its cultural and religious life as a recognized nationality in the USSR, there is a growing conviction that the traditional line of finding in the Jew a scapegoat for economic and other ills is being pursued in the USSR,"

Pointing out that Jews in many countries have, from time to time, protested against these death sentences and their execution, the British Jewish leader continued: "We again appeal with all earnestness to the Soviet authorities to mitigate the severity of these sentences, having regard to the offenses for which they were inflicted; to conduct a campaign of enlightenment against anti-Semitism; and, in other ways, to allay the apprehensions which are widely felt regarding the position of the Jewish community in the USSR."

#### Four More Soviet Jews Sentenced for 'Economic Crimes.'

LONDON, July 15. (JTA) -- Prison terms totaling 33 years were imposed on four Jews in Moldavia who were convicted on charges of "illegal gold and currency transactions," it was reported here today from Moscow,

The reports were based on an account in a Moldavian newspaper which indicated that two other persons with Jewish names were implicated and might have been imprisoned. The account failed to specify what imprisonment might have been imposed on the other two. Moldavia is a Soviet province on the Black Sea.

The heaviest sentence of 15 years was imposed on Semyon Kaporov, whose property was confiscated. Fishel Kleinman, a factory worker, received eight years. Two women, Frieda Goldsman, a housewife, and Dr. Sura Glusman, formerly a staff member in a Kishinev city clinic, each was sentenced to five-year terms,

#### SIR KEITH JOSEPH BECOMES MEMBER OF BRITISH CABINET; IS 44 YEARS OLD

LONDON, July 15. (JTA) -- Sir Keith Joseph, one of the most prominent Jews active in the Conservative Party and in various high governmental posts, was named by Prime Minister Harold Macmillan this week-end to the Cabinet position of Minister of Housing and Local Government, Mr. Macmillan appointed Sir Keith when he shook up his Cabinet, removing seven top Ministers.

Sir Keith, who is 44, had been Parliamentary Secretary in the same Ministry. Since 1961, he had been Minister of State on the Board of Trade. He succeeded Dr. Charles Hill, a Cabinet member who visited Israel recently. Sir Keith is a former trustee of the Friends of the Hebrew University.

#### TEL AVIV DISTRICT ATTORNEY TO FACE TRIAL FOR FALSELY POSING AS LAWYER

JERUSALEM, July 15. (JTA) Yaakov Bar-Or, former Tel Aviv district attorney, at present suspended, and an assistant prosecutor at the Eichmann trial, will be tried shortly in a District Court here on charges of falsely posing as a qualified lawyer, it was announced by the Ministry of Justice here. The Ministry did not specify whether he would be tried in the Tel Aviv court, where he had appeared as prosecutor, or whether the trial would be transferred to the Jerusalem or Haifa District Courts.

The indictment charges that Mr. Bar-Or obtained his registration as a lawyer, and a salary on a professional grading scale, by making false claims about his professional qualifications. He was suspended from his post on May 31 - the day after Eichmann's execution, after charges were investigated by the police.

#### GERMAN PRESS CONSIDERS SENTENCE AGAINST EICHMANN'S AIDE AS MILD

FRANKFURT, July 15, (JTA) -- Some of the leading newspapers here today denounced the mildness of the sentence meted out by the local court against Otto Hunsche, one of Adolf Eichmann's principal wartime aides, who sent 1,200 Hungarian Jews to their deaths at Auschwitz. At the same time, Heinz Wolf, the chief prosecutor here, announced he would appeal against the light sentence to a higher court.

During his long, Il-week trial, Hunsche, a captain in Hitler's SS, who had worked with Eichmann at Budapest, Berlin and Prague, had been charged with "complicity" in the murder of the 1,200 Hungarian Jews whom he had sent to Auschwitz in 1944. However, despite evidence showing that he knew where the deported Jews had been sent, he was convicted only of "cooperation" with their murderers. The court sentenced him, theoretically, to five years' imprisonment at hard labor.

The court also deducted nearly four years from the sentence, allowing "time off" for a previous 27-month prison sentence Hunsche had served for war crimes, as well as 19 months "off" for the time he had been in jail awaiting the trial just concluded,

Criticizing both the verdict and the sentence, the Frankfurter Allgemeine Zeitung noted today that Hunsche will probably serve only three months' imprisonment as a result of his latest mild conviction. The Frankfurter Rundschau called the sentence "shocking," and accused the judge who presided at the trial of "ignorance," The prosecutor, in his summation to the court, had requested a life sentence for Hunsche,

# TARBUTH FOUNDATION ALLOCATES \$100,000 FOR FOUR EDUCATIONAL PROJECTS

NEW YORK, July 15. (JTA) -- The launching of the first four educational and cultural projects by the Tarbuth Foundation (Foundation for the Advancement of Hebrew Culture and Education), together with initial allocations totalling more than \$100,000 for their implementation, was announced today following the first annual meeting held in its headquarters here,

The Tarbuth Foundation was incorporated earlier in the year under the laws of the State of New York for the promotion of Hebrew education and culture in all its aspects. Its formal establishment was announced with initial gifts by Abraham and Jacob Goodman of New York, including a large allocation for an accredited college for Hebrew studies and teachers' training in New York.

Dr. Emanuel Neumann, world Zionist leader, who was the original sponsor of the Foundation, was elected as its president. Abba Eban, Israel Minister of Education and former Israel Ambassador to the United States, was elected honorary chairman, and Abraham Goodman, chairman of its Board of Directors. Other officers elected at the annual meeting include David Morgenstern, secretary; and Jacob Goodman, treasurer.

At the same time, the Board of Birectors of the Foundation was enlarged by the addition of four prominent Jewish leaders; Dr. Abba Hillel Silver of Cleveland; Benjamin Harris of Chicago; Samuel Daroff of Philadelphia; Professor Shalom Spiegel of New York. The four educational and cultural projects launched in furtherance of the Foundation's comprehensive program encompass:

- The publication of a series of modern Hebrew classics designed to meet the needs of students of Hebrew in high schools, colleges and teachers' seminaries, for which an initial allocation of \$50,000 has been made,
- 2) To facilitate the introduction of Hebrew language courses in public high-schools and colleges in the United States, in cooperation with the National Hebrew Culture Council, for which an initial amount of \$25,000. has been allocated,
- 3) The initiation of a program of Hebrew instruction in summer camps and institutes, for which a similar allocation of \$25,000. has been voted.
- 4) The providing of in-service training for teachers of Hebrew in communities lacking teachers' seminaries.

Making public further details of these projects, Dr. Neumann announced that the projected publication of the series of modern Hebrew classics will consist of ten books in the first series, each containing the original Hebrew text, vocalized, with introduction, notes and vocabulary.

The program of Hebrew instruction in summer camps and institutes will include the publication of pedagogic material designed for this purpose.

In the field of Hebrew teachers' training, Dr. Neumann said that "it was planned to develop such a practical program for in-service training in cooperation with the American Association for Jewish Education;

#### YESHIVA UNIVERSITY RECEIVES \$1,000,000 GIFT FROM WURZWEILER FOUNDATION

NEW YORK, July 15, (JTA) -- A gift of \$1,000,000 was given here today by the Gustav Wurzweiler Foundation to Yeshiva University for development of the first school of social work under Jewish auspices. The presentation, on behalf of the trustees of the Foundation, was made by Dr. Joseph H. Lookstein, rabbi of Congregation Kehilath Jeshurun. Half of the sum has already been paid, Dr. Lookstein said.

Gustav Wurzweiler, who died here in 1954 at the age of 58, was born in Germany. He conducted his own banking firm there, and came to this country in 1941. Here, he was affiliated with a brokerage firm and became a member of the New York Stock Exchange. He was a founder and board member of Help and Reconstruction, an organization that assists refugees from Central Europe.

Dr. Samuel Belkin, president of the Yeshiva University, announced today that the university's new, \$3,000,000 classroom-administration building will be opened to student use tomorrow, for the first time. The building is the first to be completed as part of a \$30,000,000 development program. The new structure contains 35 classrooms, three large lecture halls, conference rooms, offices for top officers of the university, and facilities for student lounges and student activities.

#### FORD MOTOR COMPANY FUND GIVES \$25,000 GRANT TO BRANDEIS UNIVERSITY

WALTHAM, July 15, (JTA) -- The Ford Motor Company Fund has given Brandeis University a special, unrestricted grant of \$25,000 for beyond-the-budget purposes. The grant is one of several designed to "give college and university presidents a source of funds for any special project or other activity for which no provision is made in the regular school budget," Benson Ford, Fund president, said.

Brandeis President Abram L. Sachar, in accepting the gift, noted that "the Ford Motor Company's grant comes to the University at the beginning of a \$65.1 million of evelopment campaign which is concerned chiefly with securing endowment, It is especially meaningful because, being unrestricted, we can draw upon it for our day-to-day needs."

#### NEGRO LEADERS DENOUNCE 'BLACK NATIONALISTS' FOR ANTI-JEWISH SLOGANS

NEW YORK, July 15, (JTA) -- Negro leaders in Harlem were split today over charges that a group of Black Nationalists had used anti-Semitic slogans in their protest against plans by a Jewish businessman to open a restaurant in the Negra area.

The restaurateur, Sol Singer, offered to reduce the racial tensions by asserting he was ready either to take in Negro partners in the proposed restaurant or to sell out to Negroes. He made the offer after undergoing three weeks of militant and occasionally anti-Semitic picketing.

The picketing was denounced by Jackie Robinson, a former star baseball player, who is now vice-president of a coffee company which operates a chain of restaurants including several in Harlem, and by A. Philip Randolph, president of the Brotherhood of Sleeping Car Porters. Both are leaders in the Negro community.

Mr. Randolph called a press conference to discuss Mr. Singer's offer and to denounce "provocative, inflammatory" tactics of the Black Nationalists. He said that they had chanted such slogans as "Jew go away -- black man stay." Mr. Robinson said: "All my life I have been fighting against this same thing as it applies to Negroes. Black supremacy is just as bad as white supremacy."

## WORLD OSE TO CELEBRATE 50TH ANNIVERSARY; FOUNDED IN RUSSIA IN 1912

PARIS, July 15. (JTA) -- the 50th anniversary of the founding of OSE, the World Union for the Protection of the Health of the Jews, will be celebrated during 1963, This was decided upon today at a meeting of the executives of the World Union of OSE here. The celebrations will take place mainly in Israel, Dr. N.L. Wolf, director of OSE in Israel, has been charged with preparing the celebrations. OSE was founded in St. Petersburg, Russia, in 1912.

## SAMSON ERDBERG, AUTHOR OF 21 JEWISH NOVELS, DIES IN NEW YORK; WAS 70.

NEW YORK, July 15. (JTA)--Prominent Jewish authors and journalists participated in funeral services here for Samson Erdberg, well-known Yiddish author, who died at his suburban home in Long Island of a heart attack. He was 70.

Born in Poland, Mr. Erdberg was educated in Warsaw, Berlin and Paris, and came to this country in 1915. He was on the editorial staffs, successively, of the Wahrbeit, Tageblatt and the Day-Morning Journal, all national Yiddish dailies. At the same time, he was a prolific author, having written 21 novels. He also translated into Yiddish a number of Hebrew and English classics.
