U.S. URGED TO IMPRESS MCSCOW WITH NEED TC GUARANTEE ISRAEL'S SECURITY

TEL AVIV, July 14. (JTA) -- Rep. James Roosevelt, California Democrat and eldest son of the late President Franklin D. Roosevelt, stressed that the Soviet Union must be called upon by the United States to help guarantee the integrity and security of Israel, along with the similar guarantees it had already given to the Arab nations, Congressman Roosevelt was the principal speaker at today's session of the 66th annual convention of the Zionist Organization of America, being held at ZOA House here.

Referring to the greeting sent to the ZOA parley here last week by President Kennedy, asserting that "the integrity and security of Israel and of all other free mations in the Middle East" is a matter of concern to the United States, Mr.Roosevelt

"If Israel is to survive, the U.S.A. must convince the Communists and the Arab world that the full strength of our military and economic resources are behind the achievement of peace between Israel and her neighbors -- that we truthfully mean that these resources are totally pledged to guarantee the integrity and security of Israel, and that we shall welcome the aid of the Communist countries in achieving this aim in a context that will bring the same integrity and security to all free nations in the Middle East, "

In view of "recent news," said Mr. Roosevelt, "it is plain that Russia and other Communist nations are making very sure" by aiding Egypt with modern weapons, that the integrity and security of the Arab states is guaranteed. "It is important, therefore," he continued, "that the American people understand that, if there is to be integrity and security for Israel, there must be the same determination by the non-Communist nations to give the same assurance to Israel which the Communist nations are expressing to others.

U.S. Aid to Israel Seen as Measure to Prevent Aggression

"I believe," he continued, "that only thus can there finally be a meeting of minds with respect to those conditions which must precede the final coming of peace between Israel and its neighbors. The desire to be triends with all other free nations in the Middle East, as President Kennedy puts it, must fit in with the realities of what is truly happening today."

Should an invitation for discussing Arab-Israeli peace be declined, said Mr. Roosevelt, "it must be made clear that we are not afraid, but determined, to take whatever steps are necessary -- militarily and economically -- to prevent the strength of Israel's apparent enemies from reaching a point where aggression would be too inviting to resist,"

In another address, Abraham Goodman, of New York, prominent ZCA leader, told the convention that the ZCA House "bridges the gap between Israelis and Americans," He disclosed plans for the expansion of ZCA House and its activities, including the establishment of a USA-Israel Institute for Research, and for studies to be conducted in America and in Israel.

SOVIET REPORTED IN NEW ARMS DEAL WITH EGYPT: AIDING ROCKET PROGRAM

WASHINGTON, JULY 14. (JTA) -- Egypt has made an entirely new arms deal with the Soviet Union which may include aid to build up missile production and weapons of a more sophisticated nature than previously provided, it was learned today from Government sources. The arms deal is believed partly financed in a loan of \$44,400,000 recently granted by Russia to Egypt, The loan was disguised as covering "development of industrial products,"

Specific details are not yet available in Washington on weapons involved, but it is believed that the new arrangement will not only cover equipment lost in Yemen by Egyptian forces, but new weapons, as well as more Soviet participation in the Egyptian rocket program. The new military agreement is the fourth major deal between Egypt and the Soviet Bloc since 1955. State Department sources said the news would not affect U.S. plans to extend new economic assistance and loans to Egypt.

AGUDAT ISRAEL DEMANDS LAW AGAINST MISSIONARY WORK IN ISRAEL

JERUSALEM, July 14. (JTA) -- The Agudat Israel world executive concluded its weeklong conference here today with the adoption of a resolution calling on the Israeli Government to enact legislation against the spread of missionary activities in Israel. The delegates also voted to set up a world central organization for Agudat Israel's complex of independent schools in Israel which are operated outside the Government educational network

The executive also decided to convene a world convention of Agudat Israel next summer in Jerusalem, and to embark on the construction of a new settlement, Kiryat Agudat Israel, for immigrants from the United States.

In other resolutions adopted at the final session of the conclave, the delegates condemned Egyptian threats to destroy Israel, and the refusal by Jorden to permit access to the Wailing Wall. Other resolutions called for the immediate halt by Jordan of construction activities on the ancient Mount of Olives cemetery, one of Jewry's sacred shrines,

KNESSET MEMBERS PROTEST TO MINISTER AGAINST SUPREME COURT JUSTICE

JERUSALEM, July 14. (JTA) -- Parliamentary members of the National Religious Party asserted today that Supreme Court Justice Haim Cohen had disqualified himself from sitting in cases dealing with matters of personal status, because of statements he made at the American-Israeli "Dialogue" held in Jerusalem last month under the auspices of the American Jewish Congress.

Justice Coher's comments, which were sharply critical of the legal basis for the determination of Jewishness in Israel, touched off a public debate, and were the subject of an unprecedented public rebuke by the Israel Chief Rabbinate. The issue was taken up again by a Religious Party Knesset deputation at a meeting with Justice Minister Dov Joseph. The deputies conveyed to the Justice Minister the "gravity" with which they viewed the Justice's comments.

They cited a statement from a transcript of the Justice's remarks, quoting him as telling participants in the "Dialogue" that "it is, I think, one of the bitterest ironies of fate that the same biological or racist approach which was propagated by the Nazis and characterized in the infamous Nuremberg laws should, because of an allegedly sacrosanct Jewish tradition, become the basis for the official determination or rejection of Jewishness in the State of Israel.

Specifically, the Justice added, "I consider it one of the most deplorable failures of the State that it has hitherto been unable to absorb originally non-Jewish women and other non-Jewish or half-Jewish survivors of Nazi persecution as full-fledged Jews for all intents and purposes,"

The religious deputies told Minister Joséph that the statement was a "serious insult to the nation's honor and tradition." They noted that rabbinical sources had pointed out that members of all the categories cited by Justice Cohen could assume full Jewish status, according to both Jewish religious law and Israeli law, by conversion to Judaism, a procedure readily available in Israel.

\$1,000,000 HOLDAY VILLAGE' INAUGURATED IN ISRAEL FOR TOURISTS

PARIS, July 14. (JTA) -- Israel's first "Holiday Village," a \$1,000,000 project built by one of Europe's foremost travel associations, was officially inaugurated today, on the French National Independence day, by the French Ambassador in Israel.

The village was built by the European Club for Tourism, a non-Jewish travel group with more than 500,000 members in France, and other European countries. The village, situated in the vicinity of Tel Aviv, on the Migdal-Ashkelon Beach, was created by the ECT in cooperation with the Histadrut, Israel's Labor Fedration,

The "Holiday Village" will enable prospective tourists to enjoy in Israel normal hotel comforts at popular prices, such as a two-week stay in the village, and return by jet plane to Paris, for \$200. The village is made up of small bungalows, each with private bathroom, kitchen and patio. It stretches along a private beach:

The initiative of the travel group for the project was taken at the demand of its members, a majority of them non-Jews. Four thousand members have already registered for a vacation at the new village.

ATTORNEY GENERAL KENNEDY DRAWS ATTENTION TO ANTI-JEWISH BIAS

YOUNGSTOWN, Ohio, July 14. (JTA) -- Attorney General Robert F. Kennedy draw attention to the fact that anti-Jewish discrimination still exists in the United States and must be combatted.

Addressing a meeting of Slovak Americans of the Roman Catholic faith, Mr. Rennedy said that Negroes were not the only victims of bias. He told the group that American Jews also face discrimination.

GREEK JEWRY PROTESTS RELEASE OF NAZI COLLABORATOR WHO DEPORTED JEWS

ATHENS, July 14. (JTA) -- Leaders of the Central Board of Jewish Communities protested to the Government yesterday against the release from prison of a man sentenced to death in 1947, after being convicted of helping the Germans round up Greek Jews during World War II for deportation to the Nazi death camps.

The man is Constantine Recanati. A war crimes trial here convicted him in 1957 and sentenced him to death, but the sentence was commuted to life imprisonment. Last Wednesday, he was released under amnesty legislation intended to free imprisoned Communists.

GLOBKE APPEARS AS DEFENSE WITNESS FOR NAZIS WHO KILLED JEWS

VUPPERTAL, July 14. (JTA) -- Dr. Hans Globke, controversial State Secretary to Chancellor Konrad Adenauer, testified at a Nazi war crimes trial here that Nazi execution squad members had to carry out orders or face severe punishment.

Dr. Globke, whose service as an official of the Nazi Interior Ministry has provoked charges he helped prepare the legal basis for the Nazi regime, was a defense witness for four former SS officers charged with killing thousands of Jews and other victims in Nazi-occupied Russia. Dr. Globke is currently being tried in absentia in East Berlin on charges arising from his Nazi career.

He told the court that as far as he knew, execution squad members had to carry out orders. He said as a Reich Interior Ministry official, he used to meet colleagues from other Nazi Ministries weekly for an interchange of opinions. "At those meetings it was reported that soldiers attached to the execution squads generally were unable to dodge this duty unless they were prepared to be shot themselves or be sent to a concentration camp," he testified.

SOVIET GOVERNMENT PERMITS JEWISH FAMILY TO LEAVE RUSSIA FOR BRAZIL

RIO DE JANEIRO, July 14. (JTA) -- The Soviet Government has granted permission to a Jewish family, originally from Brazil, to leave the Soviet Union to return to this country, it was reported here today. The family, 12 members in all, and comprising a Mr. and Mrs. Sisman, their children and grandchildren, is the first from Brazil to be permitted to leave Russia.

The Sismans were among a group of some 1,000 Brazilians -- about half of them Jews -- who settled in Russia several years ago for ideological reasons. When Brazil and the Soviet Union established diplomatic relations two years ago, the Brazilians began to besiege this country's legation in Moscow with requests for aid in seeking to return here. The Sismans were the first family to receive Soviet permission.

ARAMCC REPORTED NO LONGER DISCRIMINATING AGAINST JEWS IN JOBS

NEW YORK, July 14. (JTA) -- A study by a field examiner of the New York State Commission for Human Rights has established that the Arabian-American Oil Company, Aramco, is complying "in good faith" with the order issued by the Commission to discontinue discrimination against Jewish Job applicants, it was reported last night by the American Jewish Congress, the organization which had filed an anti-bias suit against the oil firm more than six years ago,

The compliance check established that Aramoo now offers Jobs to Jewish applicants, and that applicants for Jobs requiring travel to Saudi Arabia are no longer asked whether they are Jews. If the applicant is approved, he receives a letter stating that he is "qualified for employment." He is then told to obtain a visa from the local Saudi Arabian consulate. No applicant has been refused a visa under this system, although there is no indication that any of the applicants have been Jewish.

Aramco has informed the State Commission that Saudi Arabia no longer requires that visa applicants be "sponsored." While the case was pending, Aramco took the position that the King of Saudi Arabia required every visa applicant to have a "sponsor," and that Aramco was required to vouch for the fact that the visa applicant was eligible for admission to Saudi Arabia - that is, that the person was not Jewish.

THREE U.S. NAZIS ARRESTED IN NEW YORK; HAD TRUCKLOAD OF ARMS

NEW YORK, July 14, (JTA) -- Three men accused by police of being members o Nazi groups were arrested in The Bronx this morning in front of a hamburger stand which has been the scene of anti-racist demonstrations. They were charged with having a truckload of arms and ammunition. Police identified the men as Edward Cassidy, 15; Paul Joachin, 35; and John Corrigan, 20.

According to Morris Weintraub, assistant District Attorney in The Bronx, Cassidy had cards showing he was a major in the Renaissance Party, as well as in the American Nazi Party. The truck, said Mr. Weintraub, contained a rifle, revolvers, shotguns, bullets and a tear-gas gun. All three were charged with violating the Sullaw Law, a state law forbicding the possession of deadly weapons, inciting to riot and "anarchy."

WASHINGTON POLICE CANCEL PERMIT FOR NAZI PARTY DEMONSTRATION

WASHINGTON, July 14. (JTA) -- Heeding a protest by Rep. Seymour Halpern, New York Republican, District of Columbia police today announced that the American Nazi party and other bigots would not be allowed to parade and demonstrate here against Negroes and Jews at the time of a massive civil rights gathering on August 28,

Rep. Halpern had questioned a previous police ruling to permit the anti-Semitic mass rally. He said in a telegram to police chief Murray: "It is only asking for a bloody explosion to permit a violence-oriented agitation organization to take to the streets when civil rights supporters are here and emotions are brimming over." He stressed that "the criminal records of the Nazis and their fellow travellers indicate that they represent a known public nuisance."

A police statement today said that no parade permits will be issued to any groups other than the anti-discrimination organizations directing the August 28 march.

ZIM LINES ESTABLISH PASSENGER SERVICE BETWEEN ISRAEL AND SO, AMERICA

NEW YORK, July 14. (JTA) -- The inauguration by the Zim Lines of a new passenger service between Israel and other Mediterranean countries and Brazil, Uruguay and Argentina was announced today by the American-Israeli Shipping Co., Inc., U.S. representatives of Zim.

The service calls for four round trip voyages during the fall, winter and spring of 1963-64 by the S/S Theodor Herzl. The liner will sail from Haifa and will call enroute at Piraeus, Naples, Lisbon, Canary Islands, Rio de Janeiro, Santos, Montevideo and Buenos Aires. The one-way voyage will occupy 22 days. The ship's return voyages will be via the same ports, but will omit Montevideo on the first and third trips and will omit Piraeus on all return trips.

SCHOLARSHIP FUND FOR JULIUS HABER ESTABLISHED AT ISRAELI SCHOOL

HAIFA, July 14. [JTA) -- A scholarship has been established at the Reali School here in honor of Julius Haber of New York, veteran American Zionist, on the occasion of his 75th birthday and the 50th anniversary of the school. The scholarship fund totaling 10,000 pounds (\$3,333) was set up by Mr. Haber's sons in Israel and the United States, who studied at the school.

MILWAUKEE JEWISH LEADER BEQUEATHS \$150,000 FOR HAIFA TECHNION CHAIR

MILV-AUKEE, July 14. (JTA) -- A \$150,000 bequest by the late Carl Fechheimer, a Milwaukee engineer, to establish a chair in electrical engineering at the Technion-Israel Institute of Technology, was announced here today by Nathan L. Berkowitz, president of the Milwaukee chapter of the American Technion Society. Mr. Fechheimer had been the first president of the chapter.

ISAAC PAIEWONSKY, FATHER OF VIRGIN ISLANDS GOVERNOR, DEAD; WAS 78

ST. THOMAS, V.I., July 14. (JTA) -- Isaac Paiewonsky, one of the most prominent merchants in the Virgin Islands, and father of Governor Ralph Paiewonsky, died here yesterday, aged 78. Gov. Paiewonsky is the first St. Thomas-born chief executive.

The elder Paiewonsky, known affectionately to many here as "Papa Paie," came to St. Thomas from Lithuania at the age of 13. Among the many enterprises which he developed and owned was a shipping service, which he used during World War II to supply the islands with drugs and other essentials. In 1945, the legislature here voted a formal resolution of gratitude for this service to "Papa Paie,"

FUNERAL FOR JACOB HOLTZMANN ATTENDED BY N.Y. POLITICAL LEADERS

NEW YORK, July 14. (JTA) -- Prominent state and local political leaders and representatives of the Jewish community attended funeral services today at the Brooklyn Jewish Center for the late Jacob L. Holtzmann, a founder of the Center, and a member of the State Board of Regents from 1949 to 1958. He died here yesterday, aged 75.

Mr. Holtzmann was active in politics since 1912, when he joined the late Theodor Roosevelt's National Progressive Party. He later was a delegate to the Republican national conventions in 1948, 1952 and 1956. As a member of the State Board of Regents, he was one of the chief exponents of educational television. In addition to his activities in the Brooklyn Jewish Center, of which he was a founder, he was formerly a member of the board of overseers of the Jewish Theological Seminary of America, and was awarded an honorary degree by the Seminary.

ALBERT ABRAMOWITZ, NOTED ARTIST, DEAD; EXHIBITED PAINTINGS IN ISRAEL

EAST MEADOW, L.I., July 14. (ITA).— Albert Abramowitz, an artist, 12 of whose paintings were recently accepted for display by the Museum of Ein Harod, Israel, died here yesterday. He was 84. Born in Riga, M.r. Abramowitz studied at the Russian Imgerial Academy at Odessa and came to the United States in 1916. A number of his woodcuts are on display in the British Museum.
