KHRUSHCHEV SAYS NUCLEAR WEAPONS SHOULD NOT BE GIVEN TO MIDDLE EAST

LONDON, July 29 (JTA) -- Soviet Premier Khrushchev has agreed, in his talks with British Foreign Secretary R.A. Butler, that the Middle East is one area where the principle of non-dissemination of nuclear weapons should be applied in a practical sense, it was reported here today from Moscow.

It was also reported that Soviet Foreign Minister Gromyko reiterated to the British diplomat the Soviet stand of categorical refusal to "put up one kopek, shilling or cent" for United Nations peacekeeping activities in the Middle East and in the Congo; The Soviets consider these operations "unlawful;"

REPORTS THAT ESHKOL PLANS TO VISIT MOSCOW ARE DENIED IN JERUSALEM

JERUSALEM, July 29 (JTA) -- Prime Minister Levi Eshkol's office denied categorically here today reports in the foreign press claiming that Mr. Eshkol is contemplating a trip to the Soviet Union to meet with Soviet Premier Nikita S; Khrushchev.

The reports, as received here, stated that Mr. Eshkol would like to follow his trips, made this summer, to Washington and Paris, where he had met with President Johnson and President de Gaulle, with a similar summit visit to Moscow. According to the reports, Yosef Tekoah, Israel Ambassador to the USSR, was carrying on conversations with the Soviet Foreign Ministry in Moscow with a view to have Mr. Khrushchev extend an official invitation to Premier Eshkol.

Mr. Eshkol's office said today those reports are "incorrect." It was pointed out that, in an address before the Israel Parliament last week, Mr. Eshkol said, among other things, that he would welcome an invitation to meet Mr. Khrushhev.

Eshkol Tells Press He May Meet with West German Chancellor

JERUSALEM, July 29 (ITA) -- Premier Levi Eshkol, addressing a press luncheon here today, said that he may meet with Chancellor Ludwig Ernard of West Germany: He added that, while he had no definite plans now for such a meeting, "my meeting Chancellor Ernard is not excluded;" He explained that he felt that meetings with heads of state were always useful;

Asked how he envisaged Israel-West German relations after termination this year of reparations payments to Israel, he replied that "as a farmer, I never put the cart before the horse;"

In replies to other questions, the Premier voiced satisfaction with the stand of African leaders at the recent Egyptian-sponsored African Unity Conference at Cairo who declined to allow themselves to be dragged by President Nasser into the Israel-Arab dispute. He also described the existing status quo on relations between religious and secular elements in Israel as satisfactor;

ISRAEL-SYRIAN BORDER CLASHES EVOKE QUESTION IN BRITISH PARLIAMENT

LONDON, July 29 (JTA) -- British representatives at the United Nations are "in touch with United Nations authorities" in New York about the recent border clashes between Syria and Israel, a spokesman for the Government told the House of Commons today. He asserted that the incidents are now being investigated by the United Nations Truce Supervision Organization, and that "a report to the authorities concerned" will be submitted by UNITSO.

The statement was made by Minister of State, Robert Mathew, in answer to a question by Eric Johnson, a Conservative member of Parliament. "What are the British representatives in the United Nations Security Council doing in regard to the unprovoked attacks made by Syrian forces against Israeli police and civilians inside Israel territory on July 2 and July 6?" the British deputy asked;

In his reply, Mr. Mathew pointed out that, while both Israel and Syria had submitted letters on these incidents to the Security Council, neither of the members had

requested that the Council hold a meeting on the issue. He stated that the two Governments had given "conflicting accounts" regarding the incidents.

(Israel had complained formally to the U.N. Security Council about Syria's latest series of aggressions, chargi g that Syria had carried out 29 shooting attacks against Israel during a four-week period ending July 6; Later, the U.N. Syrian-Israel Mixed Armistice Commission issued a report stating that "both sides" had fired. Israel maintained it returned the fire only twice during the 29 attacks, and rejected the MAC's report because it did not indicate which side had started the firing.)

ARAB COUNTRIES WARN FRENCH AIRCRAFT FIRM AGAINST DEALING WITH ISRAEL

LONDON, July 29 (JTA) -- Thirteen Arab League countries and five Arabian Gulf nations have warned the French aircraft firm of Marcel Dessault it will be black-listed in three months if it does not stop doing business with Israel, it was reported here today from Beirut;

The company makes the Mirage and Mystere jet fighters which France has supplied in substantial quantities to Israel. The Arab boycott commissioner, Mahammad Mahub, also said that the French firm must also cancel an agreement with Israel for production of aircraft spare parts;

BELGIAN GOVERNMENT CRITICIZED FOR PUBLISHING ARAB BOYCOTT STATEMENT

BRUSSELS, July 29 (JTA) -- The Socialist daily, "Le Peuple," sharply criticized today the publication by a Government trade periodical of the contents of an Iraqi anti-Israel boycott statement aimed at Belgian exporters;

The statement was published by the bi-weekly publication of the Belgian Office of External Trade. It called to the attention of exporters the "obligation" to present to the Iraq Embassy in Brussels for approval documents such as "a statement from the shipowners certifying that the ship carrying the goods is not Israeli and will not touch an Israeli port;"

The Socialist daily said it was "regrettable and even inadmissible" that an official Belgian publication should support the Arab blockade against Israel by publicizing the demands of the Iraq Embassy;

ARAB LEAGUE CLAIMS ISRAEL DISCRIMINATES AGAINST ITS ARAB CITIZENS

LONDON, July 29 (JTA) -- The Arab League headquarters in Cairo has instructed its New York representatives to urge Arab representatives at the United Nations to ask the U, N, for its attitude on alleged "racial discrimination" against Arabs living in Israel, according to a Cairo dispatch received here today.

Charging that such discrimination exists, the League declared the situation of the Arabs in so-called "occupied Palestine" constituted a "flagrant violation" of the United Nations Charter and the Universal Declaration on Human Rights;

DIRECTOR OF SUPERMARKET CHAIN IN ISRAEL ARRESTED; ARSON SUSPECTED

TEL AVIV, July 29 (JTA) -- Abe Feinberg, general director of Supersol, a chain of supermarkets in Israel owned largely by Canadian investors, was arrested here last night in connection with suspected arson. He was remanded today for a hearing before a magistrate in Tel Aviv tomorrow.

The warehouse, store and offices of Supersol in this city were gutted by a fierce fire 10 days ago. At that time, police and fire department officials said that virtually all Supersol records had been destroyed in the conflagration. Police said today that arson was suspected immediately, since the fire had started simultaneously in two separate locations on the Supersol property.

It was disclosed today that the Canadian board of directors of Supersol suspended Feinberg from his post several weeks ago, alleging that there were discrepancies in the firm's Isreel records; Feinberg, who is 33, was born in the United States, and settled in Israel shortly after the end of World War II. He is a graduate of the Hebrew Union College in Cincinnati, He had been awarded a Fubright Fellowship, and had participated in a number of archeological projects in Israel since he came here; Feinberg was under police interrogation all day today and, according to police, refused to take a lie detector test;

EX-OFFICIAL OF NAZI MINISTRY TESTIFIES ON DEPORTATION OF JEWS

MUNICH, July 29 (ITA) -- A former Transport Ministry official in Nazi Germany testified at a war crimes trial here today that he did not know that the trains he supplied for the transport of Jews were taking them to death camps;

That statement was made by Albert Ganzenmuller, former state secretary in the Nazi Ministry, in the trial of former SS Gen. Karl Wolff, who is being tried on charges of complicity in the wartime murders of 300,000 Jews;

RED CHINESE SOURCES SAY JEWS STILL 'INTERNED' IN BIRO-BIDJAN CAMP

BRUSSELS, July 29 (JTA) -- Citing Red Chinese sources, a Belgian Catholic daily published a lengthy article today reporting that a large number of Jews allegedly are "interned" in Biro-Bidjan, the once much-publicized Jewish autonomous republic in the Soviet Union.

"La Libre Belgique" asserted that the Soviet or East European Jews live in an 'immense internment and forced labor camp," Indignantly describing the "inhuman conditions" imposed by the non-Jewish local authorities on this "Biro-Bidjan hell," the Catholic daily also assailed the fate of Jews throughout the Soviet Union, seeking to refute the Soviet Government claims that Jews in Russia enjoy equal rights;

"In reality, anti-Semitism flourishes throughout the country on all levels of society," the daily writes, "In these conditions, it is not surprising that, despite all precautions taken by the authorities, proof of some of the particularly eloquent manifestations of this anti-Semitism from time to time reaches the free world,"

ANCIENT SYNAGOGUE EXCAVATED IN BUDAPEST; DATES BACK TO MIDDLE AGES

LONDON, July 29 (JTA) -- Hungarian archeologists have uncovered the remains of a 14th century synagogue on the site of the ancient town of Budetar, now part of Budenest, it was reported here today from that city.

Dr. Alexander Schreiber, director of the Jewish Theological Seminary in Budapest, was called in to decipher the Hebrew inscriptions on the walls. These indicated that there was a Jewish community in Budetar in the early Middle Ages which built the synagogue. The discovery was described as an unexpected one.

JEWISH CONGRESS OFFICERS FOUND 'NOT GUILTY' IN JORDAN MURAL PICKETING

NEW YORK, July 29 (JTA) -- Twelve American Jewish Congress officials who picketed the Jordanian Pavilion at the World's Fair on May 25 were found not guilty today of disorderly conduct charges by Judge Bernard Dubin in Queens County Criminal Court:

In his ruling, Judge Dubin held that the World's Fair was "quasi-public property" and was therefore not exempted from the requirements of the First and Fourteenth Amendments to the U,S; Constitution, which guarantee free speech;

Howard M. Squadron, a Congress vice-president, said: "Many of the officers of the American Jewish Congress are currently abroad attending meetings of international Jewish organizations. On their return in the early fall, we will meet to consider what further steps our organization will take -- including the possibility of further picketing -- to express our objections to the malicious and insulting mural at the Jordanian Pavilion;"

"It is within the power of Robert Moses, World's Fair president, to see to it that this mural is removed. Now that the court has spoken and the right to protest the Jordanian libel has been upheld, we hope that Mr. Moses will exercise his power to remove this blight from a fair that seeks to promote the theme 'Peace Through Understanding.'

Judge Rebukes World's Fair Authorities for Not Removing Mural

In his ten-page decision, Judge Dubin rebuked Fair authorities for their failure to remove the mural; "It is my opinion that the World's Fair authorities might have made some effort, whether legally bound or not, to have the offensive mural removed, They objected to one defendant exhibiting an innocuous placard, yet a mural is allowed to remain which many people feel creates hatred and bigotry against a foreign nation and a race and people. The reasoning seems to be inconsistent;"

Judge Dubin also cited "the background and participation in community service" of the 12 leaders, which he said made it "evident that none of them had an intent to provoke a breach of the peace." He noted there was "no use of offensive, disorderly, threatening, abusive or insulting language on the part of any of the defendants. There was no proof that their actions annoyed, disturbed or interfered with or obstructed or was offensive to any passerby; "

ORT TO DOUBLE CAPACITY OF ITS VOCATIONAL SCHOOLS IN ISRAEL

JERUSALEM, July 29 (JTA) -- Education Minister Zalman Arranne announced today the signing of an agreement between the Ministry and ORT under which the organization has agreed to double the capacity of its vocational schools within the next five years. The number of pupils in such schools is expected to reach 50,000 by the end of that period; ORT now operates trade and vocational schools in 31 cities and towns throughout Israel, including three-year and four-year vocational high schools;

INDIANAPOLIS JEWISH FEDERATION APPROVES C.R.C. STAND ON CIVIL RIGHTS

INDIANAPOLIS, July 29 (JTA) -- The annual meeting of the Jewish Weliare Federation here gave an overwhelming vote of confidence to the civil rights and church-state activities of the Jewish Community Relations Council of this city, Federation officials announced today:

Some of the activities of the JCRC were questioned at the annual meeting, as were other issues concerning the Jewish community. To test the feelings of the 300 community leaders at the meeting, ballots were taken on each of the issues debated;

The meeting voted 123 to 49 in favor of the Jewish Community Relations Council continuing its work on equal rights for Negroes, civil rights in general, and open occupancy; On the issue of church-state relationships and, in particular, on the Council's concern with the teaching of religion in public schools, the JCRC was supported by a vote of 142 to 28.

Federation officials, however, pointed out that the voting represented only the opinions of those attending the annual meeting, and need not be construed as final results to determine Jewish community policy.

ISRAEL TO DEVELOP APPAREL AND TEXTILE EDUCATION; PLANS FASHION SCHOOL

MEW YORK, July 29 (JTA) -- A school is planned by the Government of Israel in Tel Aviv to train apparel designers and engineers on recommendation of officials of the New York Fashion Institute of Technology;

The plan was disclosed yesterday at a press conference by Dr. Lawrence L. Bethel, president of the Institute, who, with two aides, recently visited Israel. They made the visit on invitation from Pinhas Sapir, the Israel Minister of Commerce and Industry, after he had visited the Institute here.

Dr. Bethel said that if the plan is accepted, construction of the school at a cost of \$3,000,000 would be started for completion in October of 1966. He added that the faculty would be recruited from the Institute here. For that purpose, he said, he proposed that three faculty members go to Tel Aviv for three years to teach in the Institute there. In addition, 10 or 12 graduates of the New York Institute would be prepared to teach in the Tel Aviv school;

He said that, despite the fact that textile and apparel manufacture "constitute the largest industrial operation" in Israel, almost nothing has been done there for textile and apparel education. The New York Institute is operated jointly by the University of the State of New York, the New York Board of Education, and the Educational Foundation for the Apparel Industries.

MAPAI HOUSE IN ASHDOD TO BE NAMED FOR LOUIS SEGAL; CORNERSTONE LAID

TEL AVIV, July 29 (JTA) -- The cornerstone for the Mapai house in Ashdod, which is to be named for the late Louis Segal, for many years general secretary of the Farband Labor Zionist Order, was laid yesterday in ceremonies attended by Farband delegates, Mapai leaders and representatives of Ashdod workers;

Ashdod is expected to become soon a city of 250,000 inhabitants and Mapai decided to names its house in the new city in memory of Segal, "one of the greatest leaders in the American Jewish labor movement," said Reuven Barkatt, who brought the greetings of Mapai.

S. Bontcheck, Farband president, described the late Jewish leader's personality and accomplishments. Representatives of Mapam, Achdut Avodah and religious groups also brought greetings.

MOSES SMITH, NOTED AMERICAN MUSIC CRITIC, DIES IN BOSTON; WAS 63

BOSTON, July 29 (JTA) -- Moses Smith, music critic of the Boston Transcript, and brother of Louis P; Smith, past president of the Combined Jewish Philanthropies of Greater Boston, died yesterday following a lengthy illness; He was 63;

A native of Chelsea, Mass., he was graduated from Harvard College and Harvard Law School; Instead of becoming a lawyer, he turned to journalism and became the music critic of the Boston American. He gained national acclaim in 1934 when he became the music critic of the Boston Transcript, succeeding the renowned H.T. Parker, regarded in his day as one of America's most distinguished music critics;

PROF: ROGOSINSKI, NOTED JEWISH SCIENTIST, DIES IN DENMARK; WAS 70

COPENHAGEN, July 29 (ITA) -- Dr. Werner Wolfgang Rogosinski, professor of pure mathematics at Aarhus University, died at Aarhus yesterday at the age of 70; Born in Germany, the Jewish scientist had been on the faculty of Gottingen University, and was professor emeritus of Durham University. He was a leading member of the Mathematical Institute at Aarhus.
